Cautious investors seen avoiding 'risk on' trades

MUMBAI: Market players are keeping their fingers crossed as investors are weighed down by the continuing bearish sentiment due to a combination of domestic and global factors. Continuous foreign fund selling, weakness of the rupee, the escalating tariff war that was started by the US and a not-sogood quarterly corporate results have pulled the sensex and nifty down by around 2.5% each last week. Investors do not see any positive trigger that could stop the slide."These declines stem from concerns over US tariff policies and slowing corporate earnings, leading to widespread sell-offs, particularly in small-cap stocks," said Krishna Appala, senior research analyst, Capitalmind Research in a note. On Friday, while the sensex ended at 75,939 points, the nifty ended at 22,929 points. Foreign funds have been the largest sellers in the Indian market so far this year with the net outflow already over Rs 1 lakh crore, data from NSDL and BSE showed.Of the total in Feb so far, the net outflow is nearly Rs 21,300 crore. Next week's trading trend, like in the past few weeks, is expected to be determined by trading pattern by foreign fund managers, market players said. The ongoing tariff war that was started by US President Donald Trump after assuming office on Jan 21, is yet to take a definite shape. So the related uncertainties are weighing heavily on markets around the world. Till there is some stability or certainty relating to US's trade relations with its other major trading partners, investors will remain cautious and prefer to avoid 'risk.

Stampede: No steps taken despite early signs of trouble

NEW DELHI: A day after the devastating stampede at New Delhi Railway Station, there were many questions but few answers. While the lack of measures that could have prevented such a situation was apparent, passengers also flagged a range of lapses ranging from absence of proper communication from railway staff to nonavailability of trained medical help.There were early signs of trouble. Around 8.15pm, two hours prior to the stampede, several X users began posting about the growing crowd near the platforms. Yet, no measures were taken to manage the situation, it has been alleged. Despite clear warning signs, the congestion only worsened. One user "Shiv Ganga posted, Express-12560. New Delhi -Overcrowded Platform No. 12 (last-minute change from 14). Despite having a ticket, we can't enter the coach. The first-class TTE has locked the door, but no one is managing the other AC coaches." Many passengers claimed that they were caught off guard by the last-minute platform change which contributed to the chaos. Stranded passengers rely on each other for help in chaos Railway



officials were quick to refute allegations that there was a last-minute change in platform. "The matter is being investigated by a high-level committee. No train was cancelled, nor was there any change in platform... Let the committee submit its report and findings," said a senior railway officer. The sale of around 1,500 general class tickets every hour in such a situation also raised serious questions about accountability. Many passengers claimed that the influx should have been halted in time. The lack of clear announcements regarding train arrivals was another major concern raised by passengers, with many believing it contributed significantly to the stampede particularly in

the case of the special train. Passengers at the station claimed that the

announcements unclear due to background noise.There was little to no visible medical assistance available on the platforms. Stranded passengers were left to fend for themselves, relying on each other for help in the chaos. Several families that spoke to said that doctors or trained responders could have made a real difference. "Even on normal days, when the station is crowded, there's no one to assist those in need. Getting a wheelchair for the elderly or disabled is always a Sometimes, struggle. porters are paid extra to carry elderly passengers on the trolley," said a vendor who didn't wish to be named.

After Punjab govt's criti- **NEW DELHI:** After a his-Assembly elections, the Bharatiya Janata Party (BJP) is now gearing up for a major decision: who will become the next chief minister of Delhi? The party secured a commanding 48 seats out of 70, sweeping the Aam Aadmi Party (AAP) aside and ending its decadelong rule in the capital.

BJP Legislature Party meeting scheduled for tomorrow, February 17, was postponed. Now this meeting will be held on February 19. The swearing-in ceremony of the chief minister will also be held on 20th February instead of 18th February, ANI reported quoting sources. BJP's return to power in Delhi after 27



vears has raised anticipation over the leadership choice. While several names have been floated, sources suggest the party is likely to select a leader from among the winning MLAs to avoid the necessity of byelections.

Parvesh Verma emerged as a strong contender following his victory over Arvind Kejriwal in the New Delhi constituency. The son of former chief minister Saheb Singh Verma, Parvesh has twice won the West Delhi Lok Sabha seat and is seen as a strong representative of the Jat community, which played a crucial role in the BJP's electoral success.

Vijender Gupta, the leader of the BIP in the outgoing Assembly, is also being considered. Gupta secured his third consecutive victory from Rohini and is seen as an experienced leader capable of leading the state government. Additionally, former Delhi BJP chiefs Satish Upadhyay and Virendra Sachdeva have been named as potential choices. The BJP has a history of making unexpected choices for key leadership roles, often selecting lesser-known figures to introduce fresh perspectives. This has fuelled speculation that the party might opt for an unconventional pick. Some reports suggest the possibility of appointing two deputy chief ministers.

Maha Kumbh: SRN Hospital saves life of Nepali devotee suffering from brain stroke

DR. KAMLESH SONKAR AND HIS TEAM TOOK QUICK DECISIONS

Mahakumbh Nagar: Doctors of Swaroop Rani Nehru Hospital have once again succeeded in saving a patient's life through timely and correct treatment. 85year-old Ramdhani, who is a resident of Lumbini, Nepal and was staying at Shanti Kutia (Mauni Baba Ashram) of Maha Kumbh for the last one month, was brought to the Trauma Center of Swaroop Rani Nehru Hospital in a critical condition. The patient complained of weakness in the right side, difficulty in speaking (aphasia) and mild fainting. She had a problem of hypertension, and all these symptoms were present for the last two hours.

Senior neuro physician Dr. Kamlesh Sonkar and his team took quick decisions and got the patient's CT scan and other necessary tests done, which revealed that the patient had suffered an ischemic stroke. If the stroke is treated at the right time, the patient's condition is more likely to improve. Therefore, Dr. Sonkar's team

procedure without delay, which removed the blockage in the patient's blood vessels and restored blood flow. Due to quick medical assistance, the patient's condition became stable, which in-

vival and speedy recovery. According to Dr. Kamlesh Sonkar, brain stroke is a medical emergency in which the supply of oxygen is disrupted due to blockage in the blood ves-

sels of the brain. This condition includes paralysis, difficulty in speaking and in serious cases it can even cause death.

He said that if the patient gets medical help within four and a half hours of the stroke, then his/her chances of survival and complete recovery are high. It is very important to identify brain stroke early and start treat-

Dr. Sonkar, who has also served at Sanjay Gandhi PGI, Lucknow, said that the common symptoms of stroke include weakness or numbness on one side of the body, face becomes crooked, difficulty in speaking or understanding things, sudden dizziness or loss of balance and includes trouble seeing in one or both eyes. If any of these symptoms appear, the patient

According to Dr. Rajkumar Chaudhary, conodal officer of the Trauma Center, the modern imaging technology, experienced doctors and emergency services available here are proving to be extremely beneficial for the patients. As per the instructions of the Chief Minister Yogi Adityanath ji, keeping in mind the Maha Kumbh 2025, the facilities of the Trauma Center have been

continuously improved, due to which patients are getting high level medical services.

Some important precautions should be taken in case of brain stroke. The patient should be kept calm and lying down. His blood pressure should be checked and he should be taken to the hospital immediately. Aspirin or any other medicine should not be given without doctor's advice, because it can worsen the condition.

The patient's daughter Rita expressed her gratitude to Dr. Kamlesh Sonkar, Dr. Prabhat Singh, Dr. Archana Ojha, Dr. Sandeep, Dr. Sujit, Dr. Tej Pratap and the entire neurology team. It was because of their promptness and efficiency that Ramdhani's life could be saved. The family thanked the doctors and the hospital administration and said that this incident proves that by getting the right treatment on time, a serious condition like brain stroke can be controlled and the patient can be given a new life.

At present, this facility is available only in SGPGI Lucknow, RML Lucknow and BHU Varanasi in Uttar Pradesh, whereas it is available in abundance in America and Europe. Prayagraj: In the months of November, December and January, despite discharging departmental responsibilities and the busy schedule of Maha Kumbh, Uttar Pradesh government's Industrial Development Minister and Prayagraj City South MLA Nand Gopal Gupta Nandi is continuing his campaign to help the economically weak and people affected by serious diseases. Fiscal capacities in national growth

India's economic progress is a composite reflection of the growth trajectories of its states. Given the federal structure of the country, each state operates with a degree of autonomy in implementing policies that drive their individual economies. This results in a broad spectrum of growth rates across states, highlighting significant disparities. For the nation to achieve holistic growth, it is imperative for all states to experience economic advancement. Despite this, there is a notable discrepancy in the attention paid to fiscal matters at different levels of government. The Union Budget, detailing the central government's finances, often garners substantial scrutiny and debate for its potential impacts on the nation's economic direction. In contrast, state budgets, which are crucial for addressing local needs and fostering regional development, do not attract a similar level of public and analytical scrutiny. Fiscal capacity, the government's ability to generate revenue from available tax and nontax bases, is crucial for several reasons. First, it underpins a government's ability to provide essential public goods and services. These range from healthcare and education to infrastructure and defense, which are fundamental for the welfare of the citizenry and the smooth functioning of the economy. Without adequate fiscal capacity, governments may struggle to maintain these services at levels that meet public demand and expectations, potentially leading to social unrest or a decline in the quality of life. Second, fiscal capacity is vital for economic development and growth. Governments need resources to invest in infrastructure projects like roads, bridges, and digital networks, which are critical for enhancing productivity and competitiveness. Such investments not only improve current living standards. but also set the stage for future economic expansion. The Asian Development Bank Institute (ADBI) in 2017 and the World Bank in 2015 highlighted the risk of economies falling into a 'middle-income trap' where they are unable to transition to high-income status due to inadequate fiscal capacity among other factors.

Moreover, fiscal capacity is essential for macroeconomic stability. It allows governments to manage economic cycles more effectively, applying fiscal stimulus in downturns and restraint in booms to maintain economic stability. The Covid-19 pandemic's impact on Indian states underscored this point, as reduced fiscal capacities constrained their ability to respond effectively to the crisis and its economic repercussions.

Finally, a robust fiscal capacity enables equitable social development. It allows for redistributive policies that can mitigate income inequality and fund social safety nets for the vulnerable. Studies have shown that factors such as high per capita income, education levels, and low corruption contribute to higher fiscal capacity, which in turn can be used to foster a more inclusive society.

Given that state governments account for over 60 per cent of general government expenditure in India, enhancing their revenue-generating capacity is imperative for the needed investment in areas such as education, research and development, and skill development.

The Reserve Bank of India recently released a report on state finances, which gives an insight into the state budgets of 2023-24. It has some important findings. First, revenue mobilisation in Indian states comprises both tax and non-tax revenues, with a significant portion coming from state's own tax revenues (SOTR). Over the years, there has been a noticeable increase in SOTR, growing from 5.7 per cent of GDP in 2003-04 to 6.9 per cent in 2022-23. This growth, particularly in the post-GST era, reflects a shift in the composition of tax.

revenues. with the State Goods and Services Tax (SGST) becoming a predominant source.

Movements were either crushed badly by this government which suppressed democracy

This time, the first phase of voting for the Lok Sabha elections is to be held on April 19 and the entire BJP lobby including the Modi government at the Center is trying to win more than 400 seats. But it seems that by giving the slogan of 'This time we cross 400', BJP does not want to win so many seats but wants to snatch them. Otherwise, any government would not only get nervous due to so many protests from different sections of the people all over India, but would also try to pacify the angry people and also accept their legitimate demands. But despite opposition on many issues across the country, not only the Modi government at the Center and Prime Minister Narendra Modi, but even a single BJP worker is not ready to bow down. Not only this, the Modi government at the Center is eager to come to power at the Center for the third time by crushing every protest, every movement and every person who opposes its policies like an intoxicated elephant. In fact, if we look at the two tenures of the Modi government at the Center in the last 10 years, we find that it has not refrained from crushing any movement, any protest or any opposition. Be it the movement by ex-servicemen demanding One Rank One Pension, be it the movement of farmers, be it the



daughters and women wrestlers, or any demonstration by unemployed youth demanding jobs, Be it the movement of women employees of Anganwadi centres, or the protests against EVM Tehelka, or the movements in Jammu and Kashmir and Ladakh to the North-Eastern states. In this way, if we look at the last 10 years of the tenure of the Modi government at the Centre, about twenty types of movements took place at various places; But most of the movements were either crushed badly by this government which suppressed democracy or they were suppressed to such an extent that their voice could not reach the country and abroad. The remaining work in ending these movements was done by a special group of Modiya and those people who have got contracts for various odd jobs in the country. However, if we look

in the country in the last 10-12 years, then first of all we have to look at the protests that took place across the country against the Anna movement and the Nirbhaya incident, due to which the UPA central government was ousted. However, the UPA central government of that time also tried to crush both types of movements; But not to the extent that the Modi government at the Center has done anything to crush all the movements. If we talk about the time after Prime Minister Narendra Modi came to power at the Centre, then the Patel movement of Gujarat, Maratha movement of Maharashtra, farmers movement of Maharashtra, farmers movement of Tamil Nadu, Anganwadi movement, teachers' movements in different states.

Apart from the movement of unemployed youth and the movement of

women wrestlers, all the farmers' movements across the country and the farmers' movement that started in the year 2020 have been crushed by the Modi government at the Center and the BJP state governments. Their demands and problems have been ignored. And the agitators and protesters have been kicked and water cannons have been used. In the first farmer movement against the three agricultural laws, an attempt was made to end the movement by putting all kinds of pressure on the farmers, and this time, when the central government did not fulfill its promises, the farmers decided to march to Delhi. So the attack on them was intensified. Attempts were made to harm them in every possible way, which again led to the martyrdom of 16 farmers. There is still a ban on farmers coming to Delhi as if they are not food providers but terrorists. Recently, Section 144 was imposed in Delhi for more than a month to stop the farmers and even today Section 144 is applicable at some protest sites in Delhi. For example, after the protest by women wrestlers was crushed at Jantar Mantar, Section 144 is still in force and no victim can sit there and raise his voice. Recently, regarding crushing the farmers movement, Rajasthan's Jat leader Hanuman Prasad Beniwal

wrote on Twitter handle '@narendramodi ji, the way he arrogantly wrote on India

Let me remind you that you did not fulfill the promise made to the farmers during the farmers' movement. Therefore, the step to agitate again for the farmers and their rights was forced to be taken. On one hand you say that violence has no place in democracy. Farmers are being shelled at the behest of the other government, keeping in mind the current situation after the Rashtriya Lok Dal, which fought for the farmers of Western UP, joined hands with the BJP, it is your utmost responsibility to Take cognizance yourself and agree to the demands of the farmers! L

"Whether it is district-level GDP, or district-level socioeconomic data, the time has come to generate district-wise data for better targeting and design of policies," Kant said at an event organised by the ministry of statistics and proimplementation (Mospi) to mark 75 years of the National Sample Survey (NSS). Kant called for continued innovation in the statistical field to keep data a power-



and competitiveness and urged that adoption of new technologies will make India globally more relevant.

"Technologies such as AI and ML (Machine Learning) can significantly improve data collection methods by automat-

ful tool for growth, inclusivity, ing processes. For instance, the UK's Office for National Statistics (ONS) is exploring AI to enhance data collection and analysis, aiming to improve the timeliness and quality of official statistics," said Kant. He said incorporatnon-traditional data

sources, such as satellite imagery and mobile data, can complement existing survey data. "The success of the next 25, 50, or even 100 years of India's growth will depend on how well we continue to collect, interpret, and use data," Kant said. Rao Inderjit Singh, MoS for statistics & programme implementation, pointed out how NSS surveys have influenced key areas like employment, consumption, health, and education, driving critical policy decisions.

He emphasised govt's ongoing commitment to advancing NSS, integrating new technologies, and ensuring it remains relevant in the years to come.

IZYUM: A Russian ballistic missile strike on Tuesday killed five people including a pregnant teenager and wounded more than four dozen others in the east Ukrainian town of Izyum, officials said. 

Vietnam's restrictive internet law comes into force

A new internet law in Vietnam, Decree 147, gives the government increased control over internet access and content in the name of national security and social order. livelihoods. A new internet law that gives the Vietnamese government expanded powers over internet services and people using them is set to officially take effect Wednesday. Decree 147 expands government



control over access to information on the internet for reasons of "national security" and "social order."The law requires social media platforms providing services to users in Vietnam to store user data and provide it to authorities on demand. The government issued the decree this November, and it requires organizations to take down anything the authorities consider "illegal content" within 24 hours. Decree 147 has sparked concerns, with researchers and experts tracking the country saying that the law is part of a growing crackdown on civil society. "Because the Vietnamese police treat any criticism of the Communist Party of Vietnam as a national security matter, this decree will provide them with yet another tool to suppress dissent," said Patricia Gossman, associate Asia director at Human Rights Watch.
