Operation Sindoor outreach: How government chose 25 countries for all-party delegation

NEW DELHI: In a major diplomatic initiative following Operation Sindoor, the central government has deployed seven all-party delegations of Members of Parliament to key global capitals starting May 23, with the objective of presenting a united national stance against Pakistansponsored terrorism.

51 political leaders, including parliamentarians and former ministers from various parties, and 8 former ambassadors are set to tour 25 nations, including those that are a member of United Nations Security Council (UNSC), along with other influential nations.

The 10-day outreach mission will be led by senior MPs such as Shashi Tharoor, Ravi Shankar Prasad, Sanjay Kumar Jha, Baijayant Panda, Kanimozhi Karunanidhi, Supriya Sule, and Shrikant Eknath Shinde. The initiative is being coordinated by Parliamentary affairs minister Kiren Rijiju, who released the complete list of delegation members and their respective destinations shortly after the programme was announced.

How were the countries selected?

5 other influential nations This was confirmed at the all-party delegations briefing by foreign secretary Vikram Misri on Tuesday.

"We are going to all countries that are members of the UNSC, they are about 15 in number.

We are also going to five other countries that will Beating Retreat Resumes At become members of the

UNSC in the days to come. A few such countries have been selected, whose voice is heard on international level, these nations are very important. So, representatives are going to over 25 nations," BJP MP Aparajita Sarangi cited Misri saying. Why these countries were selected?

As Pakistan will remain a UNSC member for next 17 months, it would use the platform to propagate its false narrative. Hence, the government chose these nations to present India's side of the story. The neighbouring nation, at several occasions in the past, has used the platform to make anti-India remarks to push

"When meeting will be held at the UNSC, Pakistan, which would be a member of the UNSC for the next 17 months, will definitely try to present its position. It will make anti-India claims. So, it is essential now and our government rightly thought that MPs of different parties should visit these different countries together and present our narrative to the bureaucracy and political representatives there...and we condemn Pakistan's approach of promoting terrorism," Sarangi said.

"This is our responsibility. We want to give a message that India stands united against terrorism. Under the leadership of PM Modi, government of India honours the security of 140 crore people of the country...There is zero tolerance to terrorism," she added. India launched Operation Sindoor on May 7 in retaliation to the Pahalgam terror attack that killed 26. The armed forces targeted nine terror infrastructure in Pakistan and Pakistan-occu-

pied Kashmir killing nearly

100 terrorists.

RIL moves SC against Delhi HC order in \$1.7 billion gas dispute with govt

NEW DELHI: Reliance UK's BP Plc. and Canadian Industries Ltd (RIL) and its foreign partners have moved the Supreme Court against the Delhi High Court's February ruling quashing an arbitral award in their favour in the dispute with the Centre's \$1.7 billion claim over alleged siphoning of gas from a Krishan=Godavari field off the Andhra coast.

RIL filed the lead petition ners BP Exploration (Alpha), a subsidiary of firm Niko Ltd filed similar petitions separately.

The high court had on February 14 ruled against RIL and its partners and upheld the government's claim on the ground of making "unjust enrichment" by extracting gas that

When the World No. 1 chess player took on 143,000 people in a historic freestyle

Norwegian chess legend Magnus Carlsen faced an unprecedented challenge this month — playing a single freestyle chess game against over 143,000 people around the globe. Billed as "Magnus Carlsen vs The World," the match was hosted by Chess.com, and ran from April 4 to May 13. It was the first-ever online freestyle game to feature a reigning or former world champion.

Unlike traditional games, this clash followed a "freestyle" format, where the non-pawn pieces are randomly arranged at the start, allowing for a greater emphasis on creativity over memorisation. Carlsen, playing with the white pieces, was pitted against a global team of players —



Team World — who collectively voted on each move, with both sides allotted 24 hours per turn.

Despite Chess.com's predictive models favouring Carlsen, the game proved far more evenly matched than expected. By move 32, the world had checked Carlsen's king into a stalemate scenario known as "threefold repetition," ending the game. Reflecting on

the match, Carlsen praised the quality of play from his formidable opponent: "Overall, 'the world' has played very, very sound chess from the start. Maybe not going for the most enterprising options, but kind of keeping it more in vein with normal chess which isn't always the best strategy, but it worked out well this time." Before leaving, they tried to liquidate their properties and cars and transferred under \$800,000 in cash from their bank accounts in New Zealand to accounts held in India.

'Police inactive and absent': What are key findings of HC-appointed panel on Murshidabad violence

NEW DELHI: A report by three-mem-

ber committee set up by Calcutta high court to investigate the anti-Waqf protests Murshidabad that turned violent has pointed to serious lapses by local authorities in West Bengal. The report noted that the "main attack" took place on April 11 and the "local police were completely inactive and absent". It further alleged that a local councilor played a



key role in orchestrating the attacks in Dhulian town.The high court on April 17 directed the formation of a committee to identify and reha-

bilitate those displaced by the violence. During the protests over the Waqf Act, a father and son — Harogobindo Das and Chandan Das -

were discovered brutally murdered with multiple stab wounds at their home in Shamshergani's Jafrabad locality.

Glittering Decay: The Hidden Costs of Global Advancement: Dr. Ajai Kumar Sonkar

Prayagraj: Renowned scientist Dr. Ajai Kumar Sonkar, whose insights bridge the realms of biology and ecology, urges us to confront the inconvenient truth behind the modern idea of progress. When you look at the world's most developed and affluent nations-Australia, the United States, Denmark, Sweden, and Finland-you find countries celebrated for their technological prowess, high living standards, and economic strength. On the other end of the spectrum lie nations like Nepal, Bhutan, Bangladesh, and Niger, often described as underdeveloped due to their limited infrastructure, industrial output, or GDP per capita.

But herein lies a disturbing contradiction.

When you investigate which countries have the highest cancer incidence, a emerges. The very nations celebrated for their "development" consistently top the charts for cancer rates. Countries like Australia, the U.S., Belgium, and Denmark

often report cancer rates that are two to three times higher than those seen in many developing nations. For Example - Australia -Australia has one of the highest age-standardized cancer incidence rates globally. According to the Australian Institute of Health and Welfare (AIHW), the age-standardized incidence rate for all cancers combined was approximately 503 cases per 100,000 people in 2023. Other sources also report similar figures, with some indicating rates around 452 cases per 100,000 people.

South Asian Nations -Nepal - Data from the Nepal Health Research Council (NHRC) indicates that the age-adjusted incidence rate in Nepal was approximately 65.6 cases per 100,000 people in 2019.

Bhutan - A study reviewing cancer incidence in Bhutan reported age-adjusted incidence rates of 76.4 per 100,000 population among males and 101.7 among females between 2014 and 2018.

Bangladesh - According

to data from the Global Burden of Disease Study, Bangladesh had an agestandardized cancer incidence rate of approximately 134.5 per 100,000 people in

This is not a statistical coincidence. It is a biological warning bell.



And this is not limited to cancer alone - the same story holds true for all deadly diseases. It signals that the environments we call "modern" may actually be biologically destabilizin developing countries, the majority of cancer cases are increasingly linked to the imitation of Western lifestyles-processed food consumption, sedentary habits, chemical-laden environments, and exposure to synthetic pollutants.

Dr. Sonkar observes,

"We've built systems that may appear successful on paper but are quietly sabotaging human biology and Earth's natural balance.'

Yes, modern development has brought undeniable benefits-advanced hospitals, reliable infrastructure, longer lifespans, and instant connectivity. But beneath this glossy surface lies a health and ecological crisis. Industrialization has flooded our lives with chemicals, microplastics, artificial foods, and environmental toxins. Water. air, and soil are all compromised by synthetic sub-

As Dr. Sonkar explains, "We've strayed so far from nature that our bodies now struggle to heal themselves. constant battle with artificial environments they were never designed to endure."

Worse yet, modern life is not only physically toxicit is scientifically proven to

be mentally and emotionally stressful. Today's so-called "successful life" is riddled with chronic deadlines, competition, digital fatigue, and social isolation. Dr. Sonkar calls stress "the silent poison," stating, "Stress is the mother of all deadly diseases. Heart disorders, diabetes, cancer, and mental illness-they all originate from prolonged

This same development model is wreaking havoc on the planet. Deforestation, plastic-filled oceans, chemical-laced rivers, and greenhouse gas emissions are just the visible symptoms. According to Dr. Sonkar's environmental research, "The Earth has its own immune system. When we keep assaulting it, the consequences become globaland irreversible.'

Ironically, many underdeveloped countries-those we often look down uponare, in fact, biologically more resilient. Their populations are still closely connected to nature. They consume fresh, local food, engage in physical labor, breathe

cleaner air, and live in tighter-knit communities. Traditional medicine and holistic health systems still prevail. Dr. Sonkar notes, "Their simplicity isn't backwardness-it's biological intelligence. It shields them from the lifestyle diseases that have become epidemics in the West.'

The core message is clear: our current development model, while impressive on the surface, is dangerously flawed. It neither ensures human well-being nor safeguards ecological balance. As Dr. Sonkar rightly states, "If progress is making us sick and destroying the planet, then it's not progress-it's disguised decay.

He argues that we must redefine what progress means. Economic growth alone can no longer be the measure of development. If our bodies are breaking down, if our minds are fray ing, and if our ecosystems are collapsing, we are building a world that looks advanced on the outside but is biologically broken on

India's naval advancements will fuel its Indian **Ocean ambitions**

As India approaches, the nation has achieved a significant milestone in strengthening its naval capabilities. In an exceptional move reflecting strategic foresight, Prime Minister Narendra Modi recently commissioned three advanced naval platforms in a single day: a destroyer, a frigate, and a submarine. However, in a fastchanging security environment in the Indo-Pacific, the developments in naval capabilities must be measured in a relative context— capabilities of arch rivals and a swiftly evolving security domain, that is. Now, five points need to be underscored in this context. The commissioning of advanced naval platforms highlights India's aspiration to establish itself as a net security provider in the Indian Ocean Region (IOR). Over the years, India's maritime security strategy has significantly evolved. The 2015 Security and Growth for All in the Region (SAGAR) vision reflects India's dedication to fostering regional cooperation in the Indo-Pacific. This vision is supported by initiatives such as the Indian Ocean Rim Association (IORA) and the Indian Ocean Island Countries (IOIC), which emphasise coastal connectivity and sustainable development. PM Modi's address at the 2018 Shangri-La Dialogue further reinforced India's strategic perspective for the Indo-Pacific. The SAGAR vision has gained traction through frameworks such as the Indo-Pacific Oceans Initiative (IPOI) and the Information Fusion Centre for the Indian Ocean Region (IFC-IOR), aiming to tackle regional security issues and counter China's expanding influence. While China's People's Liberation Army Navy (PLAN) has grown to become the world's largest by fleet size, it still lacks the operational capabilities and combat experience of the United States. India's navy, although the smallest of its armed forces, has consistently demonstrated efficiency and timely acquisitions. Compared to the Indian Air Force, which faces critical squadron shortages, the navy pragmatically acknowledges domestic limitations in engine development. It relies on foreign collaborations to fill gaps, ensuring progress. However, I'll turn to that later. To establish itself as a net security provider, the Indian Navy must sustain the momentum it has recently achieved in naval defence exports. Although this initiative began in earnest only in 2011, it gained significant traction after 2016. India has transitioned from being a cautious supplier of naval equipment, primarily targeting countries such as Mauritius, Sri Lanka, and the Philippines, to a more prominent player in defence exports. For many years, India's exports to nations such as Seychelles, the Maldives, Mauritius, and Sri Lanka were limited to refurbished ex-navy and coast guard vessels. However, this trend has undergone a remarkable transformation in recent years. Naval ships, as of 2024, account for over 61 per cent of India's total defence exports. This shift highlights India's growing capability to manufacture advanced platforms and its determination to emerge as a dependable supplier of defence equipment to neighbouring countries. This development is a critical component of India's regional and maritime strategy, especially given China's rapid ascent in modernising PLAN and expanding its influence in the Indian Ocean by providing naval assets to smaller nations. China has already established itself as the leading defence exporter to both Pakistan and Bangladesh.

It delivered two Ming-class submarines to Bangladesh in 2017, gifted a P625 frigate to Sri Lanka in 2019, and committed to exporting Yuan-class submarines to Thailand. Although the Thai deal encountered difficulties when Germany, refused to supply key propulsion components.

Slowing capital expenditure is good. Don't invest in BSNL, save for shortfall instead

The Union government's capital expenditure (capex) continues to be a cause for concern. Of course, the extent of its decline has reduced somewhat — from 35 per cent at the end of the first quarter of the current financial year to 15 per cent at the end of six months. But the latest number for the April-November 2024-25 period shows that the Union government's capex was still 12 per cent lower than what it was in the same period of 2023-24. Instead of aiming for the targeted 17 per cent growth to ~11.11 trillion in capex for 2024-25, the government will have to strive hard to at least cross the figure of ~9.48 trillion reached last year. What has led to this decline? A widely held view is that the sevenphase general elections, which began on April 19 and ended on June 1 last year, caused a slowdown in capex. But if that indeed is the reason, the decline in capex in the first quarter should have been reversed in the second quarter of 2024-25. And certainly, the first two months of the third quarter should have raised the trajectory of capex growth to a higher level. There has been some improvement, but a 12 per cent decline in the April-November 2024-25 period is no comfort. Look at the slightly different trajectory seen in the Union government's revenue expenditure growth during the same period. The Budget for 2024-25 had projected a rise of over 6 per cent to ~37.1



trillion in revenue expenditure. At the end of June 2024, the growth was just about 2 per cent, but it has been rising since then, reaching 4.2 per cent by the end of the first six months of 2024-25 and climbing even higher to 7.8 per cent during April-November 2024-25. So, if revenue expenditure has gained momentum, why has capex failed to follow suit? A close analysis of the government's capex numbers presents an interesting picture. Over 90 per cent of the Centre's total capex during 2024-25 was accounted for by just six sectors roads, railways, defence, telecom, transfer to states and new schemes. Their share in total capex in 2023-24 was a little less at 87 per cent. But the 12 per cent decline in the first eight months of 2024-25 is primarily the result of a marked slowdown in only two of these six areas — roads and defence, which accounted for over 40 per cent of the total capex outlay for 2024-25. Capex on the construction of roads and highways fell by 16 per cent, while defence saw a decline of 15 per cent. This is serious and

has worrying implications for both infrastructure and defence. The problem of slowing expenditure in these two areas should not have been difficult to fix. Either effective monitoring of spending is lacking, or there are serious problems with project execution, reflecting the poor expenditure-absorbing capacity of these two sectors. This is borne out by a relatively good performance of the Indian Railways, which accounts for over 22 per cent of this year's capex. At ~1.68 trillion, the Indian Railways' capex is just about 1 per cent lower than its spending during April-November 2023. With regard to the transfer of special assistance as loans to states for their capex and additional central assistance for their externally aided projects, the Union government's performance was slightly better. In the April-November 2024-25 period, these transfers rose by about 5 per cent, although much lower than the budgeted increase of 41 per

In contrast, such

by about 24 per cent to ~1.15 trillion. It appears that these transfers will take a hit in the current year and for the first time since this initiative to help states boost their capex was undertaken a couple of years ago. Significantly, this has not yet adversely impacted the states in a big way. The capex of 25 states (accounting for 95 per cent of all the states' and Union territories' total capex budget) has risen by just about 1 per cent in the April-November 2024-25 period, although states like Andhra Pradesh, Himachal Pradesh, Kerala, Mizoram, Odisha, Telangana, Uttar Pradesh, Uttarakhand, and West Bengal saw their capex fall varying margins. Eventually, however, this will have an adverse impact on the states' capex programme and its growthenhancing effect. There are two more sectors that account for another 13 per cent of the Centre's capital expenditure budget. But they bring out an intriguing aspect of why the government's capex has been slowing. They suffer from a peculiar problem, which has nothing to do with either the relevant sectors' expenditure-absorbing capacity or the absence of effective expenditure monitoring. The bulk of the capex under telecommunications was meant for infusing equity into state-owned Bharat Sanchar Nigam Ltd, or BSNL. Of the total capex of ~0.84 trillion, the proposed transfers during the entire amount for BSNL's equity

2023-24 had risen sharply infusion accounted for as much as ~0.83 trillion. But the total expenditure under this head in the first eight months of 2024-25 is only 6 percent of what has been budgeted. In other words, a decision to transfer the equity amount promised to BSNL would increase the government's capex by a significant margin. Why this money has not been transferred is puzzling. Last year, against a budgeted BSNL equity infusion of ~0.53 trillion, the actual infusion was higher at ~0.65 trillion. This year, no action on this front even after eight months is a puzzle as this failure also contributes significantly to the decline in the Centre's capex. More importantly, the Budget for 2024-25 had allocated a significant amount of ~0.66 trillion for capex on central sector schemes and projects. Of this, a large chunk, estimated at ~0.62 trillion, was earmarked for new schemes that the government would announce during the year. However, in the first eight months of the current year, only 4 percent of that total outlay has been used up, leaving ~0.63 trillion yet to be spent. It is likely that the government may not need this amount or it may have kept its powder dry to meet any new schemes that it might announce later in the year, for which such capital allocations will be useful. For the Union finance ministry, currently busy preparing the Budget for 2025-26, such a state of play with regard to slowing capital

Will Israel-Hamas Ceasefire **Really Lead To Peace?**

Ronald Reagan took over as the new US president, Iran freed 52 American hostages it had been holding for over a year. That projected Reagan as a strong leader sending a powerful signal to US allies and its foes. His predecessor, Jimmy Carter, did all the negotiations and tried his best to have the hostages released while he was still the president. But Tehran would not let him take the glory. Forty-four years on, Donald Trump is taking the credit for the Gaza ceasefire deal, which will come into effect a day before his inauguration, cementing his reputation as a tough leader. Biden can say that the deal happened under his watch. But there is no doubt that it was Trump whose pressure led to achieve the goal. He declared on his social media platform Truth Social: "This EPIC ceasefire agreement could have only happened as a result of our Historic Victory in November, as it signalled to

the entire World that my On January 20, 1981, on the day Administration would seek Peace and negotiate deals to ensure the safety of all Americans, and our Allies." Days after he threatened that there better be a Gaza deal by his January 20 inauguration or "all hell would break out", his special envoy to the Middle East, Steven Witkoff, landed in Tel Aviv last Saturday. It was the Sabbath, the day of rest for Jews. But Witkoff insisted on meeting the Israeli Prime Minister, Benjamin Netanyahu, that day. At their meeting, he conveyed Trump's message that the incoming President of the United States wanted to end the Gaza war and demanded that a ceasefire agreement be signed immediately. The format of the three-stage deal announced on Wednesday was proposed by Biden in May last year and was later also endorsed by the **UN Security Council. But both Hamas** and Israel kept dragging the negotiations over it. In Isreal, Netanyahu refused to give any concessions to Hamas and continued.

The sins of fathers shall be visited upon the sons—this ominous pronouncement in the Bible has now come true for Tulip Siddiq, a 42-year-old minister in the British government, but with a twist. In her case, it wasn't her father's sins that visited upon her but those allegedly committed by her aunt, the deposed prime minister of Bangladesh, Sheikh Hasina Wazed. And it cost Siddiq her job. Slapped with a range of corruption charges by Bangladesh's Anti-Corruption Committee (ACC),

which forced an internal government inquiry, Siddiq has strenuously denied any wrongdoing—except that of ignorance about benefiting from dubious transactions. But she has paid the price and resigned as UK treasury minister on Tuesday, though she stressed that an independent review found she had "not breached the ministerial code". If the sins of aunts can impact nieces, then can daughters escape their mothers'? Ever since Siddig's case hit the headlines, the spotlight has slowly but surely turned

to Sheikh Hasina's daughter, Saima Wazed, also known as Putul, who was elected regional director of the World Organisation's Southeast Asia branch amid considerable controversy in February 2024. An editorial in the eminent medical journal The Lancet had earlier questioned if she was fit for the job, as she only held a master's degree in psychology while rival aspirants were doctors with years of public health experience. The ACC has now initiated a probe into how she got the job: on her

own merit or her mother's intervention as prime minister. All eyes are now on Putul and whether she'll be forced to follow in her cousin's footsteps. What does it all mean for 77-year-old Sheikh Hasina, who has been sheltering in New Delhi since fleeing Dhaka on 5 August after a violent student uprising against her 15-year continuous tenure as Bangladesh's prime minister? There is no doubt that the charges being hurled at her, her family, and her friends are coloured by political prejudice from those now in power.

"One can expect new allocations towards augmentation of power distribution infrastructure, especially in high density/ urban load centres, in view of the sharp rise in peak demand over the last few years," said Anujesh Dwivedi, Partner at Deloitte India. He noted that there may be some allocation towards supporting the preparatory work especially on the listing of power utilities, or some incentive mechanism for promoting initiatives on private sector participation or listing of utilities at the state level because they are increasingly being seen as the much needed structural reforms the sector needs. The industry is optimistic of a wider coverage of the Revamped Distribution Sector Scheme by including smart metering in infrastructure definition.

> "This would direct more financing for a sector which seeks to bring down India's transmission and distribution losses to 12% and improve recovery for state utilities," Goyal said. Goyal also noted that power transmission despite significant potential has not seen any notable monetisation events which could address the latent investor demand. "Government should announce a time-bound privatisation programme for assets owned by PGCIL," he said. The sector also sees the PLI scheme for solar value chain to continue with possible reduction in the duty structures for solar equipment.





Jaipur LPG tanker crash: Investigation finds fault on part of NHAI

NEW DELHI: An investigation into the Jaipur LPG tanker crash that claimed 21 lives has pointed out faults on the part of NHAI and its agencies, and the owner and consigner of the tanker for noncompliance of safety standards as well as negligence of the deceased driver of the goods truck that hit the tanker. The findings of the crash investigation conducted by the Institute of Road Education (IRTE) with support from the Jaipur Police was presented at a

mock court, chaired by former IPS Kiran Bedi, on Wednesday at the College of Traffic Management Faridabad. The probe report mentions that the tanker driver can be absolved of the offence of dangerous or negligent driving as he took the U-turn on the highway "cautiously". However, the FIR by the Jaipur Police, registered hours after the fatal crash, has accused the drivers of the LPG tanker and the goods truck of speeding and negligence, which, according to

police, resulted in the accident. The FIR has not mentioned any other entity for the crash. Police are yet to file a chargesheet in the case.The crash happened on the Jaipur-Kishangarh highway in Rajasthan on Dec 20 last year. goods-carrier truck collided with the BPCL tanker carrying LPG when the tanker was making the Uturn. Display 'be kind to animals' message on public transport, Centre suggests

NEW DELHI: In the first such move in the country to sensitise people about animal safety, the Centre has suggested all states/UTs to display the slogan "Be kind to Animals" in English, Hindi, or regional languages on all public transport vehicles with effect from April 1.

Sending an advisory on the proposal, the road transport and highways ministry on Tuesday (Feb 25) said the slogan can be painted or can be put in the form of a sticker.

The ministry noted that the move to display such slogans was taken based on the receipt of submissions with respect to "promoting compassion



towards animals and to promote safety of animals on roads".

It advised that the colour of the font may be selected to enhance the readability depending on the colour of the public transport vehicle used in the respective state. "This will help drivers be

mindful of animals/birds on the

streets and make roads safer for all," said animal welfare activist Gauri Maulekhi while applauding the move.

Underlining that the slogan resonates with India's cultural ethos, she said the ministry's initiative will not only enhance road safety but also advance animal

NEW DELHI: Former Tihar PRO Sunil Kumar Gupta made an explosive claim that air hostesses of Sahara Airlines used to come to Subrata Roy in jail and remain with him for hours. This was one of the many facilities provided to the late founder of Sahara Group when he was in jail. In an interview with ANI, Gupta claimed that Arvind Kejriwal, then-chief minister of Delhi, was aware of all that but did not take any action.

Recounting his experience with Subrata Roy when Roy was an inmate, Gupta said he was first kept in a regular jail. But he needed a facility with video conferencing so that he could negotiate with the buyers of his hotels following which he could pay the lenders back. "The Supreme Court's direction said that everything has to be done legally. But I saw that a lot of illegal things were happening...Before this, the Delhi High Court had called me and it said that there are several complaints of bribery and extortion at the jail," Gupta said. Gupta said he raised the issues at meetings chaired by DG Prisons but the DG thought Gupta was complaining against him. Then Gupta approached Kejriwal and informed him about the facilities that he thought were being extended to him illegally.

"Arvind Kejriwal asked me if I could shoot a video of it. I told him it wouldn't be right for me and he could come here and check it for himself. He then said that DG Prison is an IPS officer who comes under Central Govt and we do not know if we can do anything about him..." he said.

In a 1st in India, bird flu detected in domestic cats

PUNE: The first cases of avian influenza virus (H5N1) in domestic cats in India were reported from Chhindwara district in Madhya Pradesh, raising concerns about the bird flu pathogen mutating and infecting humans.

"H5N1 is classically an avian

virus, but certain mutations allow it to replicate in mammalian hosts. This adaptability concerns because influenza viruses have the potential to trigger pandemics, as seen in past outbreaks like Covid-19," a scientist said. Scientists from ICAR-NIHSAD and Union govt's animal husbandry department have documented the cases this Jan in Chhindwara, which borders Nagpur - where several big cats died of bird flu in Dec last year.

The scientific team identified It found that all infected cats lethargy before succumbing to the illness within one to three days after sample collection. The study identified 27 mutations in the virus found in cats. Scientists called for enhanced surveillance in domestic poultry, wild birds, and mammals, including pets and humans, given the virus's ability to jump between species. "Although human infections

have been rare, we must anticipate the virus adapting to efficient transmission to and between humans. Human-tohuman transmission is still not efficient, but ongoing changes in the virus signal to us to stay vigilant and prepared even for a pandemic," virologist Jacob John said. On the virus's potential to cause a global outbreak, John cautioned: "H5N1 is new for humans. We do not have immunity against it. If humantransmission to-human becomes efficient, as an extension of the present pattern of mammalian transmission, it is going to be a concern.

breakthrough in developing a hyperloop test track (422m) by IIT Madras with support from Indian Railways, the government is now planning development of a 50km corridor for commercial transport, said minister Ashwini Vaishnaw. It may be the longest hyperloop track in the world.

"The first tube will go a long way in developing technologies. The time has come when after the first two grants of \$1million each (nearly ?9cr), the third grant of \$1million will be given to IIT Madras for fur-



ther developing the hyperloop project in a nice way. And once we see the commercial or rather pre-commercial where the product is ready, then within the railway set-up we will start the first commercial project. We will decide a site, which can be used for good commercial transportation of 40km-50km and then we will go for it," Vaishnaw said while addressing the closing ceremony of Asia's first Hyperloop Global Competition by IIT Madras.Sources said the test track for commercial operation will help railways assess

viability of the technology. The hyperloop track can allow speeds of up to 1,200kmph. The successful development of the first test track, which was completed in Dec last year, will be the base for future development. There are 8 hyperloop projects around world Hyperloop systems are expected to dramatically reduce travel times between cities, offering an alternative to traditional rail and air travel. The hyperloop concept envisions high-speed, low-pressure pods travelling at speeds of up to 1,200 kmph.

Ebola-hit Uganda begins vaccination trial: Who

GENEVA: Uganda on Monday started a vaccination trial for the Sudan species of the Ebola virus four days after an outbreak was confirmed, the world health organization announced.

It is the sixth time Uganda has been hit by an outbreak of the Ebola Sudan virus, for which there is no approved vaccine. Of the five other Ebola species, just one has licensed vaccines. The deadliest Ebola epidemic killed more than 11,300 people in west Africa between 2013 and 2016. The UN health agency said it had supported Ugandan health authorities in getting the trial ready in the days following the announcement that a 32-yearold male nurse had died of Ebola in Kampala. "This vaccination trial was initiated with record speed," Who chief Tedros Adhanom Ghebrevesus said on X. He said the trial, launched at a ceremony in Kampala by Uganda's health minister, "demonstrates the importance of investing in R&D for vaccines and treatments and outbreak response preparedness".

'Critical achievement'

This trial marks how good this candidate vaccine is at preventing disease caused by the Sudan Ebola virus. Previous phase 1 and 2 trials had already been conducted to ensure the candidate vaccine's safety and ability to provoke an immune response from those receiving the jab, the Who said. A system was put in place to test candidate vaccines during a previous outbreak of the Ebola Sudan virus in Uganda in 2022, paving the way for a trial during the next outbreak, the Who added. The Who said Friday the first 2,160 doses of the candidate vaccine were already in the capital Kampala as part of the preparations for another outbreak. It said those deemed "at highest risk" were eligible to join the trial.

The doses are being used in a "ring" vaccination scheme where first jabs are given to all contacts of confirmed Ebola patients and contacts of contacts. The Who said the first ring defined Monday involved 40 direct contacts and contacts of contacts of the health worker who died.

Pregnant teenager among five Ukrainians killed by Russian missile

IZYUM: A Russian ballistic missile strike on Tuesday killed five people including a pregnant teenager and wounded more than four dozen others in the east Ukrainian town of Izyum, officials said. Vietnam's restrictive internet law comes into force

A new internet law in Vietnam, Decree 147, gives the government increased control over internet access and content in the name of national security and social order. It mandates tech companies to store user data, verify accounts, and remove deemed illegal content within 24 hours. Critics argue this suppresses free speech and impacts livelihoods. A new internet law that gives the Vietnamese government expanded powers over internet services and people using them is set to officially take effect Wednesday. Decree 147 expands government control over access to information on the internet for reasons of "national security" and "social order."The law requires social media platforms providing services to users in Vietnam to store user data and provide it to authorities on demand. The government issued the decree this November, and it requires organizations to take down anything the authorities consider "illegal content" within 24 hours. Decree 147 has sparked concerns, with researchers and experts tracking the country saying that the law is part of a growing crackdown on civil society. "Because the Vietnamese police treat any criticism of the Communist Party of Vietnam as a national security matter, this decree will provide them with yet another tool to suppress dissent," said Patricia Gossman, associate Asia director at Human Rights Watch. The decree requires tech giants like Facebook and TikTok among other organizations., to verify user accounts using people's phone numbers or personal identification numbers. It requires companies to store that data. Decree 147 also requires organizations to provide search and content-scanning tools to government authorities upon request. It limits certain functions, like live video streaming, to only verified accounts.
