Spent Rs 66,000, Pune farmer gets Rs 664 for 7.5 quintals of rainhit onions

PUNE: Sudam Ingle, a farmer from Purandar, spent around Rs 66,000 on his onion crop this season. The incessant rains damaged most of his yield, but he managed to salvage a portion and spent another Rs 1,500 to pack and transport it to the Purandar market yard for sale on Friday. To his shock, Ingle received just Rs 664 for 7.5 quintals of onions. "This was from one acre of land. I still have onions from another 1.5 acres, but I won't sell them; I'll run a rotor and turn them into fertiliser for next year. That's more profitable than selling," he said. "I'm still a relatively big farmer. I don't know how smaller farmers with just one or two acres, many of whom have taken loans, will survive. If the govt doesn't step in, farmer suicides will increase." Ingle's story is echoed across Maharashtra's farmlands, where relentless rains and collapsing prices have left farmers struggling to survive. From onions, tomatoes, potatoes to pomegranates, custard apples, to soyabean, almost every crop has taken a hit this season. With no money in hand, farmers have no purchasing power, directly affecting rural markets that flourish during Diwali.

To err is human, courts shouldn't shy away from rectifying error: SC

Admitting judges can also commit mistakes as they are human, SC said courts should not shy away from accepting them and rectifying errors if committed. The maxim 'actus curiae neminem gravabit', which means the act of the court shall prejudice no one, is a principle firmly embedded in Indian jurisprudence and no party should suffer owing to an error, delay or inadvertence attributable to the court itself, a bench of Justices Vikram Nath and Sandeep Mehta

The discovery of the body of a newly married woman hanging from a noose in Dashrathpur village, under the Kaushambi Karari police station area, has caused a stir. The bride's family, upon receiving the news of her death, has accused her in-laws of murdering her for dowry. The deceased had returned to her in-laws' home on Wednesday after celebrating Diwali. The news of her death arrived that morning. Based on the complaint from the bride's family, the police have registered a case, taken the



body into custody, and sent it for a post-mortem examination. The investigation is underway. According to the information, Hiralal alias Mithun, son of Kishori Lal, a resident of Dashrathpur village in the Karari police station area, was married to Vimla Devi

alias Gorki, 19 years old, daughter of Chandra Pal, a resident of Purkhas village in the Sarai Akil police station area, about 6 months ago. It is alleged that since the marriage, the in-laws were demanding additional dowry and harassing the deceased. A few days after



the marriage, Bimla Devi's in-laws, husband Hiralal alias Mithun, father-in-law Kishori Lal and mother-inlaw, together started demanding additional dowry every day and started beating, abusing and torturing her physically and mentally. Bimla's brother-in-law Rahul lives outside and used to demand dowry through phone and instigated his family members. Bimla had gone to her parents' house for 3 days to celebrate Diwali festival. On Wednesday, at about 2.30 pm, Hiralal alias Mithun

forcibly called Bimla from her house and brought her to Dashrathpur, where the in-laws beat her and hanged her. India should do more than just watch US-China chip war

The outgoing Joe Biden administration has been unusually active in recent weeks, making significant decisions with long-term implications. These include lifting certain restrictions on Ukraine and imposing stricter trade measures on China. The structural effects of these moves will become evident in 2025 and beyond. As recently as early December, the administration delivered its third major blow to China's semiconductor industry. This effort seeks to curtail China's ability to access and produce advanced chips that could support artificial intelligence for military purposes or pose risks to the United States' national security. For India, these developments are not merely a geopolitical spectacle but hold direct strategic relevance. Beyond observing this unfolding competition, New Delhi has an opportunity to assess its role in helping the US build resilience in semiconductor production and supply chains amid the intensifying "chip war." The US has maintained dominance in the semiconductor industry since Silicon Valley pioneered the technology. Over time, however, East Asian nations such as Taiwan and Japan emerged as key manufacturing hubs, incentivised by government subsidies. As Chris Miller highlights in his book Chip Wars: The Fight for the World's Most Critical Technology, this evolution allowed the US to establish critical business and strategic alliances in a region vulnerable to Russian influence during the Cold War. In the current Cold War-style rivalry between the US and China, these alliances remain crucial in countering Beijing's ambitions for a unipolar Asia. China, while not a leader in manufacturing advanced semiconductors, holds a commanding position in the production and supply of critical rare earth minerals, accounting for 70 per cent of global output. These minerals are essential for creating integrated circuits used in chips for civilian and military purposes. In response to US export restrictions, China has banned exports of key minerals such as gallium, germanium, and antimony, while tightening control over graphite, further complicating global supply chains. These minerals are essential components in making integrated circuits of chips, for both civilian and military applications. Despite its dominance in rare earth mining, China's position is not unassailable. First, the US is the second-largest producer of rare earth minerals globally. Second, China relies on US technology to process these minerals into complex semiconductors with game-changing capabilities. However, the Biden administration's efforts aim to prevent China from independently developing technology to control other parts of the semiconductor supply chain. While the Trump 1.0 administration adopted a hawkish stance on China, the Biden administration has taken robust measures to restrict Beijing's access to semiconductor technology. What plays in the US' favour is that China depends on foreign hardware and expertise to enhance its chip production capabilities. Indeed, this shows a fragile balance of dependencies. No conversation on chips can be complete without Taiwan. Taipei remains central to the global semiconductor industry, with its dominant chipmaker TSMC supplying a significant share of the world's semiconductors. The island's President has described this dominance as a "silicon shield," offering a degree of protection against China, which claims sovereignty over Taiwan. However, from the US perspective, Taiwan's role also creates vulnerability to supply chain disruptions, particularly as crossstrait tensions rise. To mitigate this risk, the Biden administration passed the CHIPS and Science Act in 2022, pledging nearly \$53 billion to boost US semiconductor manufacturing.

Hindus Hounded In Their Own Country

Sambhal, in western Uttar Pradesh, hit the headlines in late November when a courtorder ASI survey of the early 16th century Babri Masjid in the township ran into trouble with the local Muslim populace, leading to a volatile situation. Protestors rained stones upon the police, leaving around two dozen personnel injured. Five Muslim youths, including a minor, were killed, allegedly in police firing on protesters, a charge that police vehemently denied. The autopsy discounted the culpability of police as the ammunition recovered from the bodies of victims was not used by the UP Police. The police have made a counter-claim of recovering empty cartridges of Pakistani origin from the spot. They claim that a day before the survey was scheduled to begin, Zia-ur-Rehman Barq, MP, Sambhal visited the mosque and delivered a provocative speech. An FIR registered by the police names him in addition to Sohail Mahmood, the son of local MLA Iqbal Mahmood, for inciting the mob through social media posts. An antiencroachment drive was launched by the administration. This led to interesting revelations since then, that have shifted the discourse from early 16th century to late 20th century events. These revelations are equally suggestive. The local Hindus, who are a minority in the township, insist that the mosque was built by the Mughal invader Babur in 1526 by demolishing a temple of Lord Vishnu, originally erected by Prithviraj Chauhan in the 12th century. This belief appears deeply ingrained, though H.R. Nevill,



ICS, in the district gazetteer (1911), discounts the idea, arguing that Sikander Lodi, a known iconoclast, would not have allowed a Hindu shrine to occupy the loftiest site in temporary capital (Moradabad: A Gazetteer, p. 147). While acknowledging that Babur visited Sambhal, Nevill attributes the construction of the mosque to his general, Hindu Beg, to which Babur set up an inscription. However, the revised Gazetteer Moradabad (1968), written by Esha Basanti Joshi, IAS (Retd), presents a different view. She states that the town of Sambhal (originally Sambhalpura) perhaps stands on a series of scattered mounds, each said to mark the site of some ancient building or settlement. The highest of these mounds is known as the Kot (fort) and indicates the ruined site of the old fort of Sambhal, which was built before the advent of Muslims in the

The only building left standing on the site was once a Hari Mandir (a temple of Vishnu) but was later converted into a mosque (Gazetteer of India: Uttar Pradesh – Moradabad, p. 26). She bases her account on the description of A. Fuhrer in Monumental Antiquities and Inscriptions in the North-

Western Provinces and Oudh (1891). Joshi informs us that Babur visited Sambhal on 2 October 1527 and stayed there for two days. Earlier, he had sent his general, Hindu Beg, to subjugate the Afghan governor of Sambhal, Qasim Sambhali, who was subsequently defeated (Gazetteer of India: Uttar Pradesh -Moradabad, p. 42). A recent WhatsApp wisecrack cuts through the Gordian knot of this debate, asking why Muslims would oppose an ASI survey unless there is something to hide from the public eye. Following the violence in Sambhal and Chief Minister Yogi Adityanath's vow that no miscreant involved would be spared, the police and local administration sprang into action. A manhunt was launched to apprehend the culprits, while simultaneous drives against encroachment and electricity pilferage were undertaken. These efforts unexpectedly revealed two temples in Muslim-majority areas that had been closed for decades. The first discovery was a Shiva/Hanuman temple in Khaggu Sari, adjoining the Deepa Sarai locality. The temple had reportedly been closed for the past 46 years. This struck a chord in the collective memory of Sambhal, as it had been abandoned fol-

lowing the riots of March

1978, after which the Hindus vacated locality. the Bulldozers clearing encroachments near the temple uncovered three mutilated deity images from an adjacent well. Shortly thereafter, a closed Radha-Krishna temple was discovered in the Sarai Tareen locality. At the time of writing, a third temple, referred to as the Banke Bihari Temple, has come to in Laxmanganj, Chandausi, within Sambhal district. It appears that the Hindu community withdrew from Laxmanganj as the Muslim population grew, leaving the temple abandoned. Meanwhile, in a related development, a neglected temple of Siddheshwar Mahadev was reopened in the Madanpura area of Varanasi. The temple was founded by Ajay Sharma, President of the Sanatan Raksha Dal. Although the temple's closure was reportedly not due to any dispute, it had fallen into disuse as Hindus withdrew from the area, which experienced a significant growth in the Muslim population. In almost all these temples, with help from the administration, daily rituals and bhajans have started. However, the longterm challenge remains sustaining these activities, given the demographic shifts that had initially alienated the Hindu community from these areas. Critics often accuse the Ram Janmabhoomi Movement, which culminated in the demolition of the abandoned Babri Mosque in Ayodhya (1992), of being catastrophic for communal peace and harmony in India. This raises the question: why did Hindus feel compelled to

in Sambhal following the 1978 riots? What exactly transpired in Sambhal on 29 March 1978? According to the statement made by S.D. Patil, the then Minister of State for Home Affairs, in the Rajya Sabha on 23 November 1978 (unstarred question no. 301), Sambhal experienced severe communal disturbances on 29 March 1978. The unrest apparently began when some members of the Muslim community objected to Holi titles conferred by the student union of the local college upon two Muslim girls. This led to violent clashes accompanied by widespread looting and arson. Police had to resort to firing in three locations to control the mob. As per the minister, 17 people lost their lives, 33 were injured, and the esti-

mated loss was around Rs 25 It might be noted, provided the minister's description is authentic, that the violence was not provoked by the sprinkling of colours or water on any unwilling individual during Holi. Instead, it was sparked by a cultural act performed by the student union of the local college. Holi, after all, is a cultural festival; it is not even Vande Mataram, which used to rile former Sambhal MP Shafiqur Rahman Barq so much that he walked out of Lok Sabha when the House was dissolved on May 8, 2013. B. Rajeshwari, in Communal Riots in India: A Chronology 1947-2003 , notes that the Sambhal riots of 1978 were attributed to a bootlegging rivalry between Hindus and Muslims, with the latter allegedly seeking to dispossess Hindus of their property

Why's Turkey erupting for Ekrem Imamoglu? He's the biggest threat to Erdogan yet

In Turkey, the vox populi is rising once again, reminiscent of the Gezi uprising that occurred 12 years ago. After a week of continuous protests in multiple cities—against the arrest of Istanbul mayor Ekrem Imamoglu—authorities have put a ban on gatherings and detained close to 2,000 individuals. The unlawful and unconstitutional arrest of Imamoglu is the culmination of over two decades of political erosion under President Recep Tayyip Erdogan's increasingly autocratic governance. It has systematically

undermined democratic institutions, silenced dissent, and played up the Islamist agenda internationally, particularly on the matter of Kashmir. Now, in the streets of Turkey's major cities, thousands of people, mostly students and youth, are pushing back against Erdogan, and their defiance is growing louder by the day. At the heart of this unrest lies the struggle for Turkey's political future—and the figure leading charge—Ekrem. Imamoglu, a calm and charismatic mayor, was arrested under politically motivated

embezzlement—accusations that many see as a pretext for silencing a rising political star. His arrest was an absurd spectacle. Taken from his walk-in closet while calmly adjusting his tie, Imamoglu was detained merely hours before he was set to be nominated as the presidential candidate by Turkey's Opposition in the 2028 elections. For a leader with immense support across Turkey, this act of political repression has galvanised protests not just in Istanbul but across the nation. But why


To stand in this house is to be Cambridge who took the paper. The reminded of what is most beautiful about religious faith: its ability to give solace and to inspire, its aspiration to these great and lovely heights, in which strength and delicacy are so perfectly conjoined. In addition, to be asked to speak here on this day, the fourth anniversary of the notorious fatwa of the late Imam Khomeini, is a particular honour. When I was an undergraduate at this college, between 1965 and 1968, the years of flower-power and student power, I would have found the notion of delivering an address in King's Chapel pretty far-out, as we used to say; and yet, such are the journeys of one's life that here I stand. I am grateful to the Chapel and the college for extending this invitation, which I take as a gesture of solidarity and support, support not merely for one individual but, much more importantly, for the high moral principles of human rights and human freedoms that the Khomeini edict seeks so brutally to attack. For just as King's Chapel may be taken as a symbol of what is best about religion, so the fatwa has become a symbol of what is worst. It feels all the more appropriate to be speaking here because it was while in my final year of reading history at Cambridge that I came across the story of the so-called satanic verses or temptation of the Prophet Muhammad, and of his rejection of that temptation. That year, I had chosen as one of my special subjects a paper on Muhammad, the rise of Islam, and the caliphate. So few students chose this option that the lectures were cancelled. The other students switched to different special subjects. However, I was anxious to continue, and Arthur Hibbert, one of the King's history dons, agreed to supervise me. So as it happened I was, I think, the only student in

next year, I'm told, it was not offered again. This is the kind of thing that almost leads one to believe in the workings of a hidden hand. The story of the 'satanic verses' can be found, among other places, in the canonical writings of the classical writer al-Tabari. He tells us that on one occasion the Prophet was given verses which seemed to accept the divinity of the three most popular pagan goddesses of Mecca, thus compromising Islam's rigid monotheism. Later he rejected these verses as being a trick of the devil saying that Satan had appeared to him in the guise of the Archangel Gabriel and spoken 'satanic verses.' Historians have long speculated about this incident, wondering if perhaps the nascent religion had been offered a sort of deal by the pagan authorities of the city, which was flirted with and then refused. I felt the story humanized the Prophet, and, therefore made him more accessible, more easily comprehensible to a modern reader, for whom the presence of doubt in a human mind, and human imperfections in a great man's personality, can only make that mind, that personality, more attractive. Indeed, according to the traditions of the Prophet, even the Archangel Gabriel was understanding about the incident, assuring him that such things had befallen all the prophets, and that he need not worry about what had happened. It seems that the Archangel Gabriel, and the God in whose name he spoke, was rather more tolerant than some of those who presently affect to speak in the name of God. Khomeini's fatwa itself may be seen as a set of modern satanic verses. In the fatwa, once again, evil takes on the guise of virtue; and the faithful are deceived. It's important to remember what the fatwa is.

Honking ban ordered by **DoE for schools**

Delhi: As one enters this studio in the middle of Hindu College at Delhi University, they are greeted by pulsating scents and a diverse range of notes, from sweet to spicy, balmy to effluvious. Instead of books, pupils in this classroom-like setup experiment with different combinations of essential oils to produce scents that they associate with their favourite perfumes. Enter the Sanganeria Olfactory Studio, a place that looks like a cleanroom

but functions more like the Hogwarts House of Potions from the beloved Harry Potter books. In accordance with the New Education Policy, 2020, the college has instituted a new certificate program called "Sustainable Perfumery: the art of creating



fragrances and nurturing careers," which is held at the studio. According to Benu Arora, a faculty member affiliated with the course, it is the first of its sort in the country. The course's concept emerged during the development of the Undergraduate Curriculum Framework. This course is 11 months long. Since the nation lacks any formal education programs teaching people how to create their own fragrances, we recognized a significant unmet need in the market and set out to provide it. Hindu College principal Anju Srivastava explained that the lengthy implementation process was due to the fact that, when the curriculum was drafted, it was forwarded to specialists and knowledge partners for refinement.





SC calls Punjab's NRI quota a 'fraud' on medical education

Delhi: The Supreme Court called Punjab's medical colleges' extension of the non-resident Indian (NRI) quota a "fraud" that excludes meritorious candidates. A bench chaired by Chief Justice of India (CJI) Dhananjaya Y Chandrachud dismissed petitions challenging a Punjab and

Haryana court ruling that invalidated Punjab government's proposal to widen the NRI quota criteria to include distant relatives. We must



end NRI quotas today! The bench, which included Justices JB Pardiwala and Manoj Misra, said the NRI quota was being used to circumvent merit-based admissions. The bench called such a broad interpretation of NRI eligibility, which permitted distant relatives to qualify, a "moneyspinning tactic" that undermined the school system. "All three petitions fail. Keep this under control. This scam must end. This NRI business is a scam. Senior counsel Shadan Farasat stated that Himachal Pradesh and Uttar Pradesh previously employed the larger NRI quota interpretation during the hearing. The Court rejected these arguments, stressing that the larger definition weakened merit and permitted less deserving individuals to be admitted based on money and connections rather than academic. performance. The panel agreed with Bhandari that NRI quotas should be kept for real NRIs and merit should not be ignored.

For Elnaaz, this appearance was more than a walk down the ramp, it was a moment to stand for something larger than herself.



India wants Rs 3 lakh cr in defense manufacturing

Delhi: The gov ernment wants to produce Rs 3 lakh crore in defence by 2029, strengthening India's standing as a global powerhouse. Now, 65% of defense equipment is made from locally, 65-70% import dependency According to the Ministry of Defence, 16 DPSUs, over 430 licensed enterprises, and 16,000 MSMEs boost indigenous production capabilities. "The private sector contributes 21% to total defence production, fostering innovation and efficiency," it said. The government wants to expand defence exports to Rs 50,000 crore by 2029, strengthening India's position as a global manufacturing hub and supporting economic growth. Defence exports rose 32.5% to Rs 21.083 crore in FY 2023-24 from Rs 15,920 crore in FY 2022-23. Indian defence exports increased 21 times from Rs 4,312 crore in



2004-14 to Rs 88,319 crore in 2014-24, demonstrating growing involvement in the global security sector. India exports defense equipment to over 100 nations, with the US, France, and Armenia buying most in 2023-24. In 2024-25, the Ministry of Defence signed a record 193 contracts worth Rs 2,09,050 crore, nearly doubling the previous record. These include 177 contracts, 92%, awarded to the domestic industry for Rs 1,68,922 crore, 81% of the overall contract value. This emphasis on indigenous manufacture supports defence production self-reliance.

The government plans to borrow Rs 8 lakh crore, 54% of its Rs 14.8 lakh crore FY26 borrowing, in the first half. It didn't frontload the borrowing program to avoid raising rates while the RBI pumped record liquidity into the system. Since the market reported little demand for 30-year and longer bonds, the government announced it would borrow less in FY26. Thus, front-loading of the borrowing program has been avoided due to government (fiscal consolidation without compromising quality of expenditure).
