SC: Remarriage after spouse's death no bar to custody claim

NEW DELHI: Remarriage after the death of a spouse cannot be a stumbling block to claim custody of a child from the first marriage, Supreme Court has said while allowing a father to take back custody of his minor son who was taken away by in-laws after the death of his first wife.

A bench of Justices B R Gavai and K Vinod Chandran said the welfare of the child could be better taken care of by the father who is the natural guardian and set aside the order of Allahabad high court which rejected his plea. Noting that the father had remarried and the child was comfortably residing and pursuing his education at his maternal grandfather's house, the HC had said that the welfare of the minor child, which is of paramount consideration, would be served by letting him continue with his grandfather and the father was granted visitation rights to meet the child regularly on the first day of every month. The father thereafter approached the apex court and his inlaws again highlighted his remarriage as a ground to deny him custody and told SC that his remarriage soon after the death of the first wife was rightly considered by the HC. The bench, however, did not agree with the findings of the Allahabad high court and set aside its order. "The father is an educated person and holding a responsible position having been appointed to the administrative services of the state. Though the father has re-married, it cannot stand against the claim for custody; especially since otherwise, there would have been a question raised as to how the child would be taken care.

At Paris meet, PM pitches open source global framework for AI

At the AI Action Summit in Paris, PM Modi emphasised the need for global efforts to establish AI governance, standards, and transparency. Highlighting Al's potential for societal benefits in health, education, and agriculture, Modi stressed inclusivity for the Global South and the importance of democratizing technology. India will host the next AI summit.

At Paris meet, PM pitches open source global framework for AI As he underlined the positive potential of artificial intelligence and the unprecedented scale and speed of its development, PM Modi on Tuesday called for collective global efforts to establish governance and standards that uphold shared values, address risks, and build trust, given a deep inter-dependence across borders in the use of the technology.Addressing the Al Action Summit at the Grand Palais in Paris, which he co-chaired with French President Emmanuel Macron, Modi said governance is not just about managing risks and rivalries but also about promoting innovation, and deploying it for the global good.



He sought pooling together of resources and talent to develop open-source systems that enhance trust and transparency.

"So, we must think deeply and discuss openly about innovation and governance," the PM said, adding that AI is very different from other technology milestones in human history. He announced that India will host the next Al summit.While India, Japan, China and Australia were among the 60-odd signatories, US and UK did not endorse the joint communique, again highlighting differences in approach.

PM bats for AI access to **Global South**

Vice-President J D Vance, who led the US delegation, said AI could be strangled by excessive regulation. In his address, the PM called for global AI partnership to be more inclusive of Global

South and its priorities concerns and needs even as he welcomed the decision to set up an Al Foundation and endorsed a leaders' declaration that focused on promoting inclusivity, sustainability, accessibility and ethics in the technology's uses.

"Governance is also about ensuring access to all, especially in Global South. It is where the capacities are most lacking - be it compute power, talent, financial data, or resources,"

said Modi, as he spoke about the need to address biases as AI reshapes society, economy and security and even writes the codes for humanity in this centu-

Modi said AI can help transform millions of lives by improving health, education and agriculture.

251 out of 543 Lok Sabha MPs face criminal cases, including 19 of 20 Kerala MPs

NEW DELHI: Data on criminalisation of polipresented Supreme Court on Monday showed that of the 543 Lok Sabha MPs, as many as 251 face criminal cases, and of them, 170 are charged with offenses that are punishable with an imprisonment of five or more years. Collating the data from various high courts, amicus curiae and senior advocate Vijay Hansaria submitted a 83-page report to a bench of Justices Dipankar Datta and Manmohan. It stated that 19 out of 20 MPs (95%) from Kerala faced criminal charges, and 11 of them faced serious cases.

No discontent in Punjab AAP, asserts Bhagwant Mann; all **MLAs attend Delhi meet**

Bhagwant Mann on Tuesday dismissed claims by Congress and BJP of unrest brewing among AAP MLAs, tamping down speculation that the ripples from AAP's Delhi debacle may pose a risk to his govt. Talking to reporters after the surprise move of party boss Arvind Kejriwal to summon Punjab CM, ministers, MPs and MLAs to Delhi, Mann took on Congress and "switching sides is Congress's culture" and reminded Partap Singh Bajwa, the leader of opposition in Punjab, that his party drew a blank in Delhi.Ahead of the meeting, which AAP said was attended by all 92 Punjab MLAs, Bajwa had alleged that the party was preparing the ground to oust Mann from the CM's post. He had also claimed that

over 30 AAP MLAs were in touch with his party. Instead of counting our MLAs, he should see how many Congress candidates won in Delhi," Bhagwant Mann said. Kejriwal and other senior functionaries held a meeting with Punjab functionaries to ostensibly thank them for their involvement in Delhi campaign.

According to AAP, the meeting at Kapurthala House saw all MLAs from Punjab and MPs from the state come together in what the party projected as a show of solidarity and normalcy amid the gloom of the Delhi loss. Centre plans stiffer fines for those entering India illegally

NEW DELHI: Any foreigner valid passport or visa could invite a jail term of up to five years and a fine of up to Rs 5 lakh. In case entry and stay in or exit from India by a foreigner is with a forged passport or travel document, the imprisonment will not be less than two years, but may extend to seven years, and the fine, Rs 1 lakh, can go up to Rs 10 lakh.

These are provisions of the **Immigration** Foreigners Bill, 2025, set to be introduced in Lok Sabha in this session, that seeks to repeal four Acts with overlapping provisions on the related subjects of immigration and foreigners, and consolidate them into a single, comprehensive legislation. The four



Acts are Foreigners Act, 1946; Passport (Entry into India) Act, 1920; Registration of Foreigners Act, 1939; and Immigration (Carriers' Liability), 2000. As of now the maximum penalty for a foreigner entering the country without a valid passport or travel document, including visa, is five years in jail and fine. For those entering on a forged passport, the maximum penalty is eight years in jail and up to Rs 50,000 fine.The bill also seeks to make all higher educational institutions and universities liable to share information on any foreigner admitted,

with the registration officer specified for such category of foreigners. This provision will also apply to all hospitals, nursing homes and other medical institutions with lodging facilities on their premises.

It is proposed under the bill that any foreigner over staying his/her visa or violating conditions of the visa, or accessing a prohibited or restricted area, will be punished with up to three years in jail or fine of up to Rs 3 lakh, or both.The bill also proposes to hold a carrier responsible for ferrying a foreigner found by the immigration officer here as not having a valid passport or travel document/visa.

The immigration officer can impose a penalty of up to Rs 5 lakh on the carrier, though not without hearing its version.

If the penalty is not paid, it may be recovered by seizing or detaining the carrier that may be an aircraft, ship or any other mode of transport.

India-France strategic ties to get major boost

NEW DELHI: India's expansive strategic partnership with France is set to get a further boost with two mega deals being virtually finalised for direct acquisition of 26 Rafale-Marine fighters, as well as the construction of three additional Scorpene submarines, which will collectively be worth almost Rs 1 lakh crore (Euro 10.6 billion). As PM Narendra Modi left for Paris on Monday, government sources told TOI that the Rs 63,000 crore deal for 22 singleseat Rafale-M jets and four twin-seat trainers for Navy is now with the cabinet committee for security (CCS), awaiting the final nod. The Rs 33,500 crore deal for 3 additional diesel-electric Scorpene submarines, to be constructed by Mazagon Docks (MDL) in collaboration with French Naval Group, in turn will soon head for CCS after inter-ministerial consultations.

Ahead of PM Modi's US trip, India eyes new military plane deal

India now seems to be reviving its case for the procurement of six more advanced P-8I long-range maritime patrol and submarinehunting aircraft from the US, which was put on hold around three years ago. Ahead of Minister Prime Narendra Modi's summit with President Donald Trump in Washington Thursday, government sources told TOI the case is being "re-



examined" due to the operational need to further expand surveillance in the Indian Ocean and beyond due to the everexpanding Chinese footprint in the region. "The US has been asked to quote a reasonable price for the

six P-8I aircraft for the proposed ment-to-government deal under its foreign military sales (FMS) programme. It will then be seen whether it is feasible or not," a source said. The Navy already has 12 P-8I aircraft, packed with multi-mode radars and advanced electrooptic sensors as well as Harpoon Block-II missiles, MK-54 lightweight torpedoes, rockets and depth charges.

tributes to the negative effects of stress on cognitive function and mood regulation. When stressed, the body releases glucocorticoids that activate enzymes that break down glycogen into glucose, thereby depleting glycogen

gen is primarily stored in astrocytes, which are glial cells that innervate neurons. A drop in brain glycogen contributes to hypoglycemia, because glycogen serves as a storage for glucose, which the brain primarily uses for energy. So when brain glycogen levels drop, it causes a lack of readily available glucose, which causes blood sugar levels to drop. Low blood sugar levels, or hypoglycemia, cause cravings for sugary foods. This is because the body craves sugar to raise blood sugar levels.

Thus when blood sugar levels fall, the body induces to eat sugary foods to increase them. Thus, stress leads to craving for sugar and refined carbohydrates. Dr Ajai said that the growing unhealthy and untimely eating habit among the youth, especially late at night, cannot be changed by persuasion or pressure, rather these

methods can make the situation even worse. The youth can be brought out of this serious situation only by engaging them in creative work and providing them a stress-



Beijing might claim that packing the plateau

Therefore, the frontier highway will also be an economic asset, apart from being a strategic masterstroke. This will also develop a connectivity conduit by interlinking the East-West Industrial Corridor Highway and the Trans-Arunachal Highway. It will also discourage migration from the border space to urban areas. The development will become more distributive than concentric. Pressure on the urban space will be primarily eased. The volatilities of the border space and Chinese hegemonic gravity will be minimised because of India's fully prepared, vigilant presence in the

The Myanmar chapter is currently in the doldrums. The Chinese alleged involvement in derailing democratic government there disturbs the geopolitics in the region, which imposes a cloud of uncertainty around India's infrastructure projects in Myanmar. Given the geopolitical complexity in the region, India makes measured strategic progress and anchors its hold firmly and irreplaceably. Building tunnels, bridges, airports, railroads, highways, etc, has become part of the process that systematically ensures India's strength and resilience. On the contrary, China's determined efforts in building highways, tunnels, bridges, railways, etc, on the Tibetan Plateau explain its preparedness. The skirmishes it indulges in along the Line of Actual Control (LAC) indicate its ulterior motive. Though Beijing might claim that packing the plateau with high-tech infrastructure is mainly for the economic development of Tibet, the territorial desires embedded in this exercise cannot be ignored. The Nyingchi-Lhasa rail line and highway that Beijing has built, as well as some sections that remain under construction, come close to the McMahon Line. Its concept of reconstituting border villages and a host of other things are symptoms of the region's complex geopolitics. Chinese brinkmanship has been primarily responsible for the disturbed geopolitics of the region. Much of these crises is expected to be resolved by the frontier highway. Therefore, India puts the required effort in the right direction to ease these tensions in the region.

West Siang, Upper Siang, Dibang Valley, Lower Dibang Valley, Anjaw, and Changlang in Arunachal Pradesh adjoining Tibet and Myanmar is a geostrategic mile-

stone. It was conceived in 2016 and is expected to be completed in 2027. Work in this direction has started at a quick pace. This shows the urgency and importance India gives to its territorial integrity.

The infrastructural development that China has brought along the McMahon Line is quite extensive. The frontier highway is a precise and direct response to this and to curb China's irrationality. The highway will become an allweather road to handle any geopolitical and geostrategic pressure likely to emanate from the other side of the border. From Tawang to vijayanagar, wnich covers the entire border space in Arunachal Pradesh, the frontier highway is a milestone in India's robust preparedness in the eastern Himalayas. The dragon finds a fitting competitor. The scale with which China develops its infrastructural might, both at the border and in the hinterland, the frontier highway is a geostrategic imperative. The risk these complex infrastructures present leaves no scope for a second thought but to act urgently to protect the territorial integrity of India. The frontier highway manifests India's right intent and seriousness in addressing the possible dangers that the enemy constantly poses. The frontier highway will present the required checkmate to Chinese bullying attitudes in the region. Beijing's reaction to these infrastructural initiatives is not new. It always does this to keep itself relevant in the thick of things. However, it has no business in making any comment as Arunachal Pradesh is an integral part of the sovereign India. China uses this drama to keep the issue alive and effectively uses its propaganda machinery to develop.

Well-functioning market requires a suitable regulatory role of the state

The Modi government's main move in the Union Budget 2025 has been to cut personal income tax. As finance minister Nirmala Sitharaman said in her speech, it is meant to boost demand in the economy. However, the government doesn't expect a higherthan-usual increase in other non-debt receipts and has budgeted a decline in the deficit. The budgeted capital expenditure is the same as the revised estimates for 2024-25.The tax cut should be seen in the context of other fiscal policy moves the Modi government has made in the last decade to boost growth.Since 2016, the Indian economy has struggled to sustain rapid growth. From 2016 to 2019, it was in a relentless showdown, with GDP growth falling to 3.9 per cent in 2019-20. The GDP then fell sharply in 2020-21 due to the pandemic.After this sharp decline, high GDP growth numbers created a false sense of complacency, but the compound annual growth rate between 2019-20 and 2024-25 is only 4.8 per cent. The latest GDP estimates suggest that the economy is slowing down again with growth clocking at 5.4 per cent in the July-September quarter of 2024. Even if we set aside the critiques of GDP estimation in India, growth remains a topic of concern in policy conversations.The government's response to an economic challenge depends on what it considers to be the root cause. The Modi government's actions over the past decade suggest that it seeks



to address India's economic growth pangs through fiscal policy. Consequently, fiscal policy has done much of the heavy lifting in the government's growth strategy over the past decade. In the economic slowdown from 2016-17 to 2019-20, the government sought to maintain its expenditure. To do so without increasing the reported fiscal deficit, from 2017-18 to 2019-20, it transformed a significant part of its onbudget expenditure into offbudget expenditure done by public enterprises. It also sharply raised cesses and surcharges on petroleum products, which are not shared with the states. These unusual tactics allowed the government to spend more, and expenditure continued outpace growth.These tactics also allowed the government to introduce new cash transfer schemes such as PM KISAN and increase allocations to existing schemes.In 2019, in an effort to stimulate investment, the government announced major tax breaks for corporates, especially in manufacturing. At the time, corporate tax collection had been growing rapidly while rose to 3.21 per cent.

other taxes were struggling to deliver the budgeted increase. The tax cut led to a sharp reduction in the corporate tax to GDP ratio in the subsequent years. As the pandemic hit, fiscal policy became even more central. The pandemic allowed the government to suspend its concern for deficits and bring the off-budget expenditure to the Budget in 2020-21. For a few years, revenue expenditure as a percentage of GDP was higher than its prepandemic levels. Among other things, this allowed the government to increase subsidies and cash transfers, and introduce production-linked incentives for manufacturing in India. Total subsidies as a percentage of GDP have now gone back to their pre-pandemic levels.The most important change in expenditure since the pandemic has been in its composition. Of the Union government's total expenditure, the share of capital expenditure has increased. Its share rose from 12.5 per cent of total expenditure in 2019-20 to 22.2 per cent in 2023-24.In 2019-20, capital expenditure was 1.67 per cent of GDP. It

in 2023-24, before moderating to 3.14 per cent in 2024-25 (revised estimates). It is again budgeted to be 3.14 per cent of GDP in 2025-26.At the same time, there was a reduction in capital expenditure by public enterprises in these years. If we consider the combined capital expenditure by the Union government and its public enterprises from the prepandemic years, there has been a decline.Between 2017-18 and 2019-20, the combined capital expenditure was 4.94 per cent of GDP, while it has been only 4.32 per cent of GDP between 2022-23 and 2024-25. This probably shows the limitations of implementation capacity that a capital expenditure strategy tends to run into.So, in the last decade, the government has tried a variety of fiscal tactics—from increasing expenditure by "creatively" easing the Budget constraints, to giving generous corporate tax cuts, to introducing new welfare schemes, to increasing on-budget capital expenditure. The cut in the personal income tax is the latest in this series of measures. If this does not work, there are other arrows in the fiscal quiver—cut in GST, for instance. The fiscal policy landscape in India is such that there are always some instruments at the government's disposal, especially because it borrows domestically for the most part, that too, through financial institutions it controls.All this tells us something about the government's explanation of how the economy works and

what the challenges are. The government probably does not see deeper problems in the political economy. Now that it has made so many fiscal policy interventions, perhaps it should consider whether these can truly address the growth pangs of the Indian economy. The fundamental challenge for the Indian economy for over a decade has been the lack of revival of private investment and the lackadaisical performance of merchandise exports. While the latter performed well for about six quarters in the post-pandemic period, this was due to temporary opportunities created at that time—the exports are now back to low growth. Similarly, there have been a few quarters of better private investment activity in recent years, but we are not yet in a period of revival.On the other hand, some highproductivity services sectors continue to be the silver lining. The IT services exports have continued to grow and export services such as business and management consultancy as well as public relations have doubled from the pre-pandemic years. The FM's Budget speech and Economic Survey 2024-25 hinted at actions beyond fiscal policy—deregulation and tax code simplification. Depending on what reforms will follow, these can be steps in the right direction. However, two points are worth considering.

First, mere deregulation is not enough—a well-functioning market requires a suitable regulatory role of

India's GST system is now a mess. Those who designed it also are confused

While this may seem like a trivialisation of GST, it actually lays bare how the system has now rebounded on its initial promise of bringing ease of doing business in the country. The Finance Minister's four-minute explanation on the taxation of popcorn highlighted how complex the system has become. It shouldn't take anybody that much time to explain the applicable tax rates on a single product. Since then, GST has been ridiculed, derided, lamented about, and generally panned by laypeople and even former government officials who worked on its implementation. That is why India's Goods and Services Tax is ThePrint's Newsmaker of the Week. So, what is the issue behind GST on popcorn? You see, as per the taxman, depending on your taste preferences, popcorn can either be a namkeen (salty) or a salted caramel popcorn packets with mithai (sweet) — forget that those questions along the lines of.

two terms have never been used by anyone to refer to popcorn. Readyto-eat popcorn, salted and spiced for taste, and sold loosely attracts a GST rate of 5 per cent. That same popcorn, if packaged and labelled. attracts a rate of 12 per cent. One wonders what happens if the vendor tears open the packet and sells loose popcorn to the customer. Perhaps the universe will explode, who knows? Things get even trickier when you talk about caramel popcorn. Those who prefer this flavour will have to shell out 18 per cent GST, regardless of whether it is packaged or sold loose. To stand in this house is to be again. This is the kind of thing that solace and to inspire, its aspiration to these great and lovely heights, in which strength and delicacy are so perfectly conjoined. In addition, to be asked to speak here on this day, the fourth anniversary of the notorious fatwa of the late Imam Khomeini, is a particular honour. When I was an undergraduate at this college, between 1965 and 1968, the years of flower-power and student power, I would have found the notion of delivering an address in King's Chapel pretty far-out, as we used to say; and yet, such are the journeys of one's life that here I stand. I am grateful to the Chapel and the college for extending this invitation, which I take as a gesture of solidarity and support, support not merely for one individual but, much more importantly, for the high moral principles of human rights and human freedoms that the Khomeini edict seeks so brutally to attack. For just as King's Chapel may be taken as a symbol of what is best about religion, so the fatwa has become a symbol of what is worst. It feels all the more appropriate to be speaking here because it was while in my final year of reading history at Cambridge that I came across the story of the so-called satanic verses or temptation of the Prophet Muhammad, and of his rejection of that temptation. That year, I had chosen as one of my special subjects a paper on Muhammad, the rise of Islam, and the caliphate. So few students chose this option that the lectures were cancelled. The other students switched to different special subjects. However, I was anxious to continue, and Arthur Hibbert, one of the King's history dons, agreed to supervise me. So as it happened I was, I think, the only student in Cambridge who took the paper. The next year, I'm told, it was not offered

reminded of what is most beautiful almost leads one to believe in the about religious faith: its ability to give workings of a hidden hand. The story of the 'satanic verses' can be found, among other places, in the canonical writings of the classical writer al-Tabari. He tells us that on one occasion the Prophet was given verses which seemed to accept the divinity of the three most popular pagan goddesses of Mecca, thus compromising Islam's rigid monotheism. Later he rejected these verses as being a trick of the devil saying that Satan had appeared to him in the guise of the Archangel Gabriel and spoken 'satanic verses.' Historians have long speculated about this incident, wondering if perhaps the nascent religion had been offered a sort of deal by the pagan authorities of the city, which was flirted with and then refused. I felt the story humanized the Prophet, and, therefore made him more accessible, more easily comprehensible to a modern reader, for whom the presence of doubt in a human mind, and human imperfections in a great man's personality, can only make that mind, that personality, more attractive. Indeed, according to the traditions of

the Prophet, even the Archangel Gabriel was understanding about the incident, assuring him that such things had befallen all the prophets, and that he need not worry about what had happened. It seems that the Archangel Gabriel, and the God in whose name he spoke, was rather more tolerant than some of those who presently affect to speak in the name of God. Khomeini's fatwa itself may be seen as a set of modern satanic verses. In the fatwa, once again, evil takes on the guise of virtue; and the faithful are deceived. It's important to remember what the fatwa is. One cannot properly call it a sentence, since it far exceeds its author's jurisdiction; since it contravenes fundamental principles of Islamic law.

Delhi: According to officials, the standing comof Delhi mittee University (DU) will meet to evaluate suggestions for a number of value addition courses (VAC), including four that are centered on the Bhagavad Gita and one called An Introduction to Viksit Bharat. The committee's emphasis on incorporating modern applications of Indian philosophy and development topics into the curriculum is highlighted in the agenda, which was made public on Wednesday.

With themes like "Gita for Holistic Life," "Gita Leadership Excellence,"



"Gita for Sustainable Universe," and "Gita for Navigating Challenges," four of the six VACs that are being considered are centered around the Bhagavad Gita. Based on Karmayoga, Jnanayoga, and Bhaktiyoga, the Gita for Holistic Life syllabus suggests teachings on self-management, resolving problems in modern life, and methods of action,

knowledge, and devotion. The course will also include practical components. The other courses will cover similar thematic applications of Gita's teachings to leadership, sustainability, and life's problems. Gita undoubtedly be able to offer us some direction, but it seems ridiculous to introduce so many VACs on Gita. In addition to practical elements like field trips to communities, self-help groups, and farmers' organizations, the proposed chapters will address the role of technology, infrastructure, agriculture, and sustainability, he said.

'Sister had gone to US on tourist visa, no idea why she was deported': Brother

AHMEDABAD: A wave of despair spread across many parts of Gujarat as 33 illegal immigrants, including 13 women and eight children, landed in Ahmedabad early Thursday from Amritsar after they were deported from US. Faces covered by masks, without any luggage and a few with backpacks, they were taken to Gujarat Police vehicles stationed at the airport and whisked away to their homes. All of them were deported under the 'catch and release' policy of Trump administration and were part of a larger group of 104 Indians who were sent back from the US this week. "My sister was handcuffed during the deportation. She hasn't talked much with us. She had gone to US on a tourist visa. We have no idea why she was deported,"

TN should appeal SC ruling on domicile quota

Delhi: A day after the Supreme Court banned domicilebased reservation in specialized and education higher including PG medical courses. MK Stalin's Tamil Nadu government declared it would file a review petition to vindicate its rights and uphold social justice. Health min-Subramanian said the SC order would affect the state's 69% reservation and quotas for in-service applicants in government medical colleges and minorities in self-financing medical colleges. He said that the order would violate state rights. Fewer dropouts, but school retention issues

Delhi :The Economic Survey 2024-25 released in Parliament shows that less than half of Indian students complete higher secondary education, despite declining dropout rates across all levels.Dropout rates were 1.9% for primary (Classes I to V), 5.2% for upper primary (Classes VI to VIII), and 14.1% for secondary. Retention rates—the percentage of children who stayed enrolled since

first gradewere 85.4% for primary, 78% for elementary, 63.8% for secondary, and 45.6% higher ondary.



According to the education ministry's Unified District Information System for Education-Plus (UDISE+ 2023-24) report, India's enormous educational system serves 248 million students in 1.5 million schools with 9.8 million instructors. Government schools make up 69% of schools, enroll 50% of pupils, and employ 51% of teachers. The research showed 22.5% private schools, 32.6% student enrollment, and 38% teachers.

Digital infrastructure has improved. Computers in schools rose from 38.5% in 2019-20 to 57.2% in 2023-2024, while internet connectivity rose from 22.3% to 53.9%. The poll said the NEP 2020 is based on the idea that "education and human capital development are among the foundational pillars of development."The union government introduced NEP on July 29, 2020, to modernize the education system from school to higher education while maintaining it "rooted in Indianness". Higher education enrollment rose 26.5% to 43.3 million in 2021-22 from 3.42 crore in 2014-15, according to the poll. The poll found that tripling educational infrastructure would be needed to meet the government's 2035 goal of 50% GER in higher education.

The administration also said people who answered or apologized would not be punished. After an unusual general body meeting the IITTA approached the board of governors. They worry the administration may act fast and deny office bearers a fair hearing, further undermining trust.
