Minister was addressing the 120th foundation day celebrations of Tamil Nadu-based City Union Bank. President Draupadi Murmu attended the event as the chief guest. Sitharaman said that in the last 11 years, more than 56 crore Jan-Dhan accounts have been opened, with a total deposit of Rs 2.68 lakh crore. She said that 67 per cent of these accounts have been opened in rural or semi-urban areas, with 56 per cent accounts held by women. The Finance Minister said that a bank account is not just a passbook, but it is a passport of opportunities, which enables access to credit, savings, insurance and dignity.

Sitharaman said that India's scheduled commercial banks have recorded a huge improvement in their asset quality, resulting in a reduction in NPAs. He said Prime Minister Narendra Modi has recently announced the formation of a task force for next generation GST reforms with a clear objective to simplify rules, reduce compliance costs and create a more enabling ecosystem for startups, micro, small and medium enterprises (MSMEs) and entrepreneurs.

Delhi : Mohan Bhagwat, chief of the Rashatriya Swayamsevak Sangh (RSS), stated that a Hindu Rashtra cannot be described in terms of the western idea of a nation state since it is equitable and



does not discriminate based on religion or language. While the Sangh does hold talks on 'Achar, Vichar, Sanskar" (behavior, ideology, and values), he claimed that it does not push its perspective on anyone, emphasizing its independent identity and autonomy from the government. It is thought that Bhagwat was trying to emphasize the BJP's autonomy and independence, albeit he did not specifically mention any organization. Despite staying out of electoral politics, the Sangh is thought to be essential in the BJP's intellectual foundation, policy formulation, and organizational appointments, as well as the party's political strategy and policy. Speaking on the first day of the Sangh's three-day lecture series 'New Horizons,' which is part of its centenary commemoration, Bhagwat emphasized once again that the RSS, which has triumphed against "challenges and false allegations" throughout its history, was not established in response to or in opposition to anyone.

Shadow education is on the rise, with 33% of students enrolling in private lessons

Delhi : The most recent Comprehensive Modular Survey (CMS) on education that the government issued found that about one-third of school-aged children now use private tutors, with the trend being even more pronounced in metropolitan regions.

The results provide a picture of a system in which public schools play a pivotal role in rural India but private schools and paid tutoring are becoming more popular among urban families. As part of the 80th round of the Sample National Survey, the ministry of statistics and programme implementation surveyed 52,000 and households around 58,000 pupils to determine how much money families spent on education. Although public



schools still make up the majority schools in the country (55.9%), they have a much larger impact in rural areas (where 2/3 of students attend). Only 30.1% of urban students attend public schools, with parents clearly favoring prinon-public vate, schools. In metropolitan locations, where disposable wealth and aspirations influence choice, private schools make up a disproportionately large portion


During India-Pakistan tensions, Delhi tests air sirens

Tax terror and India's same-sex couples

When a homemaker and a lawyer went to the Bombay High Court this month, they were not asking for the right to marry; they were asking for the right not to be taxed for giving gifts to each other. In their petition, they argued that Section 56(2)(x) of the Income Tax Act exempts gifts between spouses from tax, but does not extend that exemption to same-sex couples since the law does not recognise them as spouses. In their case, the absence of marriage recognition meant the presence of a tax bill. It is a reminder that even without entering the debate on marriage equality, the law is already punishing same-sex couples in small and large ways that are rarely discussed. This tax case is not an isolated problem. It is one of the many points in a web of laws where the word 'spouse' decides who is entitled and who is excluded. Inheritance laws under the Hindu Succession Act, 1956 or the Indian Succession Act, 1925 give priority to a legally recognised spouse, leaving partners as legal strangers. Many states also offer concessional stamp duty for property transfers between spouses, but same-sex couples pay the higher rate because they cannot produce a marriage certificate. In practice, it can mean paying significantly more for the same transaction. These gaps are not just about money; they appear in moments of crisis. Research on discrimination in Indian hospitals has shown that gueer people are often denied recognition of their chosen partners as next of kin. In emergencies, this can mean being refused entry to an intensive care unit (ICU) or being blocked from giving consent for urgent treatment.The Surrogacy (Regulation) Act of 2021 and the Assisted Reproductive Technology (Regulation) Act, 2021 go further, excluding same-sex couples from surrogacy and restricting adoption to single individuals or married heterosexual couples. In effect, the laws treat them as incapable of raising a child together, no matter their stability or commitment. Employment rules reinforce the same pattern. In government service, Leave Travel Concession (LTC), medical reimbursement, and family pension benefits are tied to a recognised spouse. Private companies may choose to extend coverage, but the default language in most HR manuals mirrors the government's. Studies of India's insurance sector show that traditional group health insurance schemes frequently exclude same-sex partners, and even where some progressive companies extend coverage, it is not guaranteed by law. The Employees' Provident Fund allows broader nominations, but pension rules under the Employees' Pension Scheme, 1995 limit eligibility to spouses or children. Even when a company accepts a same-sex partner as a nominee, it is a discretionary gesture, not a right protected by law. Immigration policy adds another layer of instability. A foreign national married to an Indian citizen can apply for a dependent visa or be registered as an Overseas Citizen of India, but same-sex partners cannot. They rely on tourist or business visas that require regular renewals, creating a constant risk of separation if paperwork lapses or rules change. These are invisible forms of insecurity that heterosexual couples rarely have to confront. The lack of recognition also weakens legal protections when relationships end. The Protection of Women from Domestic Violence Act, 2005, while covering women in domestic relationships, leaves uncertainty about its application to same—sex couples. Maintenance and alimony provisions in personal laws and the Criminal Procedure Code apply to spouses, shutting out partners who may have been financially dependent for years. Without these remedies, breakups can mean abrupt eviction, loss of shared assets, and no legal recourse.India's own courts have already recognised that families do not fit a single template. In the Deepika Singh v. Central Administrative Tribunal judgment, the court observed that such atypical manifestations of the family unit.

External Affairs Minister S Jaishankar Trump. There is a strong degree of truth in this warning. Contrary to the prevailing analysis that Trump has induced India and China to improve and repair ties, the bilateral relationship has shown little to no sign of improvement and arguably has even deteriorated under the calmer surface. Let me explain.At present, the quantum of trends as well as indications of 'improved' ties in the bilateral relationship can be divided into four categories. First, a return to diplomatic and economic 'normalcy' such as the resumption of flights, religious pilgrimages and border trade. Second, increasing talk of economic convergence amid a gradual return of Chinese investments. Third, growing peace and tranquillity at the border. And finally, strategic/geopolitical convergences in the age of



by US-based notaries. Over the past few months, the ED has seized vital evidence through raids at multiple medical colleges in Odisha and West Bengal. The confiscated NRI certificates were thereafter transferred to Indian missions and embassies for verification by the agency. It was discovered that the majority of them were counterfeit. These medical schools were paying middlemen to get false NRI paperwork made, according to the investigation.

The NGT has rejected DJB's plan to redirect sewage to DSTPs

Delhi: The NGT has ruled against the Delhi Jal Board's (DJB) plan to link 43 stormwater drains that empty into the Barapullah drain to DSTPs, describing it as a "temporary solution" that won't solve the underlying problem of pollution. A court led by Prakash Justice Shrivastava issued an order directing various authorities, including the DJB and the Delhi government, to develop a long-term strategy to stop sewage from going into stormwater drains. These stormwater drains are not suitable for sewage flow. While tapping and redirecting the drains to the DSTP might work as a stopgap solution, it will eventually lead to overflowing when it rains because the stormwater drains won't be able to handle as much water. Because these DSTPs are susceptible to flooding after rainstorms, the bench noted that untreated sewage will once again reach the water supply. These instructions were given during a hearing

The third order said, "Virender Singh Chahal IPS (AGMUT -1991), holding the charge of Spl CP (Licensing & Legal Division) has been posted as Director General (Civil Defence) with immediate effect."

Vehicle Renewal Fee for Vehicles Over 20 Years Old Raised to Rs 10,000 by Government

Delhi: To discourage the retention of vehicles older than 20 years, the transport ministry has increased the registration renewal charge. A notice from the Ministry of Road Transport & Highways (MoRTH) states that the renewal charge for LMVs older than 20 years is now Rs 10,000, up from Rs 5,000. A motorcycle's renewal charge would increase from 1,000 to 2,000 rupees as stated in the notice, if the bike is more than 20 years old. Delhi: The ministry of electronics and IT (Meity) announced that the Union government has amended the Aadhaar rules to allow private entities use Aadhaar authentication service delivery. The amendments aim to give residents "ease of living" and "better access services". Ministry Aadhaar Notified Authentication for Governance Good Welfare, (Social Innovation, Knowledge)

Amendment Rules, 2025, revising 2020 "The amendrules. ment allows government and non-government entities to use Aadhaar authentication, promoting trusted transactions for both providers and users," stated the announcement.
