NEW DELHI: The Congress is once again under BJP fire. And once again, the ammunition for this all-out attack has been provided by a party leader. P Chidambaram's reality check on the future of INDIA bloc has left the Congress scurrying for cover. "The future (of INDIA bloc) is not so bright, as Mritunjay Singh Yadav said. He seems to feel that the alliance is still intact, but I am not sure. It is only Salman (Khurshid) who can answer because he was part of the negotiating team for the INDIA bloc. If the alliance is totally intact, I will be very happy. But it shows at the seams that it is frayed," Chidambaram said at a book launch in the national capital on Thursday.

He also hoped that the alliance can "still be put ing several government's



together, there's still time". The BJP, as expected, latched to Chidambaram's remarks and unleashed a fierce offensive against the Congress. And why not? After all, the leadership of opposition's INDIA bloc is with the grand-old-party Mallikarjun Kharge is its chairperson. effectively. Ironically, his remarks come at a time when the Congress was already struggling over statements made by Shashi Tharoor in support of PM Modi's policies during the India-Pakistan standoff. Several BJP leaders

Some reports citing Congress sources had suggested that the party had expressed displeasure with Tharoor's statements and was of the view that the Thiruvananthapuram had crossed the Lakshman Rekha this time around. However, Tharoor had dismissed these reports and called them "media creation without any evidence."

Chidambaram's statement coming in this backdrop put the party once again on the backfoot.

Citing Chidambaram's reality check, the BJP and its allies have been relentless in targeting the Congress and the INDIA bloc calling it a "greeddriven coalition", "Mahathagbandhan", "opportunistic alliance", "kushti-dosti model", "company of looters", "group of corrupt leaders", "ghamandiya alliance" Some even raised questions on Congress's leadership role and claimed that the grandold-party is fading and has no future. INDIA bloc, which was launched with a lot of fanfare is actually gasping for breath today and to that extent Chidambaram is spot on in his assessment. But to announce that from a public platform definetely helps party's political rivals - the BJP in this case. It will be interesting to see how the Congress reacts to this new challenge. Party leader Udit Raj, who had slammed Tharoor for 'becoming BJP's spokesperson', had a word of advice Chidambaram. "Party has given him a lot. He and his son are MPs. Since the party is not in power, Chidambaram ji should go around the country and conduct a dialogue," he said.

Author Salman Rushdie attacker sentenced to 25 years in prison in 2022 stabbing case

NEW DELHI:

The man who stabbed acclaimed author Salman Rushdie on stage during a 2022 lecture in western New York has been sentenced to 25 years in prison. Hadi Matar, 27, convicted in was February of attempted murder and assault after attacking Rushdie as he prepared to speak at the Chautauqua Institution. The brutal assault left Rushdie, 77, blind in one eye and seriously injured.

He was stabbed over a dozen times in the head and torso. Matar also wounded another man on stage. Though Rushdie did not attend Friday's sentencing, he submitted a victim impact statement. He had previously testified, recounting the harrowing moment he believed he was going to die. Before sentencing, Matar made a brief statement criticizing Rushdie and invoking free speech, calling the author a "hypocrite."

Why Apple won't find it easy to move iPhone production from India to US

Bengaluru: Apple has big expansion plans for India plans that are now being frowned upon by US President Donald Trump. Currently, Apple does not manufacture iPhones in the United States, but Trump wants that to change. Trump has made it clear to Apple CEO Tim Cook that he has a 'problem' with US tech giant 'building all over India'.The majority of iPhone production occurs in China, whilst facilities in India make approximately 40 million units annually. That's roughly 15% of Apple's total production.

Trump on Thursday revealed that he asked Apple CEO Tim Cook to stop iPhone manufacturing in India and relocate production to the United



States.Trump said, "I had a little problem with Tim Cook yesterday. I said to him, 'Tim, you're my friend. I treated you very well. You're coming in with \$500 billion (investment). But now I hear you're building all over India. I don't want you building in India."

NEW DELHI: Jammu and Kashmir chief minister Omar Abdullah and former CM Mehbooba Mufti on Friday engaged in war of words over reinstating the Tulbul Navigation Project after the suspension of Indus Waters Treaty.

The argument started after Abdullah suggested on Thursday a possible resumption of construction at the Tulbul Navigation Barrage on Wullar Lake, considering the suspension of the Indus Waters Treaty. The role of state fiscal capacities in national growth

India's economic progress is a composite reflection of the growth trajectories of its states. Given the federal structure of the country, each state operates with a degree of autonomy in implementing policies that drive their individual economies. This results in a broad spectrum of growth rates across states, highlighting significant disparities. For the nation to achieve holistic growth, it is imperative for all states to experience economic advancement. Despite this, there is a notable discrepancy in the attention paid to fiscal matters at different levels of government. The Union Budget, detailing the central government's finances, often garners substantial scrutiny and debate for its potential impacts on the nation's economic direction. In contrast, state budgets, which are crucial for addressing local needs and fostering regional development, do not attract a similar level of public and analytical scrutiny. Fiscal capacity, the government's ability to generate revenue from available tax and nontax bases, is crucial for several reasons. First, it underpins a government's ability to provide essential public goods and services. These range from healthcare and education to infrastructure and defense, which are fundamental for the welfare of the citizenry and the smooth functioning of the economy. Without adequate fiscal capacity, governments may struggle to maintain these services at levels that meet public demand and expectations, potentially leading to social unrest or a decline in the quality of life. Second, fiscal capacity is vital for economic development and growth. Governments need resources to invest in infrastructure projects like roads, bridges, and digital networks, which are critical for enhancing productivity and competitiveness. Such investments not only improve current living standards. but also set the stage for future economic expansion. The Asian Development Bank Institute (ADBI) in 2017 and the World Bank in 2015 highlighted the risk of economies falling into a 'middle-income trap' where they are unable to transition to high-income status due to inadequate fiscal capacity among other factors.

Moreover, fiscal capacity is essential for macroeconomic stability. It allows governments to manage economic cycles more effectively, applying fiscal stimulus in downturns and restraint in booms to maintain economic stability. The Covid-19 pandemic's impact on Indian states underscored this point, as reduced fiscal capacities constrained their ability to respond effectively to the crisis and its economic repercussions.

Finally, a robust fiscal capacity enables equitable social development. It allows for redistributive policies that can mitigate income inequality and fund social safety nets for the vulnerable. Studies have shown that factors such as high per capita income, education levels, and low corruption contribute to higher fiscal capacity, which in turn can be used to foster a more inclusive society.

Given that state governments account for over 60 per cent of general government expenditure in India, enhancing their revenue-generating capacity is imperative for the needed investment in areas such as education, research and development, and skill development.

The Reserve Bank of India recently released a report on state finances, which gives an insight into the state budgets of 2023-24. It has some important findings. First, revenue mobilisation in Indian states comprises both tax and non-tax revenues, with a significant portion coming from state's own tax revenues (SOTR). Over the years, there has been a noticeable

increase in SOTR, growing from 5.7 per cent of GDP in 2003-04 to 6.9 per cent in 2022-23. This growth, particularly in the post-GST era, reflects a shift in the composition of tax revenues. with the State Goods and Services Tax. Jammu and Kashmir - A period of transformational change



Free trade deal between India and the UK finalized

Delhi: India and the United Kingdom have finalized a free trade agreement (FTA), which will increase the export of textiles, leather, and engineering goods from India while reducing tariffs on British whisky, cars, and medical devices. The agreement, according to Prime Minister Narendra Modi, will facilitate trade, investment, and the creation

of jobs. After three years of negotiations, the FTA between the world's fifth and sixth biggest economies was finally finalized.



Modi and Boris Johnson had originally aimed to conclude the accord by October 2022. Differences on a variety of subjects, including alcohol and automotive tariffs, the mobility of Indian professionals, and political unrest in the UK, have since impacted the negotiations.

Concluded amidst worldwide economic uncertainty caused by US President Trump's tariff policies, the accord may pave the way for future pacts of a similar kind with other countries, the US included. With the United States, the European Union, Oman, Peru, and New Zealand, India is presently in the midst of free trade agreement negotiations. Since Britain's departure from the EU in 2020, the FTA has been its most substantial trade agreement.



The UK and India close key trade deal in 'new age' of **Trump tariffs**

Delhi : Britain and India signed a longawaited free trade agreement as tariff upheaval caused by U.S. President Donald accelerated Trump commerce in whisky, cars, and food. After three years of stopstart negotiations, the world's fifth and sixth economies largest reached a deal to boost bilateral commerce by 25.5 billion pounds (\$34 billion) by 2040. British PM Keir Starmer said the enhanced partnership would lower trade obstacles in a "new era for trade". Nations are

Following the resignation of representatives of Prosus, Peak XV Partners and Chan Zuckerberg Initiative from the board of Byju's in June last year, it has been reduced to a familyrun entity, comprising Raveendran, his wife and co-founder Gokulnath and his brother Riju Raveendran."This EGM is procedurally invalid, contractually in contravention of our AOA (Articles of Association) and SHA (Shareholders Agreement), legally on the wrong side of the Companies Act, 2013," a company spokesperson said in a statement on Thursday. Byju's said that with Raveendran and board members deciding to skip the EGM, it will not have the required quorum and cannot proceed to discuss or vote on the agenda. "As custodians of Byju's, it is the responsibility of the founders to respect the established procedures of law and protect the company's integrity," the company added. The EGM is supposed to take place on Friday morning, according to the EGM notice reviewed by. Investors claim that they will hold the EGM as per plan but if the resolutions are put to vote, then they will test the law in court, lawyers said.
