Himachal: 1,789 women will become Panchayat

Shimla: This time in Himachal Pradesh, 1,789 women will be in charge of the Gram Panchayat Pradhan. In the Panchayat elections held in the year 2020, 1,808 women were in charge of the Gram Panchayats. Recently, the government has about Panchayats as Nagar Panchayats, while four new Gram Panchayats have also been formed by cutting off Yol Cantt. Compared to the last Panchayat elections, now there are 3,577 Gram Panchayats in the state. During the tenure

Delhi: The Supreme Court has directed the High Courts and lower courts across the country to dispose of bail and anticipatory bail petitions within six months. A bench of time frame. Preferably Justices JB Pardiwala and R Mahadevan said, "The High Courts as as subordinate courts should dispose of bail and anticipatory bail petitions within a short



within three to six months."

The bench said that applications directly related to the right to personal liberty cannot be left pending for years.

The court said that long delays not only defeat the purpose of the Code of Criminal Procedure (CrPC) but are also tantamount to deprivation of justice, contrary to the constitutional values enshrined in Articles 14 and 21. The court said that bail and anticipatory bail applications should be decided expeditiously on the basis of their mer-

There is a greater risk of floods in lower areas due to the breaking of glaciers

Dehradoon

The rising water level of the rivers of the state is a matter of concern, one of the main reasons for which is the large scale breaking of glaciers. Due to heavy rains



and melting of glaciers, the amount of water in the rivers is increasing, which has increased the risk of silt and floods in the lower areas. Geologists have warned that if the condition of the glaciers does not improve, then the risk of floods in the lower areas situated on the river banks will increase further in the future. According to Professor HC Nainwal of the Department of Geology of Hemvati Nandan Bahuguna Garhwal Central University, the glaciers of Uttarakhand and Himachal Pradesh are retreating by 5 to 20 meters every year. What is even more worrying is that their thickness is continuously decreasing. Hanging glaciers break more, which increases the incidence of avalanches. Professor Nainwal has cited changes in the earth's temperature and emission of gases as the main reasons behind the rapid breaking of glaciers. The gases emitted from forest fires are also having a bad effect on them. The breaking of glaciers will increase the amount of water and silt in the rivers. This will not only increase the risk of floods in the lower areas but will also reduce the capacity of the reservoirs of hydroelectric projects. The storage capacity of the reservoirs will decrease due to the accumulation of silt, which will reduce power generation. Apart from this, the sea level will also rise. Professor Nainwal believes that it is very important to reduce the emission of gases to save the glaciers. There is a dire need to formulate a nationwide pol-

Delhi: The New Election Commission has told the Supreme Court that any direction to conduct a special intensive revision (SIR) of the voter list at regular intervals across the country would encroach upon the exclusive jurisdiction of the Election Commission. In a counter affidavit filed in the Supreme Court, the Election Commission said that it has full authority over the policy of amendment in the voter list.



The counter affidavit said that the Chief Electoral Officers of all states and union territories except Bihar have been directed to amend

UGC bans 3 private universities from PhD admissions for 5 years

Due to academic misconduct and UGC regulations, University Sunrise (Churu), University (Alwar), and Singhania University (Jhunjhunu) have been forbidden from accepting PhD students for five years (2025-26 to 2029-30). Admissions at three Rajasthan universities were suspended immediately.Following admission exam protocols, Research Advisory Committee (RAC) creation, and thesis evaluation criteria, the UGC found their inadepractices quate. Another 30 are being examined. The UGC said, "After analysing/ examining/evaluating the information/ data submitted by the universities, Standing Committee has found that three universities did not follow the provisions of the UGC PhD regulations and also the academic norms for the award of PhD degrees...



VB accuses Majithia in 40,000-page chargesheet

Delhi: In the matter of disproportionate assets (DA), the Vigilance Punjab Bureau (VB) filed a 40,000-page chargesheet against Bikram Singh Majithia, a leader of the Shiromani Akali Dal (SAD) and a former minister, in a Mohali court. In the court of additional sessions judge Hardeep Singh was presented the chargesheet, which was enclosed in four sealed trunks.

Delhi: Three and a half ensures authenticity," after the national medical registry was began, less than 6,500 doctors have registered and 284 have been approved. The projected 12 lakh doctors working in India would take 40 years to register and approve at the current rate. Union health minister JP Nadda launched the Medical National Register (NMR) Portal of the National Medical Commission (NMC) to register all Indian MBBS doctors. "The uniqueness of NMR is that it is linked with doctors' Aadhaar IDs, which

claimed the health ministry. NHA and NMC's NMR site will provide dynamic, authentic, and consolidated doctor data, it stated. The government claimed that "the speedy and easy registration process on the portal will facilitate the timely updation of the data", yet doctors have had registration issues. The Kerala State Medical Council confirmed my NMC registration. In 110 days, my application has been returned with unrelated questions four times, including questions about the University

The NMR is required by Section 31 of the NMC Act, 2019. Starbucks workers expand strike across US cities

Starbucks workers have extended their ongoing strike to four more cities, including New York, according to the union that represents more than 10,000 coffee shop workers.

The strike stemmed from failed negotiations between Starbucks and union representatives, disputes over wages, staffing levels, and work schedules remaining unresolved. According to news agency Reuters, the fiveday strike, which began on , initially mpacted Starbucks locations in Los Angeles, Chicago, and Seattle. As of Saturday, the industrial action has expanded to include New Jersey, New York, Philadelphia, and St. Louis.While the union

did not specify the location of the walkout in New Jersey, it confirmed that the strike continues to disrupt operations in the newly added cities.

The union's strike spans in 10 cities, including Columbus, Denver and Pittsburgh, during festive period, potentially affecting the company's Christmas revenue.



In Hindu Rashtra, there is no Hindu vs. non-Hindu division

Delhi: Mohan Bhagwat, chief of the Rashatriya

Swayamsevak Sangh (RSS), stated that a Hindu Rashtra cannot be described in terms of the western idea of a nation state since it is equitable and does not discriminate based on religion or language. While the Sangh does hold talks on "Achar, Vichar, Sanskar" (behavior, ideology, and values), he claimed that it does not push its perspective on anyone, emphasizing its independent identity and autonomy from the government. It is thought that Bhagwat was trying to emphasize the BJP's autonomy and independence, albeit he did not specifically mention any organization. Despite staying out of electoral politics, the Sangh is thought to be essential in the BJP's intellectual foundation, policy formulation, and organizational appointments, as well as the party's political strategy and policy. Speaking on the first day of the Sangh's three-day lecture series 'New Horizons,' which is part of its centenary commemoration, Bhagwat emphasized once again that the RSS, which has triumphed against "challenges and false allegations" throughout its history, was not established in response to or in opposition to anyone.

Assam Govt. Approves Inter-Religious Land Transfer SOP

Delhi: Assam's government authorized a SOP for interreligious land transfer. In a briefing, Assam Chief Himanta Biswa Sarma said "all such transfers will come to the government". Assam is sensitive, this land transfers must be handled carefully. We will review all transfers that come to the government. "The District Commissioner will make the final decision based on the buyer's source of funds, whether the land sale will affect the local community's social fabric, and whether any national security threats are involved," Mr. Sarma added. Shadow education is on the rise, with 33% of students enrolling in private lessons

Delhi : The most recent Comprehensive Modular Survey (CMS) on education that the government issued found that about one-third of school-aged children now use private tutors, with the trend being even more pronounced in metropolitan regions.

The results provide a picture of a system in which public schools play a pivotal role in rural India but private schools and paid tutoring are becoming more popular among urban families. As part of the 80th round of the Sample National Survey, the ministry of statistics and programme implementation surveyed 52,000 and households around 58,000 pupils to determine how much money families spent on education. Although public



schools still make up majority the schools in the country (55.9%), they have a much larger impact in rural areas (where 2/3 of students attend). Only 30.1% of urban students attend public schools, with parents clearly favoring prinon-public vate, schools. In metropolitan locations, where disposable wealth and aspirations influence choice, private schools make up a disproportionately large portion a third of the total) of

students.



The deal will also enable the return of displaced people in Gaza to return to whatever is left of their homes, and daily delivery of food and other supplies by hundreds of trucks. But things can still go wrong. There can be accidents or attacks from either side, which could break the truce. But even if the guns in Gaza do go silent on Sunday and the ceasefire holds for its intended period, the real challenge will come in the second stage of the agreement, when negotiations for ending the war and return of all remaining hostages would begin. Is Israel ready for a permanent end to the war? And what will stop a Palestinian activist from firing at Israel, given the bitterness in the community after Israel's campaign? There is not a single Palestinian left in Gaza who has not lost a friend or relative at the hands of Israel in this war. The third and final phase will involve the reconstruction of Gaza, whose infrastructure has been destroyed by the Israeli bombardments. The Arab countries that funded reconstruction in the past will be reluctant to do it this time unless they are sure that Israel will not destroy it again. It is also not clear who will govern Gaza now, as Hamas, even in its muchweakened form, will be unacceptable to both Israel and the United States. How Trump will react in the second and third phases is not possible to predict given his nature. In office, he may act differently. But both Israel and Hamas know that things have dramatically changed over the past 15 months when the current war began with the attack on Israel by the militant group on October 7, 2023. Israel's military response was swift and massive. One by one, it eliminated all the top leaders of Hamas and its ally Hezbollah and destroyed their military infrastructure. This also led to a regime change in Syria, where Bashar Assad was forced to flee the country and seek refuge in Russia. Hezbollah's primary backer.

Iran, has also been weakened following Assad's fall. Israel may have succeeded in decapitating the leadership of Hamas and Hezbollah and destroying their war machines. But the human cost of its military response in Gaza has also hit its international image and sparked a global outcry. Its brutal military campaign killed over 47,000 people in Gaza, displaced most of its 2.3 million population and destroyed more than 80% of residential buildings. Most of the victims have been innocent civilians who are now living in famine-like conditions, with hardly any access to health, food, clean water or proper shelter. For the first time, Israel has faced genocide accusations at the International Court of Justice. The International Criminal Court even issued arrest warrants against Netanyahu and his former defence minister on charges of war crimes and crimes against humanity. A successful ceasefire may bring an immediate end to the sufferings of Gaza's population, and the end of the current war may achieve a little more. But that does not mean the end of the wider conflict between Palestinians and Israel. While the Gaza war raged on, Israel expanded its settlements in the West Bank, and violence by settlers in that part of the territory has also increased in recent months. Peace in the Middle East continues to remain elusive. The Palestinian conflict is unlikely to be resolved without a two-state solution, as proposed by most countries, including India. However, the current Israeli government has rejected that idea. Trump may have helped push the ceasefire deal, but he has shown no interest so far in supporting a two-state solution.

that there may be some rationalisation of duties on capital goods required for solar upstream manufacturing could be seen so that overall that industry can really take off. "We expect continuation and maybe broadening of the PLI support towards the solar module value chain. We already have a few interventions there, which are likely to be extended deeper," Dwivedi said. Similarly, on the battery manufacturing front, the industry expects localization of the value chain given competing countries have already advanced beyond India. In the green hydrogen segment, the industry believes the government may bring in hydrogen purchase for specific sectors like (green) steel. On the EV front, the industry seeks more support towards building public charging infrastructure given the anticipated increase in the EV penetration. "Under the PM E-drive, we already have an allocation of about Rs 1,100 crores for FY26. Given that the final guidelines have not been released until now, I think even the allocation under FY25 may get added and FY26 budget may be increased as the country expects an acceleration in EV adoption in FY26," Dwivedi said. While the government has already launched a rooftop solar scheme and announced viability gap funding for offshore wind projects, industry players expect increased allocations, particularly towards solar and wind, along with higher



budgetary capital expenditure in green hydrogen and battery storage infrastructure. Along with this, the sector also expects the government to increase its coverage of households under PM Suryaghar. "Under the Atmannirbhar Bhart scheme, there should be a scheme for the home grown EPCM companies to create indigenous technical capabilities in the country and reduce the foreign exchange outflow. We would also like to see a reduction on GST for engineering equipment and a reduction in import duties on chemicals in India," said Umesh Sood, CEO Simon India Ltd. Sunil Singhvi, President, Indian Electrical Electronics Manufacturers Association noted that there is a need for strong policy support to foster growth, drive innovation, and enhance sustainability in the power sector. "One of the main requests is to expand the PLI scheme, which aims to increase domestic production of crucial electrical components

essential power projects, such as the advanced High Voltage Direct Current (HVDC) systems." he said. Extension of the Production Linked Incentive (PLI) scheme for solar energy value chain, increased allocation towards Suryaghar Muft Bijlee Yojana, and greater thrust to distribution and transmission infrastructure are likely to be the key features of the upcoming Budget, as far as the energy sector is concerned.

Sources said these proposals figured not only in the budget wish lists of the industry, but also in the respective recommendations from the ministries of power and renewable energy to the finance ministry, ahead of the Budget. "Given the success of PM Suryaghar scheme with almost 600,000 installations in just nine months since its launch, one could probably see additional allocation to target more households," said Ashwin Jacob, partner at Deloitte India. "As far as evacuation of power from offshore wind

projects is concerned, we would want to see the VGF or budgetary support to continue or get enhanced," he added. "We hope to see a decisive increase in funding to accelerate the green energy transition. Priorities must include scaling renewable energy by addressing grid and transmission challenges, advancing Battery Energy.

Storage Systems (BESS) for grid stability and reliable power, doubling energy efficiency and digitalizing the energy sector through AI, smart meters, and data-driven solutions. Streamlining rooftop solar programs with simplified approvals, financing, and monitoring is equally vital," said Saurabh Kumar, Vice President - India, Global Energy Alliance for People and Planet (GEAPP). Sharat Goyal, CEO of Impact Infracap also expects the government to remove restrictions on state wise caps on roof top capacity for net-metering for industrial establishments. "Further, adoption of batteries to substitute use of diesel generators for back-up power should receive incentives and policy support given their role in reducing dependence on imports," he said. While the government is increasingly working towards enhancing the country's RE capacity, the distribution and transmission infrastructure for its evacuation still needs to be strengthened. With the peak demand for power growing at a rate of 8-9% annually, the industry is looking forward to strengthening of climate resilient infrastructure augmentation. "One can expect new allocations towards augmentation of power distribution infrastructure, especially in high density/ urban load centres, in view of the sharp rise in peak demand over the last few years," said Anujesh Dwivedi, Partner at Deloitte India. He noted that there may be some allocation towards supporting the preparatory work especially on the listing of power utilities, or some incentive mechanism for promoting initiatives on private sector participation or listing of utilities at the state level because they are increasingly being seen as the much needed structural reforms the sector needs. The industry is optimistic of a wider coverage of the Revamped Distribution Sector Scheme by including smart metering in infrastructure definition.

"This would direct more financing for a sector which seeks to bring down India's transmission and distribution losses to 12% and improve recovery for state utilities," Goyal said. Goyal also noted that power transmission despite significant potential has not seen any notable monetisation events which could address the latent investor demand. "Government should announce a time-bound privatisation programme for assets owned by PGCIL," he said. The sector also sees the PLI scheme for solar value chain to continue with possible reduction in the duty structures for solar equip-

India-China ties — improvement signs are loud, problems sliding under the radar

Contrary to the prevailing analysis that Trump has induced India and China to improve and repair ties, the bilateral relationship has shown little to no sign of improvement and arguably has even deteriorated under the calmer surface. Let me explain.At present, the quantum of trends as well as indications of 'improved' ties in the bilateral relationship can be divided into four categories. First, a return to diplomatic and economic 'normalcy' such as the resumption of flights, religious pilgrimages and border trade. Second, increasing talk of economic convergence amid a gradual return of Chinese investments. Third, growing peace and tranquillity at the border. And finally, strategic/geopolitical convergences in the age of

External Affairs Minister S Jaishankar Trump. Across all these four domains, recently warned journalists against 'improvement signs' are loud but orating' trends are getting more entrenched under the radar.This entails signs such as resumption (or planned resumption) of direct flights, exchange of journalists, enhanced people-to-people ties, issuing of visas for businesspersons, resumption of border trade and the sharing of hydrological data. The drip-feed of small but persistent and incremental news pertaining to these developments shapes and reinforces the idea that ties are improving over time. However, this is based on a false causal theory. The two countries are aiming to reinstate exchanges and processes that were the norm until 2019. However, no one was ever of the view back in 2019 that relations were positive and improving because such exchanges existed. In other words, the resumption of these processes says very little about real improvement in ties.

Assess UV technology in sewage treatment, NGT directs IIT Delhi

The report stated that of 37 STPs in the city, seven were yet to be installed with a disinfection system, four had not installed any system, while among others, 15 had deployed UV and 11 had chlorination-based disinfection systems to treat bacteria in sewage before discharging the treated water into drains. For those yet to be installed, the process was initiated or tenders awarded.

NCERT Unit Assigns Partition Blame to Congress, Jinnah, and Mountbatten

The NGT has rejected DJB's plan to redirect sewage to DSTPs

Delhi: The NGT has ruled against the Delhi Jal Board's (DJB) plan to link 43 stormwater drains that empty into the Barapullah drain to DSTPs, describing it as a "temporary solution" that won't solve the underlying problem of pollution. A court led by Justice Prakash Shrivastava issued an order directing various authorities, including the DJB and the Delhi government, to develop a long-term strategy to stop sewage from going into stormwater drains. These stormwater drains are not suitable for sewage flow. While tapping and redirecting the drains to the DSTP might work as a stopgap solution, it will eventually lead to overflowing when it rains because the stormwater drains won't be able to handle as much water. Because these DSTPs are susceptible to flooding after rainstorms, the bench noted that untreated sewage will once again reach the water supply. These instructions were given during a hearing

Anyone can take these measures individuals, RWAS, land-owning agencies, or concerned agencies—without needing prior clearance, as long as they notify the tree officer within 24 hours and provide proof, such as photographs taken from three different perspectives, of the incident. Flipkart Under Investigation for GST Billing Loophole

Delhi owned Flipkart under a preliminary tax probe for allegedly changing its invoicing processes to lessen its tax due. Investigators claimed the corporation disguised seller marketplace fees as "transportation costs" to claim reduced GST rates for small road transport operators. It would lower the company's tax bill. Online marketplace activities like buying, selling, charging vendors commission, listing, and facilitating payments normally incur 18% GST. Privatized entities can employ **Aadhar authentication**

Delhi: The ministry of electronics and IT (Meity) announced that the Union government has amended the Aadhaar rules to allow private entities use Aadhaar authentication service delivery. The amendments aim to give residents "ease of living" and "better access services". Ministry Aadhaar Notified Authentication for Governance Good Welfare, (Social Innovation, Knowledge)

Amendment Rules, 2025, revising 2020 "The amendrules. ment allows government and non-government entities to use Aadhaar authentication, promoting trusted transactions for both providers and users," stated the announcement. Ιt stated that the amendment will make non-government ecommerce, travel, tourism, hospitality, and health services easier to use.

allow Aadhaar authentication only "in the interest of good governance, preventing leakage of public funds, promoting ease of living of residents and enabling better access to services for them" to use digital platforms for good governance, social welfare benefit dissipation prevention, and innovation and knowledge dissemination. removed "in the interest of good goverpreventing nance, leakage of public funds access to services for them" and added "promoting ease of living of residents and enabling better access to services for them" as the fourth purpose, expanding the reasons authentication.

More than one-third (33.7%) of OAES' workforce is female in OAEs (owned account enterprises).Femaleowned businesses rose to 26.2% in 2023-24 from 22.9% in and 9.7% to 14.2% in other services. Female workers comprised 18.5% of recruited workers. Female workers were
