India will be run by the traditions of Ram, Krishna and Buddha, not by Babur and Aurangzeb: Yogi

Lucknow Chief Minister Yogi Adityanath was at his witty best on Monday during the Winter Session, successfully cornering the Samajwadi Party, Congress, and other opposition parties on key issues accountable. He cornered them on key issues such as Sambhal, Bahraich, the Constitution, and communal riots, making them face the truth. CM Yogi made it clear that only the traditions of Ram, Krishna, and Buddha will endure in India, not those of Babur and Aurangzeb. Addressing the situation in Sambhal, CM Yogi pointed out a historical divide between Turks and Pathans. He recalled that Shafiqur Rahman Barq, a former SP MP (now deceased), had once proclaimed himself not as an Indian citizen, but as a descendant of Babur. The Chief Minister then posed a stark question to the opposition: "Will you uphold the legacy



of invaders, or the traditions of Ram, Krishna, and Buddha?" He reiterated, "Only the tradition of Ram, Krishna, and Buddha will endure in India, not that of Babur and Aurangzeb." CM Yogi questioned why there is no issue when a Muharram or any Muslim procession passes peacefully through a Hindu locality or in front of a temple, but problems arise when a Hindu procession passes through a mosque or a Muslim-majority area. "Can't the saffron flag be raised on Indian soil?" he asked. "If a Muslim

Baatne and Katvane, but we have made it clear—'Na Batenge, Na Katenge.'" Referring to NCRB data, CM Yogi highlighted that communal riots in Uttar Pradesh have dropped by 97 to 99 percent since 2017. "Since 2017, there have been no riots in UP. But between 2012 and 2017, during the Samajwadi Party's tenure, there were 815 communal riots, and 192 people lost their lives. From 2007 to 2011, there were 616 incidents, with 121 deaths," he pointed out. The CM recalled the long history of communal unrest in Sambhal, which has been a hotspot since 1947. "There were deaths and riots in 1947, and 1948, and continued unrest through the decades, with significant violence in 1978, where 184 Hindus were burned alive. In 1980-1982, there were more riots, and in 1990-1992, five people were killed.

Sambhal violence: Giriraj blames opposition for trying 'to burn nation'

NEW DELHI: Union minister and BJP MP Giriraj Singh on Monday blamed the opposition for the violence in Uttar Pradesh's Sambhal, calling it a "pre-planned strategy" akin to the Godhra incident. Clashes during a court-mandated survey at the Mughal-era Jama Masjid on Sunday left three dead and over 20 police personnel injured. A fourth injured person died on Monday. "Crowd of 2,000-3,000 people began throwing stones": How Sambhal violence unfolded



Tight security measures, including prohibitory orders and internet suspension, have been implemented in Sambhal to prevent further escalation. Entry of outsiders into Sambhal has been barred till November 30. A magisterial probe

has also been ordered into the violence. Police have lodged seven FIRs in connection with the violence, naming Samajwadi Party MP Zia-ur-Rehman Barq and local SP MLA Iqbal Mehmood's son Sohail Iqbal as accused. Meanwhile, Sambhal

Deadly smog: Central panel allows 'hybrid mode' in Delhi-NCR schools



NEW DELHI: The Commission for Air Quality Management (CAQM) on Monday allowed Delhi-NCR schools to conduct classes in a "hybrid mode," combining physical and online sessions wherever feasible, in response to Supreme Court directives. The decision comes amid hazardous air quality in the region due to persistent smog. "State governments in the NCR shall ensure that all classes up to 12th standard are conducted in a 'hybrid' mode, both 'physical' and 'online,' wherever online mode is feasible," the CAQM order stated. It added that the choice of online learning would rest with students and their guardians. This relaxation applies to Clauses 5 and 8 of Stage-IV and Clause 11 of Stage-III of the Graded Response Action Plan (GRAP). The Supreme Court had earlier raised concerns about students' access to online education, mid-day meals, and air purification at home, urging CAQM to address these challenges. The CAQM highlighted the particular impact of GRAP Stage-IV restrictions on students in Grades 10 and 12, who require physical attendance for board exams and practical classes. "Students of classes X and XII are most impacted...due to Board examinations and practicals," the panel noted. The hybrid model will apply to Delhi and NCR districts such as Gurugram, Faridabad, Ghaziabad, and Gautam Buddha Nagar. State governments in other NCR areas may also implement similar measures. Separately, the Supreme Court refused to relax other GRAP-4 restrictions, including the construction ban and truck entry curbs, until

Monday, he said the BJP does selective manipulations to convince people that there were no wrongdoings. He also wanted to go

back to the paper ballots system. The ruling BJP-led Mahayuti alliance in Maharashtra won a landslide victory in the assembly elections, shattering the Congress-led Maha Vikas Aghadi's dream to wrest power. The BJP won the highest ever 132 seats for the party, while the Shiv Sena

led by Shinde bagged 57 seats and NCP won 41 seats to take the Mahayuti total to 230 seats. Congress as part of MVA won just 16 seats. "We analysed the Maharashtra poll outcome deeply. We felt that in many places EVMs were manipulated.

RBI gives Paytm 15 days more before curbs kick

MUMBAI: In a relief to customers, RBI on Monday relaxed the deadline on most of the restrictions imposed on Paytm Payments Bank to March 15 from Feb 29, including accepting fresh deposits. It also clarified that QR codes and soundboxes that are not linked to PPBL will continue to work after mid-March. However, RBI made it clear that there is no coming back for the payments bank to these services. RBI unambiguously advised customers to apply for new Fastags and National Common Mobility Card (NCMC) cards used in metros and buses if they are currently Paytm customers. It also said that those who are using PPBL savings accounts to receive subsidies, salaries or government benefits should open new bank accounts. Paytm shares, which have been ham-

Prayagraj: In today's competitive era, ensuring availability of energy for the progress and development of the nation is a major agenda of North Central Railway. Availability of energy can be ensured by controlling wastage in relation to the demand of energy and by encouraging energy conservation.

North Central Railway has bagged two awards this year in the competition of zonal railways by adopting various energy efficient technical measures. It has set an example for other bodies by winning the "First Prize" of "Uttar Pradesh State Energy Conservation Award-2024" organized by Uttar Pradesh New and Renewable Energy Development Agency (UPNEDA). This award was received by Shri Kuldeep Kumar, Deputy Chief Electrical Engineer/General/ North Central Railway and Shri Praveen Nevalkar, Se-

nior Section Engineer/Drawing/Headquarters in the ceremony of Energy Conservation Day-2024 organized in Lucknow on 14.12.2024.

Apart from this, Subedarganj Railway Station was awarded the "Certificate of Merit" in the "National Energy Conservation Award-2024" organized by BEE. This award was received by Shri Akhilesh Kumar, Deputy Chief Electrical Engineer / Headquarters in the ceremony of Energy Conservation Day-2024 organized in New Delhi on 14.12.2024.

Committed to energy conservation, North Central Railway has installed 12.47 MW solar power plant, 100% energy efficient LED tube lights, BLDC fans and 5 star rated air conditioners in all 411 railway stations, all 265 railway service buildings and all railway residences. This resulted in saving of 16 million units of



energy and Rs 14.4 crore in railway revenue in the year 2023-24. As a result, emission of 14544 metric tonnes of carbon dioxide was prevented in the year 2023-24. Solar power plants generated 11.8 million units of friendly electricity in the year 2023-24 and 8.3 million units in the year 2024-25 (April-November). This resulted in saving of revenue

of Rs. 4.93 crore in the year 2023-24 and Rs. 3.69 crore in the year 2024-25 (April-November). As a result, emission of 9921 metric tons of carbon dioxide was prevented in the year 2023-24 and 6938 metric tons in 2024-25 (April-November).

Due to 100% electrification of 3285.366 route kilometers in the entire North Central Railway, there was a 98% reduction in diesel consumption and time, resulting in saving of railway revenue.

Apart from this, 24.38 crore units of electricity were saved through regenerative braking by 3 phase AC locomotive, which has resulted in saving of Rs 146.3 crore in railway revenue. Apart from this, due to providing electricity through HOG in coach lighting, diesel consumption of power car has reduced by 6294 kilo liters in the year 2023-24, which has resulted in saving of Rs 55.4

crore in railway revenue.

On this occasion, Chief Electrical Engineer, North Central Railway, Shri Anup Kumar Agarwal congratulated the entire team of the electrical department for their commendable contribution. He expressed special gratitude to Chief Electrical Engineer/Energy Management Shri K.M. Singh and his team for making this successful.

North Central Railway is committed to the sustainable use of green energy. In this direction, work has been approved by the Railway Board to install 17.84 MW solar plants in the year 2024-25, which will be completed by the year 2025-26. This will increase the estimated annual production capacity of North Central Railway's total green energy to 32.3 million units (MU). This will reduce 27187 metric tons of carbon emissions and save Rs. 14.9 crore in revenue.

Editorial

Clumsy and ill-informed analogy gone wrong

President George W Bush was famous for his quite often hilarious gaffes, but he has been receiving steady competition from the 81-year-old President Joe Biden. The latest Biden pronouncement may be more by way of a clumsy and ill-informed analogy gone wrong. Luckily for him, his presidential election rival, the almost 78-year-old Donald Trump, makes quite a few bloopers too.

Republican contender, former President Donald Trump, may be tough on Mexican immigrants with his infamous, if not too effective, border fence and wall, but Democrat Joe Biden, the incumbent president, is in harmony with the Democratic Party pro-immigration stance. This even in the face of internal advice that he should tough talk on the same border issue. Of course, hordes of poor and largely illiterate illegal immigrants in 2024 who don't speak English are not as welcome as they were in the 1870s. In the 19th century and before, immigrants, largely from Europe, slaves brought in from Africa, and some immigration from China, helped to populate the vast country. They threw out the British colonists, pushed back the French and Mexicans, subdued the native Red Indians, built the engines of growth, and even fought a civil war amongst themselves. Immigrants, many originally poor and persecuted in their erstwhile home countries, have been a crucial feature of American DNA. This is what Biden meant, but perhaps he should have stopped right there. Immigrants into America are known and lauded for their hard work, ingenuity, and grit, and Biden was addressing a crowd of mostly Asian Americans. More recently, the brilliant IIT educated ones from India, its 'brain drain' and America's gain, have been most useful in building America's preeminence in IT, other technology, and commerce. Scores of Indian-origin CEOs of marquee companies on the Nasdaq and S&P 100 indices have led to the joke that you can't be CEO in America if you aren't Indian. It is a complete makeover of the earlier American image of India as a land of teeming poverty, with tigers, snake charmers, and fakirs thrown in. President Joe Biden, keen to distinguish his candidature from that of Donald Trump, decided to praise immigrants at a campaign reception fundraiser. On the campaign trail for Biden 1.0, he had vowed to enact legislation to make the immigration process more 'humane' in contrast to President Trump's mostly intended, but not implemented, harsh measures. This time, too, Trump is speaking of deportations.

However, as president, Biden could not make much progress on immigration legislation without bipartisan support because of surges of illegal immigration at the southern border. And calls, certainly from Republicans, but even from Democrats, to seal the border and crack down on asylum seekers. Some went so far as to call for banning asylum altogether. But the consensus is that, at this fundraiser, Biden let his analogies run away with him. Biden said American allies and partners Japan and India are struggling economically 'because they're xenophobic'. He included 'frenemy' China and combatant Russia in the illustration as well. Japan is opening up to a cautious immigration policy as it grapples with its diminishing and ageing population, and its economy has been showing signs of recovery from a 25-year-long recession. It is keen, however, not to import terrorism and other social upheavals into its very well-ordered culture. India is the most populous country in the world, with 65 per cent of its people under the age of 35. It is the fastest-growing major economy in the world.



The job of the Drugs Department is to stop drug smuggling

The responsibility of the police is also to stop drug smuggling, but it is also almost a failure in this matter, and even if some honest policemen catch drug smugglers somewhere, then nothing much happens to the drug smugglers. Many times they get released easily on the basis of money or on bail. The job of the Drugs Department is to stop drug smuggling, but it also seems almost unsuccessful in this. Anyway, drug smuggling is continuously increasing and so is the number of drug users. The Central Government should pay full attention to this and drug smugglers should not be spared under any circumstances. The police should keep a close watch on such gangs outside or around schools, who smuggle drugs and make innocent school children their victims. It is surprising and sad that not only minor boys studying in schools fall prey to these drug smugglers, but minor girls also fall prey to this. Not only the Modi government at the centre, the state governments, the drug department, de-addiction centres, the police, but also the teachers teaching in schools and the parents of the children should pay attention to this. Because a small negligence can ruin the lives of children who are considered the future of the country. And I think this can be felt the most by those parents whose children have ruined themselves or are ruining themselves by getting addicted to drugs. Recently, news of school going children taking



drugs has come to light in Gujarat. And this matter came to light when parents took two children to the doctors after their strange behaviour and their sleeping at home after tuitions, when the doctors got the urine test of both the children done. Actually, these children used to drink coffee somewhere while returning from tuitions, after which they used to hit the bed and sleep as soon as they came home. These children neither ate food on time, nor studied properly, nor talked to anyone in the family. On this, the family members showed them to the doctors and then it was found out that both of them take drugs. Living in a tower of Jhanda Lal Chowk, they were caught stealing bicycles in school uniform and it was revealed that they had started taking drugs, they were stealing to buy drugs. Actually, about a week ago, Gujarat Police arrested 5 people with about 500 kg of cocaine under a joint operation. Earlier in June this year, hybrid ganja and other drugs worth about Rs

3.5 crore were hidden in children's items in Gujarat, which were seized by the police. And before that, more than 3 thousand kg of drugs worth crores were recovered from Gujarat at Adani Port. Similarly, drugs worth crores are recovered every year in Gujarat and apart from arresting a few people, the police or AIIMS department is unable to take any action that can completely stop it. And today, not only in Gujarat, but in other states as well, the business of drug smuggling is increasing. The question is who is behind this? And the second question is why children, especially those studying in schools, are being made victims of drugs? Till a few years ago, it was seen that only children who pick garbage take drugs? But now the cases of children from well-off families taking drugs and other types of intoxication are increasing. The increase in the number of child patients coming to de-addiction centers is no small matter. In the year 2022, the Modi government of the Center itself told the Supreme

Court that 1 crore 58 lakh minor children in the country between the ages of 10 and 17 years are consuming some form of intoxication, most of whom consume a particular type of dangerous intoxication. For example, they are taking drugs etc. The government had also told the court that minor children of this age are consuming many types of intoxicants including cocaine, hashish, marijuana, alcohol, heroin, LSD, morphine, opium, cannabis. Citing a survey, the Modi government of the Center had told the Supreme Court that among all types of intoxicants, the people of India consume alcohol the most, about 16 crore people, out of which more than 5 crore 7 lakh people are seriously addicted to alcohol. After alcohol, they prefer cannabis and opium intoxication, the population of those who consume them is more than 3 crore 1 lakh, out of which the number of cannabis addicts is about 25 lakh. This matter came to light when a petition was filed in the Supreme Court by an NGO named Bachpan

Bachao Andolan and the Supreme Court had sought a reply from the Modi government at the Centre. In this matter, the Modi government at the Centre also provided many other information about drug addicts, but did not take any concrete steps to stop drugs and other types of intoxicants. Anyway, every year on 8 June, National Drug Destruction Day is celebrated on a large scale in India and every year on 26 June, International Day against Drug Abuse and Illicit Trafficking is also celebrated at the international level and on both these occasions, children are the victims. Not only the Central Government, its de-addiction centres, but also the state governments and their de-addiction centres and all the government institutions working in the name of de-addiction spend crores and billions of rupees, but despite this, the number of drug addicts is increasing in India from drug trafficking to drug addiction, in which the most worrying thing is children getting addicted to drugs. While the Dr. Ambedkar International Centre of the Central Government has launched a very ambitious scheme like Nasha Mukta Bharat Abhiyan (NMB A) across the country, whose de-addiction centres are running in every district of the country, despite this, the increasing number of drug addicts, especially children, is not only a matter of concern, but it also seems clear that the government is wasting money on these de-addiction centres.

Maharashtra: MVA Or Mahayuti? All Depends On Who Wins 4 Zones

With elections due in a month, election fever has gripped the entire Maharashtra. While the MVA has released a list of 158 candidates, Mahayuti has announced candidates for 182 seats. Maharashtra has six key regions—Vidarbha, Marathwada, Western Maharashtra, North Maharashtra, Mumbai and Thane-Konkan—each of which has its own dynamics. Naturally, the alliance that wins four of these six regions will go on to form the government, and thus, parties are tailoring their strategies zone-wise. While Vidarbha has 62 seats, the Northern zone has 35, Marathwada 46, the Western zone 70, Mumbai 36, and Thane-Konkan 39. In the Lok Sabha elections earlier this year, the MVA was leading in Vidarbha, the West, Marathwada and Mumbai and was able to win 30 of the 48 Lok Sabha seats. The ruling Mahayuti was ahead in just the North and Thane-Konkan regions. The MVA and the Mahayuti each have three

players, with specific strengths. The Congress led from the front in Vidarbha, defeating the BJP in one-to-one contests. In Mumbai, the Uddhav Thackeray-led Shiv Sena held sway, and in Western Maharashtra, it was the Sharad Pawar-led Nationalist Congress Party (NCP) that came out on top.

In Marathwada, all three parties from the MVA played their part. On the other hand, from the Mahayuti, the Eknath Shinde-led Shiv Sena was ahead in the Thane-Konkan, while the BJP dominated Northern Maharashtra.

The BJP and the two factions of the Shiv Sena have emerged as the only parties with a pan-state presence in the state and they led in assembly segments in all zones in the general elections. On the other hand, the Congress was not in the lead in any assembly segment in the Thane-Konkan region, as was the case with the Sharad Pawar-led NCP in the Mumbai segment.

Rafah offensive and war in Gaza : Threat of a dangerous escalation

The war in Gaza is due to complete seven months on May 7, marking the longest war in Gaza since Israel's voluntary vacation of Gaza in 2005. Contrary to expectations, borne more out of Israel's enormous military superiority against Hamas as well as past conflicts in Gaza, the conflict has not ended swiftly.

During this time, however, Israeli strikes have flattened Gaza to the ground, making it completely uninhabitable, perhaps for decades. The stench of death and decay overwhelms the thin strip straddling the Mediterranean Sea, with estimates of over 34,500 deaths, including 13,000 children, and over 77,500 injured and maimed for life. Medical aid, food, and water have been severely restricted, and most international aid agencies, including UNRWA as well as WCK (World Central Kitchen), have been targeted and prevented from delivering lifesaving aid. Despite a UN Security Council resolution of March 25 calling for an immediate ceasefire and the unconditional release of hostages, neither of the warring parties has been able to come to a common understanding.

In the midst of it, there was a period of dangerous escalation when an Israeli strike on April 1 targeted the Iranian Consulate building in Damascus, Syria, resulting in the deaths of seven members of the Islamic Revolutionary Guard Corps (IRGC), including General Mohammad Reza Zahedi, the senior-most commander in Lebanon and Syria. Outraged by the attack on its 'sovereign territory', Iran retaliated on April 13 with a massive and well-synchronised attack by drones

and missiles. While most of the drones were intercepted mid-air, some of the missiles found their mark and struck the Nevatim Israeli air base in the Negev desert. Nevatim is the air base from which Israel launched its F-35 fighters that attacked the Iranian consulate in Damascus. Despite decades of hostility between Israel and Iran, this was the first time that Iran had launched strikes directly on Israel from its territory.

Israel and its allies, though forewarned by Iran of the retaliation, were surprised that Iran had actually called the bluff this time.

Israel, under pressure at home, responded with a strike into Iran on April 19, when loud explosions were heard in the vicinity of the city of Isfahan in the early morning hours. It was reported that Iranian air defences had shot down 'three drones' over the skies of the city. Although some media outlets later presented satellite pictures to show that some part of the Air Defence Battery in Isfahan was damaged, neither Iran, Israel, nor the US commented on it. With tit-for-tat strikes into each other's territory, there is a general sense that both countries have called it quits as far as targeting each other directly is concerned. With this threat of escalation over, the focus has shifted back to Gaza and finding means to put an early end to the war. As a part of the effort, US Secretary of State Blinken was in the region recently to hold talks with Arab leaders. He also stopped over in Israel, meeting PM Netanyahu in an effort to convince him to agree to a ceasefire and also to deter him from launching a ground offensive in Rafah. Whether Blinken was successful in convincing Netanyahu on it or not is a different question all together. Also, if and when the Rafah offensive takes place, what are its implications for ending or escalating the conflict.

Pakistan's need to show stability at home

Pakistan is getting ready for the Shanghai Cooperation Council meeting in Islamabad, starting from 15 October. As part of the preparations, the government has announced a three-day holiday in the capital city, basically to ensure that no protests take place around that time—especially from the Pakistan Tehreek-e-Insaf, which recently tried to hold a rally and sit-in. Also, the whereabouts of Khyber-Pakhtunkhwa Chief Minister Ali Amin Gandapur are reportedly still unknown. Sources claim he is being held at an Inter-Services Intelligence safe house for as long as the foreign dignitaries are in town. At


the core of these efforts is Pakistan's need to show stability at home while managing its relationships with both India and, even more so, China—especially in light of the Karachi terror attack and what it could mean for the China-Pakistan Economic Corridor (CPEC).

Containing the PTI crowd in the run up to the SCO summit is a priority, especially to demonstrate to guests like India's External Affairs Minister S Jaishankar that things are not so bad in Pakistan. Islamabad was certainly not excited by his taunts at the recent United National General Assembly session,

where he spoke about Pakistan's poor economic conditions. There is a possibility that things might not be too pleasant on the sidelines of the SCO, with political pressure on both the host and the Indian guest to project strength. Beyond keeping Islamabad peaceful and secure, clamping down on the PTI also sends a signal both to India and Imran Khan that any overtures between the PTI and India will not be welcome, especially after Jaishankar's unfriendly remarks. Recently, PTI's information advisor Barrister Muhammad issued a statement saying that he would like to invite Jaishankar

to address a PTI rally. While this was certainly highly provocative, it should not be seen as the party's greater willingness to talk to India. At best, it may be a move to encourage Delhi and the larger international community to think of Imran Khan as a leader capable of thinking outside the box. While Bollywood filmmakers such as Sudhanshu Saria, director of the recent release Ulajh, may have their fantasies about a new kind of Pakistani leader, one hopes there are saner elements in Delhi who don't fall into such imaginary traps. Khan is definitely embroiled in a battle with Pakistan.

Delhi Prime Minister Narendra Modi expanded health coverage for senior citizens aged 70 and above through the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (PM-JAY) and other health sector projects, totaling ₹12,850 crore. The PM chastised the Delhi and West Bengal administrations for not implementing the Ayushman Bharat health insurance policy out of "political interests" and said he was sad that the elderly from these states could not receive free treatment under the expanded program. Many of us grew up in families where illness had a major impact on everyone, especially in poorer households. To alleviate poverty, the government launched the Ayushman Bharat Yojana, covering hospitalization costs up to 5 lakh, according to Modi. Approximately 4 crore (40 million) underprivileged individuals in India have received free treatment through the Ayushman Yojana.

Arvind Kejriwal, a former Delhi chief minister and Aam Aadmi Party national convener, warned the PM not to politicize health care. "Under the Delhi government's scheme, every person living in Delhi gets complete treatment free of cost no matter how much it costs... I request you to study the Delhi model and instead of Ayushman Bharat Yojana, implement the Delhi model all over India so that people can benefit on the ground," he wrote on X.

Delhi's new senior citizen home in Paschim Vihar, north west Delhi, is ready for opening. The capital's fifth elderly and infirm facility, officials said. Four old age homes at Bindapur, Wazirpur, Tahirpur, and Kanti Nagar are operated by the social welfare department, while eight others, including Paschim Vihar, are under development. A senior social welfare official said the five-story geriatric care building is ready for the city's elderly who require shelter. The new senior home will house 96 people. "The building finished early this year. A few finishing touches can be done 10-15 days before the inauguration. An official said the fire department's no objection certificate is required before the center's opening. Destitute Delhi citizens 60 years and older who have no family can live in old age homes if they don't have an infectious condition. Residents receive free housing, food, clothes, bedding, TV-radio, books, an amusement center with religious and spiritual programs, health check-ups, and physiotherapy. For the elderly to "interact with each other, sit together and talk about their joys and sorrows" officials set up round tables. "No one wants to live in old age homes, but the government must develop them and offer all the amenities they need. The official added we will provide free cutting-edge facilities to seniors in old age homes. Another senior age home in Sarita Vihar may open in 2025. More such residences are planned for Vasant Kunj, Janakpuri, Rohini, Geeta Colony, and Chhatarpur.

Delhi Chief secy checks borewell concessions

Delhi: The National Green Tribunal has directed Delhi's chief secretary to investigate a Voluntary Disclosure Scheme concession to Paharganj hotels and guesthouses. The tribunal said authorities did not record such a document. The tribunal asked Delhi Jal Board (DJB) and Delhi Pollution Control Committee (DPCC) to explain the scandal. The October 22 decree targeted over 500 hotels and guesthouses' illicit groundwater extraction. "On the preceding occasion, authorities took the view that under the Voluntary Disclosure Scheme (VDS), the following hotels/guesthouses revealed their

borewells, consequently, they were functioning on that premise.. However, DJB, DPCC, and all other authorities referred to the VDS but did not register it. The bench led by NGT chair Justice Prakash Shrivastava stated that they did not float the VDS and do not have a

MoUs signed, MCD press building project stalled

Delhi: Delhi Municipal Corporation's initiative to turn its Old Press building in Chandni Chowk into a museum commemorating its 161-year history has lagged. Despite signing a memorandum of understanding with the Indira Gandhi National Centre for Arts earlier this year to conserve century-old

artifacts and digitize rare documents for the museum and a second MoU for consultancy in setting up the museum, MCD hasn't upgraded the building. MCD also sought Old Press building conservation advice from the Aga Khan Trust for Culture (AKTC) in March. An MCD official said, "IGNCA is conserving and digitizing papers,

pictures, Wilson's survey sheets, registers, and abhinandan patras. However, the Old Press Building's conservation and restoration is conceptual, therefore its duration cannot be determined." IGNCA officials said several maps had been conserved and the center was working on documentation.

Woman taking bus 23% more than before

Delhi: A recent survey on Delhi's free public bus travel found that 45% of women never take the bus, while 35% do so everyday or three to five days a week. Greenpeace India launched the report 'Riding The Justice Route' on the fifth anniversary of the Delhi government's 'pink ticket' policy, which made public bus commuting free for women, after surveying participants and examining its impact on their lives. The report says one in four women now take buses after fare-free riding. After the plan began, 23% of women ride buses at least four times a week, and 15% of women who never used buses before do so today. The survey found that less than 50% of women bus riders feel "mostly safe" when



traveling to, waiting at, and riding a bus. The survey also found that 77% of women felt unsafe taking the bus after 5 pm and 2/3 believe the bus station lighting is inadequate. 57% of women in the Rs 50,000-Rs 1 lakh monthly household income band travel a bus daily, the highest of all income categories. The survey found that 45% of Delhi women did not use fare-free

public bus transport in the preceding month. The survey also found that only 75% of Delhi women can take the bus when they need to. According to 64% of Delhi women, shared auto rickshaws and e-rickshaws are their most popular means of transportation. "This shows their prevalence and importance as an intermediary mode of transport for women.

Aerocity restaurants are open twenty-four hours a day

Delhi: The Delhi government approved the 24-hour operation of restaurants in Aerocity, a well-known hospitality district close to the IGI Airport, in an effort to boost tourism and spur economic growth. According to an official statement, Aerocity, which is already home to a few 4-star and higher-rated hotels that are open 24/7, will now see its restaurants follow suit, providing more access to a variety of dining alternatives. According to the report, Chief Minister Atishi gave his approval to the plan, which aims to increase government revenue.

India exports 33% more iPhones in April-Sept

Delhi: Apple's iPhone exports from India rose by a third in the six months to September, highlighting its efforts to expand manufacturing and lessen dependence on China. According to people familiar with the subject, the US business exported roughly \$6 billion of India-made iPhones, up a third from a year earlier. Exports are expected to exceed \$10 billion in

fiscal FY24. Apple is rapidly extending its production network in India, taking advantage of local incentives, a talented labor, and technical breakthroughs. India is essential to the company's effort to reduce its reliance on China, where dangers have grown with Beijing's US tensions. Apple's vendors Foxconn, Pegatron, and Tata Electronics assemble iPhones in southern India. Located on Chennai's outskirts, Foxconn is India's top supplier and exports half of its iPhones. According to sources, Tata Group's Karnataka facility exported \$1.7 billion in iPhones from April to September. Last year, Tata became the first Indian assembler of Apple's best-selling product by buying this unit from Wistron.

High Contributors 448cr to City Kitty

Delhi: celebrations are about colorful gatherings with friends and family, typically featuring alcohol. A record 3.9 crore liquor bottles were sold in the capital's 680 outlets controlled by four government organizations in the fortnight before Diwali. In the 15 days before Diwali, 2024 sold more bottles and had higher sales value than 2022 and 2023. In 2022, 1.9 crore bottles worth Rs 324 crore were sold before Diwali. In 2023, 2.7 crore were sold, totaling Rs 433 crore. This data excludes booze sales and values from 900+ hotels, clubs, and restaurants. Industry insiders said booze sales are down for three weeks before Dussehra because many people avoid alcohol for religious reasons. Demand rises after Dussehra and peaks two days before



Diwali. The season's sales were 35 lakh bottles, down to 34 lakh. October 31 was Diwali, a dry day and public holiday. Nearly 28 lakh bottles were sold the day before Diwali in 2023, a season high. Whisky, rum, vodka, gin, beer, wine, and other alcoholic drinks in varying sizes are included in the sales data. Besides Excise duty and VAT revenue increased this year, according to officials. Current fiscal year, up about 7% from Rs 2,849 crore in 2023-24. Delhi's 2024-25 budget expected.

111 stores are approved to remain open 24/7

Delhi: As of right now, there are over 700 stores and commercial institutions in the city, with 111 of them receiving permission from Chief Minister Atishi to function around the clock. According to the government, the initiative's goals were to boost economic activity and provide new job possibilities in the capital. Every facility that received approval was classified as commercial, retail.

DDA Reverses Sports Hub Fee Hike



Delhi: Delhi Development Authority reversed the membership price increase at all municipal sports centers hours after lieutenant governor V K Saxena ordered it. Raj Niwas wrote on X: "LG advised DDA to rescind the circular that raised sports complex membership and other costs after hearing from members and public representatives. India tabhi to badhega!" LG chairs DDA. Later, a DDA spokesman

stated the membership fee hike circular was removed. The proposed rise on Oct. 18. In a circular dated Oct. 14, DDA revised the membership cost for its 17 sports complexes, effective Nov. 1. The lifetime membership price for government employees in Siri Fort complex was raised to Rs 1.5 lakh from Rs 49,090, while other complexes charged Rs 1 lakh. The lifetime price for non-government employees was Rs 7

lakh for Siri Fort, up from Rs 1,07,380, and Rs 3 lakh for other sports complexes. This was in addition to Siri Fort's Rs 1,500 monthly fee and other sports complexes' Rs 1,200. New senior, temporary, and associate memberships were deleted from the updated policy. Members were angered by the "unfair" rise. Signature campaigns and LG intervention were requested by several groups.

Delhi: Investigators have mapped the Bambahas syndicate's operations and located 100 members. After a gunshot at a northwest Delhi businessman's house, the Bambahas demanded Rs 10 crore insecurity money' Kaushal Chaudhary, India operations chief, and Amit Dagar supervise Gurgaon and Haryana, according to a Bambahas syndicate dossier. In outer Delhi and Rohini, convicted mobsters Neeraj Bawana and Naveen Bali operate. Yamunanagar, Chandigarh, and neighboring districts are under Bhuppi Rana. Sukhpreet Budda and others run Punjab. "A police report says. Arshdeep Singh Gill (Arsh Dalla) from Canada and Patial from the US manage enterprises abroad. Chaudhary joined the alliance after Davinder Bambahas was slain in September 2016, according to the document. Davinder stayed with Chaudhary and Dagar in Gurgaon before the clash, building an alliance. Dagar, in Rohini jail, Lucky Patial after Davinder's murder, strengthening the connection. Chaudhary met Bambahas' keyman, Fateh Nagri, in Sangroor jail and agreed to collaborate. Then, northeast Delhi's Neeraj Bawana/Naveen Bali, Tillu Tajpuria Gang, Sunil Rathi group, and Chhenu Pehalwan gang joined the Bambahas gang. They opposed the Lawrence Bishnoi-Kala Jathari terror syndicate in Punjab, Haryana, and Delhi. The Bambahas gang's biggest partners met sympathetic gangs in Delhi, Haryana, Rajasthan, etc. in 2021 and began working together to extend their power and operations. The Bambahas killed Shiromani Akali Dal youth leader Vicky Micky Kheda in August, which led to the death of Punjabi pop artist Sidhu Moose Wala. Lawrence Bishnoi-allied Bambahas helped the Tajpuria syndicate kill Jitender Gogi. Gogi was publicly shot in Rohini Court.



10k DDA vacancies out of 14k housing ministry positions'

Delhi: The Union Ministry of Housing and Urban Affairs told the Rajya Sabha that 77.5 percent of sanctioned posts at the Delhi Development Authority (DDA), the capital's main landowning agency and responsible for implementing key central government schemes, are vacant. In a written response to Communist Party of India (Marxist) leader and Rajya Sabha MP from Kerala V. Sivadanan, Minister of State for Housing and Urban Affairs Tokhan Sahu said 10,030 of the DDA's 12,932 sanctioned posts (in various groups) were vacant as of 30 October. While the DDA is the worst-affected of the 20 housing ministry government organizations, autonomous agencies, and public sector undertakings,



others are understaffed. The Centre's construction arm, the Central Public Works Department (CPWD), which oversees several major development projects, including the Modi government's ambitious Central Vista Redevelopment Project, had 27% (2,671 out of 9,703) sanctioned posts vacant as of 30 October. In addition to developing housing and commer-

cial units in Delhi, the DDA prepares the Master Plan of Delhi-2041 (MPD) and all development control requirements.

PM-UDAY, which grants ownership rights to residents in 1,731 unauthorized colonies, is also being implemented. Nearly 400 Delhi slums on central government land were redeveloped by it a few years ago.

Delhi government hospitals have not filled key positions for nearly a year.

Delhi: Health minister Saurabh Bharadwaj blamed lieutenant governor VK Saxena for not starting the hiring process through the services department saying Delhi government hospitals and dispensaries were short on doctors and healthcare workers. Bharadwaj claimed he repeatedly complained to the LG about the shortage of doctors in government hospitals, but nothing was done. He sent five letters to Saxena and other bureaucrats in April 2023 about the issue.

ICG rescues 12 crew members of Indian ship sunk in North Arabian Sea- Pakistan's Maritime Security Agency provided full cooperation in search and rescue mission

New Delhi The Indian Coast Guard (ICG) has rescued 12 crew members of the Indian ship MSV Al Piranpir that sank in the North Arabian Sea. The special thing was that close cooperation was seen between the Maritime Security Agency (MSA) of Pakistan with the Indian Coast Guard in this search and rescue mission. The Maritime Rescue Coordination

Center (MRCC) of both the countries also maintained constant communication during the entire operation. The rescued crew is being brought to the Porbandar coast of Gujarat. In fact, the Indian sailing vessel (Dhau) Al Piranpir, which left from Porbandar for Bandar Abbas in Iran, sank on the morning of 04 December due to turbulence and flooding in

the sea. The distress call was received by the ICG's Maritime Rescue Coordination Center Mumbai, which immediately alerted the ICG Regional Headquarters (North West) in Gandhinagar. After this, ICG ship Sarthak was immediately dispatched to the mentioned location. Pakistan's MRCC was also contacted to alert the sailors in the area and requested.

Australia announced playing XI for Adelaide Test

Adelaide Fast bowler Scott Boland will replace injured Josh Hazlewood in the upcoming Adelaide Test of the Border-Gavaskar Trophy (BGT) against India. Australian captain Pat Cummins announced the playing XI on Thursday. The Adelaide Test will be Boland's first match for Australia in the last 18 months. According to Cricket Australia (CA), captain Cummins also confirmed that Mitchell Marsh will be fit to bowl in the Adelaide Test. Boland played his last Test against England in the prestigious Ashes 2023 series. On the other hand, Marsh has been included in the playing XI even after suffering from back stiffness, due to which he was unable to bowl at full strength during India's second innings in the Perth Test. In



the pre-match press conference, Cummins referred to Boland's performance in Canberra, when he played a two-day practice match against India for the Prime Minister's XI. The captain said that Boland's preparation has been "very good". Cummins said, "A few days ago in Canberra he hit some good shots, his preparation has been very good. He is happy with his rhythm and his performance. But you know as a captain it is great to have a player like Scotty coming straight into the field. You know that if

you need him, he can bowl a lot of overs, he is very consistent and performs well at this level. So he looks ready to play." Cummins said that some Australian players have played a lot of Tests with the pink ball, but some of them have not played much. The captain said that the players have trained well in the last few days. He said, "It's hard to say, some of our players have played a lot, some of them haven't played the pink ball much. I think there is a bit of acclimatisation needed."

Railway Bill could not be passed in Lok Sabha, proceedings adjourned for the day amid uproar by opposition

Para 4.22 of the NEP states that 'Indian Sign Language (ISL) will be standardized across the country and content for national and state curriculum will be prepared for use by students with hearing impairment. Local sign languages will be respected and taught wherever feasible and relevant. An exclusive PM e-Vidya channel dedicated to the promotion of Indian Sign Language has been envisaged to promote ISL as a language as well as a school subject to facilitate language learning by a larger population. The channel will disseminate learning content in the areas of career guidance, skill training, mental health, class-wise curriculum content, communication skills for school children (central and state curriculum), teachers, teacher trainers and other stakeholders. Congress prepares for 2025 Delhi assembly elections

The project aims to help economically disadvantaged women live decent lives and become financially independent. He said they wanted Delhi women to benefit from the plan quickly. The finance, planning, and law departments would approve the cabinet note, according to a top Delhi official. Government prepares senior folks' fifth home

Delhi: Delhi's new senior citizen home in Paschim Vihar, north west Delhi, is ready for opening. The capital's fifth elderly and infirm facility, officials said. Four old age homes at Bindapur, Wazirpur, Tahirpur, and Kanti Nagar are operated by the social welfare department, while eight others, including Paschim Vihar, are under development. A senior social welfare official said the five-story geriatric care building is ready for the city's elderly who require shelter. The new senior home will house 96 people. "The building finished early this year. A few finishing touches can be done 10-15 days before the inauguration. An official said the fire department's no objection certificate is required before the center's opening. Destitute Delhi citizens 60 years and older who have no family can live in old age homes if they don't have an infectious condition. Residents receive free housing, food, clothes, bedding, TV-radio, books, an amusement center with religious and spiritual programs, health check-ups, and physiotherapy. For the elderly to "interact with each other, sit together and talk about their joys and sorrows" officials set up round tables. "No one wants to live in old age homes, but the government must develop them and offer all the amenities they need. The official added we will provide free cutting-edge facilities to seniors in old age homes. Another senior age home in Sarita Vihar may open in 2025.



Core sector growth drops to 6.3% in May

In May, the eight key industries grew 6.3% year-on-year, down from 6.7% in April, mostly due to weaker steel, refinery products, and crude oil output, the commerce ministry. Core sector growth was 5.2% in May 2023. As a sequential measure, core sector output grew 3.7% in May. May output usually rises from April. In the preceding 12 years, the month-on-month growth averaged 6.8%, but this year it was lower. telecommunication systems to refuse UPC requests in the seven-day period and test the systems before the system was rolled out across India. The (DoT) wrote to TRAI in September 2022, "It has come to the notice that mobile connections are being fraudulently ported out by the criminals/fraudsters.

Two new booze vends will cheer up domestic flyers at Delhi airport

Delhi: Delhi Consumers' Cooperative Wholesale Store Limited plans to open a liquor shop at T3's arrival section by the first week of July and another at T1's departure area in the following weeks. This strategy aims to help Delhi restore share of domestic liquor sales after the closure of private-operated premium liquor stores due to the rescission of Delhi Excise Policy 2021-22 in September 2022.



International passengers can buy liquor at T3's duty-free shops. Following this trend, domestic terminals will shortly open shops. The Delhi Excise Policy 2021-22 allowed six private

premium liquor stores in the Delhi airport's domestic terminals at its height. After the scheme was canceled amid CBI and ED probes for alleged irregularities, the Delhi govern-

ment returned to the excise regime and gave retail liquor to four government corporations. Delhi Tourism and Transportation Development Corporation and Delhi State Civil Supplies Corporation tried to rent airport space for booze shops but couldn't negotiate conditions. Finally, Delhi Consumers' Cooperative Wholesale Store Limited found space for the shops.

Magenta Line is first driverless Metro network

Delhi: All 29 Magenta Line trains are presently unmanned. DMRC has removed the drivers' cabins, although an attendant is present after three-four trains. They will be removed in phases. Magenta Line trains would be fully automated. "Magenta Line can now transport people without drivers. DMRC officials stated attendants will be removed gradually. The Pink Line will follow the Magenta Line. Full automation is available



on Magenta and Pink lines in Delhi Metro's 97km network. Only one network operates driverless trains in India. Driverless trains will operate in DMRC's Phase-IV expansion lines. Driverless train

operation was inaugurated on the Janakpuri West-Botanical Garden Magenta Line in December 2020 and the Majlis Park-Shiv Vihar Pink Line in November 2021. A train operator was present until now to

instill trust and support. With the expertise from these two lines, we will try this in Phase IV soon. We installed track monitoring cameras for driverless operations in Phase IV "DMRC managing director Vikas Kumar. A DMRC spokesman remarked, "Driverless trains increase flexibility and eliminate human errors. The system also increases coach availability for operations. Driverless trains eliminate pre-induction.

LG junks IP Univ plea for fee hike

Delhi: officials from the LG secretariat announced on Saturday that Lieutenant Governor VK Saxena had turned down a proposal from Guru Gobind Singh Indraprastha University (GGSIPU) to charge affiliation fees to government institutes that are affiliated with it.

The decision was taken to safeguard students' interests, as the affiliation fee would have increased the total fee that students would have to pay. According to an official from the LG secretariat, this change could have a disproportionate impact on low-income students who depend on public universities for their



affordable higher education. At the same time, LG has proposed that GGSIPU look at other ways to make money to supplement their budget. All institutions that raise their own funds are required by law to pay an affiliation fee (Statute 24, Clause 5), although schools that get no funding from the fed-

eral or state governments are exempt from this requirement. Officials from the LG noted that government institutes already have a lot on their plates financially, what with paying for things like provisional affiliation applications and affiliation renewals. The course and institute's location determine the exact amount.

Shooting, hockey out of 2026 Youth oly

Delhi : For the long-awaited 2026 Youth Olympics in Dakar, Senegal, the executive body of the International Olympic Committee (IOC) removed shooting, weightlifting, and hockey from the list of medal sports, severely hurting India's medal hopes.

programme" are shooting, weightlifting, and hockey. With four medals from shooting (two gold and two silver), two from hockey (two silver each), and one from weightlifting, India brought home thirteen medals from the 2018 Youth Games in Buenos Aires, Argentina.

198 college stipend mums get NMC show-cause

Delhi: The National Medical Commission (NMC) has issued show-cause notifications to 198 medical colleges—115 public and 83 private—for failing to report undergraduate intern, post-graduate resident, and senior resident stipends.

A Supreme Court order required all medical colleges to submit their 2023-24 stipends to NMC. Officials said the 198 colleges with show-cause orders failed to comply, prompting the action.

NMC will penalize colleges who refuse stipends and reduce seats

Delhi: The National Medical Commission (NMC) has issued a show-cause notice to medical colleges that have not submitted intern/resident stipend details. Deans and principals of 115 government and 83 private medical institutions received the notice recently. Maulana Azad Medical College, Atal Bihari Vajpayee Institute of Medical Sciences, Dr. RML Hospital, and Dr. Baba Saheb Ambedkar Medical College is Delhi government college. The Commission



inquired why erring institutes should not be penalized in its notice. The NMC provided a list of government and private colleges without stipend details. The official NMC notification reads, "Many universities have yet to supply the required data on the above email

addresses. These medical colleges' failure to submit information reg. [regarding] resident stipend payment is taken seriously, and those who have not submitted the necessary information are directed to show cause why they should not be penalized." The delinquent med-

IIT-D placements rise 25%, 53% of students get jobs in last drive

Delhi: A recent IIT Delhi departure poll reveals the diverse career prospects of its 2024 graduates. The poll of August graduates shows a shift toward off-campus placements. The survey found 53.1% of students (1,411) got jobs. Meanwhile, 8.4% (224 students) self-employed, 1.7% (45 students) joined startups, and 2.5% (66 students) started businesses. Many graduates pursue intellectual or competitive goals. About 13.5% (359 students) have chosen higher education, and 1.8% (47 PhD holders) are awaiting postdoctoral research or faculty employment. 12.1% (321 students) are preparing for civil services, engineering, and government career exams. The institute's August 10 convocation event

Exam centers to get CCTVs from NIOS to reduce malpractices

Delhi: To ensure transparent and seamless assessments, the Board of Secondary Education (BSE) will use AI-powered CCTV cameras and webcasting of the annual High School Certificate (HSC) exam 2024. Pauses, violations of rules, such as logistical issues in storing or distributing question papers, cheating, malpractice, invigilator incompetence, or cell phone use in HSC exam centers, can now be identified quickly. The board has strategically placed AI-supported CCTV cameras and webcasting for real-time test hall surveillance. Advanced features in these cameras can detect strange behavior in the medical room. "The annual matric examination 2024 will be completely hi-tech and technology-enabled to make the process transparent and error-free," stated BSE secretary Nihar Ranjan Mohanty.



Over 5.5 lakh students will take the yearly HSC exam from February 20 to March 4, 2024. More than 2,990 centers will host the exam this year. Hypersensitive and sensitive test centers, strong rooms where question papers will be maintained, and district education officers will have AI-enabled CCTV cameras. "We are working on identifying the centres based on the reports of DEOs," he said. The BSE sends a three-tier squad of 160 persons to examination centers to check for wrongdoing and ensure smooth board exams.
