NEW DELHI: The fans at the M Chinnaswamy Stadium were on the edge of their seats as Royal Challengers Bengaluru edged out Chennai Super Kings in a nail-biting thriller that went down to the final ball. On the third delivery, he removed the legendary Dhoni, swinging the match back in RCB's

Then came chaos — a waist-high no-ball followed by a single from new batter Shivam Dube. With six needed off three, Jadeja managed just a single. Four were needed off the final ball. Dayal bowled a low full-toss, Dube struck it to long-on, but RCB's fielding held strong. Only two runs were scored. Dayal's calm under pressure sealed a memorable win for RCB, lifting them to the top of the points table amid wild celebrations.

Trade items including dry fruits and chemicals worth around \$500 million are reportedly entering India via intermediary nations such as the UAE, Singapore, Indonesia and Sri Lanka, according to an official, quoted by news agency PTI. The official indicated that a considerable portion of the Pakistani exports previously sent directly to India are now being channelled through alternative countries.The UAE reportedly serves as a repackaging and relabelling point for Pakistani fruits, dry dates, leather, and textiles before their dispatch to India, whilst chemicals are reportedly sent via Singapore. FIR filed against Sonu Nigam over 'emotionally provocative' remarks at Bengaluru concert

NEW DELHI: An FIR has been registered against renowned singer Sonu Nigam following allegations of disrespectful comments about the Kannadiga community during a musical programme in Bengaluru.

The complaint was initiated by Dharmaraj A, who heads the Bengaluru city district unit of Karnataka rakshana vedike, an organisation advocating for Kannada interests.The allegations claimed that Sonu Nigam made "objectionable and emotionally provocative" remarks that offended the Kannadiga community's sensibilities and fostered discord amongst various groups linguistic Karnataka. The official complaint stated, "This complaint is lodged against the renowned singer Shri Sonu



Nigam for making objectionable and emotionally provocative statements during a musical event held on April 25 and 26, at East College Point Engineering Technology, Virgonagar, Bengaluru, which falls under your police station's jurisdiction. His statements have deeply hurt the sentiments of the Kannadiga community, incited hatred among various linguistic communities in Karnataka, and are likely to provoke violence. A video of Shri

Sonu Nigam's statement has gone viral, causing widespread outrage among millions of Kannadigas across the state."

The event took place while the singer was performing at East Point College of Engineering Technology in Virgonagar, Bengaluru, on April 25. When a fan persistently requested him to perform a Kannada song, Sonu refused, stating that the fan was making demands in an aggressive manner. He then stated, "Yahi kaaran hai,

Pahalgam mein jo hua hai na. Yahi kaaran hai jo kar rahe ho, jo kiya tha na abhi. Dekho toh kaun saamne khada hai." The response drew severe backlash from not just the Kannadiga community but also from public across India, who spoke against making the comparison.

Police officials have registered the case under Sections 351(2), 352(I), and 353 of the Indian Penal Code and have commenced their investigation.

The controversial remarks were delivered during a stage performance and were recorded on video, which subsequently spread across social media platforms, triggering significant backlash from Karnataka residents.

The airport is being developed through a public-private partnership

Noida International Airport Ltd (NIAL) at Jewar, in the Gautam Buddha Nagar district of Uttar Pradesh, conducted its first flight validation test on 9 December. According to NIAL officials, the first commercial flight from Noida International Airport is scheduled to take off on 17 April 2025. Indian Prime Minister Narendra Modi had inaugurated the construction of NIAL during a well-attended foundation stone-laying ceremony on 25 November 2021. An IndiGo test flight travelled from Delhi's Indira Gandhi International Airport (IGIA) to NIAL, completing the final security-related analysis for the facility. Officials stated that the flight was conducted under close coordination between the pilots and the air traffic controllers (ATC). There were no passengers on board when the flight landed on the 3.9-kilometre runway shortly after noon. Earlier, the Directorate General of Civil Aviation (DGCA) had granted flight and security approvals. Technically, the airport will now be readied for commercial operations. The Airports Authority of India (AAI) oversaw the exercise, and all data collected will be submitted to the DGCA for review. Supervising personnel included officials from the DGCA, the Ministry of Civil Aviation (MoCA), NIAL, and the Uttar Pradesh Civil Aviation Department. The test assessed systems such as airspace coordination, communication protocols, emergency response readiness, and runway performance. Previous milestones included the successful calibration of the Instrument Landing System (ILS) and the Precision Approach Path Indicator (PAPI) in October 2024.

With the validation flight completed, we are committed to finishing the airport project before the end of April", said Union Minister.

To stand in this house is to be reminded of what is most beautiful about religious faith

To stand in this house is to be reminded of what is most beautiful about religious faith: its ability to give solace and to inspire, its aspiration to these great and lovely heights, in which strength and delicacy are so perfectly conjoined. In addition, to be asked to speak here on this day, the fourth anniversary of the notorious fatwa of the late Imam Khomeini, is a particular honour. When I was an undergraduate at this college, between 1965 and 1968, the years of flower-power and student power, I would have found the notion of delivering an address in King's Chapel pretty far-out, as we used to say; and yet, such are the journeys of one's life that here I stand. I am grateful to the Chapel and the college for extending this invitation, which I take as a gesture of solidarity and support, support not merely for one individual but, much more importantly, for the high moral principles of human rights and human freedoms that the Khomeini edict seeks so brutally to attack. For just as King's Chapel may be taken as a symbol of what is best about religion, so the fatwa has become a symbol of what is worst. It feels all the more appropriate to be speaking here because it was while in my final year of reading history at Cambridge that I came across the story of the socalled satanic verses or temptation of the Prophet Muhammad, and of his rejection of that temptation. That year, I had chosen as one of my special subjects a paper on Muhammad, the rise of



Islam, and the caliphate. So few students chose this option that the lectures were cancelled. The other students switched to different special subjects. However, I was anxious to continue, and Arthur Hibbert, one of the King's history dons, agreed to supervise me. So as it happened I was, I think, the only student in Cambridge who took the paper. The next year, I'm told, it was not offered again. This is the kind of thing that almost leads one to believe in the workings of a hidden hand. The story of the 'satanic verses' can be found, among other places, in the canonical writings of the classical writer al-Tabari. He tells us that on one occasion the Prophet was given verses which seemed to accept the divinity of the three most popular pagan goddesses of Mecca, thus compromising Islam's rigid monotheism. Later he rejected these verses as being a trick of the devil

saying that Satan had appeared to him in the guise of the Archangel Gabriel and spoken 'satanic verses.' Historians have long speculated about this incident, wondering if perhaps the nascent religion had been offered a sort of deal by the pagan authorities of the city, which was flirted with and then refused. I felt the story humanized the Prophet, and. therefore made him more accessible, more easily comprehensible to a modern reader, for whom the presence of doubt in a human mind, and human imperfections in a great man's personality, can only make that mind, that personality, more attractive. Indeed, according to the traditions of the Prophet, even the Archangel Gabriel was understanding about the incident, assuring him that such things had befallen all the prophets, and that he need not worry about what had happened. It seems that the Archangel Gabriel, and the God in whose name he spoke, was rather more tolerant than some of those who presently affect to speak in the name of God. Khomeini's fatwa itself may be seen as a set of modern satanic verses. In the fatwa, once again, evil takes on the guise of virtue; and the faithful are deceived. It's important to remember what the

One cannot properly call it a sentence, since it far exceeds its author's jurisdiction; since it contravenes fundamental principles of Islamic law; and since it was issued without the faintest pretence of any legal process. (Even Stalin thought it necessary to hold show trials)! It is, in fact, a straightforward terrorist threat, and in the West it has already had very harmful effects. There is much evidence that writers and publishers have become nervous of publishing any material

most reverential and anodyne sort. There are instances of contracts for books being canceled, of texts being rewritten. Even so independent an artist as the filmmaker Spike Lee felt the need to submit to Islamic authorities the script of his film about Malcolm X, who was for a time a member of the Nation of Islam and performed the hajj or pilgrimage to Mecca. IndiGo orders 30 long-haul planes for \$9.5 billion



Delhi: In 2027, IndiGo will fly nonstop between India and remote locations using its own widebody aircraft. The Rahul Bhatia-founded mega budget carrier "has agreed" to order 30 twin-aisle Airbus A350-900s worth over \$9.5 billion at list price and an option for 70 more. Indian travelers will have two domestic airlines, Air India and IndiGo, running medium to ultra long-haul routes on dual aisles (Vistara merges into AI this year), as well as many foreign carriers. IndiGo "agreed to order" 60 Trent XWB engines for 30 A350s. IndiGo evaluated the B787 Dreamliner, but Boeing's ongoing issues persuaded it to stick with Airbus, which has over 1,000 A320 family single aisles on order and is the world's largest A320 operator. Airbus controls India's single aisle market, but troubled Boeing is no longer the only wide body with Indian carriers. Since last year, Airbus has been receiving orders for big birds, starting with AI. IndiGo leased two B777s from Turkish Airlines to run a daily Delhi/Mumbai-Istanbul trip. After that experience, it ordered wide bodies for delivery in 2027, IndiGo's 21st year. Airlines can acquire 70 more A350-900 "at its discretion, for possible future needs under certain conditions," they say. IndiGo had over 10 crore passengers in 2023 on 350 planes.

Delhi: Dr. Sandip Ghosh, the former principal of RG Kar Medical College and Hospital in Kolkata, has recently faced intense scrutiny after the tragic rape and murder of a doctor on duty at the institution. Vietnam's restrictive internet law comes into force

A new internet law in Vietnam, Decree 147, gives the government increased control over internet access and content in the name of national security and social order. It mandates tech companies to store user data, verify accounts, and remove deemed illegal content within 24 hours. Critics argue this suppresses free speech and impacts livelihoods. A new internet law that gives the Vietnamese government expanded powers over internet services and people using them is set to officially take effect Wednesday. Decree 147 expands government control over access to information on the internet for reasons of "national security" and "social order."The law requires social media platforms providing services to users in Vietnam to store user data and provide it to authorities on demand. The government issued the decree this November, and it requires organizations to take down anything the authorities consider "illegal content" within 24 hours. Decree 147 has sparked concerns, with researchers and experts tracking the country saying that the law is part of a growing crackdown on civil society. "Because the Vietnamese police treat any criticism of the Communist Party of Vietnam as a national security matter, this decree will provide them with yet another tool to suppress dissent," said Patricia Gossman, associate Asia director at Human Rights Watch. The decree requires tech giants like Facebook and TikTok among other organizations., to verify user accounts using people's phone numbers or personal identification numbers. It requires companies to store that data. Decree 147 also requires organizations to provide search and content-scanning tools to government authorities upon request. It limits certain functions, like live video streaming.



Elon Musk reacts to Democratic Party's favorability dropping to a record low: 'Public is wise'
