Absconding PFI member murder in Kerala

NEW DELHI: A member of the banned Popular Front of India (PFI), who was wanted in connection with the murder of an RSS leader in 2022, was arrested from Kerala, the National Investigation Agency (NIA) said on Wednesday. Saheer K V was carrying a reward of Rs 4 lakh and was absconding since the murder of RSS leader Srinvasan on April 16, 2022 in Palakkad district of Kerala, a spokesperson of the federal agency said. Terming his arrest as a "major breakthrough", the official said an NIA fugitive tracking team (FTT) traced him to a relative's house in Palakkad and arrested him.

"Also a resident of Palakkad, Saheer was part of the PFI assault and protection team that had carried out the targeted killing. He was also responsible for providing protection to the main assailants of Srinivasan," the spokesperson said. The official said the NIA investigations showed that the accused, who was PFI's Pattambi area president, was involved in various conspiracies of the PFI leaders to eliminate Srinivasan, as part of the banned outfit's bigger scheme to create terror among members of a particular community and to establish Islamic rule in India by 2047. On March 17, the NIA had filed a

charge sheet against 59 accused, including the PFI as an organisation, in the murder case even as investigations are still continuing. Abdul Naser, had died on January 2, while efforts are on to track and trace the remaining 11 absconding



Forces put on alert, to stage flag marches in Manipur capital

NEW DELHI:

Security agencies Manipur are on high alert to counter potential disruptions by banned terror groups following the imposition of President's rule. With a heavy deployment of forces and flag marches scheduled in Imphal, security has been tightened after CM N Biren Singh's resignation. Over 250 lives have been lost in nearly 21 months of ethnic violence. IMPHAL: Security agencies are on high alert in Manipur to counter any mischief by banned terror groups following imposition of President's rule in the state, officials said on Thursday. There is a heavy deployment of forces within the Imphal valley areas which have seen attacks on police by cadres of Arambai Tenggol group, they said, adding, Assam Rifles and



other paramilitary forces will be conducting flag march in Imphal city to ward off any untoward breakdown of law and

They said security was beefed up in the state, especially the valley, after CM N Biren Singh's resignation on Feb 9, after nearly 21 months of ethnic violence that has claimed over 250 lives so far. Four days after his resignation, President's rule imposed in strife-torn Manipur on The state assembly.

Be careful in criminal cases tied to matrimonial disputes: Calcutta HC

KOLKATA: Courts need to be cautious when dealing with criminal cases based on matrimonial disputes, Calcutta HC Wednesday while quashing FIRs against two women registered by their sister-in-law under IPC section 498A. The court noted that the allegations against the two petitioners were "general and omnibus" in nature.

The matter pertained to a case of cruelty and dowry harassment, filed by a Kolkata woman against her husband and in-laws on Sept 27, 2021.

A single bench of Justice Gupta Kumar observed that tendency to implicate the husband and all his immediate relatives is not uncommon.



"Even after the conclusion of a criminal trial, it is often difficult to ascertain the real truth. The courts have to be extremely careful and cautious while dealing with these complaints and should take pragmatic realities into consideration," the bench observed.

The complainant alleged in the FIR that she was tortured, both mentally and physically, for dowry by her husband and inlaws. But, the judge noted that no specific role in the alleged harassment could be attributed to her married sisters-in-law, who approached the HC seeking quashing of the crimicomplaint and nal chargesheet filed against them.

The court noted that the complainant got married on May 5, 2009, and had a child on March 1, 2010.

She has been residing at her parents' place with her daughter since Sept 16, 2021, and lodged the police complaint on Sept 27, 2021, after almost 12 years of marriage. The sisters-in-law named in the complaint got married on Feb 16, 2007, and Nov 3, 2009, and were living away from the complainant's matrimonial

The woman alleged that her sisters-in-law threatened and harassed her over the phone. However, the court said no specific date, time, or mobile number was mentioned in her complaint or statement, thus making it impossible to ascertain the role of the petitioners in the offence.

Govt to stop duty-free import of yellow peas this month

New Delhi: Government will not extend duty-free import of yellow peas beyond February, food and consumer affairs minister Pralhad Joshi said Thursday. Government had allowed duty-free import of yellow peas in Dec 2023 and subsequently extended it thrice till Feb 28 to tide over the increase in prices of tur dal. 'We are stopping the duty-free import of yellow peas," Joshi told reporters. Sources said the issue of duty on yellow peas is likely to be taken up by Group of Ministers (GoM) headed by home minister Amit Shah next week. The food ministry has given its comments and a final decision will be taken by GoM, Joshi added.India Pulses and Grain Association (IPGA) chairman Bimal Kothari said govt.

Replace Urdu with Sanskrit: Rajasthan education department to govt school

JAIPUR: Rajasthan education department has directed a govt school in Jaipur offering Urdu as a third language to suspend classes in the subject and introduce Sanskrit as an option.

The February 10 order to Mahatma Gandhi Govt School (RAC Battalion) states that the decision was based on a letter addressed to the department from the office of Jai Narayan Meena, special assistant to education minister Madan Dilawar.



"The minister ordered the creation of Sanskrit teachers' posts and close down Urdu (classes). Therefore, make sure to send the complete proposal for opening Sanskrit as a third language in your school to this office," the order states.

Meena didn't respond to texts and calls from TOI, which has a copy of the directive.

Dilawar's OSD Satish Gupta said the order was issued because not enough students in that school had Urdu as their third language to justify teachers being deployed full-time. Amid protests by the teachers,

the education minister's media coordinator claimed Thursday that no such order was

issued.



This hydrocele was 6.8x2 cm, which is very rare in female infants. Dr Sanjay Kumar said that such cases are seen very rarely and many surgeons have not seen such cases. According to available research, hydrocele of

rare condition, with studies showing a prevalence of about 0.74% to 0.76% in girls under 12 years of age, which means it affects a very small percentage of the female population ; most cases are seen in children and are considered uncommon in adults. Dr Sanjay said that the report of this rare case will be sent for publication in national and international medical journals. 

Has Britain been taken over by Islamists?

British MPs have been forced to hire personal bodyguards following threats by Islamist groups over Britain's support of Israel in the Gaza war. Three unnamed women MPs have been given additional security. Prime Minister Rishi Sunak issued a statement following the direct threats to British MPs: "Legitimate protests (have been) hijacked by extremists to promote and glorify terrorism, elected representatives verbally threatened and physically, violently targeted and antisemitic tropes beamed onto our own Parliament building." Threats of physical violence against British MPs have increased further since the killing by the Israeli army last week of over 100 Palestinian civilians seeking food aid in north Gaza. London has become a safe haven for Islamist extremists. Pakistan-origin mayor Sadiq Khan, in office since 2016, is accused of being soft on Islamists because he relies on Muslim votes in mayoral elections. As in India, Muslims in Britain vote in blocs. This was highlighted by the victory of controversial politician George Galloway last week in a by-election in Rochdale, a town in Greater Manchester. The by-election showed how deeply the Gaza war is influencing British politics. Labour party leader Keir Starmer is widely expected to be the next British prime minister given Labour's lead in opinion polls of more than 15 per cent over the Conservative party. In the Rochdale by-election, Starmer, a staunch supporter of Israel, suspended Labour's official candidate Azhar Ali for making antisemitic comments on Israel's war in Gaza. In the absence of party support for a Labour candidate, Galloway romped home to victory. A strong backer of Palestine, Galloway, who leads the small Workers Party of Britain, said after his win: "Labour will pay a high price for the catastrophe in the Gaza war." This alarmed Starmer enough to apologise to Rochdale voters after Galloway's win: "I regret we had to withdraw our candidate (Ali) and apologise to the voters of Rochdale." Galloway has promised to make life difficult for both Starmer and Sunak as campaigning gets under way for the UK general election later this year. Putting aside their parties' differences, Starmer and Sunak have come together to support Israel which could alienate young Britons, both white and ethnic minorities. It could make the result of the general election less predictable. It's not only British politicians who are under threat of violence. Crime in London has soared. Young knife-carrying gangs on mopeds snatch expensive watches, mobile phones and other personal effects. Several Indian tourists speak of being robbed in broad daylight in central London. According to a Sky News report: "India's business elite feel they have to look over their shoulder while visiting areas such as Mayfair in London due to the risk of being mugged. The theft of high-value timepieces sold on the black market has become a criminal enterprise in the UK capital in recent years with one former watch dealer telling Sky News it is 'more lucrative than drugs'. "High-profile targets include former world boxing champion Amir Khan, who was forced to hand over his £70,000 Franck Muller watch in a gunpoint robbery in east London."The man blamed for the descent of London into a crime-laden metropolis is mayor Sadiq Khan. On his watch crime in London has soared. British tourism authorities have issued a warning to London police that foreign holidaymakers have safer cities to visit in Europe other than London and more action is needed to make the city safer for tourists. The demographics of London are changing rapidly. According to the latest census, British whites now comprise only 30 per cent of London's population. Other European whites permanently resident in London account for another 20 per cent. The balance 50 per cent are ethnic minorities from India, Pakistan, Bangladesh, China and the Caribbean.

2047 sets the tone for 2024 elections

The battle for the general elections 2024 in India has started well before the formal announcement of the poll schedule by the Election Commission. With the Narendra Modi-led releasing its first list of candidates, the race to control the Lok Sabha is off to an early start for the ruling dispensation while the Opposition continues to flounder from blunder to blunder. The deft manner in which key regional alliances have been struck by the BJP even as the Congress witnesses an exodus of leaders points to the stark divergence in confidence levels between the two political formations. By now it ought to be clear that the I.N.D.I. alliance is a nonstarter in most states with the failure to coordinate seat sharing. Barring the deep south, the opposition alliance is not much of a factor in most states. A key leading indicator of the direction in which the political winds are blowing is the steady flow of talent towards the BJP. If the first list of candidates released by the BJP is anything to go by, a generational shift is underway with several veterans bowing out of the electoral race.

Recording a stunning 8.4% GDP growth during the third quarter of 2023-24, the economic tailwinds and geopolitical undercurrents seem to be working in concert to propel the country towards the goal. Recognising the significance of the moment, PM Modi's government has bet big on sunrise technology sectors that will fuel the Indian economy in the decades to come.

In the last few weeks a slew of decisions by the government underscore the central role technology has come to occupy in Modi's vision for a Viksit Bharat by 2047. From announcing to the nation, the final shortlist of astronauts for India's first manned space mission Gaganyaan to approving the first semicon-

ductor fab to come up in the country, Modi's technonationalism is emerging as the crucial mantra in this race to 2047 with 2024 as an important stopover. Semiconductor investments spanning from the east in Assam to the west in Gujarat, underscore how Modi's thrust on a technology-driven economy has become a political priority. With the decision to completely liberalise the space sector opening up to a hundred percent in foreign direct investment (FDI), sunrise sectors are poised to play a crucial role in sustaining and further accelerating the economic momentum. Casting a wide social safety net has been a hallmark of Modi's technonationalism over the past decade. The results from this laser focus on keeping the socio-economic fabric intact is most visible in the declining levels of extreme poverty across India. For the first

time the World Poverty

the World Data Lab based in Vienna, has estimated extreme poverty in India to be below three percent. Writing for the Brookings Institute, an American think tank, noted economist Surjit Bhalla alongside Karan Bhasin, observed that extreme poverty stands eliminated in India as commonly defined in international benchmarks. This important socio-economic milestone on the road to a developed India by 2047 comes on the eve of general elections with a confident PM Modi making his case to the voters for what he believes to be an imminent third term. It also comes at a time when the aspirational middle class in India is experiencing accelerating growth as witnessed in the rising levels of automotive ownership, mobile phone penetration and exponential growth in digital payments.

In stark contrast to the decadal growth vision of the Modi led-BJP rooted in techno-nationalism, the narrative from the opposition continues to be regressive and lacking in a vision. Far from laying out a roadmap for a developed India, the political opposition's messaging has been a mish-mash of unsustainable entitlement programs bordering on fiscal irresponsibility and scorched earth politics of caste that is seeking to inflame social faultlines. The sullen petulance of the political opposi-

Conference document, which not only outlined inner and outer Tibet in unambiguous terms but also endorsed Sir Henry McMahon's Line, which determined the border between India and Tibet. Much of historiography will also ponder aspects such as why Major Bob Khathing and his posse of the noble Assam Riflemen "liberated" Tawang only in 1951, decades McMahon drew a thicknibbed terrain line that today subtly corresponds to the Thagla Ridge as well as the "Watershed," which determines borders, boundaries and frontiers in the sense by

Scammer Ketan Parekh back in Sebi net, banned from market

Delhi: The notorious market operator Ketan Parekh is back in Sebi's sights after being sentenced for stock exchange manipulations. Parekh (KP) was a key figure in a frontrunning operation discovered by the markets regulator. Sebi investigations showed that KP and Rohit Salgaocar,

Singaporean Indian, front-ran a foreign fund's trades for unlawful gains. Parekh never traded, but his Kolkata associates did. Sebi banned KP, Salgaocar, and 20 others from the market. They must also repay approximately Rs 66 crore in unlawful gains. Sebi investigations showed that a large US asset manager registered many funds as foreign portfolio investors. This consulted Salgaocar before trading in India. Salgaocar also referred FPI transactions to Motilal Oswal and Nuvama for commission. When

KP then passed the knowledge to his Kolkata conduits, who executed insider deals before Motilal Oswal and Nuvama traders did. Sebi found Parekh frequently changed his phone number. NEW DELHI: India's economy is estimated to slow to a four-year low in 2024-25 due to moderation in manufacturing and sluggish investment, while robust growth in the farm sector is expected to provide some support and help boost rural consumption.

The first advance estimates for the current financial year, released by the National Statistics Office (NSO) on Tuesday, showed gross domestic product (GDP) is estimated to grow by 6.4%, sharply lower than the 8.2% recorded in 2023-24.

The 6.4% growth projection is the lowest since the Covid-19 pandemic and comes on the back of a

The slowdown was expected given the deceleration in the July-Sept quarter when growth slowed to a seven-quarter low of 5.4%, triggering calls for a rate cut by the central bank. A recent finance ministry report had said that a combipolicy stance and macroprudential measures by the central bank, and structural factors, could have led to the slowdown and all eyes are now on the Feb 1 Budget.

Government eyes \$100 billion FDI as it sets up EFTA platform

NEW DELHI: With an eye on receiving \$100 investment from European Free Trade Association (EFTA) nations Switzerland, Norway, Iceland Liechtenstein - government on Monday announced the setting up of a dedicated platform to promote trade, investment and business facilitation between the two regions.Last March. India and the four European nations had signed a free trade agreement, which included an investment commitment in return for tariff reductions by New Delhi on products, including chocolates, watches and cut and polished diamonds. The agreement is not yet operational but is expected to be in force later this year. Commerce and industry minister Piyush Goyal said all the four EFTA nations have moved forward in seeking to implement the agreement.

"With the \$100 billion



FDI, I believe that we could be catalysing overall investments of may be \$400 billion or \$500 billion in the Indian ecosystem," the minister said, adding that a million direct jobs could be created. Government eyes FDI The setting up of the dedicated investment desk is seen as an important step and it will be the centralised support mechanism for companies from the EFTA region looking to expand in India. It will provide market insights and regulatory guidance, business match-making and assistance in navigating India's policy and investment landscape. "It will help businesses from EFTA countries navigate areas of con-

cern and it will make it easier for them to do business in India, Goyal told reporters. He also said India has offered EFTA countries an opportunity to have dedicated enclaves in either of the 20 industrial smart cities, being developed by National Industrial Corridor Development Corporation, or in the 100 industrial hub and spoke model areas announced in Budget. "We are in dialogue with the countries to see if any of these (industrial parks) could be dedicated to companies from their respective countries," Goyal added. Helene Budliger Artieda, Swiss state secretary said that they are informing their companies.

Commercial LPG hike by Rs 16.5 per cylinder, jet fuel up 1.45%; household cooking gas remains unchanged

NEW DELHI: The cost of commercial LPG and aviation fuel prices surged on Sunday following the monthly revision aimed at aligning with trends in international oil prices. State-owned oil firms raised commercial LPG rates, used in hotels and restaurants by Rs 16.5 per to Rs 1818.50 per 19 kg cylinder. Aviation turbine fuel (ATF) prices in Delhi, which hosts one of India's most active airports, saw an increase of Rs 1,318.12 per kilo litre, marking a 1.45 per cent increment. The new rate stands at Rs 91,856.84 per kl, according to state-owned fuel retailers. The prices of ATF and LPG vary from state to state, depending on local taxes, including VAT. This marks the second consecutive monthly increase in jet fuel prices, which were previously raised by Rs 2,941.5 per kl, or 3.3 per cemt, on November 1. ATF prices were reduced by 6.3 per cent (Rs 5,883 per kl) on October 1 and by Rs 4,495.5 per kl, or 4.58 per cent, on September 1. In Mumbai, the ATF price increased to Rs 85,861.02 per kl on Sunday from Rs 84,642.91 previously. The price of commercial LPG have also increased for the seventh consecutive month. In the most recent review on November 1, commercial LPG prices were raised by Rs 62 per 19-kg cylinder. Over the course of five price hikes, commercial LPG prices have increased by Rs 172.5 per 19-kg cylinder, reaching their peak this year. Four monthly price reductions before the current cycle began in August were offset by the recent hikes. Prices for 19-kg cylinders were reduced by Rs 148 across the four rounds. Currently, commercial LPG costs Rs 1,980 in Chennai, Rs 1,927 in Kolkata, and Rs 1,771 in Mumbai for a 19-kg cylinder. However, the rate of cooking gas used in domestic households, however, remained unchanged at Rs 803 per 14.2-kg cylinder. State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise the prices of ATF and cooking gas on the first of each month.

policymakers around the world sought to prop up growth through cheap money and unconventional monetary tools. In a widely expected decision, the BOJ ditched a policy put in place since 2016 that applied a 0.1% charge on some excess reserves financial institutions.
