'Like Team India': PM Modi bats for Centre-state cooperation - key takeaways

NEW DELHI: Prime Minister Narendra Modi on Saturday batted for cooperation between the Centre and states to achieve the national goals, as he chaired a meeting of Niti Aayog.

"If Centre and states work together like Team India, no goal is impossible," Prime Minister Modi said at Niti Aayog governing council meeting.

He also said, "Viksit Bharat is the goal of every Indian. When every state is Viksit, then Bharat will be Viksit. This is the aspiration of its 140 crore citizens."

The theme of this year's meeting was 'Viksit Rajya for Viksit Bharat@2047', with a focus on the role of states in helping India become a developed country by 2047, according to a press release from NITI Aayog.

The Prime Minister also urged states to focus on development. "States should develop at least one tourist destination per State at par with global standards and by providing all facilities and infrastructure. One State: One Global Destination. It would also lead to development of the neighbouring cities as tourist places," PM Modi



said while chairing the 10th Governing Council Meeting of NITI Aayog on Saturday at Bharat Mandapam, New

Hailing India's rapid urbanization, PM said, "India is getting rapidly urbanized. We should work towards

future ready cities. Growth, innovation and sustainability should be the engine for the development of our cities."

At the Governing Council Meeting, Andhra Pradesh chief minister Chandrababu Naidu suggested creating three dedicated sub-groups of states, in partnership with the Union Government and NITI Aayog, to accelerate efforts toward achieving the goal of a developed India by 2047.

As per a statement issued by the State government, the first sub-group would focus on driving GDP growth by encouraging investments, enhancing manufacturing and exports, and generating employment. This would be supported through central Viability Gap Funding for public-private partnership (PPP) projects.

The second sub-group would address population management, aiming to help India make the most of its demographic strengths while also preparing for future issues such as population ageing and declining fertility rates.

The third sub-group would work on promoting technology-based governance by leveraging tools like artificial intelligence, quantum computing, drones, and digital platforms to ensure efficient, real-time, citizenfocused administration.

Container ship capsizes off Kerala coast; 21 rescued, 3 remain onboard

NEW DELHI: A Liberia- Coast Guard (ICG) immeflagged container vessel, MSC ELSA 3, capsized after departing Vizhinjam on Saturday, port prompting a major rescue operation by the Indian Coast Guard, reported All India Radio News Trivandrum.

The incident occurred approximately 38 nautical miles off the coast of Kochi, with the vessel seeking urgent assistance. The authorities have urged caution as there is a possibility of hazardous materials hitting the shore. The Indian

Apex Court quashes gangster case against ex-director admin SHUATS

Prayagraj: The Supreme Court has quashed the gangster case FIR No. 850/ 2018 registered at Thana Naini, Prayagraj against former director administration of SHUATS Vinod B Lal. Senior Advocate Mr. Siddharth Dave and Advocate Kumar Vikrant Ghosh, appearing for the petitioner, submitted that the case registered against the petitioner does not allege any specific direct act on the appellant, he further said that there is no allegation of use of force and violence in the said FIR. According to him, the allegations do not show that the primary purpose behind the alleged offences was to disturb public order. The bench of Justice J.B. Bhajan Lal, 1992 which laid down the parameters for quashing of FIR and subsequent proceedings. After analysis, the Bench observed that the allegations made in the FIR or complaint are so absurd and inherently impossible that no prudent person can ever conclude that there is sufficient ground to proceed against the accused. The allegations made in the FIR do not constitute cognizable offences but only non-cognizable offences. The allegations also fail to disclose whether any act of violence, threat, display of violence, intimidation or coercion was committed to achieve the said objective. Even in the chargesheet filed pursuant to the investigation in the said FIR, apart from repeating the contents of the FIR, only a vague reference has been made to the Uttar Pradesh quashed.



He quipped whether Modi government bypassed convention? "While no special session was held following terror attacks in the past and the decision to convene a parliament session rests with the government, during both the 1962 and 1971 wars, the parliament was kept in loop. The parliament was briefed after the last major terror attack on civilians the Mumbai terror attack in November 2008 - as the winter session convened only days after the attack. Parliament should be told about what has happened and what has been done by India although there are no specific rules and it is for the government to decide to take the parliament into confidence. A look at significant global diplomatic outreach efforts by previous governments shows that in the aftermath of the 26/11 Mumbai terror attack, the parliament attack in 2001, and even the multi-party delegation sent to the UNHRC in 1994 following increasing violence in Kashmir - unanimous resolutions were passed in the parliament. While no special session was called, both the 2008 Mumbai terror attack and the 2001 parliament attack saw discussions in parliament with then Prime Ministers Manmohan Singh and Atal Behari Vajpayee delivering statements. The present diplo-

matic outreach comes after the Pahalgam terror attack when 26 civilians were killed on April 22 in the worst attack on civilians since 2008 and the largest military escalation between India and Pakistan since the Kargil war in 1999. 'Unacceptable to brief foreign governments while Indian people remain in the dark'. As the first batch of the seven allparty delegations left on Wednesday, opposition parties said that it was "unacceptable" that foreign governments would be briefed while India's parliament and people will remain in the dark," he opined.

Congress leader Shekhar Bahuguna added, "The government's decision to send all-party delegations to key countries, in-

cluding UNSC members, after Operation Sindoor has been marked by opacity and exclusion. Political parties were neither consulted nor briefed, and there is no clarity on the mandate of these delegations. It is unacceptable that foreign governments will be briefed while India's own parliament and people remain in the dark.

Before reaching out to the world, the government must first respect its own people and institutions. India deserves transparency, unity, and dignity - not arrogance, opacity, and suppression.'

Shekhar Bahuguna also claimed, "While the government has convened two separate all-party meetings - one after the Pahalgam attack, and the other after

Operation Sindoor - Prime minister Modi did not attend either. He did make a statement following the Pahalgam terror attack, but it was at a rally in Bihar. His address to the nation following Operation Sindoor came only after the four-day long conflict ended with a ceasefire, which Trump claimed he had mediated, and 48 hours after the ceasefire itself. While Modi's statement was a departure from the US' claims, he did not make any direct references to Trump, who has since continued to reiterate the claims on various occasions. Trump went on to claim that he brought back the two countries from the brink of a nuclear war, and that trade was used as leverage to broker the ceasefire."

Constitutional Crossfire: President's Reference Puts Judiciary In The Dock

In an extraordinary move that has the scope to reshape the contours of the Indian Constitution, the President of India has invoked a rarely used power under Article 143 to refer a legal question to the Supreme Court. The question? The very scope and legitimacy of the Supreme Court's extraordinary powers under Article 142. At its heart, this momentous referral has placed two of the republic's most powerful constitutional authorities—the President and the Supreme Court—on a potential collision course. The reference from the Rashtrapati Bhawan paradropped close to a month after the Supreme Court ruled that the President must decide on bills referred by Governors within three months. This landmark decision came after the court overturned the Tamil Nadu Governor's decision to withhold approval for pending bills. The court ruled that Governors cannot indefinitely delay assent to Bills passed by the state legislature. Such inaction amounts to a 'pocket veto', a concept alien to the Indian constitutional system. Bills can be reserved for the President only in specific circumstances (e.g., when required by Articles like 254(2), 31A, etc.). It cannot be used as a tool to block legislation falling within the State's domain," the bench, comprising Justices JB Pardiwala and R Mahadevan, had said in the verdict dated April 8, 2025. President Droupadi Murmu's reference in a way challenges the alleged judicial activism of the apex court, particularly questioning the reach and limits of its power to "do complete justice". Article 142 has often been described as a judicial wild card—a provision invoked to bridge legal gaps, deliver equitable outcomes, and, at times, sidestep the legislature. The invocation of the advisory jurisdiction by the President of India appears to seek clarity on the scope and extent of the extraordinary jurisdiction of the apex court. However, the said reference, if looked at from a wider lens, appears to be much more than unusual since an extraordinary constitutional power is being used to challenge another i.e. Article 143, which empowers the President to seek the advisory opinion of the Supreme Court on questions of public importance, but is a rarely used tool. When Was This Extraordinary Measure Last Used By A President? The last time this jurisdiction was invoked was in 2016, when then-President Pranab Mukherjee sought the court's opinion on whether the government could bypass the Rajya Sabha to enact the Goods and Services Tax (GST) by treating it as a Money Bill.On April 12, 2012, the then President Pratibha M Patil used it in connection with the 2G spectrum allocation, asking eight questions. These included judicial interference in policy matters and whether auction as the only method that can be used to allocate natural resources. President Murmu's current reference invoking the advisory jurisdiction is more than just a legal query—it is a moment of reckoning for the basic structure doctrine itself. Speaking to News18, senior advocate Siddharth Luthra said, "This reference to my mind is to determine what is the way going forward, to what extent the Supreme Court will direct Governors and Presidents to act, to what extent will they determine and sit over jurisdictions of Governors and Presidents."

Senior advocate Sanjay Hedge, meanwhile, said, "Reference is not a review. Presidential reference is a question to court in its advisory jurisdiction. Supreme Court had clarified its advisory iurisdiction is recommendatory and not binding."Judgment of court is a verdict of court, it can be overcome only through process known to law which is an adjudicatory process. This is an opinion; it cannot directly override a judgment," he added. The apex court, for the longest time, has assert-

ed that certain foundational . principles—like judicial independence, federalism.

The Pakistan government has cemented its relationship with the powerful army chief, General Asim Munir, by rewarding him with the title of Field Marshal. While it's not clear whether the idea originated with the army or the government, Munir's elevation to a five-star rank signals the Shehbaz Sharif government's allegiance to the commander of the largest service branch, an act that will have far-reaching political and institutional implications.Notwithstandin g the general sense of jubilation in the country over the popular perception of a tactical victory against India, this particular decision came as a shock and may not serve Asim Munir's interests in the long run. Many people who were previously silent after the end of the conflict, or who had been generally happy with the Pakistan Air Force's achievement, suddenly took to their keyboards to mock the decision. Some pointed out how Munir has been steadily accumulating prefixes, while others drew comparisons to Ugandan dictator and army chief Idi Amin or joked about whether the title of Quaid-e-Azam would be next. There is a growing sense among many that the government should have stopped at celebrating the military achievement, rather than indulging in this kind of overdrive.As some observers I spoke to suggested, the decision may reflect the political cunning of the government, which could be attempting to shift negative focus back onto the powerful army chief-previously hailed as a hero. Others said the initiative was

way of signalling to Munir that, since the Pakistan Muslim League-Nawaz (PMLN) could go so far as to make him Field Marshal, he should remain invested in this partnership and not consider rapprochement with Imran Khan or party.Indisputably, the government prioritised shortterm political gains over long-term institutional consequences. With his promotion to five-star general, Munir is now the most senior commander in the country disrupting the institutional balance within the armed forces. Ironically, he now outranks the Chairman Joint Chiefs of Staff Committee (CJCSC), a four-star general who heads the body created in the 1970s to ensure parity among the three services and coordinate joint planning.A five-star army chief attending CJCSC meetings renders the proceedings

institutional imbalance echoes a similar issue from the Zia-ul-Hag era when. after declaring martial law and becoming president in 1977, Zia could no longer participate in CJCSC meetings. As a result, the Vice Chief of Army Staff (VCOAS) attended instead, undermining the intended balance among the services. This not only weakened joint planning but also sidelined the question of political control over the largest service.

Munir's elevation is likely to create similar complications. As some of my sources suggested, he may try to resolve the issue by appointing a four-star VCOAS—a move believed to be aimed at calming nerves within the army, where many are now uncertain about their futures. But history suggests that a four-star general in the army often ends up being

miss this decision as a mere political stunt, given its institutional implications. Crucially, the promotion is unlikely to make Munir more powerful than he already is. He and the institution he leads are already immensely powerful. No political party worth its salt today has even a notional interest in holding him or the military accountable. The last institution with any capacity to do so—the higher judiciary—backed off at the start of the conflict, when the Supreme Court conceded to the use of military courts to try civilians for treason.Furthermore, Munir has already outlined his vision for the state: a "hard state", hellbent on crushing dissent, refusing dialogue with those that appear belligerent, and upholding the national ideology through military means. One is also reminded of his earlier the army chief's undoing.It promises to transform

Pakistan into a trillion-dollar economy—a goal far more ambitious than convincing people to sacrifice for sustaining the military, especially in the wake of recent conflict.The civilian government's eagerness to appease the general also suggests that no one will raise questions this November when his current three-year term ends, and it comes time to legally extend it by another two years—taking him to November 2027. After that, another five-year extension seems likely. This is when the road may get bumpy for him. Even the two-year extension is already a problem: many three-star generals, who serve four-year terms, will now retire without a chance at promotion.Sadly, Pakistan has not seriously considered the implications of these extensions. Another fiveyear term after 2027 could open up a Pandora's box, as it has for previous generals during their second extended tenures. This is when all powerful generals tend to make mistakes, including caving in to international pressures, resulting in a push from within institution.So far, no general has survived an extended term or managed to end their second term nicelyfrom Zia-ul-Haq and Pervez Musharraf to Ashfaq Parvez Kayani and Qamar Javed Bajwa, the ending for all of them was not as rosy as their beginning. Munir will struggle to maintain a balance within his own service, a task fraught with pitfalls. As many within army circles recall, even Musharraf had to negotiate hard with his corps commanders to get decisions accepted during his extend.

Indian borders. Many even said despite substantial evidence in this regard. Beijing offered mediation between the two warring South Asian countries but was at a loss when Pakistan preferred to approach the United States for a ceasefire. China's efforts to whitewash Pakistan-based terrorists and its diplomatic support to Islamabad have dented the image of China as a responsible country. Its myopic vision to back its "all-weather" friend at all costs is expected to cost it its long-term strategic objectives. However, it was in the military showdown that China's image took a dent. Most of its military equipment - estimated to have cost Pakistan more than \$20 billion - underperformed, missed their targets, malfunctioned, destroyed, or fell like duds in the war theatre. For instance, China sold to Pakistan its "vigorous dragon" J-10 C fighter aircraft.

70% of Manipur firearms surrendered after governor call

Delhi: In response to governor Ajay Bhalla's call last month, about 70% of Manipur's guns surrendered came from four Valley districts: Imphal East, Imphal West, Thoubal, and Bishnupur. CRPF sources reported that 991 guns surrendered were between February 20 and the governor's deadline to voluntarily return weapons looted after ethnic unrest in Manipur in May 2023. This period saw rebels and protests across the state surrender 11,526 366 hand ammo, grenades, 230 explosives, and 10 IEDs. Rebels in Imphal West surrendered 349 arms,



Premji pledges 2,250 crore for college education of girls



Delhi: Azim Premji Foundation has com-mitted to giving 2,250 crore over three years to help more girls com-plete their college education, making it the country's largest direct benefit transfer scheme by a not-for-profit private entity. Under the initiative, a girl who has completed her standard X and XII from a government school can apply for the Azim Premji schol-arship. Billionaire and philanthropist Azim Premji's eponymous founda-tion, Azim Premji Foundation, would give 30,000 a year to up to 250,000 girl students. This translates to ?750 crore a year, which, over a three-year degree program, would total 2,250 crore. "The basic purpose of this is to allow girl children to complete their higher education," said. Anurag Behar, chief executive officer of Azim Premji Foundation. "If a girl has completed 10th and 12th from a government school and is admitted to a bona fide college, the child is eli-gible to get 30,000 every year for the duration of her course." Beginning in September, a girl who starts college and has received the Azim Premji scholarship will receive *90,000 over a three-year degree program.
