NEW DELHI: After T shirts and masks, the Congress MPs on Tuesday protested outside Parliament donning "Modi-Adani" bags, which had caricatures of Prime Minister Narendra Modi and billionaire Gautam Adani printed and 'Modi Adani Bhai Bhai' written on the side. This marks the latest in a string of opposition attacks on the government, alleging that it is sidestepping discussions about the bribery allegations involving Adani in the US. Jobless men' who abducted Sunil Pal bought gold with ransom money



MEERUT: Mumbai-based comedian Sunil Pal was allegedly kidnapped and held hostage for 24 hours by five men from UP who lured him to Meerut under the pretext of organ ising a comedy show. The kidnappers told Pal that they were unemployed and demanded a ransom of Rs 20 lakh (but settled for 7.5 lakh later), which they used to purchase jewellery. The accused promised Pal that they would repay the amount after they found a job. The kidnappers even gave him Rs 20,000 in cash so that he could fly back home

Pal, known for his stand-up comedy and acting, was invited to perform at an event in Haridwar and had even received part payment in advance. Speaking to TOI, Pal recounted how the episode quickly went south, "I didn't suspect any thing unusual as everything seemed legitimate. They sent a car to pick me up from the Delhi airport last Monday. After reaching Meerut, a group of men forcibly transferred me into another vehicle. They blindfolded me and warned me that they had a poison-filled injection and would kill me if I didn't cooperate." Pal added, "They threatened to inject poison in me and demanded Rs 20 lakh for my release. I managed to negotiate and transferred Rs 7.5 lakh to two accounts they provided. They then gave me Rs 20,000 to book flight tickets for Mumbai and promised to repay the ransom once they found jobs." Pal described the episode as "terrifying" but said he was relieved to return home safely.

The role of state fiscal capacities in national growth

India's economic progress is a composite reflection of the growth trajectories of its states. Given the federal structure of the country, each state operates with a degree of autonomy in implementing policies that drive their individual economies. This results in a broad spectrum of growth rates across states, highlighting significant disparities. For the nation to achieve holistic growth, it is imperative for all states to experience economic advancement. Despite this, there is a notable discrepancy in the attention paid to fiscal matters at different levels of government. The Union Budget, detailing the central government's finances, often garners substantial scrutiny and debate for its potential impacts on the nation's economic direction. In contrast, state budgets, which are crucial for addressing local needs and fostering regional development, do not attract a similar level of public and analytical scrutiny. Fiscal capacity, the government's ability to generate revenue from available tax and nontax bases, is crucial for several reasons. First, it underpins a government's ability to provide essential public goods and services. These range from healthcare and education to infrastructure and defense, which are fundamental for the welfare of the citizenry and the smooth functioning of the economy. Without adequate fiscal capacity, governments may struggle to maintain these services at levels that meet public demand and expectations, potentially leading to social unrest or a decline in the quality of life. Second, fiscal capacity is vital for economic development and growth. Governments need resources to invest in infrastructure projects like roads, bridges, and digital networks, which are critical for enhancing productivity and competitiveness. Such investments not only improve current living standards. but also set the stage for future economic expansion. The Asian Development Bank Institute (ADBI) in 2017 and the World Bank in 2015 highlighted the risk of economies falling into a 'middle-income trap' where they are unable to transition to high-income status due to inadequate fiscal capacity among other factors.

Moreover, fiscal capacity is essential for macroeconomic stability. It allows governments to manage economic cycles more effectively, applying fiscal stimulus in downturns and restraint in booms to maintain economic stability. The Covid-19 pandemic's impact on Indian states underscored this point, as reduced fiscal capacities constrained their ability to respond effectively to the crisis and its economic repercussions.

Finally, a robust fiscal capacity enables equitable social development. It allows for redistributive policies that can mitigate income inequality and fund social safety nets for the vulnerable. Studies have shown that factors such as high per capita income, education levels, and low corruption contribute to higher fiscal capacity, which in turn can be used to foster a more inclusive society.

Given that state governments account for over 60 per cent of general government expenditure in India, enhancing their revenue-generating capacity is imperative for the needed investment in areas such as education, research and development, and skill development.

The Reserve Bank of India recently released a report on state finances, which gives an insight into the state budgets of 2023-24. It has some important findings. First, revenue mobilisation in Indian states comprises both tax and non-tax revenues, with a significant portion coming from state's own tax revenues (SOTR). Over the

years, there has been a noticeable increase in SOTR, growing from 5.7 per cent of GDP in 2003-04. to 6.9 per cent in 2022-23. This growth, particularly in the post-GST era, reflects a shift in the composition of tax revenues. with the State Goods and Services Tax.

Why military interventions will never let Pakistan become a democracy?

What facet of the military's participation in the nation's political apparatus contributes to its operational dysfunction? Alternatively, what constituent of the military's involvement propels society towards the precipice of civil conflict?

From a subjective standpoint, the military's influence on decision-making processes, notably in formulating foreign and internal security policies, does not inherently manifest as problematic.

Given its precarious geopolitical surroundings, the contextualisation of Pakistan as a security state from its inception underscores the historical roots of such a paradigm.The 1990s witnessed the ascendancy of a militaryoriented perspective, accentuating assumed internal threats to the nation's survival. This perspective gained further traction in the aftermath of the post-9/11 security paradigm. The substantial role assumed by the military in shaping foreign and security policies finds its justification in these historical antecedents. Critics of the military's pervasive role in



these processes must proffer alternatives, pragmatic implying the establishment of alternative institutional frameworks to curtail the involvement of military bureaucracy. However, complications arise when the military bureaucracy exploits international linkages forged during policy formulation to consolidate its influence within the country's power structures.

In the post-Musharraf epoch, military leadership assumed the mantle of de facto diplomats for Pakistan. The security landscape emerged as the preeminent foreign policy concern for successive governments in Islamabad, prompting foreign leaders, including foreign ministers and heads of state from Western and Muslim nations, to seek consultations primarily with the Chief of Army Staff (COAS).

The high-profile international visits undertaken by the Army chief were extensively publicised in domestic and international media during this time. This heightened visibility finds rationale in the geopolitical reality that Pakistan and its adjacent Afghanistan were focal points in global terrorist networks, hosting the headquarters of major international terror organisations.

A historical context is pertinent, wherein the nexus between the Pak-Afghan border areas and mainland Afghanistan was implicated in major terrorist incidents worldwide. In such scenarios, the discernment of a foreign leader is of manageable complexity; the point of contact for addressing such difficulties is perceived to be the Army chief rather than the Prime Minister of Pakistan. The irony is underscored by

the conspicuous absence of institutional capacity within the prime minister or the civilian government to formulate policies germane to these concerns. Despite the technical attribution of military capacity within the ambit of the prime minister's executive powers, the unequivocal proclamations of the military's media wing regarding its intent to support civil governments on diverse policy matters substantiate the de facto institutional autonomy exercised by the army. This nuanced interplay unfolds within Islamabad's structured and disciplined bureaucratic milieu, characterised by an absence of tumult or disorder. The constitutional powers of the prime minister are willingly ceded, facilitating the encroachment of the Chief of Army Staff and the military bureaucracy, particularly in scenarios where civilian governments lack the independent capacity for policy formulation and execution. However, it is essential to note that this singular dynamic does not make Pakistan's political system dysfunctional. Comparable instances of military leadership involvement in the formulation and execution of foreign and security policies are observable in other

nations. The difficulty associ-

ated with the military's engagement in Pakistan lies primarily in its role as a partisan actor in the nation's political coninternal tentions.

This predicament is further underscored by the extensive historical record depicting the Pakistani military's involvement as a participant in ideological, religious, sectarian, and political conflicts. The epoch of General Zia-ul-Haq's military regime stands out as a significant period wherein the military was ostensibly positioned as the guardian of the state's ideological frontiers. During this tenure, the military administration actively contributed to the cultivation and reinforcement of profound religious and sectarian divisions within society through legislative measures, persisting as unresolved issues within the broader Pakistani political landscape. Since its inception, Pakistan has manifested itself as an ideologically diverse society, accommodating various political, religious, sectarian, and ideological factions, a characteristic dating back to British colonial rule. However, the Zia-led military sought to impose an ideological homogeneity on Pakistani society, endeavouring to enforce a fundamentalist interpreta-

CBI ensures murder convict sent back to **India from UAE**

Central Bureau of Investigation coordinated the return of a absconding life convict charged with murder from United Arab Emirates, following a detailed operation which involved geo-locating and tracking the suspect through Interpol. The subject was identified as Narender Singh.

The central agency had got a Red Notice issued against him from Interpol's General Secretariat on Nov 7 last year on the request of Haryana Police.

The notice, as per the protocol, was circulated to all member countries for location and arrest of the subject. After the subject was located, the global operations centre of CBI coordinated with Interpol-Abu Dhabi, Haryana Police, Indian Embassy in Abu Dhabi and the ministry of external affairs to initiate the process for his return.

More than 50% of patients face delay in discharge due to time taken to process mediclaim: Study

GURUGRAM: A new lenges encountered by **study from he**althcare provider Pristyn Care found that 5 out of 10 patients face delays in discharge due to the time taken to process insurance claims. To alleviate the hassle experienced by health insurpolicyholders, Insurance Regulatory Development Authority of India (IRDAI) is likely to introduce a 100% cashless hospital network that will include both empanelled and non-empanelled hospitals.The study indicates that over 40% of individuals attribute delays in health insurance claims in India to hospital administrative processes, while 25% cite a lack of coordination between hospitals and insurproviders. Complex documentation procedures also significantly contribute to these delays. Furthermore, the survey under-

patient families throughout the insurance claims process, with nearly 4 out of 10 respondents reporting difficulties with customer support regardthe claims process. The study also found that 6 out of 10 individuals never initiated the health insurance claim process. Among those who did, 34% expressed dissatisfaction with the paperwork, while 40% faced challenges in receiving timely responses from their insurance providers. Roughly 3 out of 10 patients encountered discrepancies between approved and final amounts. Additionally, around 38% of respondents reported that the discharge process took over 8 hours, with hospitals requiring a similar timeframe to process claims. Approximately 4 out of 10 individuals lacked clarity on their policy's terms and

conditions Furthermore, about 18% expressed dissatisfaction with the communication received from their insurance providers regarding claim statuses.

Commenting on the findings, Dr. Vaibhav Kapoor, Co-founder of Pristyn Care, said, "There is a huge gap between the intended ease of cashless health insurance and the reality experienced by policyholders. Despite 75% of survey respondents having cashless insurance, a significant number still face challenges during the claim process. This additional creates stress for patients and families already dealing with a medical emergency. However, it's encouraging to note that insurance providers have already started digitizing and using tech to make the process quick and smooth.

Dramatically raises US tariffs on Chinese EVs and chips

"We're not going to let China flood our market, making it impossible for American automakers to compete fairly," Biden declared in the White House Rose Garden. He's been using similar tactics to win over blue-collar voters in swing Rust Belt states. The White House stated EV tariffs will treble to 100% this year and semiconductor duties will rise from 25% to 50% by next year.

The sanctions targeted \$18 billion in Chinese imports, including batteries, vital minerals, and medical supplies. Biden said China has substantially supported critical sectors, forcing corporations to produce more than the world can consume and flooding the market with unfairly priced commodities. The president's announcement followed a review of tariffs imposed by then-president Trump on \$300 billion in Chinese imports. The Biden administration maintained tariffs.

Beginning on April 30, Canada will only accept petitions for permanent residency linked to ten or fewer startups per approved organization for processing each year.
