He expressed deep concern over the growing global drug trafficking, especially the spread of highly dangerous substances like fentanyl. Fake certificates, false loans: Deception Exposed

BAREILLY /SHAMLI

Two separate cases of financial irregularities involving government benefits and microfinance loans have surfaced in Bareilly and Shamli districts of Uttar Pradesh. In Bareilly's Aonla region, the district administration has confirmed that several married women received widow pensions despite their husbands being alive. According to the official inquiry report submitted by the Sub-Divisional Magistrate, multiple instalments of the pension amount—totalling 1.23 crore—were transferred into the accounts of 56 married women and two ineligible

According to complaints, the operator of a women's selfhelp group allegedly used identity documents of several members to acquire multiple loans from microfinance institutions, including Bandhan Bank and other finance companies. After securing lakhs of rupees in unauthorised loans, the operator reportedly disappeared, leaving the women

liable for repayments. Victims claim that loan

recovery agents are now visiting their homes, demanding instalments and threatening to seize household belongings. One complainant stated that although she had repaid her earlier loan two years ago and declined any new loan offer, she recently discovered a running loan under her name with a monthly instalment of ₹2,800. Another victim alleged verbal abuse and intimidation by agents. As of now, about 15 women have come forward, accusing the group operator of withdrawing multiple loans using their documents.

The complainants have approached police, requesting an official investigation into the alleged fraud and collusion between the group operator and loan agents. Police officials have stated that inquiries are underway and appropriate action will follow based on evidence gathered.

Pilibhit BLOs get reward boost for their role in SIR

The Special Intensive Revision (SIR) of the voter list is underway across Uttar Pradesh, with Pilibhit district introducing unique incentives to encourage improved performance by Booth Level Officers (BLOs). According to an official circular. BLOs who complete the highest number of digitisation tasks during the SIR drive will receive rewards including a jungle safari at Pilibhit Tiger Reserve, family lunch at Chuka Beach, movie tickets, and appreciation certificates.

The SIR campaign began in Pilibhit on 4 November. As part of the exercise, 1,522 BLOs and 52 district-level officers have been deployed. BLOs are door-to-door conducting visits, distributing verification forms, collecting details, and uploading all information digitally. The district administration has prepared a performance-based incentive model to ensure timely completion of digitisation targets.

Officials stated that the first-

ranked BLO from each assembly segment based on the maximum digitisation completed will be eligible for the rewards after the conclusion of the SIR process. The initiative is aimed at improving accuracy in voter list revisions while ensuring accountability in field operations.

The administration has also warned of action against BLOs showing negligence during the campaign. Parallel awareness efforts are being carried out to prevent fraud and misinformation related to SIR formalities.

Historic market under threat: Akhilesh Yadav

Samajwadi Party president Akhilesh Yadav on Friday accused the government of taking decisions that have created a severe livelihood crisis for thousands of traders in Banaras' historic Dalmandi market. Speaking at a press conference at the party office in Lucknow, he said the administration's move was driven political motives rather than heritage protection.

Yadav stated that Dalmandi has long been an important commercial center and holds significant historical value. According to him, local traders have been facing continuous pressure for several years due to widening-related decisions, which he claimed are now

He alleged that officials were intimidating traders in the name of road expansion, citing similar situations in Meerut and Akbarnagar

Traders present during the press conference appealed to the government to withdraw the widening plan, arguing that shifting them to areas such as Lhta or other localities would not be viable due to lack of customer access.

Yadav further said the Dalmandi polling booth has historically shown poor results for the BJP, claiming traders were being "punished" for political reasons. He added that the SP will stand firmly with the traders and that the market, which supports thousands of families, should not be demolished.

Solar Tech gives Gandhi's charkha a modern makeover

A solar-powered spinning wheel drew significant attention at the Khadi Festival that began on Friday at the Central Sanskrit University campus in Lucknow. The upgraded machine, demonstrated during the inauguration, showcased how solar technology is now being used for weaving and thread-making, replacing manual spinning once associated with Gandhi's charkha.

More than 160 entrepreneurs and units from across Uttar Pradesh have set up stalls displaying khadi products, handicrafts, and items produced using both traditional and modern techniques. The festival also features Banarasi sarees, woolen garments, Uttarakhand caps, and

AI maps intestinal

A researcher at Lucknow University has developed an advanced artificial intelligence technique capable of detecting stomach and intestinal diseases at an early stage. The system analyses endoscopy images using a deep semanticsegmentation model that marks affected regions with high precision.

According to researchers involved in the project, the technology can identify even the smallest abnormalities, including polyps, ulcerative colitis indicators, and microlevel tissue changes that are often difficult to detect through visual examination alone. By highlighting these patterns during endoscopic evaluation, the tool supports doctors with a clearer

In her written complaint, the woman stated she had been living in a rented house in Buxar locality, where a man named Pawan Pal allegedly

raped her at gunpoint in 2020 after threatening her children. She claimed the accused continued to exploit her, resulting in pregnancy. She later gave birth to a girl in October 2023. When she revealed the truth to her husband, he ended their relationship. The woman also alleged harassment by the accused's family, including forced signatures on blank papers.

Civil servants are running India's regulatory bodies. It dilutes institutional independence

Looking back at India's reform story of more than three decades, it is worthwhile to recall that economic liberalisation of the 1990s had a few implicit assumptions of how an economy should function and grow on a sustainable basis. One of those assumptions followed from the government decision to allow the private sector to operate in areas that were hitherto monopolised by state-owned enterprises. Under such liberalisation, it was assumed that while the government would continue to frame policies for areas opened up to the private sector, the regulation or enforcement of those policies would be undertaken by independent regulators through rules framed by them. A classic example of this thinking was India's telecommunications sector that was opened up to the private sector in the early 1990s. This was followed by the setting up of the Telecommunication Regulatory Authority of India or Trai a few years later. Subsequently, the business of basic telephone services, run in large parts of the country by a government department, was hived off to a newly created state-owned enterprise. Something similar, in varying degrees, happened in other areas such as the insurance, airports, and power sectors. In addition, the Competition Commission of India (CCI) was set up to regulate and adjudicate upon issues of market dominance and practices that undermined competition in various sectors. The principle was clear: Let the government frame the policy (and not run a business), while independent regulatory bodies could enforce the policy by framing necessary rules. Another implicit assumption behind such a separation of responsibilities between the government and the regulators was about who should steer those regulatory bodies. To impart autonomy and independence to these institutions and insulate them from government interference, the pool of talent for hiring key personnel was widened. Experts and private-sector professionals in related fields, along with even retired members of the judiciary (though under some pressure as was seen when the legislation for setting up the CCI was framed), were among those the government believed could be hired to head these regulatory institutions. Thus, the first chairperson of the Central Electricity Regulatory Commission was an economist. Trai was set up under the chairmanship of a retired judge and its next chairperson was a former banker. Even the first capital market regulator was a banker in the late 1980s, and the first chairperson of the insurance sector regulator was a former chairman of the Central Board of Direct Taxes. The first fullfledged chairperson of the CCI was a retired Indian Administrative Services (IAS) officer. So, there was a mix of regulatory heads chosen from a pool of experts from both the government and the private sector. In spite of a few civil servants heading these institutions, the idea that continued to be pursued was to insulate regulation from the stranglehold or influence of the political executive. The third significant aspect of regulation in the early days of economic reforms was the framing of rules for appointing heads of regulatory bodies in a way that effectively ruled out conflicts of interest. Thus, a regulator would usually not be considered for another job in the government system after the completion of his or her term. The idea was that the regulator should be able to act freely and fairly without any expectation of future assignments from the government or the private sector. Indeed, one of the regulators under the law was, until recently, barred from accepting any government job after having served in that regulatory post. These were guardrails to preserve the integrity and independence of regulators. However, the situation with regard to the last two assumptions behind the regulatory framework has changed significantly in the last few decades.

Can A 'Technocrat' Fix All That's Wrong With BJP In Kerala?

On June 9, 2024, as the Modi 3.0 government was set to swear in, Rajeev Chandrasekhar came up with a cryptic tweet: "Today, curtains down on my 18-year stint of public service, of which three years I had the privilege of serving with PM Narendra Modiji's Team Modi 2.0. I certainly didn't wish to end my 18 years of public service as a candidate who lost an election, but that's how it has turned out". The tweet was deleted after a day, and the amended version conveniently laid the blame for the confusion on an "intern". It was an emotional response, a mark of Chandrasekhar's utter disappointment with not finding a place in Modi 3.0. It also signified how the 'technocrat' was not a run-of-the-mill politician who believed in rehearsed or curated responses. Less than a year since then, the Bharatiya Janata Party (BJP) high command has now sprung a surnaming Chandrasekhar as its new Kerala state president. By no was Rajeev means Chandrasekhar the frontrunner. Incumbent K. Surendran, who overstayed his term by two years, was tipped to get another year's extension, until the assembly elections in the state in 2026. There were other contenders too, such as firebrand Sobha Surendran and veteran MT Ramesh. Even conventional wisdom suggested that social engineering compulsions would go against Chandrasekhar, a Nair hailing from Thrissur. With the two Malayalis in Modi's third ministry being a Nair and a Syrian Christian—Suresh Gopi and Kurian—an



Ezhava/Hindu OBC candidate would've been the more practical option. But the high command had enough reasons to pick Chandrasekhar. The BJP in Kerala is a divided house with multiple factions, and none of the frontrunners would have been able to function smoothly on account of internal dissension. Even K. Surendran's five-year term was marred by friction with the PK Krishnadas-led faction, as well as his running feud with Sobha Surendran. The BJP leadership reckons that Rajeev Chandrasekhar can carry all the factions together. He is not a natural politician, but the central leadership deems that this very characteristic will become Chandrasekhar's USP. It is very much a repetition of the 'K. Annamalai' experiment in Tamil Nadu.

True, Chandrasekhar's acceptability cuts across factions. But there are various other considerations at play. For all the gains it made elsewhere, the BJP has hardly had any electoral impact in Kerala, despite a steady rise in vote share. Even after faring reasonably well in the 2024 Lok Sabha polls, cornering nearly 20% votes and Suresh Gopi's win from Thrissur, it did badly in the Palakkad by-election last November. That loss probably put paid to Surendran's hopes to stay on until the assembly polls, as he had turned the issue into a battle of prestige. The central leadership also cannot quite understand why the BJP does so poorly in a state where the Rashtriva Swayamsevak Sangh (RSS) has the second-largest network of shakhas (branches) in the country. For a long, the RSS in Kerala had been deeply involved in the functioning of the state BJP, though the party's ideological mentor has taken a backseat in recent times. This was meant to afford more autonomy to the state party president, but it ultimately culminated in RSS organising secretary K. Subash's resignation, with the Sangh not naming a replacement in his stead for an extended period.

Now, Rajeev Chandrasekhar's appointment is likely to be followed by the RSS naming an organising secretary to assist the new president in his functioning. The last time the high command named an out-of-the-box candidate as state president was in the run-up to the 2016 assembly polls, when veteran Sangh leader Kummanam Rajasekharan, whose hardliner image and association with the Nilakkal protests of 1982

had proved to be a baggage for the party in the past. The leadership also believes that Chandrasekhar can cater to sections of Kerala's aspirational middle class that are yearning for change and are unhappy with both the ruling Left government and the Congress-led United Democratic Front (UDF).

Since Chandrasekhar doesn't fit the mould of a regular politician, he may be able to connect better with this class and some increasingly 'apolitical' sections of voters that support, say, a Shashi Tharoor. In many ways in fact, it was the spirited contest that he put in against Tharoor in the Lok Sabha election Thiruvananthapuram, despite being a late entrant, that may have propelled Chandrasekhar to the coveted position today. Giving a tough fight to Tharoor, a lot of people were left wondering whether Chandrasekhar could have emerged victorious had he been pencilled in sooner. "Ini Karyam Nadakkum" ('Now things will move') was Chandrasekhar's campaign slogan. This may well be called Chandrasekhar's second coming in Kerala politics. Contrary to what many may believe, the Thiruvananthapuram wasn't

his initiation in state politics, even if he was based in Bengaluru until then. Much before that, he had been a key mediator for getting the Bharat Dharma Jana Sena (BDJS), affiliated to the Ezhava community outfit Sree Narayana Dharma Paripalana Yogam (SNDP), to join the National Democratic Alliance

(NDA) in 2016. That is when Chandrasekhar was named the NDA's vice-chairman for Kerala, despite being a Rajya Sabha MP from Karnataka. Now, he may be expected to act as a bridge to the Christian clergy and cater to their grievances. The Christian community in Kerala has traditionally stood with the Congress, although cracks have begun to appear in recent times. Chandrasekhar may be expected to utilise issues such as the controversy surrounding the Munambam suburb of Ernakulam, where some 600 LChristian and Hindu families are protesting against the Wakf Board's claim over the area. Notably, Chandrasekhar was a key figure in getting veteran leader PC George to merge his splinter party with the BJP. Shone George, the latter's son, is also expected to emerge as an important leader during Chandrasekhar's term. It would also be remiss Chandrasekhar's ownership of Asianet News, which has consistently topped (Broadcast Audience Research Council) ratings for Malayalam news channels. He is the majority shareholder of the news channel through the holding company Jupiter Capital. While some BJP leaders think that with the channel maintaining an independent editorial line Chandrasekhar's business interests may backfire on him, that could be a thin reading of the situation. This view got amplified recently when he had to tweet an apology on account of the channel's alleged slighting of the Maha Kumbh on a news

Before Imamoglu, conservatives from the AKP had ruled Istanbul for 25 years. Erdogan himself owes the foundations of his political career to his mayorship of Istanbul in the 1990s.

Trump should withdraw USCIRF's authorisation. It's interfering in India's domestic governance

In a strongly worded statement, Government of India has condemned and refuted the findings of the US Commission on International Religious Freedom report as "biased and politically motivated, and continuation of persistent attempts to misrepresent isolated incidents and cast aspersions on India's vibrant multicultural society which reflects USCIRF's deliberate agenda rather than a genuine concern for religious freedom". Though this is not the first time such reports have painted India as a coun-

try highly intolerant of its religious minorities, the March 2025 report is the first time a recommendation has been made for India to be designated as "country of particular concern". It alleges that minorities in India are facing 'deteriorating treatment'. Fifteen other countries, including Afghanistan, Russia, China, Pakistan, and Saudi Arabia, have been found to be treating their respective minorities badly. Three aspects of this report should be of concern to New Delhi, and it should be brought to

the attention of those the report is supposedly submitted to. The first is the report's mention of the assassination of separatist Sikh elements in Canada posing as members of the Sikh religious community and the alleged attempt on the life of another Khalistani separatist. "The Indian government also continued to expand its repressive tactics to target religious minorities abroad, specifically members of the Sikh community and their advocates... International reporting and intelligence from the Canadian govern-

ment corroborated allegations linking an official in India's Research and Analysis Wing (RAW) and six diplomats to the 2023 assassination attempt of an American Sikh activist in New York," the report has said. It's important to note that these radical elements do not represent the Sikh community. While the Government of India has categorically rejected the allegation, the Canadian government and the prosecuting authorities in the then Biden dispensation initiated legal actions against Indian

BJP has a new Muslim strategy up its sleeve. Saugat-e-Modi isn't just about Bihar election

the Narendra Modi government has stirred conversation Eid kits for 32 lakh underprivileged Muslims, described as a goodwill initiative timed with the holy month. The offering appears festive, including familiar Eid ingredients such as dry fruits, semolina, vermicelli and sugar. The kits also include kurta-pyjamas for men and suit fabrics for women, all neatly packaged to reach Muslim households before Eid. At first glance, it appears to be a thoughtful cultural outreach by the Bharatiya Janata Party, an attempt to bring warmth and festivity into homes that might otherwise go without. But as with most things in Indian politics, the surface is rarely the whole story. The move hasn't gone unnoticed by political observers. Why this sudden and massive outreach to Muslimsby a party that has so far built much of its narrative on distancing itself from appeasement politics? This is the same BJP whose leaders have routinely criticised political opponents for attending Iftar parties, framing such gestures as opportunistic pandering. And yet, here we are, with the ruling party preparing curated Eid hampers not just for a symbolic few but for over 30 lakh Muslim households. For many, the question is not whether the gesture is kind but why now, and why like this? The BJP's 'Saugat-e-Modi' kits have not only surprised political commentators but also drawn scathing remarks from the Opposition. For some, it's a clear contradiction of the BJP's usual stance on such gestures. But for political analysts watching the timing closely, the move seems less like a change of heart and more like a strategic calculation—with Bihar in mind. The upcoming Bihar assembly election has raised concerns within the BJP that rising Opposition

This Ramadan, a quiet gesture from momentum could impact not just the party, but also its key allies-Nitish Kumar's Janata Dal (United), Chirag Paswan's Lok Janshakti Party (Ram Vilas), and Jitan Ram Manjhi's Hindustani Awam Morcha (Secular). In that light, the Eid outreach feels less like an act of cultural generosity and more like a political buffer—an attempt to soften the blow in a state where coalition math can shift quickly. That analysis may hold some truth—but it also seems to overlook the broader outreach pattern the BJP has been steadily building, particularly toward poor Muslims, Pasmanda communities, and Muslim women. Over the past few years, the party has made targeted efforts to create an opening within sections of the Muslim electorate long seen as distant. In the 2023 urban local body elections in Uttar Pradesh, the BJP went as far as fielding Pasmanda Muslim candidates—a move once considered politically unthinkable. Of the 395 Muslim candidates it fielded, 54 went on to win. These numbers may seem modest when seen in the larger national context, but they speak to a subtle shift in the party's

> One that goes beyond gift boxes and hints at reimagining of BJP's political strategy - at least on the surface. BJP's effort to engage with Pasmanda and poor Muslims isn't new. In UP, Danish Ansari, a Pasmanda Muslim, was appointed as Minister of State for Minority Welfare, Muslim Waqf, and Haj in Yogi Adityanath's second cabinet—which was seen by many as a symbolic but politically significant move. The party and its spokespersons often claim that it was the BJP that made APJ Abdul Kalam the President of India, citing it as proof of its inclusive credentials. Tragic Road Accident: 80-Year-Old Man Dies After Being Hit by **Speeding Motorcycle Near Bidhuna**

IDF uncovers massive Hamas tunnel where Israeli soldier's body was kept

Gaza tunnel 7-km long with 80 rooms

The Israel Defense Forces (IDF) have revealed a sprawling Hamas tunnel complex in the Gaza Strip where the body of Lieutenant Hadar Goldin was secretly kept for years. Goldin was killed during a 2014 ambush in Gaza, and

Israel recovered his remains earlier this month.

According to the IDF, the newly exposed tunnel extends seven kilometres, reaches a depth of 25 metres, and contains around 80 rooms—making it one of the most extensive underground networks discovered in the region.

Video footage shared by the IDF on Thursday shows the tunnel running beneath the densely populated Rafah neighbourhood, passing under a UNRWA compound, clinics, mosques, and kindergartens.

The network reportedly hosted senior Hamas commanders, served as a base for planning attacks, and stored weapons.

The elite Yahalom engineering unit and Shayetet 13 naval commandos led the operation that exposed the complex.

During the raid, Israeli forces also arrested Hamas operative Marwan Al-Hams, accused of involvement in determining

The operation was part of months-long covert efforts to locate and retrieve Goldin's remains. Meanwhile, the Gaza conflict continues to escalate. Israeli airstrikes on Thursday killed five people and injured 18 in Khan Younis. Strikes on homes in Bani Suhaila and Abassan resulted in the death of a baby girl and several civilians.

The violence comes as both Israel and Hamas accuse each other of violating a fragile, nearly six-week-old truce. Since the war began in October 2023, more than 69,000 Palestinians and 1,200 Israelis have been killed.

The war in Gaza began after Hamas-led militants killed 1,200 people, most of them civilians, and took 251 people hostage in an attack on southern Israel on October 7, 2023.

Israel boosts air defences with \$8.7bn along with Iron Dome expansion

Israel signed a multi-billiondollar contract with defense contractor Rafael Advanced Defense Systems to expand serial production of the Iron Dome missile defense system, the Defense Ministry announced on Thursday.

The funding comes from an USD 8.7 billion U.S. aid package approved by Congress in April 2024, with USD 5.2 billion specifically earmarked to strengthen Israel's air defense systems.

The Iron Dome system, developed in Israel and manufactured in collaboration with the U.S. government, provides defense against short- and mediumrange rocket and missile threats, as well as UAV threats. Yoon indicted in Marine death probe

SEOU

South Korea's former President Yoon Suk-yeol has been indicted by a special counsel for allegedly exerting improper influence over the military investigation into the 2023 death of Marine Cpl. Chae Su-geun. Eleven former senior defence and security officials, including ex-spy chief Cho Tae-yong and former Defence Minister Lee Jong-sup, were also indicted.

The special counsel alleges Yoon pressured officials to overturn initial findings that pointed to negligence by Marine commanders, reportedly reacting with anger when briefed on the report. Although indicted without detention, Yoon is already under arrest over separate martial law-related charges and will now face trial for abuse of power and document tamporing

The Marine had died during a search mission amid heavy rains, prompting nationwide scrutiny of military accountability. Yoon denies all allegations.

Ex-CIA officer slams Imran Khan's PTI for apology demand

WASHINGTON DC

The former intelligence officer John Kiriakou claimed that his lawyer had advised him to "keep a low profile" and to be aware of his surroundings. However, he mailed them back and wrote, "In regards to your demand for an apology, I wipe my a** with your demands for an apology."

A controversy has erupted after former CIA officer and whistleblower John Kiriakou revealed that former Pakistan Prime Minister Imran Khan's party, the Pakistan Tehreek-e-Insaf (PTI), tried to coerce him into apologising for comments he made on the conflict between New Delhi and Islamabad. In an intentionally crude reply, Kiriakou wrote that he would use their letter demanding an apology as toilet paper.

Kiriakou made an assessment of the conflict while speaking to ANI in October. He warned that "Pakistanis will lose" and that nothing

good will come out of a war between the two countries.

"Nothing, literally nothing good will come of an actual war between India and Pakistan because the Pakistanis will lose. And I'm not talking about nuclear weapons. I'm talking just about a conventional war," he said.

His analysis did not sit right with the people of Pakistan as a result of which he received online abuse and death threats.

"I said, in a conventional conflict, India would beat Pakistan because it has five times the people. The death threats... I've lost count of how many death threats I received", he recalled in a a YouTube podcast with Julian Dorey uploaded on November 18.

PTI's letter condemned his remarks "in the strongest possible terms" and demanded "an immediate apology" to "his excellency, the former prime minister [Imran Khan], to the members of the party [PTI], and to the people of Pakistan."

Toll in Bangladesh earthquake rises to six

DHAKA

At least six people were killed and several injured as a massive earthquake of magnitude 5.7 jolted Dhaka and parts of the country on Friday, damaging buildings, causing fires at several places and sending panic among residents.

Three people were killed

in Dhaka, while the fourth died in the suburban river port town of Narayanganj, officials said, as local media reported injuries to at least 50 people across the country.

The other two deaths were reported from Narsingdi, where the epicentre was located some 10 kilometres beneath the surface.

The epicentre of the quake that struck at 10:38

am (local time) was at Narsigndi on the northeastern outskirts of Dhaka at a depth of 10 kilometres, Bangladesh's meteorology department said. The place is around 13 kilometres east of the seismic centre in Dhaka's Agargaon area.

Dhaka's deputy police commissioner Mallik Ahsan Uddin Sami said, quoting the fire service, that at least three people were killed after a railing, bamboo scaffolding and debris of a five-storey building fell on them at Old Dhaka's Armanitola

A bystander was critically wounded at the scene in the crowded neighbourhood, he said.

Russia claims full capture of Kupyansk

MOSCOW

Russian forces have taken full control of the strategic northeastern Ukrainian city of Kupyansk, Chief of the General Staff Valery Gerasimov announced on Thursday during a briefing with President Vladimir Putin at a military command post. The seizure of the city, located near the Oskol River, marks a major milestone for Russian operations in the region, offering a significant logistical advantage and enabling further advances westward

Gerasimov reported that Russian troops had "liberated the city of Kupyansk" and were destroying Ukrainian positions along the river's left bank. He added that conditions had been created for Ukrainian troops to surrender, claiming many soldiers were willing to lay down their arms but were being threatened by their own commanders. Ac-

cording to him, Kiev has issued no instructions regarding surrender, leaving troops "under threat of being shot or destroyed by drones" if they attempt it. Putin praised Russian forces, stating that roughly 15 Ukrainian battalions were encircled in and around Kupyansk.

Gerasimov also reported progress on other fronts: the East grouping captured 13 settlements across Dnepropetrovsk and Zaporozhye regions, while the North grouping now controls most of Volchansk in Kharkov Region. In the Donetsk People's Republic, the South grouping continues clearing parts of Konstantinovka.

Ukraine, however, has rejected Moscow's claims as exaggerated. The Ukrainian General Staff insisted that "Kupyansk is under the control of Ukraine's defense forces," denying reports of encirclement or major losses in VolĀ(Pokrovsk).

US threatens to cut weapon supply

WASHINGTON DC

The United States has warned Ukraine that it may halt weapons deliveries and intelligence sharing if Kiev does not agree to President Donald Trump's proposed peace plan by next Thursday, Reuters reported on Friday, citing two sources familiar with the discussions. One source said Washington previously used similar pressure tactics to secure a rare earths agreement with Ukraine.

Kiev acknowledged receiving a new draft peace proposal from the US on Thursday but declined to disclose details. Ukrainian officials said they were open to discussing the plan, which Washington believes could "reinvigorate diplomacy."

According to media reports, the draft includes 28 provisions. Among them are the withdrawal of Ukrainian forces from reZelenskyy says Ukraine faces choice of losing dignity Ukrainian President Volodymyr Zelenskyy warned in a

national address that the country faces one of the most challenging moments in its history as Washington pressures Kiev to consider a U.S. peace plan containing several longstanding Russian demands. The proposal reportedly requires territorial concessions, limits on Ukraine's military, and blocks NATO membership — terms Zelenskyy has consistently rejected. He acknowledged Ukraine may risk losing U.S. support if it refuses but stressed that national interests must prevail. Zelenskyy urged unity at home amid corruption scandals and said next week's peace talks with the U.S. and Russia "will be very difficult."

New York City Mayor-elect Zohran Mamdani's visit to Washington "speaks volumes" that a "communist" is coming to the White House and that US President Donald Trump is willing to meet and talk with anyone, Press Secretary Karoline Leavitt has said.

Mamdani will meet Trump in the White House Friday, the first meeting between the two and also since his victory in the New York City Mayoral election on November 4.

Trump official criticises Mamdani visit

"It speaks volumes that tomorrow we have a Communist coming to the White House, because that's who the Democrat Party elected as the Mayor of the largest city in the country," Leavitt said Thursday at the press briefing in the White House.

She said it is very telling and also "speaks to the fact that President Trump is willing to

meet with anyone and talk to anyone, and to try to do what's right on behalf of the American people, whether they live in Blue States or Red States or Blue Cities, in a city that's be-

Major fire at COP30 venue injures 21

BELEM

A fire at the main venue of the UN COP30 Climate Summit in Belem, Brazil, injured at least 21 people and triggered a chaotic evacuation on Thursday afternoon. The blaze erupted around 2 p.m. in the 'Blue Zone,' which houses negotiation halls, country pavilions, media centres, and offices of top dignitaries. Thousands rushed toward exits as smoke quickly filled parts of the complex.

The Brazilian Health Ministry said 19 of the injured suffered from smoke inhalation, while two experienced anxiety attacks. No burn injuries were reported, and 12 people were discharged after receiving

medical attention. Others remain under observation in Belem health facilities.

Secretary-General

Antonio Guterres, who was at the venue, was swiftly evacuated by UN security. India's Environment Minister Bhupender Yadav and his delegation also exited safely, officials confirmed.

Authorities shut down the

venue for more than six hours to conduct a full safety inspection. It reopened at 8:40 p.m., although the damaged country pavilion area remained closed. The UNFCC later informed participants that the site had been declared fully safe after Brazilian officials restored working conditions and renewed the operating permit.



UK makes citizenship tougher

LONDON

The UK has unveiled sweeping immigration reforms that could require some legal migrants to wait up to 20 years before applying for permanent settlement. Home Secretary Shabana Mahmood said the new rules aim to reward those who "contribute and play by the rules," while easing pressure on public services.

Under the proposal, the standard qualifying period for settlement will double to 10 years, with longer waits for low-paid workers and those who rely on benefits. Health and social care workers could face a 15-year wait, while migrants dependent on state support may wait 20 years. Illegal migrants and visa overstayers may be required to wait up to 30 years.

In contrast, NHS doctors, nurses, high earners, and entrepreneurs could gain settlement in as little as 3–5 years. Only British citizens—not permanent residents—would be eligible for benefits and social housing.

Utqiagvik enters 64-day polar nights

ALASK

Alaska the northernmost city in the United States — has entered its annual Polar Night, bidding farewell to the sun for the next 64 days. The phenomenon, driven by the Earth's 23.5-degree axial tilt, will keep the sun below the horizon until January 22, 2026.

west of Fairbanks, Utqiagvik, home to about 4,400 residents, will not experience complete darkness. Instead, the town will see brief periods of civil twilight each day — a dim blue glow that appears before dawn. Still, temperatures are expected to plunge due to the absence of daylight and heat.

Team India face buoyant SA

Team India would look to avoid an embarrassing and historic series defeat to South Africa when they lock horns in the second and final Test at the Barsapara Stadium in Guwahati on Saturday.

If India's batters were found wanting against some sustained South African spin bowling led by Simon Harmer and Keshav Maharaj, the challenge has been compunded even further this time around with the absence of regular skipper Shubman Gill.

Gill has been ruled out of the Test due to a neck injury sustained during the first Test in Kolkata. India vice-captain Rishabh Pant will be leading the team and will have a massive challenge of dealing with a South African team which has been buoyed by their first Test win in 15 years.

The visiting captain Temba Bavuma has been on an absolute roll as South Africa skipper winning 10 out of 11 Tests played so far and can register his 11th victory as captain in Guwahati.

For India and its head coach Gautam Gambhir, the Test will not just be about avoiding a series defeat but a potential turning point in terms of how they strategize and go about their approach of playing the game.

The decision to play on turning tracks adopted by Gambhir has come in for scathing criticism from all quarters with Indian batters found wanting in executing their skills.

If the pitch at the Eden Gardens turned out to be a damp squib with spinners from South Africa claiming 13 wickets between them and batters from both sides struggling and Bavuma being the only batsman scoring a fifty,

Guwahati will be an unknown entity. Going into a Test match with not knowing what to expect from the pitch is presently a scarier prospect for India and Gambhir given the recent turn of events.

India would hope their batters get their act together be it at the top of the order with the likes of KL Rahul and Yashasvi Jaiswal not firing in the Kolkata Test.

Washington Sundar's introduction as No 3 was being seen in some quarters as the ushering in of a new era by Gambhir. The ploy did not work from a match winning perspective but Washington certainly has the potential and the goods to change the course of the match with his bat as much as he does with the ball.

With the left-handed batter's promotion up the order, India can play four spinners in tandem with Ravindra Jadeja, Axar Patel and Kuldeep Yadav all in the mix. Jasprit Bumrah gave India a rollicking start in the first Test with his ruthless fifer but then things went south for the home team.

Pant feels one-off captaincy not 'best scenario'

The flamboyant Rishabh Pant on Friday admitted that leading in a one-off Test is not the "best scenario" but he is not thinking too much about the challenge that awaits India in the form of a well-knit South Africa in the second Test here.

Pant was handed captaincy after injured regular captain Shubman Gill was released from the squad ahead of the match starting here from Saturday.

"One-off match is not best scenario for a captain but I am thankful to BCCI for giving me this honour. Sometimes, if you think too much about a big occasion, it doesn't help," Pant said at the pre-match press conference. "(I) don't want to overthink. We had a tough first Test and we need to do whatever is required to win the Test," he added.

South Africa lead the twomatch series 1-0 after their memorable win at Eden Gardens, where Gill suffered a neck spasm while batting in the first innings and was hospitalised.

Pant said the team management has already taken a decision on Gill's replacement for the game but did not divulge the name.

"We have taken a decision on who will play in place of Shubman. The person who will play knows he is playing. He added, "I want to be conventional and also blend with out-of-box thinking. Want to have nice balance...We have to keep things simple and the team that plays better cricket will win it.

Rabada ruled out of second Test

Barsapara track better than Eden Gardens, says SA skipper Bavuma

South Africa pace spearhead Kagiso Rabada was on Friday ruled out of the second Test against India as he has not recovered from the rib injury he suffered during a training session ahead of the seriesopener.

"Kagiso has been ruled out of the second Test," said Proteas skipper Temba Bavuma while giving an update on the pacer, who also missed the first Test in Kolkata, which the visitors won by 30 runs.

Bayuma hinted that Lungi Ngidi, who has joined the team as a reinforcement, could feature in the Guwahati game, starting Saturday.

"Is there a temptation to play him? Yeah, definitely. That's why he's here. He can do what he can do with the new ball. If there is a bit of assistance with the new ball, especially with the early morning spots, he definitely comes into play." "We'd like to make that decision early on in the morning, but with any player that comes into the squad, comes in with the

Govt will intervene to ensure ISL is **held: Centre**

The Centre on Friday told the Supreme Court that it will intervene to ensure that the country's top-tier football competition -- the Indian Super League (ISL) -- is held and players are not put to any disadvantage.

The All India Football Federation (AIFF), on November 7, said it has not received any bid for the commercial rights of the ISL, marking another setback for Indian football as the submission deadline closed.

In a report to the apex court after an unsuccessful tender process to monetise the ISL, the court-appointed committee led by Justice L Nageswara Rao (retired) has recommended striking a balance between preserving the AIFF's authority and keeping in mind prospective bidders' commercial interests.

The committee submitted a report to the top court after the invitation for bids on the tender floated for the ISL's commercial rights found no takers, which left the sport's national federation in a fix.

Stokes shines for England

Skipper's fifer overshadows Starc's 7/58 as visitors gain advantage

In a chaotic opening day of the Ashes, Ben Stokes (centre) team skittled for 172 before taking a five-wicket haul to give England a first-innings advantage Friday in the first cricket test.

Day 1 lived up to the pre-series hype, with pace bowlers dominating on a sunny day in front of more than 51,000 spectators at Perth Stadium. Mitchell Starc took a career-best 7-58 as Australia bundled England out by the second session. Jofra Archer took a wicket in the first over of Australia's reply to show the five-man England pace arsenal wasn't to be outdone. The home team was 123-9 at stumps, still 49 runs behind.

In terms of wickets - 19 tumbled in 72 overs - the test is almost half over with four days remaining.

England lost wickets at regular intervals but batted with intent, scoring at 5.23 runs per over.

The disjointed Australian batting lineup went in defensively and lost wickets at even more regular intervals, without the flow of runs.
