Parties should have flagged roll errors before polls: EC

NEW DELHI: Amid the ongoing row over special intensive revision and "vote theft" charges, the Election Commission on Saturday said that the political parties should have raised errors in the electoral rolls during the claims and objections period of past elections. The poll body said that it shares electoral rolls with political parties ahead of any elections to correct any mistakes. "It seems that some political parties and their Booth Level Agents (BLAs) did not examine the Electoral Rolls at the appropriate time and did not point out errors, if any, to SDMS/EROS, DEOS or CEOS. Recently, some Political Parties and individuals are raising issues about errors in Electoral Rolls, including the Electoral Rolls prepared in the past,"



"It will help SDMS/EROS to remove the errors and purify the Electoral Rolls

It would have the concerned SDM / EROS to correct the mistakes, if genuine, before those elections," it added. EC also said that it "welcomes" the scrutiny of electoral rolls by parties and voters. "It will help SDMS/EROS to remove the errors and purify the Electoral Rolls which has always been the objective of ECI," it said. The poll body is also scheduled to hold a press conference on Sunday.

the poll body said in an official statement. "The appropriate time to raise any issue with the Electoral Rolls would have been during the claims and objections period of that phase,

which is precisely the objective behind sharing the Electoral Rolls with all political parties and the candidates. Had these issues been raised at the right time through the right channels.

Scorelines reversed after first-ever EVM recount in Supreme Court

JIND: His victory sealed by the first-ever recount of an EVM result in the Supreme Court, Mohit Kumar Thursday took oath as sarpanch of Buvana Lakhu village, 25km from Panipat district HQ in Haryana. In the 2022 panchayat polls, Kuldeep Singh was declared winner and served as sarpanch for 33 months. In the SC-ordered recount, the result was reversed, with Mohit found to have 51 more votes. A bench of Justices Surya Kant, Dipankar Datta and NK Singh directed the Panipat deputy commissioner-cum-election officer to issue a notification within two days declaring Mohit elected and allowing him to assume office immediately.

Aircraft-shaped balloon with Pak airline logo found in J&K

JAMMU: An aircraft-shaped balloon with Pakistan International Airlines' logo on it was found in a forward area of border town Ramgarh in J&K's Samba district on Saturday. Green and white colour, the balloon lay on the ground, a police officer said. "BSF troops manning a forward post found it. They are investigating where it came from," the officer said.

GST 2.0 game changer, will lead to single tax rate': Government sources

NEW DELHI: The Goods and Services (GST) 2.0 is set to be a "game changer" subsequently leading to a single tax rate, news agency PTI reported citing government sources on Saturday. It further slammed the Congress party's "hypocrisy" for claiming credit for the reforms saying it "was not even present in the Parliament when landmark GST law was passed in 2017". Congress leaders have



contended that the Centre was only now moving on a reform they had been advocating for years. Citing Rahul Gandhi's 2018 posts and videos calling for GST changes and a cap at 18%, the party argued that PM Modi's

announcement merely confirmed its long-standing criticism of the existing structure. Prime Minister Narendra Modi during his Independence Day address promised a Diwali gift for the citizens in the form of GST

reforms and lower tax burden. "This Diwali, I am going to make it a double Diwali for you... Over the past eight years, we have undertaken a major reform in GST... We are bringing next-generation GST reforms. This will reduce the tax burden across the country," he said. Following this, the Centre rolled out a draft blueprint for GST 2.0, proposing two primary slabs, 5% for essential items and 18% for most other goods.

'Very special privilege': Jaishankar welcomes RoK FM Cho Hyun to India



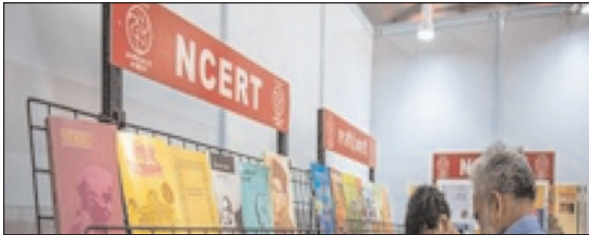

it does not mention all this. The truth is that Partition happened because of the collaboration between the Hindu Mahasabha and the Muslim League. If history has the biggest villain, it is the RSS. Future generations will not forgive the role it

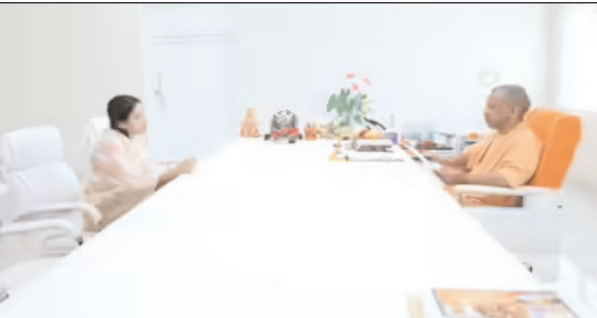

"Everyone knows who murdered my husband (Raju Pal). I want to thank the chief minister for bringing me justice

and hearing me when nobody else did. The CM gave justice to many other women like me in Prayagraj by bringing in policies like zero tolerance that led to the killing of criminals like Atiq Ahmed. Today, the entire state looks at the CM with trust," she had said. "Mere pati ke hatyare Atiq Ahmed ko Mukhya Mantri ne mitti mein milaane ka kaam

kiya' (The chief minister has buried my husband's murderer Atiq Ahmed)," she added. Hours later, Samajwadi Party expelled Pal for "indulging in anti-party activities and displaying indiscipline. "Your anti-party activities have been noted, and despite repeated cautions, you continued these actions, causing considerable damage to the party.

CHASOTI: A two-storey wooden home crumbled in seconds. Boulders roared down the hillside, mud and water swallowed fields at

down," said 26-year-old arts student Piyr Singh, who fled into maize fields as his house

collapsed behind him. By the time silence returned, his uncle and cousin were dead, two visiting pilgrims missing, and his family in shock. "My brother kept touching me, asking, 'are you alive?'" Singh said. Chasoti is now rubble. Flash floods following a cloudburst killed Thursday at least 60 people, injured 160, and left up to 70 unaccounted for.

After India, China next to feel US' secondary tariffs over Russian oil?

New Delhi: US President Donald Trump said on Friday (local time) that he does not see an immediate need to impose retaliatory tariffs on countries like China for purchasing Russian oil, but cautioned that such action could be taken "in two

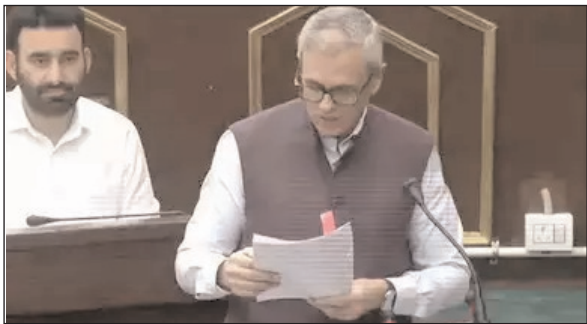


or three weeks," Reuters reported. Earlier, Trump had announced a 25% additional tariff on India

for buying Russian oil, accusing New Delhi of supporting Moscow's 'war machine.' After Trump's secondary tariffs, total duties for Indian exports to the US now stand at 50%. Trump has repeatedly threatened sanctions on Moscow.

Kashmir Press Club bungalow given to J&K Police, CM Omar tells assembly

SRINAGAR: Even as the Omar Abdullah govt has promised its revival, the Kashmir Press Club (KPC) is unlikely to be reopened at the govt building in Srinagar's Polo View market, from where it operated before being shut down in Jan 2022. The bungalow that housed KPC has been handed over to Jammu and Kashmir Police, CM Omar told the J&K assembly on Omar, however, assured that his govt was committed to providing a "suitable space" to the press club in Srinagar to enable it to function effectively. "A free independent and responsible press is the cornerstone of a vibrant democracy," he said, adding he would take concrete steps to "revive and support the press clubs in Jammu and Srinagar, providing a dedicated space for journalists". "We want that no media person should face any issues for speaking the truth," the CM told the assembly.



In a written reply to a question by PDP legislator Waheed Parra, Omar informed the assembly that the bungalow at Polo View market had been given to the media in 2018 on the verbal directions of then CM Mehbooba Mufti. Thereafter, the building was designated as Kashmir Press Club. The then govt had not issued any formal orders for this allotment, Omar said. After KPC's shut-down, govt took over the building. In 2022, an "important building of the police department", which housed the office of east Srinagar SP (city), among others, was gutted in a fire. Initially, these offices were allowed to function from the closed press club building on

a temporary basis. In 2023, the administration allotted the bungalow to J&K Police's Special Investigation Agency, the chief minister said. Parra had asked govt about the reasons for not restoring the KPC at its "allotted, authorised building". He had also asked about the measures taken by govt to get back the building from the police. Since the start of the budget session, talks of revival of KPC has gained momentum, with opposition PDP pressing govt over the issue. On March 22, Omar had said in a social media post that the press club would be revived, and "efforts being made to politicise it shall be defeated".

Akasa Air pilots demand DGCA audit amid training concerns

NEW DELHI: A group of Akasa Air pilots continues to express discontent over alleged training concerns and seeking a thorough DGCA audit following the regulator's decision to suspend two senior officials. Additionally, the pilots have informed the civil aviation ministry and DGCA about their plans to establish a pilots' union. The Directorate General of Civil Aviation has issued 10 showcase notices to the airline recently for various alleged irregularities. Meanwhile, the airline has not responded to queries regarding these matters. The airline previously dismissed claims



about pilot training practices and attrition as unfounded when these issues were raised by certain pilots earlier this month. On December 27, the DGCA suspended Akasa Air's directors of operations and training for six months due to training deficiencies. The pilots have noted that the suspended director of operations maintains the position of vice-president of operations.

The airline, operational for over two years, maintains a fleet of 26 aircraft and employs approximately 870 pilots. Several pilots reportedly face insufficient flying hours due to slower-than-expected fleet expansion. Akasa Air had earlier stated that 324 pilots had joined since October 2023, with an annualised attrition rate below 1 per cent for this category of staff.

PoK man arrested along LoC in J&K's Rajouri

JAMMU: An intruder from Pakistan-occupied Kashmir (PoK) was arrested along the Line of Control (LoC) in Jammu and Kashmir's Rajouri district Tuesday, officials said. "The man was identified as Mohammad Yaqoob, a resident of Suhana Kotli



in PoK. He had sneaked into the Indian side by crossing over the LoC in Keri sector when alert

troops arrested him. He was taken into custody for questioning," said an official. "No incriminating material was found in Yaqoob's possession. He was found intoxicated at the time of arrest," the official said. Further investigation was underway.

HC raps J&K govt over appointment of IAS officer named in arms licences scam to key post

JAMMU: The Jammu & Kashmir and Ladakh high court has expressed strong displeasure over the appointment of an IAS officer against whom CBI has sought prosecution sanction in the arms licences scam case as the commissioner/secretary of the General Administration Department (GAD). Questioning the appointment of M Raju, whose name figures in the CBI chargesheet in the case, a division bench comprising Chief Justice Tashi Rabstan and Justice M A Chowdhary asked, "Is there dearth of honest/upright IAS officers in J&K?" The bench told



additional advocate general (AAG) Raman Sharma, who appeared for GAD, that the commissioner/secretary should be immediately removed. During the hearing, advocate Sheikh Shakeel Ahmed, representing the petitioners, submitted that GAD was deliberately sending incomplete proposals to ministry of home affairs (MHA) and department of

personnel and training (DoPT) for prosecution sanction against some high-profile bureaucrats in a bid to shield them. MHA had earlier this month pointed out deficiencies in the proposals sent by J&K administration on Dec 27, 2024, seeking prosecution sanction against three IAS officers — Yasha Mudgal, Shahid Iqbal Choudhary and

Neeraj Kumar — and had asked the UT to furnish complete documents within a week. Earlier, in a communication to the J&K chief secretary on Feb 12, MHA had said the proposals for grant of prosecution sanction against M Raju (posted as Kargil DM at the time of committing the alleged irregularities) and Prasanna Ramaswamy G (former Leh DM) might be forwarded to the ministry with the administrative approval of the Ladakh LG. Taking serious note of the delays, the bench directed the J&K administration to file an action taken report on MHA's communication dated Feb 12.

Lone walks out over 'UT' mention in J&K bill, CM puts onus on Centre

SRINAGAR/JAMMU: Opposition MLASajad Lone walked out of the J&K assembly Tuesday objecting to the words "J&K UT" (Union Territory) in the first bill brought and passed by the Omar Abdullah-led National Conference (NC) govt, saying it endorsed the "catastrophic event" of Article 370's abrogation. Peoples Conference member Lone was joined by PDP MLA Waheed Parra, who argued that the bill to "normalises the Aug 5 (2019) changes by putting a stamp" on them. CM Omar assert-



ed that J&K was a "UT, whether we like it or not" and would remain so "until Parliament gives us back our statehood". "Therefore, let us not do politics over something like this," the chief minister said. Sometime after Lone left, the assembly witnessed chaotic scenes after leader of opposition, BJP's Sunil

Sharma, demanded a response from the govt on demands for regularisation of protesting daily wagers working in the PHE department for a long time. Upset with deputy CM Surinder Choudhary's answer that BJP had failed to resolve the issue in the last decade, all saffron party MLAs walked out.

India, China hold 'positive, forward-looking' talks for border management

India, China hold 'positive, forward-looking' talks for border management; Doval & Wang to meet in India. India and China hold positive talks for border management.



As India and China look to reboot ties, building upon a spell of relative calm in the border areas, they held another round of diplomatic talks in a "positive and constructive" atmosphere, seeking ways to advance effective border management. The talks also prepared ground for another meeting of the Special Representatives, Ajit Doval and Wang Yi, that India will host later this year.

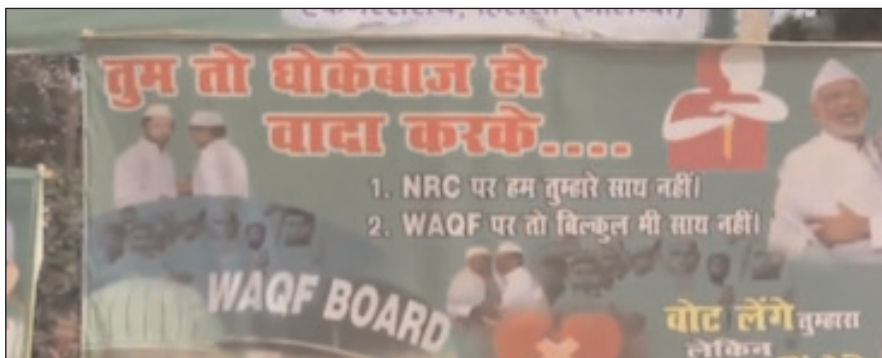
A team led by MEA joint secretary (East Asia) Gourangalal Das, which travelled to Beijing this week for what was the 33rd meeting of the Working Mechanism for Consultation & Coordination on India-China Border Affairs

(WMCC), comprehensively reviewed the LAC situation, stressing peace and tranquillity on the border is critical for the smooth development of overall bilateral relations. China said the meeting was held with a "forward-looking approach" and both sides agreed to take "concrete and effective" measures for maintaining peace and tranquillity in the border areas. According to the Indian readout, they exchanged views on early resumption of cross-border cooperation and exchanges, including on trans-border rivers and Kailash-Mansarovar Yatra. Interestingly, the Indian readout did not

mention the resumption of direct air services, something which India had agreed to "in principle" during foreign secretary Vikram Misri's visit to Beijing in January. China is keen on resumption of direct flights, but India apparently doesn't want to rush into it. Official sources, however, said technical authorities are working to reach an updated framework for the resumption.

"The two sides explored various measures and proposals to give effect to the decisions taken during the 23rd meeting of the Special Representatives on the India-China boundary question in Beijing in

'Dhokhebaaz' poster targeting Nitish over bill appears outside Rabri home



NEW DELHI: Bihar chief minister Nitish Kumar, facing a "boycott" by Muslim groups for supporting the central government's Waqf (Amendment) Bill, 2024, was targeted in a poster put up outside the residence of Rashtriya Janata Dal (RJD) leader and Bihar's former chief minister, Rabri Devi. The poster, put up by RJD member Sanju Kohli, accused Kumar of betraying the Muslim community on multiple issues, including the Waqf Bill and the National Register of Citizens (NRC).

Using lyrics from a 1996 Bollywood film "Saajan Chale Sasural," the poster labeled Kumar a "dhokhebaaz" (deceiver) who takes Muslim votes but fails to support their interests.

The JD(U) is a constituent of the Bharatiya Janata Party-led National Democratic Alliance (NDA), the country's governing coalition. The NDA governs Bihar as well. Kumar's support is crucial for the BJP as the latter lost its parliamentary majority in Lok Sabha polls last year. The poster, meanwhile, comes

two days after the same RJD leader, in another poster outside Rabri Devi's residence, targeted Kumar for not standing in attention while the national anthem was going on. In a video which went viral, the Bihar CM was seen talking and making gestures while the anthem was being played at an event in state capital Patna. Bihar is scheduled to hold assembly polls later in the year. The election will be a straight contest between the NDA and the RJD-led opposition Mahagathbandhan (Grand Alliance).

'Told me about 36 hours of continuous duty': Psychiatrist

NEW DELHI: A psychiatrist claims the RG Kar Hospital rape-murder victim consulted him for mental distress a month before her death, revealing severe work pressure and hospital irregularities. The victim had exposed issues in the procurement of medicines, leading to victimisation. The primary suspect, Sanjay Roy, received a life sentence, while the CBI continues its investigation. 'Told me about 36 hours of continuous duty': Psychiatrist claims RG Kar victim suffered acute stress. A psychiatrist consultant claimed on Monday that the RG Kar hospital victim, who was raped and murdered, had consulted him for mental health issues approximately one month before her death on August 9 last year.

Dr Mohit Ranadip said that the 30-year-old medical professional experienced severe mental distress due to extended working hours, unfair shift allocations, and her awareness of irregularities within the state-operated hospital. During an interview with a prominent Bengali television channel, the psychiatrist expressed his willingness to provide testimony to the CBI, which is investigating the rape-murder case. PTI quoted Dr Ranadip as saying, "She had told me about 36 hours of continuous duty, discrimination in allotment of shifts in the roster, and the acute mental pressure she was in as she had seen many irregularities in the purchase of medicines and medical equipment. I asked her if everyone was given similar shifts, she replied in the negative." The mental health specialist said the post-graduate trainee (PGT), was expected to return for additional counselling sessions, but unfortunately, this never materialised. Previously, the victim's parents and some colleagues had indicated that she faced victimisation for exposing certain irregularities in the hospital's procurement.

The developments in naval capabilities must be measured

As India approaches its, the nation has achieved a significant milestone in strengthening its naval capabilities. In an exceptional move reflecting strategic foresight, Prime Minister Narendra Modi recently commissioned three advanced naval platforms in a single day: a destroyer, a frigate, and a submarine. However, in a fast-changing security environment in the Indo-Pacific, the developments in naval capabilities must be measured in a relative context—capabilities of arch rivals and a swiftly evolving security domain, that is. Now, five points need to be underscored in this context. The commissioning of advanced naval platforms highlights India's aspiration to establish itself as a net security provider in the Indian Ocean Region (IOR). Over the years, India's maritime security strategy has significantly evolved. The 2015 Security and Growth for All in the Region (SAGAR) vision reflects India's dedication to fostering regional cooperation in the Indo-Pacific. This vision is supported by initiatives such as the Indian Ocean Rim Association (IORA) and the Indian Ocean Island Countries (IOIC), which emphasise coastal connectivity and sustainable development. PM Modi's address at the 2018 Shangri-La Dialogue further reinforced India's strategic perspective for the Indo-Pacific. The SAGAR vision has gained traction through frameworks such as the Indo-Pacific Oceans Initiative (IPOI) and the Information Fusion Centre for the Indian Ocean Region (IFC-IOR), aiming to tackle regional security issues and counter China's expanding influence. While China's People's Liberation Army Navy (PLAN) has grown to become the world's largest by fleet size, it still lacks the operational capabilities and combat experience of the United States. India's navy, although the smallest of its armed forces, has consistently demonstrated efficiency and timely acquisitions. Compared to the Indian Air Force, which faces critical squadron shortages, the navy pragmatically acknowledges domestic limitations in engine development. It relies on foreign collaborations to fill gaps, ensuring progress. However, I'll turn to that later. To establish itself as a net security provider, the Indian Navy must sustain the momentum it has recently achieved in naval defence exports. Although this initiative began in earnest only in 2011, it gained significant traction after 2016. India has transitioned from being a cautious supplier of naval equipment, primarily targeting countries such as Mauritius, Sri Lanka, and the Philippines, to a more prominent player in defence exports. For many years, India's exports to nations such as Seychelles, the Maldives, Mauritius, and Sri Lanka were limited to refurbished ex-navy and coast guard vessels. However, this trend has undergone a remarkable transformation in recent years. Naval ships, as of 2024, account for over 61 per cent of India's total defence exports. This shift highlights India's growing capability to manufacture advanced platforms and its determination to emerge as a dependable supplier of defence equipment to neighbouring countries. This development is a critical component of India's regional and maritime strategy, especially given China's rapid ascent in modernising PLAN and expanding its influence in the Indian Ocean by providing naval assets to smaller nations. China has already established itself as the leading defence exporter to both Pakistan and Bangladesh. It delivered two Ming-class submarines to Bangladesh in 2017, gifted a P625 frigate to Sri Lanka in 2019, and committed to exporting Yuan-class submarines to Thailand. Although the Thai deal encountered difficulties when Germany refused to supply key propulsion components.



The Union government's capital expenditure

The Union government's capital expenditure (capex) continues to be a cause for concern. Of course, the extent of its decline has reduced somewhat — from 35 per cent at the end of the first quarter of the current financial year to 15 per cent at the end of six months. But the latest number for the April-November 2024-25 period shows that the Union government's capex was still 12 per cent lower than what it was in the same period of 2023-24. Instead of aiming for the targeted 17 per cent growth to ~11.11 trillion in capex for 2024-25, the government will have to strive hard to at least cross the figure of ~9.48 trillion reached last year. What has led to this decline? A widely held view is that the seven-phase general elections, which began on April 19 and ended on June 1 last year, caused a slowdown in capex. But if that indeed is the reason, the decline in capex in the first quarter should have been reversed in the second quarter of 2024-25. And certainly, the first two months of the third quarter should have raised the trajectory of capex growth to a higher level. There has been some improvement, but a 12 per cent decline in the April-November 2024-25 period is no comfort. Look at the slightly different trajectory seen in the Union government's revenue expenditure growth during the same period. The Budget for 2024-25 had projected a rise of over 6 per cent to ~37.1 trillion in revenue expenditure. At the end of June 2024, the growth was just about 2 per cent, but it has



been rising since then, reaching 4.2 per cent by the end of the first six months of 2024-25 and climbing even higher to 7.8 per cent during April-November 2024-25. So, if revenue expenditure has gained momentum, why has capex failed to follow suit? A close analysis of the government's capex numbers presents an interesting picture. Over 90 per cent of the Centre's total capex during 2024-25 was accounted for by just six sectors — roads, railways, defence, telecom, transfer to states and new schemes. Their share in total capex in 2023-24 was a little less at 87 per cent. But the 12 per cent decline in the first eight months of 2024-25 is primarily the result of a marked slowdown in only two of these six areas — roads and defence, which accounted for over 40 per cent of the total capex outlay for 2024-25. Capex on the construction of roads and highways fell by 16 per cent, while defence saw a decline of 15 per cent. This is serious and has worrying implications for both infrastructure and defence. The problem of slowing expenditure in

these two areas should not have been difficult to fix. Either effective monitoring of spending is lacking, or there are serious problems with project execution, reflecting the poor expenditure-absorbing capacity of these two sectors. This is borne out by a relatively good performance of the Indian Railways, which accounts for over 22 per cent of this year's capex. At ~1.68 trillion, the Indian Railways' capex is just about 1 per cent lower than its spending during April-November 2023. With regard to the transfer of special assistance as loans to states for their capex and additional central assistance for their externally aided projects, the Union government's performance was slightly better. In the April-November 2024-25 period, these transfers rose by about 5 per cent, although much lower than the budgeted increase of 41 per cent. In contrast, such transfers during the entire 2023-24 had risen sharply by about 24 per cent to ~1.15 trillion. It appears that these transfers will take a hit in the current year and for

the first time since this initiative to help states boost their capex was undertaken a couple of years ago. Significantly, this has not yet adversely impacted the states in a big way. The capex of 25 states (accounting for 95 per cent of all the states' and Union territories' total capex budget) has risen by just about 1 per cent in the April-November 2024-25 period, although states like Andhra Pradesh, Himachal Pradesh, Kerala, Mizoram, Odisha, Telangana, Uttar Pradesh, Uttarakhand, and West Bengal saw their capex fall by varying margins. Eventually, however, this will have an adverse impact on the states' capex programme and its growth-enhancing effect. There are two more sectors that account for another 13 per cent of the Centre's capital expenditure budget. But they bring out an intriguing aspect of why the government's capex has been slowing. They suffer from a peculiar problem, which has nothing to do with either the relevant sectors' expenditure-absorbing capacity or the absence of effective expenditure monitoring. The bulk of the capex under telecommunications was meant for infusing equity into state-owned Bharat Sanchar Nigam Ltd, or BSNL. Of the total capex of ~0.84 trillion, the proposed amount for BSNL's equity infusion accounted for as much as ~0.83 trillion. But the total expenditure under this head in the first eight months of 2024-25 is only 6 percent of what has been budgeted. In other words, a decision to transfer the equity amount promised to

BSNL would increase the government's capex by a significant margin. Why this money has not been transferred is puzzling. Last year, against a budgeted BSNL equity infusion of ~0.53 trillion, the actual infusion was higher at ~0.65 trillion. This year, no action on this front even after eight months is a puzzle as this failure also contributes significantly to the decline in the Centre's capex. More importantly, the Budget for 2024-25 had allocated a significant amount of ~0.66 trillion for capex on central sector schemes and projects. Of this, a large chunk, estimated at ~0.62 trillion, was earmarked for new schemes that the government would announce during the year. However, in the first eight months of the current year, only 4 percent of that total outlay has been used up, leaving ~0.63 trillion yet to be spent. It is likely that the government may not need this amount or it may have kept its powder dry to meet any new schemes that it might announce later in the year, for which such capital allocations will be useful. For the Union finance ministry, currently busy preparing the Budget for 2025-26, such a state of play with regard to slowing capital expenditure could well be an opportunity.

With tax revenue growth slowing in the last few months, the apossibility of an upside earlier expected on the revenue front may be receding rapidly. Revenue expenditure is also rising at a rate higher than the budgeted 6 per cent. If the fiscal deficit target of 4.9 per cent of gross domestic product (GDP) has to be met.

Will Israel-Hamas Ceasefire Really Lead To Peace?

The right-wing parties in Israel's ruling coalition also threatened to bring down the Netanyahu government if he agreed to a ceasefire deal. Indeed, one right-wing leader, Ben Gvir, has openly admitted to successfully blocking previous attempts. Trump's pressure to agree to the ceasefire has come as a shock to right-wing Israelis, who hailed his election victory in November. In his first term, Trump moved the US embassy from Tel Aviv to Jerusalem and recognised Israel's sovereignty over the Golan Heights, a Syrian territory occupied by Israel after the 1967 war with Arabs. When Trump announced the appointment of an Evangelical Christian Mike Huckabee as his ambassador to Israel, many right-wing Israelis were thrilled, particularly those who wanted new Israeli settlements in Gaza. Huckabee is on record saying there is no such thing as the West Bank or the occupation. So, why has Trump pushed for the ceasefire? Apart from taking cred-

it for ending one of the most brutal wars in recent history, Trump may like to focus on larger issues, like relations with China and ending the Russia-Ukrainian conflict. In the Middle East, he wants Saudi Arabia to recognise Israel, which will be a huge achievement of his administration. With the continuing war in Gaza and the terrible sufferings of Palestinians at the hands of Israel, Saudis could not afford to consider having diplomatic ties with Israel. But Trump is unpredictable, which is also a reason for both Hamas and Israel to accept the ceasefire deal. Turkey, Egypt and Qatar—the host of ceasefire negotiations—pressured Hamas to accept the agreement. And while Netanyahu may have defied Biden for so long, he could not do the same to Trump and must keep him on his side. Starting on Sunday, January 19, the ceasefire will last 42 days. It will see the exchange of 33 Israeli hostages detained by Hamas and Palestinians held in Israeli prisons.

A tiny, grimy bookstore in the sub-urban town of Ambala cantt. Indicating a flashback call of the Indians' live through passion for reading. From the decades the stall, English Book Depot—since 1923 comparable to an ocean, has been an essential part of the life of the academics and the passionate students. Its owner, took enchanting in preferring the ideal book to every reader, and its shelves were stack high with everything from traditional texts to current best-sellers. For years, students would flock English Book Depot, where they would spend long hours reading poetry, novels, and textbooks in search of wisdom, knowledge and comfort.

This could call for developing book zones and reading competitiveness that use social media to build a feeling of community, or integrating digital media into reading habits, such as interrelated e-books etc. We can provide youngsters in disclosure the gratification of losing themselves in a good book by making reading more welcoming and absorbing. "Books are not just about reading; they are about happening life through the eyes of others," as English Book Depot proprietor often plight. Books continue to be a authentic source of knowledge and inspiration in a world that is changing all the time. Even as we adjust to virtual world, we have to work to manage and maintain this thoughtfulness and knowledge.

The owner of English Book Depot portrait serves as a nudge of the timeless impact that books have on human life. The benefit of reading never goes out of swing, even though our approach of collecting information may.

It is imperative to ensure in mind the teachings learnt from the history as we bargain the complexity of the digital era and ensure that both Gen Z and elderly continue to enjoy books. In the dominating era of social media, where focus spans are shorten and digital content rule prominent, the excitement of books looks like to be vanish from Generation Z. Tulip's resignation in the UK is troublesome for Hasina. Spotlight on daughter Saima

The sins of fathers shall be visited upon the sons—this ominous pronouncement in the Bible has now come true for Tulip Siddiq, a 42-year-old minister in the British government, but with a twist. In her case, it wasn't her father's sins that visited upon her but those allegedly committed by her aunt, the deposed prime minister of Bangladesh, Sheikh Hasina Wazed. And it cost Siddiq her job. Slapped with a range of corruption charges by Bangladesh's Anti-Corruption Committee (ACC),

which forced an internal government inquiry, Siddiq has strenuously denied any wrongdoing—except that of ignorance about benefiting from dubious transactions. But she has paid the price and resigned as UK treasury minister on Tuesday, though she stressed that an independent review found she had "not breached the ministerial code". If the sins of aunts can impact nieces, then can daughters escape their mothers'? Ever since Siddiq's case hit the headlines, the spotlight has slowly but surely turned

to Sheikh Hasina's daughter, Saima Wazed, also known as Putul, who was elected regional director of the World Health Organisation's Southeast Asia branch amid considerable controversy in February 2024. An editorial in the eminent medical journal The Lancet had earlier questioned if she was fit for the job, as she only held a master's degree in psychology while rival aspirants were doctors with years of public health experience. The ACC has now initiated a probe into how she got the job: on her

own merit or her mother's intervention as prime minister. All eyes are now on Putul and whether she'll be forced to follow in her cousin's footsteps. What does it all mean for 77-year-old Sheikh Hasina, who has been sheltering in New Delhi since fleeing Dhaka on 5 August after a violent student uprising against her 15-year continuous tenure as Bangladesh's prime minister? There is no doubt that the charges being hurled at her, her family, and her friends are coloured by political prejudice from those now in power.

Spending on gaming in small towns has increased 16 times in the last five years



Delhi: According to a Visa white paper on payments, spending on online gaming increased 16 times in smaller areas between 2019 and 2024. The pattern indicates that digital consumption is becoming more and more prevalent in India's non-metropolitan regions. Spending on digital services, such as gaming, online education, and entertain-

ment, has increased ninefold and sixteen fold since 2019, respectively, among consumers in smaller towns. In smaller towns, the number of consumers spending more than Rs 2 lakh a year with a single card has increased by over four times, while in category A cities, the figure has increased by 1.4 times. This change has led to a 175% increase in total card

expenditure in category C+ cities since 2019 and suggests that affluence is spreading outside of metropolitan areas. According to Niko Partners' India Market Report, the country's video game market is predicted to develop at an annual rate of 11.1%, surpassing \$1 billion in 2025 and reaching a valuation of \$1.4 billion by 2028.

Gold loans rise 50% in seven months

Delhi: Bank loans against gold jewelry rose 50.4% in the first seven months of the year. Despite single-digit growth in every other personal loan area, credit rose sharply. RBI issued sectoral deployment of bank credit Gold loans totaled Rs 1,02,562 crore in March 2024. Growth was 56% year-over-year, up from

13% in October 2023. NBFCs' move and a preference for secured loans over unsecured ones contributed to the first-seven-month gold loan surge, bankers said. Bank loans to NBFCs fell 0.7% to Rs 1.5 lakh crore in the first seven months. Bankers also said that rising gold prices allow borrowers to repay previous loans

and get higher new ones. Analysts see rising gold loan demand as an indication of financial instability. RBI ordered banks and financial companies to review and fix their gold loan rules and procedures within three months last month. After an examination, evergreening was found to hide bad loans.

Union education minister to head TISS Society, Tata Trusts to have 1 member

MUMBAI: The Union education minister will soon be the chairman of the new Tata Institute of Social Sciences (TISS) Society. The executive council of the premier institute, which will replace the governing board, will be chaired by the vice chancellor and will have four nominees of the education minister and academic representatives from TISS. Tata Trusts, which had two senior members on the governing board, will now have only one member in the society. TISS Society will facilitate the functioning of TISS, while the executive council will have the power of management and administration. The norms are in line with



those of regulatory bodies in central universities. Last year, Centre had decided to bring

all institutions that receive over 50% govt funds under its jurisdiction. TISS, a centrally

funded deemed-to-be university, has, therefore, been brought under govt's ambit. The drafting of a new memorandum of agreement (MoA) had been pending for some time. The executive council, as per the proposed MoA, will replace the governing board of the institute.

The agreement said the institute will be fully funded by govt. Earlier, the institute was managed by Tata Trusts and the governing board had a nominee of the trust as its chairperson. But, for some time, Tata Trusts has been funding only a few projects, under which there are ad hoc teaching and non-teaching positions in the institute.

NEW DELHI: The Bombay high court on stayed a special court's order directing FIR against ex-Sebi chairperson Madhabi Puri Buch and five other officials for alleged stock market fraud and regulatory violations. The stay to remain in place for four weeks. A single bench of Justice Shivkumar Dige said the special court order of March 1 was passed mechanically without going into details and without attributing any specific role to the accused. "Hence, the order is stayed till next date.

Four weeks time is given to the complainant in the case (Sapan Shrivastava) to file his affidavit in reply to the petitions," the HC said, according to news agency PTI.

The case stems from a complaint by media reporter Sapan Shrivastava, who alleged large-scale financial fraud and regulatory violations during the 1994 listing of a company on the BSE.

Most Indians avoid internet purchasing this holiday due to delivery delays and return hassles



Delhi: FarEye's holiday shopping poll found that not everyone is ready to spend online. Nearly 60% of shoppers would avoid online shopping this holiday season due to shipping delays and return issues. The survey of 1,000 Indians found that 41% plan to shop from e-commerce merchants during the holidays, but nearly 60% do not owing to delivery delays and returns issues. Poor delivery terms are causing 63% of shoppers to leave carts, and 54% predict delays during the holidays. Powered By "Consumers are frustrated with getting their deliveries on time, every time, and don't want to pay extra for returns or faster delivery," said FarEye co-founder and COO Gautam Kumar.

Your favorite Tupperware is bankrupt



Delhi: After years of declining sales and rising competition, Tupperware Brands Corp filed for bankruptcy. Tupperware, a public company, filed for Chapter 11 bankruptcy with \$500 million to \$1 billion in assets and \$1 billion to \$10 billion in liabilities. Since 2020, the cookware industry, which dominated food storage for decades, wavered in its viability. The company intended to close its only US operation and lay off over 150 workers in . Tupperware filed for Delaware bankruptcy after months of negotiations with lenders about more than \$700 million in loans.

'EC covering up voter list fraud': TMC's fresh charge

NEW DELHI: Trinamool Congress (TMC) leader Saket Gokhale on countered the Commission of India (ECI)'s claims, accusing the poll body of "covering up" the alleged voter list fraud instead of accepting it. The Rajya Sabha MP claimed the ECI was attempting to brazen out the irregularities instead of accepting "their blunder on the duplicate voter ID fraud issue".

Referring to the parts of ECI's handbook for electoral registration officers, Gokhale alleged that the poll body's clarification was "false", which "contradicted their own rules and guidelines. The TMC leader, in point-by-point rebuttal to the ECI, voiced concern over duplication of Voter IDs, or EPIC. The EPIC (Electors Photo Identity Card) number



is a unique identification number assigned to every registered voter in India by the ECI. It is printed on the Voter ID card and serves as proof of identity during elections. Gokhale, in a post on X, questioned the ECI's claim that EPIC with the same numbers were issued to multiple voters due to certain states using the same alphanumeric series. Citing the poll body's handbook, the TMC leader said Functional Unique Serial Number (FUSN) are different for every assembly constituency and that it was impossible for vot-

ers in two different constituencies, even in the same state, to have the same first three letters in their EPIC. "EPIC card numbers are an alphanumeric sequence of 3 letters & 7 digits. The ECI handbook CLEARLY states that the 3 letters, known as a Functional Unique Serial Number (FUSN) are different for EVERY Assembly constituency. Therefore, it is IMPOSSIBLE for voters in 2 different assembly constituencies (even in the same state) to have the SAME first 3 letters on their EPIC.

'It is for development of all sections': Union minister Giriraj praises

NEW DELHI: Union minister Giriraj Singh on praised the Bihar Budget for 2025-26 and said it is for the development of all sections, and added that sports, college, and medical facilities will be available in all blocks.

Household savings should recover in H1 FY25 as debt eases

Delhi: Early evidence suggests that net household financial savings, which rose to 5.3% of GDP in FY24 from 5% in FY23, will rebound substantially in the first part of FY25. An increase in net household financial savings allows government and enterprises to employ local sources for investment funding, which boosts the economy. Net financial savings peaked at 51.7% of GDP during Covid but fell to 36.1% in FY22 and 28.5% in FY23. The country's financial savings come from households, private and public corporations, and the government. Dropping personal loan liabilities has helped household net financial savings. These divisions have grown slowly due to RBI's crackdown on unsecured personal loans, gold loans, and NBFC lending. In its December 2024 bulletin, RBI reported a small increase in FY24



household net financial savings to 5.3% of GDP, up from 5% in FY23 and 7.3% and 11.5% in FY22 and FY21. A Motilal Oswal Financial Services research forecasts that net household financial savings reached 7.3% of GDP in the first half of FY25, almost double FY24. This improvement was driven by a decline in liabilities to 4.7% of GDP from 6.9% in H1 FY24 and an increase in gross financial savings. Gross financial savings climbed to 11.6% of GDP in FY24, but higher liabilities neutralized the gains, raising net personal

financial savings to 5.3%. Household liabilities were 6.4% of GDP, a 17-year high, barely below FY07's 6.6%. Gross financial savings rose due to insurance savings, fewer currency holdings, and greater capital market investments. However, household debt rose to 41% of GDP in FY24 from 37.9% in FY23. The research estimates household debt grew to 43.5% of GDP in the first half of FY25 from 31-32%. Housing loans make up 30% of household debt, whereas non-housing debt rose to 32.3% of GDP in Q2 FY25.

Government meets 13 India AI businesses for services

Delhi: The ministry of electronics and information technology (MeitY) technical panel met with thirteen companies who bid to deliver AI compute and cloud services under the IndiaAI Mission on Monday. IndiaAI COO Kavita Bhatia led the technical panel, which included MeitY, NIC, CDAC, and two IITs. Thirteen companies were chosen from 19 bidders. Jio Platforms, Tata Communications, CtrlS Datacenters Limited, E2E Networks, Yotta Data Services, CMS Computers, Hostin Services, I2k2 Networks, Orient Technologies, Vensysco



Technologies, CloudThat Technologies, Locuz Enterprise Solutions, and NxtGen Datacenter and Cloud Technologies Bidders had to either have operational AI services on cloud with at least 1,000 AI compute units installed or promise to do so within six months of signing an agreement with IndiaAI. The technical

panel asked organizations about their existing capacity, expected capacity in six months, and availability of compute units or GPUs for the IndiaAI Mission. Nvidia leads GPU manufacture internationally, followed by AMD and Intel, but the technical panel inquired if India will make data center servers and other equipment.

Jio Finance is negotiating its first debt sale

Delhi: Jio Finance, a shadow lender controlled by Asia's wealthiest industrialist Mukesh Ambani, is negotiating with a number of lenders to enter the local currency debt market for the first time.

It is anticipated that the business will enter

the market as early as the January-March quarter, which is normally a busy time for credit expansion in India, either by issuing bonds or loans.

According to those who asked not to be named since the talks are secret, the funds will be

used to lend to industry. They said that the conditions and amount of the loan are still being worked out. The action was taken because the RBI's stricter regulations make it more difficult for shadow lenders to raise bank loans in local currency.

Banks raise FD rates to increase deposits

Delhi: War for deposits continues. Top banks are modifying rates through special tenures, senior citizen privileges, and bulk deposit plans as the financial industry faces a liquidity constraint. IDBI Bank is the latest to raise super senior rates, while Bank of Baroda unveiled a liquid fixed deposit product. IDBI Bank announced the 'IDBI Chiranjeevi-Super Senior Citizen FD' for 80-year-olds. The initiative offers 65bps over the bank's ordinary fixed deposit rates and 15bps over senior citizen rates. An 8.05% interest rate is offered for 555 days, 7.9% for 375 days, 8% for 444 days, and 7.85% for 700 days. From January 13, 2025, the program will apply. Customers can withdraw Rs



1,000 after depositing Rs 5,000 in Bank of Baroda's liquid fixed deposits.

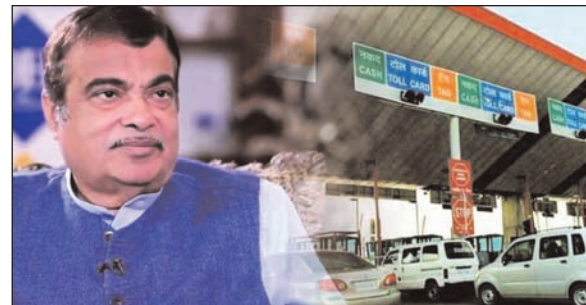
Deposits over Rs 5,000 must be multiples of Rs 1,000. Bulk deposits exceed Rs 3 crore, whereas retail deposits are below this threshold. The deposit tenure is 12-60 months, with

existing interest rates. Seniors and super seniors receive extra interest. Seniors get 0.5% for deposits up to three years and 0.6% for deposits beyond three and five years. Super seniors get 0.1% on deposits over one year.

Direct tax collection increases 20% to 21L cr

Delhi: Non-corporate tax, comprising personal income tax, outpaced corporation tax in the fiscal year up to Jan 12 by about 20% to Rs 20.6 lakh crore. The latest Central Board of Direct Taxes data estimated that refunds rose 42% to Rs 3.7 lakh crore, raising net direct tax revenues 15.9% to Rs 16.9 lakh crore. Corporation tax mop-up jumped 16.5% to Rs 9.7 lakh crore, while non-corporate tax rose 21.7% to just under Rs 10.5 lakh crore. Non-corporate tax payers include people, HUFs, enterprises, and municipal governments.

Delhi: Union road transport minister Nitin Gadkari said that the roads ministry is developing annual and 'life-time' passes for private cars to allow unlimited travel across the NH network for a single toll payment. Private cars account for 60% of NH traffic, but only 20-26% of toll income. Gadkari remarked during a 'Barrierless Tolling in India' workshop, "Private automobiles generate less money. The majority of toll revenue comes from commercial vehicles. To avoid problems, we're



exploring yearly passes. People will be relieved but we will not lose." They stated that the government is developing a plan to handle private toll operators who claim high pass user counts on certain stretches. Primus Partners and Think Infra's thinking paper, released by Gadkari,

claimed that GNSS-based tolling will enhance traffic flow by eliminating delays, lowering travel time by 20-30%, and saving 8-10 minutes each toll station. The environmental benefits include reducing carbon emissions by 50 lakh tonnes and saving Rs 12,000 crore in fuel costs.

Spending on gaming in small towns has increased 16 times in the last five years

Delhi: According to a Visa white paper on payments, spending on online gaming increased 16 times in smaller areas between 2019 and 2024. The pattern indicates that digital consumption is becoming more and more prevalent in India's non-metropolitan regions. Spending on digital services, such as gaming, online education, and entertainment, has increased ninefold and sixteen fold since 2019, respectively, among consumers in smaller towns. In smaller towns, the number of consumers spending more than Rs 2 lakh a year with a single card has increased by over four times, while in category A cities, the figure has increased by 1.4 times. This change has led to a 175% increase in total card expenditure in cat-

In FY25, gross direct tax collection increased by 20%

Delhi: According to official data released, net direct tax collection rose 15.88% year over year to approximately ₹16.90 lakh crore as of January 12 of this fiscal year. Since April 2024, the mop-up from net non-corporate taxes—which primarily consists of personal income tax—has exceeded 8.74 lakh crore.



Approximately 7.68 lakh crore was collected in net corporation

tax between April 1, 2024, and January 12 of current year. As of January 12 of this fiscal year, the net amount collected from securities transaction taxes was 44,538 crore. Approximately 3.74 lakh crore in refunds were given out during that time, a 42.49% rise over the same period last year. According to the

report, gross direct tax mop-up rose 20% to 20.64 lakh crore during that time. In the current fiscal year, the government has allocated 22.07 lakh crore from direct taxes, of which 10.20 lakh crore is collected from corporate taxes and 11.87 lakh crore from personal income tax and other taxes.

Urban Co appoints Kotak, two others for 3,000-cr IPO

Delhi: Hyperlocal services company Urban Company may file draft papers for its INR 3,000 Cr IPO by March. According to insiders, the company would issue new and existing shares in its IPO. It said that the company will mostly raise primary capital. Kotak Mahindra Capital, Goldman Sachs, and Morgan Stanley will manage the process. As revealed last October, Prosus plans to double its investment in the company before its IPO. Prosus wants to fund \$30 Mn (approximately INR 252 Cr) into hyper-local services compa-

Google pulls offline map app from Play Store per government requests



Delhi: Google and Apple removed MAPS.Me offline navigation app from Play and App Store. The app misrepresented India's border. To Google's nodal officer, Priyadarshi Banerjee, the Survey of India (Sol) submitted MAPS.Me a notice under Section 79(3)(b) of the IT Act, 2000, in December 2024. The software misrepresents Jammu & Kashmir and Ladakh, according to the notice. The app's Google Play Store homepage now displays "We're sorry, the requested URL was not found on this server". Sol reportedly provided notice to Google, but since the app is unavailable on Apple's App Store for Indian consumers, it's unclear if Apple was notified. The publisher accessed the letter using Lumen Database. It says: "The maps.me app on Google PlayStore portrays an Indian map with an incorrect external boundary, endangering India's sovereignty and integrity. The Survey of India (Sol) was appointed by the Ministry of Electronics and Information Technology (MeitY) in 2020 to "disable access to incorrect maps of India."

Gold hits new record on Mideast tension as traders



Gold soared to a record high of \$2,696.78 amid Middle East tensions and favorable US economic data, reinforcing bets on Federal Reserve interest rate cuts. Investors are turning to gold for safety due to geopolitical uncertainties and mixed economic indicators. With an impending US election, gold's upward trend is likely to continue regardless of the outcome. Gold climbed to a fresh record amid ongoing tensions in the Middle East as traders also weighed US data that kept alive bets on the Federal Reserve's interest-rate cuts. Bullion touched an all-time high of \$2,696.78 as Israel said it killed Hamas leader Yahya Sinwar, the architect of the Palestinian group's attack on southern Israel that triggered a year-long war in Gaza. Investors typically seek safety in the precious metal in times of geopolitical and economic uncertainty. Data showed US retail

sales strengthened in September by more than forecast in a broad advance. US jobless claims unexpectedly fell after jumping the previous week in Southeastern states affected by Hurricane Helene, according to the latest US Labor Department report. The US economic readings added to a slew of mixed US economic readings recently, reinforcing gold traders' expectations that the Fed will continue its rate-cutting path for the rest of the year. Gold is 1.4% higher this week, with investors repositioning portfolios ahead of the US election on November 5. With both candidates posing different risks to the economy.

it continued. Companies can post internship positions on the PM Internship platform, which started on October 3. In the current fiscal year, 1.25 lakh candidates are anticipated to be covered by the program.. The Corporate Affairs Ministry's internet platform, www.pminternship.mca.gov.in, would be used to carry it out. Internships under the initiative will

begin on December 2 in accordance with the pilot project, which is projected to cost about ₹800 crore. HDFC Bank board okays HDB Financial's Rs 12,500 crore IPO



Delhi: **HDFC Bank's** board has cleared a Rs 12,500 crore IPO for its subsidiary, HDB Financial Services, as part of the company's plan to go public. The decision was made during a board meeting held on October 19, 2024, following previous announcements in July and Sept of this year regarding the offer. The IPO will consist of both a fresh issue and an offer for sale by the bank. The OFS will include shares with a face value of Rs 10 each, aggregating up to Rs 10,000 crore, though this amount may be revised as permitted under applicable law. The fresh issue will amount to Rs 2,500 crore, bringing the total IPO size to Rs 12,500 crore. The proposed IPO size makes it the largest IPO by an NBFC. Last month,

Bajaj Housing Finance had raised Rs 6,560 crore through an IPO. The proposed IPO is subject to market conditions, regulatory approvals, and other considerations. Regulatory clearances are being sought, and the company must adhere to applicable laws, including RBI's scale-based regulations for NBFCs, which require HDB to go public by Sept 2025. Despite the IPO, HDB will continue to operate as a subsidiary of HDFC Bank, in compliance with regulatory guidelines.

Life insurance and Mediclaim exemption suggested by GST panel

Delhi: An official said term life insurance premiums and senior health insurance premiums may be GST-exempt. The GoM that set the GST rate on life and health insurance exempted GST on premiums for health insurance with coverage of Rs 5 lakh for non-seniors. Officials' health insurance premiums over Rs 5 lakh would continue to attract 18% GST.

Mid, small-cap mutual funds attract 30,350 crore on strong returns

NEW DELHI: Mid-cap and small-cap mutual fund schemes have continued to attract strong investor interest, garnering nearly Rs 30,350 crore in inflows during April-Sept of the current financial year, driven by impressive returns delivered by these segments. In comparison, the cumulative inflow into mid-cap and small-cap funds stood at Rs 32,924 crore during the same period last year, according to data from the Association of Mutual Funds in India (Amfi). The inflow trend persists despite concerns raised by market regulator Sebi over heightened inflows into small-cap and mid-cap funds, as experts believe investors will continue to favour these categories for their potential to deliver high returns. "Small caps will continue to grow at a faster rate for years to come. I expect the inflows to continue as Indians want to invest in the high-growth sectors. Small cap funds should be seen as an integral part of one's portfolio allocation and not a tactical play," Trust Mutual Fund CEO Sandeep Bagla said. Individually, mid-cap funds saw an inflow of Rs 14,756 crore and small-cap funds attracted Rs 15,586 crore in the first half of FY25. This aggregates the total inflow to Rs 30,342 crore, the data showed. The strong investor interest in mid-cap and small-cap mutual funds is driven by the potential for high returns in these segments, Tradejini COO Trivish said.



CEO Nithin 'complains' to RBI: Something needs to be done

Nithin Kamath, founder and CEO of Zerodha, has voiced his concerns to the Reserve Bank of India (RBI) regarding the proliferation of fake apps mimicking banks, brokers, and payment apps. Kamath's comments come in the wake of RBI's recent announcement of an exclusive '.bank.in' domain for all Indian banks to combat digital financial frauds. In a post on X, Kamath highlighted the growing threat of cyber frauds, exacerbated by the possibilities offered by artificial intelligence (AI). He emphasised the need for stricter measures to tackle phishing scams and fake apps, which often trick users into providing sensitive personal information. Kamath also praised RBI's initiative but urged for more comprehensive actions, including multi-layered app store policies, real-time AI-based detection, and official app directories to help users identify legiti-



mate entities. Read the post here. The sheer number and variety of digital frauds is astounding. It's fair to assume that things will only get much worse from here, thanks to AI. Both SEBI and RBI are trying to educate people and implement measures to combat these frauds. SEBI has published a consultation paper proposing unique UPI IDs for brokers to ensure that investors transfer money only to SEBI-registered brokers and not to scammers using UPI IDs with broker names. Yesterday, the RBI announced that it would implement the "http://bank.in" domain exclusively for Indian banks, aiming to counter the numerous phishing sites that

mimic legitimate bank websites. Another major nuisance, apart from payment and website fraud, is the proliferation of fake apps that mimic banks, brokers, and payment apps. Something needs to be done about these apps too. This is not the first time Kamath has raised awareness about digital frauds. He has previously advised users to verify information carefully and be cautious of offers that seem too good to be true. Users also agreed with what Kamath has said. India's own GPU could arrive in 3-5 years, 18,000 AI servers

India is gearing up to make a significant breakthrough in high-end computing by developing its own Graphics Processing Unit (GPU) within the next three to five years, while also working on an indigenous foundational Artificial Intelligence (AI) platform expected to be ready in just 10 months. Union Minister for Electronics and Information Technology Ashwini Vaishnaw made these announcements during the Budget Roundtable 2025, organized by India Today and Business Today. In a major step towards AI development, the government will roll out 18,000 high-end GPU-

based computing facilities in the coming days, making advanced computing power accessible to researchers, startups, and academic institutions. This move is crucial for reducing India's reliance on foreign chip manufacturers, particularly Nvidia, which currently dominates over 80% of the global GPU market. With AI becoming a critical driver of global innovation, India's efforts to develop self-sufficient semiconductor and AI ecosystems mark a pivotal shift. This article explores India's GPU development strategy, AI advancements, computing infrastructure expan-

sion, and the broader impact of these initiatives on the country's technological future. Developing an advanced, high-performance GPU requires cutting-edge research, skilled engineering, and robust semiconductor manufacturing capabilities. According to Vaishnaw, India is considering multiple approaches to achieve this goal, including leveraging open-source GPU architectures, acquiring licensed chip designs, and innovating its own GPU technology from the ground up.
