

'Political games' or 'govt prerogative'? **Row over selection of nominees**

NEW DELHI: Did the Centre reach out to parties for names of representatives to be included in its multi-party global diplomacy outreach on war against terror or did it decide the names "unilaterally"? Well, a row has erupted over the selection of names with some parties slamming the government for bypassing party leadership in deciding the representatives. However, the BJP and its allies have slammed those questioning the selections and said this was not about party politics about nation's but interest.While the Congress claims the government indulged in cheap politics as it sought names but ignored party's suggestions, the Trinamool Congress alleged that it was not consulted by the government and the name of its MP Yusuf Pathan was decided "unilaterally."

The Trinamool has withdrawn Yusuf Pathan from the delegation, but the Congress leaders selected by the government will continue to be a part of the govt's global diplomacy outreach. The Congress accused the BJP of playing cheap political games on serious national issues. "India is a democratic country. In Parliamentary system, to form an all-party delegation, names are sought from the parties



and those names given by parties are selected. BJP sought 4 names and we gave it, but you changed those names and selected people as your wish. BJP never comes out of its dirty acts, politics on everything. This was the issue of the nation," Congress leader Pramod Tiwari said. Congress general secretary in-charge communications Jairam Ramesh accused the government of politicising the exercise of choosing leaders for the delegations and having "malicious intent" with only one out of four Congress leaders nominated by the party making the cut.Taking a swipe at Prime Minister Modi, the Congress general secretary said the same prime minister who had abused the Congress publicly in countries such as

Australia, the US, South Korea and China, was taking the help of the opposition party in these delegations.Later, in a post on X, Ramesh said, "After 11 years of abusing and defaming the Opposition --especially the Congress -- the prime minister is now forced to send all-party delegations overseas. The truth is that the BJP's poisonous politics at home has cost us hugely abroad. Our sanctimonious diplomacy has fallen flat and India is back to being hyphenated with Pakistan."

"That is the real 'new normal'," he added. The BJP reacted sharply to the controversy and slammed both the parties for not thinking about national interest. BJP leaders claimed that it was government's prerogative to select nominees

for the global outreach. "The allegations are not right. It is the government's prerogative to send whom to which place. The party proposed its name, but it has forgotten the names of the senior leaders who understand diplomacy. The government has nominated those who have knowledge of diplomacy. There is no politics in it; few people find politics in everything and Congress is ahead of it," BJP leader Praveen Khandelwal said. Rajasthan BJP president Madan Rathore said the opposition should appreciate that their leaders were included in the all-party delegations being sent abroad to project India's united stance against terrorism.The BJP's allies have also slammed the Congress and the TMC for questioning the process of selection of members for the multi-party delegation.Interestingly, two parties - Samajwadi Party and the Biju Janata Dal - are yet to react to the row even as their members nominated for the exercise have welcomed the government's move.Samajwadi Party MP Rajeev Rai who has been named in one of the seven delegations said that Centre should have looked into the



Dead body of youth found on the banks of Khaderi river in Prayagraj: Suspected of murder, forensic and dog squad team engaged in investigation AKHAND BHARAT SANDESH

PRAYAGRAJ: The body of a 20year-old youth was found on the banks of the Khaderi river in Karolbagh area of Kareli police station in Prayagraj on Monday morning, causing a sensation in the area. As soon as the information was received, the Kareli police station took immediate action and cordoned off the entire area and informed the higher authorities.

The deceased has been identi-

fied as Puneet Prajapati, who was a resident of Alahpur police station area of Ambedkar Nagar district and was living in a rented house in Karela Bagh area of Kareli for some time

With the promptness of the police, a team of field unit, dog squad and forensic experts reached the spot and the



process of evidence collection was started. In the initial investigation, the possibility of murder is being expressed, but the police is investigating all aspects in depth.

DCP City Zone Abhishek Bharti also inspected the spot and said that the body has been sent for postmortem. The cause of death will be confirmed only after the post mortem report comes. He assured that the matter is being investigated closely

and the truth will be revealed soon. Meanwhile, the family members of the deceased have been informed and the police are trying to find out the clue with the help of CCTV footage. The team of Police Commissionerate Prayagraj is taking this sensitive matter seriously and is investigating it with full vigilance and transparency.

Student hanged herself in Koraon: Talked to someone on phone for half an hour before death, Secret will be revealed from call details

PRAYAGRAJ: A tragic incident has come to light in Pasna village of Koraon police station area in Meja, Prayagraj. Here 16-year-old student Madhu Singh committed suicide by hanging herself with a saree from a fan in her room. Madhu was an intermediate student and the only daughter of her family. The incident happened last night. In the morning, when the door of Madhu's room was found closed and there was no response on calling, the family reached the room from the back side. There Madhu was found hanging from the fan. The family immediately took her to CHC, where the doctors declared her dead. An important fact has come to light in the case. Xi Jinping's Europe tour: A visit that raises eyebrows

On his first visit to Europe post-pandemic, Xi Jinping met French President Emmanuel Macron. Xi lauded China's ties with France as a "model for the international community amid threats of a trade war over Chinese electric cars and French cognac". Xi Jinping's tour through Europe, analysts point out, highlighted China's audacious strategy to exploit the fissures within Europe amid great power contestation. Among many other developments, the armed forces of China and France announced the setting up of a new inter-theatre cooperation and dialogue mechanism. This collaboration between the two militaries' naval and air forces is aimed at further deepening mutual trust and cooperation and jointly safeguarding regional security and stability.

Such a move towards forging closer Sino-French military ties, especially amid Beijing's assertive manoeuvres in the Indo-Pacific and the South China Sea, begs the question: Can Europe, and particularly France, remain a reliable ally, or will it become more accommodating of China's controversial actions in its neighbourhood? Countries like India are watching closely, concerned about France and Europe in the future and potentially succumbing to China's diplomatic and economic enticements. China claims to be "not at the origin of the Russian-Ukraine crisis, nor a party to it, nor a participant", and thus legitimises its silence. Can we anticipate a similar approach by Europe on issues concerning Taiwan and the Philippines? In the past few years, France's relationship with China has been marked by a mixture of scepticism and strategic engagement, reflecting broader geopolitical objectives and national interests. In the recent past, France has been quite critical of China, viewing it as a 'strategic threat'. The 2021 update to France's 2017 Defence and National Security Strategic Review painted China as a 'systemic rival', 'economic competitor', and 'sometimes an important diplomatic partner'. Even as Paris sought engagement with Beijing in 2019, substantial tensions clearly existed. During Xi Jinping's previous European tour, President Macron rallied a united European front to challenge Beijing on critical European issues like unfair trade practices, restricted market access for European companies, opaque financing under the BRI, and human rights abuses in Tibet and Xinjiang.

Recent events and official statements have further underscored this stance. A parliamentary report on foreign interference in France, requested by Marine Le Pen's far-right party, highlighted China's "aggressive and increasingly malicious methods". Labelling China as the "second most serious threat to France after Russia" the report echoed sentiments from Bernard Emié, Director of French External Intelligence (DGSE), who described China as an 'aggressive with 'unbridled diplomacy'. power' Furthermore, the issue of France selling arms to Taiwan resurfaced during the pandemic when Taiwan announced plans to buy defence equipment from France to upgrade missile systems on French warships purchased in 1991 and 1992. Beijing expressed 'serious concern' and urged Paris to avoid actions that could strain Sino-French ties. Following Chinese air intrusions into Taiwan's air defence zone, a French delegation led by former defence minister Alain Richard visited Taipei to meet with President Tsai Ing-wen. This visit was seen as a powerful symbol of France's commitment to opposing China's unilateral aggression. and supporting peace, security, and stability in the Indo-Pacific.

Iran-Israel had nearly come to a confrontation

The rough weather in northwest Iran took the lives of Iranian President Ebrahim Raisi and Foreign Minister Hossein Amir Abdollahian on Sunday (May 19), along with seven others, in a helicopter crash while returning after inaugurating a dam in East Azerbaijan with his Azerbaijanian counterpart, Ilham Heydar oghlu Aliyev. The two Presidents looked happy and comfortable despite some intra-regional competition, especially in the wake of the Nagorno-Karabakh conflict. The death of President Raisi, along with his foreign minister, has indeed caused a vacuum on key developments and initiatives, especially at this time when the region is going through a highly volatile war in Gaza, which threatens to expand beyond. In March and April, Iran and Israel had nearly come to a direct confrontation that could be avoided due to pragmatism and intervention by the US and others in the region. Limited strikes saved the face for both. President Raisi, despite his conservative approaches domestically, tried to be pragmatic even as, under his watch, Iran continued on its path to increase the enrichment of uranium to keep the pressure on the West and pursued the quest to acquire parity with Israel in the nuclear domain. Perhaps the biggest credit could go to him for the Saudi-Iranian rapprochement, along with working for



a regional modus vivendi with the Arab world. His Act East policy also brought about closer relations with India and China while they worked to closely enrich ties with Russia. At the same time, in the wake of Abraham Accords and the further potential normalisation of ties between key Arab countries and Israel, Tehran emerged as a major protagonist of the Palestinian cause, given its hold on Hamas in Gaza. However, the mutually assured destruction (MAD) syndrome between Tehran and Tel Aviv continues apace and could threaten stability in West Asia. Raisi successfully secured the release of \$6 billion in exchange for some US prisoners and even restrained Shia Iraqi militias from attacking US military assets. Although Iran has been able to blunt the impact of the severest sanctions to a considerable extent, it may have been

severely compromised in the area of spare parts and technology. The fact that the President was riding in a 15year-old helicopter not only questions the choices of the pilot or the leadership in such a weather but also confirms the existence of restrictions on imports of spare parts that may have been imposed due to sanctions. What really caused the crash will only be confirmed by detailed investigations of the wreckage and Black Box. The untimely death of President Raisi has also caused a leadership vacuum, as he was mostly slated to succeed the Supreme Leader, Ayatollah Khamanei, who is 85 and is said to be ailing. But as was witnessed in the wake of the helicopter crash, Khamanei immediately took hold of the situation, assuring the country that there would be no governance crisis. As such, he decides in the end, and the armed forces, security,

and intelligence outfits, as is a challenge in itself for any well as the Revolutionary Guards (IRGC), look up to him for instructions. He also did not want to convey to his detractors, both internally and externally, that they could exploit the crisis and the transition. As for the succession issue, although the demise of Raisi has caused a vacuum, the argument for Mojtaba succeeding his father, Ayatollah Khamanei, would become more eloquent and vociferous even though the Supreme Leader personally appears not to be in favour of dynastic rule, as quoted by many insiders, for he would not like to be accused of nepotism. One more name that is being propounded to us is that of white-turbaned Ali Reza Arafi, whom the black-turbaned Supreme Leader called an original intellectual and prudent jurist. One would have to see if the colour of the turbans would matter at all. He is a member of the Assembly and was also appointed to the Guardian Council. His name has been circulating for quite some time. In any case, the presidium of an assembly of experts will identify the next leader in due course. But the 'Supreme Leader' will also have to be accepted by the masses since Iran is facing significant domestic discontent as well as huge external challenges, especially from the West and Israel. Of course, losing the President and foreign minister, especially at such a difficult time, ed Iran's entry.

As per Article 131(1) of the Iranian constitution in the event of the president's demise or incapacitation, the first vice president will take over with the approval of the Supreme Leader (de facto), and fresh elections will have to be conducted within fifty days. It reads, "In case of death, dismissal, resignation, absence, or illness lasting longer than two months of the President, his first deputy shall assume the powers and functions of the President with the approval of the Leader." Accordingly, Vice President Mohammed Mokhber has taken over the reins to conduct day-to-day affairs and organise elections with the head of judiciary and speaker of the Iranian parliament. Indeed, it's replacing the promise of prosperity as the basis of the communecessity of a powerful, nist party's hold over China. The fact that the Federal Reserve's policy of quantitative easing following the 2008 financial crisis and the purchase of government securities to increase the money supply were unquestioned exemplifies Hobbes' idea of the sovereign exercising control to prevent economic disorder and maintain stability. That, in the bastion of capitalism, it did not raise concerns about the erosion of financial autonomy and the distortion of free markets underlines the astonishing relevance of Hobbes. France's robust welfare state epitomises Hobbes' notion of the sovereign's responsibility to ensure the well-being of its citizens. The French government maintains an extensive social safety net, including comprehensive healthcare, unemployment benefits, and retirement pensions. During the COVID-19 pandemic, France's welfare spending surged as the government implemented measures to protect jobs and support incomes. However, this extensive welfare system can be critiqued for fostering dependency and reducing individual responsibility. The welfare-to-GDP ratio in 2023 was an astonishing 36 per cent. This is clearly unsustainable, but every

time France has tried to

pull back the Leviathan or cut back welfare. there have been dramatic riots. Once you create the Leviathan, clearly, there is no way back. In 2020, the French government introduced the 'Solidarity Fund', providing financial aid to businesses affected by the pandemic, and expanded unemployment benefits to cover those furloughed under the 'partial activity' scheme. These interventions, amounting to over €100 billion in expansive welfare spending, can lead to high taxation, which burdens individuals and businesses, and totally stifles entrepreneurial spirit and innovation. Additionally, the extensive welfare system creates a culture of dependency, reducing the incentive for personal initiative and self-reliance. France and its Leviathan are in a doom loop. China's model of state capitalism illustrates Hobbes' concept of the sovereign's expansive control over economic life. Punjab to Andhra to Telangana—state govts' spending on freebies harming

Every vote is important, and, therefore, political parties are trying to woo every section of society. Earlier, political parties used to make announcements about their proposed policies in their election manifestos. But for the last one and a half to two decades, they have started making announcements for free schemes to woo voters. It's beyond doubt that providing free electricity, water, or travel to everyone could ruin government budgets and increase debt too. Today, there is an ongoing competition between political parties about freebies, and in an effort to woo voters and gain power by hook or by

crook, many Indian states are already getting burdened with debt. As a result, on the one hand, they are failing to fulfil their promises completely, and on the other, the development work and essential government activities in those states are getting affected. During the 2022 assembly election in Punjab, the Aam Aadmi Party (AAP) made many promises, including free electricity. After the formation of the AAP government, some of these were implemented, but today, the situation is such that the debt burden on the government is continuously increasing and the state is trying to take more loans. The central government is also being accused of not giving money to

that the state government is irresponsibly spending on freebies to garner votes. The situation is the same in Andhra Pradesh, Telangana, Rajasthan, West Bengal, Bihar, and Jharkhand. Meanwhile, the central government is not in favour of states taking more loans because it is against the Fiscal Responsibility and Budget Management (FRBM) Act 2003. The states in debt due to expenditure on freebie schemes are unable to spend on the necessary responsibilities. Industries in Punjab are incurring high electricity bills because the AAP government is giving free electricity to nearly 60 lakh people. Infrastructure development in

the state, whereas the reality is the state is getting badly affected too. Punjab, once the state with the highest per capita income in the country, has slipped to the 19th position. Other debt-ridden states are suffering a similar fate. In its 2024 election manifesto, Congress has announced Rs 1 lakh as an unconditional cash transfer to the poor every year as part of its Mahalaxmi Scheme. If the party comes to power, the implementation of such a scheme can be frightening. It's notable that as of 31 March 2023, the total debt on the governments (central and state) in India (including the guarantees given by them) was Rs 231.7 lakh crores, which was 85.1 per cent of GDP.

In Iraq, Libya, and Egypt, when the Leviathan was toppled, it created chaos beyond imagination,

Rajasthan's school mergers endanger first-gen students, especially girls.

Delhi: With three decrees in January, the Bhajan Lal Sharma-led BJP administration in Rajasthan set into motion the merging of 449 schools with larger, better-performing schools in their neighborhood. The government claimed low enrollment (fewer than 15 kids per the Rajasthan government policy), distinct schools on the same campus, and schools near to each other as explanations. The idea has generated protests statewide, with parents strongly opposing it, since it threatens to compel youngsters, primarily girls and those from impoverished families, to drop out. The merging of all-girls institutions into co-ed institutes is a critical issue, as seen in last week's rallies in Jodhpur and Bikaner. Many parents worry this shift could endanger their daughters' safety and education. Other issues are the rise in home-to-school distance for many pupils and changes in school medium and culture. Ex-CM Ashok Gehlot and parents have opposed the move. BJP MLA Jethanand Vyas of Bikaner West asked Education Minister Madan Dilawar for an exemption for his district's girls' school. Over 1,400 pupils will fit into 20 classes post-merger. The girls worry that if the merger happens, their parents would stop them from going to school, ruining their dreams. No other all-girls government school exists. I don't know if I can finish school. I just want to study and go to college."How will we handle a shift?" "I don't know if I can keep studying," she remarked. District education officials know of the issues but said, "No schools are closing; they're merging with better-performing ones." "This move expands educational options for boys and girls, allowing for a broader range of streams." We'll keep girls in school. Modi claimed schools have been told to do this. Rajasthan has 70,233 state schools. 32,598 are primary schools. School consolidation isn't just in Rajasthan. In Madhya Pradesh, Uttar Pradesh, Himachal Pradesh, and Odisha, smaller, low-enrollment institutions are merging with larger ones.

Al adoption to boost data, cloud role hiring

CHENNAI

As companies navigate AI adoption, demand and salary growth for data science, data engineering, DevOps and cloud computing roles are expected to grow faster than other technology roles in FY25 compared to the previous fiscal, according to TeamLease Digital. The tech staffing and solu-

tions providers' snapshot analysis shows that a rise in AI, machine learning (ML), and automation skills has significantly increased the demand for datarelated roles.While 69% of job postings for data scientists mentioned ML skills in FY24, demand for natural language processing jumped from 5% in 2024 to 19% in 2025,

indicating a broad industry shift toward AI-driven solutions, the company said in a note.

The demand for AI-related roles will increase 17% in the current fiscal and about 25 per cent in FY26, Neeti Sharma, chief executive of TeamLease Digital, told. This includes roles such as data scientist, analyst and engineer.

GoM seeks GST on luxury shoes, watches to boost revenue by Rs 22,000 cr

Delhi: The Group of Ministers (GoM) approved GST rate changes that could generate Rs 22,000 crore in revenue. The GoM, led by Bihar Deputy Chief Minister Samrat Chaudhary, recommended hiking GST rates on luxury commodities like wristwatches and shoes. The GoM recommended higher GST rates on wristwatches over Rs 25,000 from 18 pei nt. The GoM proposes raising the tax on shoes over Rs 15,000 from 18% to 28%. The GoM also lowered 20-litre packaged drinking water bottle and bicycle taxes from 18% to 5%. Members suggested lowering GST on exercise notebooks from 12% to 5%. The GST on bicycles under Rs 10,000 should be cut from 12% to 5%. The GST Council under Finance Minister Nirmala Sitharaman lowered the GST on cancer medications and 'namkeens' in September. Additionally, the GoM has exempted GST on term life insurance and senior citizen health insurance premiums. The action would reduce insurer and policyholder taxes. The GST Council will receive the ministerial panel's rate rationalization suggestion by October 31.

Delhi: A recent Sebi survey found that many cash out days following an IPO, focusing primarily on listing gains. The quick money is alluring, but are they losing more? Imagine investing in the next great tech startup but selling out before it takes off. Retail investors seeking short-term gains may miss out on IPOs' long-term value. Is this early departure strategy profitable or are investors losing out? The Sebi investigation of 144 IPOs listed between April 2021 and December 2023 indicated that many individual investors sold their shares guickly. 70% of the value-weighted shares were sold within a year of the IPO. The quick turnover is especially visible when IPO shares climb sharply after listing. Sebi's data also emphasizes the "disposition effect," where investors sell rising-valued shares.

Mid, small-cap mutual funds attract 30,350 crore on strong returns

NEW DELHI: Mid-cap and small-cap mutual fund schemes have continued to attract strong investor interest, garnering nearly Rs 30,350 crore in inflows during April-Sept of the current financial year, driven by

impressive returns delivered by these segments.

In comarison, the cumulative inflow into mid-cap and small-cap funds stood at Rs 32,924



crore during the same period last year, according to data from the Association of Mutual Funds in India (Amfi). The inflow trend persists despite concerns raised by market regulator Sebi over heightened inflows into small-cap and mid-cap funds, as experts believe investors will continue to favour these categories for their potential to deliver high returns."Small caps will continue to grow at a faster rate for years to come. I expect the inflows to continue as Indians want to invest in the high-growth sectors. Small cap funds should be seen as an integral part of one's portfolio allocation and not a tactical play," Trust Mutual Fund CEO Sandeep Bagla said.Individually, mid-cap funds saw an inflow of Rs 14,756 crore and smallcap funds attracted Rs 15,586 crore in the first half of FY25. WinZO, an online gaming company, claimed that Google's Play Store prohibits Real Money Game hosting. "Due to Google's unreasonable and restrictive policy, all apps offering real money games of skill

are only available for download from their website (a process called sideloading)," it told CCI. On Android devices, using this process to reach WinZO displays a disclaimer/warning, tarnishing its image. WinZO stated warnings are without validity and "completely illegal" and cost the company. plays another "baseless warning" when users pay for skillbased games. "Such payment warnings are arbitrary as Google has not set any criteria for displaying them," WinZO complained to CCI.



Revised MFI ordinance moots 10-yr jail, 5L fine



Bengaluru: After multiple iterations, Karnataka govt has sent its ordinance to governor Thaawar Chand Gehlot, proposing severe penalties for microfinance institutions (MFIs) found guilty of coercive loan recovery practices.Under the revised draft, it will be considered a criminal offence for MFIs to use violence, intimidation or any form of coercion against borrowers or their families. The ordinance also prohibits use of external agencies to threaten or pressure borrowers into repayment and bans the frequent visi-

tation of borrowers' homes or places of work. The Karnataka Micro-Finance (Prevention of Coercive Actions) Ordinance, 2025, which has already received the cabinet's approval, has suggested up to 10 years in prison and a fine of Rs 5 lakh for MFIs involved in harassment. "It was three years (in the initial draft), now we have increased it to 10 years. This is to ensure that the heat of the law is felt (by violators)," home minister Parameshwara announced the revision Tuesday. The ordi-

nance, which has seen eight revisions in the past few weeks, is now awaiting the governor's assent. The decision to issue the ordinance comes in the wake of rising suicides and widespread complaints about predatory loan recovery practices used by MFIs. These firms have been accused of using coercive methods which have pushed borrowers, particularly farmers, women and selfhelp groups, to the brink of financial ruin. "The ordinance aims to protect and provide relief to economically vulnerable groups and individuals.

China overtakes the US as India's trading partner with \$118.4 billion

Delhi: China overtook the US as India's largest trading partner after two years, according to Global Trade Research Initiative data. India's bilateral trade with China totaled \$118.4 billion in , with imports up 3.24% to \$101.7 billion and exports climbing 8.7% to \$16.67 billion. India-US trade fell somewhat. Indian exports fell 1.32% to \$77.5 billion and imports fell 20% to \$40.8 billion in FY24, totaling \$118.3 billion. India relies heavily on Chinese imports in telecommunications, pharmaceuticals, and advanced technology, therefore its economic relations with China are closely watched. According to GTRI, "India purchased \$4.2 billion in telecom and smartphone parts, 44% of overall imports in this category, demonstrating strong reliance on Chinese components. China supplied 77.7% of India's laptop and PC imports at \$3.8 billion." In 2024, the Indian Real **Estate Sector Expects Equity** Investments of Rs 74,815 Crore

Delhi : According to a survey by CBRE South Asia, the real estate sector registered equity investments of \$8.9 billion (Rs 74,815 crore) in the first nine months of 2024, surpassing the increase of \$7.4 billion (Rs 62,210 crore) in 2023 and demonstrating a year-over-year rise of 46%. The Indian real estate market has experienced a massive boom, reaching its highest point since 2018. A significant guarterly equity investment totaling \$2.6 billion (Rs 21,857 crore) between July and September 2024 is highlighted in the report.

Mumbai, Bengaluru, and Chennai drove this expansion, contributing 66 percent of equity inflows in Q3 2024 with their respective subscriptions of \$0.96 billion (Rs 8,070 crore), \$0.40 billion (Rs 3,362 crore), and \$0.34 billion (Rs 2,858 crore). With capital inflows of \$0.31 billion (Rs 2,605 crore), \$0.27 billion (Rs 2,269 crore), and \$0.02 billion (Rs 1,681 crore), respectively, Delhi-NCR, Pune, and Hyderabad also saw a sizable portion of investments.Domestic investors, especially construction businesses, who accounted for roughly 79% of equity inflows during the July-September quarter, were the main drivers of the increase in investment momentum.

Of the overall inflows of foreign investments, 73% came from Singapore and 22% from the US.

NAAC looks to shift to new systems to grade colleges

Bengaluru: Under CBI scanner for alleged bribe-for-grades scam, National Assessment and Accreditation Council (NAAC) is looking to change the current accreditation system to binary system and maturity-based system with different metrics, while keeping at least 400 academicians away from campus visits in the past one year over fears of corruption. The binary system involves grading a college 'accredited or not', without A+, A++ grades. The maturity-based system is an evolving accreditation process which improves a college's rating over the previous level based on its improvement in performance. The current process – which is likely to be shelved -- involves a 70:30 metrics formula: 70% quantitative and 30% qualitative metrics. The latter consists



physical inspection of higher educational institutions by a peer-review team. The NAAC's plan to shift to the new twin systems follows recommendations from the Dr Radhakrishnan committee, which has suggested reforms in the accreditation process. Anil Sahasrabudhe, chairman of NAAC executive committee, said they will expedite the rollout of reforms soon. "The com-

mittee has debarred offline, physical visits and will do everything online through validation of the documents. We plan to launch both binary system and multigrade system in March. Scrap mop-up allotment of PG med seats to ineligible: HC

Bengaluru: Karnataka high court ordered Tuesday Karnataka Examinations Authority (KEA) to scrap the PG medicine seats allotted in the mop-up round to "ineligible" candidates and make them available in the next round of counselling. National Medical Commission (NMC) and Counselling Medical Committee (MCC) should permit the candidates who were allotted all-India quota seats in the MCC-conducted third round counselling to join the allotted seats till 5pm, Feb 9, a division bench comprising Justices Anu Sivaraman and Vijayakumar A Patil said in its order on a petition filed by Dr Akshay V Thuppad and others, who were aspirants in the mop-up round conducted by the KEA. The KEA was directed not to enforce the penalty clause against the students who were wrongly permitted to participate in the mop-up round in violation of the conditions stipulated it its

The brochure. The KEA was told to ensure the original documents are returned to the candidates to enable them to join the all-India quota seats at the earliest.

> The petitioners -- and similarly situated candidates who were eligible to participate in the mop-up round -- should be permitted to participate in the stray vacancy round where the seats that fall vacant should be made available and seats should be allotted to them on the basis of merit, the bench said. The KEA was directed to take steps to ensure fees -- paid by ineligible candidates who had joined the allotted colleges pursuant to the mop-up round -- are refunded to them at the earliest. The MCC and KEA were told to inform the candidates who had been allotted seats in the third round of all-India quota counselling but were permitted to participate in the counselling of the KEA without eligibility that they have to join the all-India quota seats.
