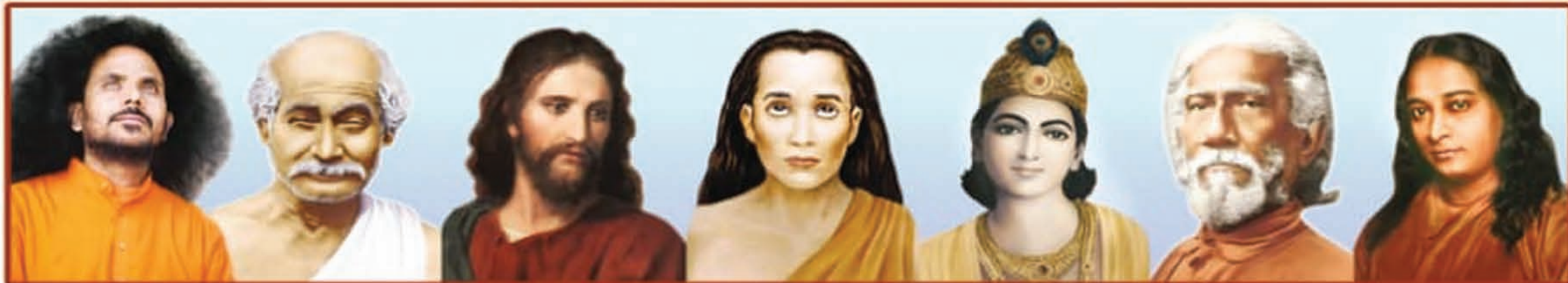

Serious Questions Raised by Energy Minister A.K. Sharma Over Posting of Officers in UP, Allegation of 25 Lakh for District Posting

Uttar Pradesh politics witnessed turmoil after the state Energy Minister, A.K. Sharma, raised serious concerns regarding the posting of officers. Speaking from a public platform, Sharma said that discussions have emerged suggesting that in some places, up to 25 lakh is being paid for district-level postings. His statement is being seen as a major question mark over the administrative system. The minister said that if such reports are true, it is extremely worrying and must be investigated seriously. He clarified that the government intention is to ensure a transparent and corruption-free system and if any irregularities are found, strict action will be taken. Following his statement, discussions have intensified in administrative and political circles. Opposition parties have termed it a direct attack on the government functioning, while leaders of the ruling



party say that the minister remarks reflect the government zero-tolerance policy against corruption. Political observers believe that such a statement from a responsible minister indicates that there is introspection within the government regarding the system. Meanwhile, the general public has begun questioning that if money is being exchanged for postings, it would directly impact the efficiency and impartiality of the administration. For now, there is a wait for an official response at the government level regarding Sharma statement. It is believed that instructions for a high-level review or investigation may be issued to uncover the Truth.

Blackout Mock Drill Held at Police Lines Parade Ground

To further strengthen the internal security system in the district, keep the general public vigilant and alert during emergency situations, provide information on first aid and life-saving techniques and assess the preparedness of various departments in the event of a natural disaster, a blackout mock drill was successfully conducted at the Police Lines Parade Ground late Friday evening. This mock drill was organized under the directions of the Additional Chief Executive Officer, State Disaster Management Authority, Lucknow and under the able guidance of District Magistrate Akshay Tripathi and Superintendent of Police Ramnayan Singh. During the drill, a blackout situation was created at exactly 6 PM. Complete darkness and silence prevailed all around, and then the sirens of the fire service started blaring. Green Energy Essential for Uttar Pradesh Progress: Brajesh Pathak

The Lucknow Management Association organized the IGB Conference titled "Transforming Real Estate in Uttar Pradesh Through Green Buildings." Deputy Chief Minister Brajesh Pathak said that working on green energy is essential for the progress of Uttar Pradesh. He emphasized that building heights should follow standard norms and buildings should have enough windows to allow natural light and ventilation, reducing the need for lights, air conditioners and fans during the daytime. He advocated for installing 100 percent solar panels in private buildings. Addressing the conference on Saturday, Pathak said that earlier, houses were built with greater height, large windows and



tall doors. However, modern large buildings now have very few windows. As a result, doors and windows remain closed throughout the day, forcing people to use artificial lighting and air conditioning. He warned that the hot air released by air conditioners is harmful to the environment. He also stressed the need to prevent water wastage. He suggested the installation of urinals in toilets and the reuse of bathing water for irri-

gation and gardening purposes. Solar Energy Must Be Given Priority. The Deputy Chief Minister said that solar energy should be promoted. The government has already made it mandatory to install 100 percent solar panels in government buildings and this should also be implemented in private buildings to save electricity. He added that public transport should be encouraged. He explained that green

buildings, recognized for their low environmental footprint, energy efficiency and use of sustainable materials, offer a strong solution. Such buildings can reduce energy consumption by 30 to 50 percent and water usage by 20 to 30 percent. They also improve the health of residents, reduce greenhouse gas impact and help mitigate climate change. Pathak further said that large-scale construction is taking place across cities in Uttar Pradesh at both government and private levels. Promoting green building practices can bring significant environmental and economic benefits. Since nearly 70 percent of India buildings for 2030 are yet to be constructed, encouraging green buildings will directly support India target of achieving net-zero emissions by 2070.

SSB 42nd Battalion strengthens security at India-Nepal border, 24/7 surveillance with face detection cameras

The 42nd Battalion of the Sashastra Seema Bal (SSB), deployed at the Rupaidiha border post on the India-Nepal border, has taken a significant technological step to further strengthen border security. Under the leadership of Commandant Ganga Singh Udawat, the battalion has installed face detection cameras in the border area. This will allow for close monitoring of the identity and activities of individuals crossing the border. According to SSB officials, these state-of-the-art cameras will enable effective monitoring of illegal infiltration, smuggling and other suspicious activities. Delhi A Controversy is rapidly deepening across colleges and universities nationwide over the "Promotion of Equity in Higher Education Institutions Regulations, 2026", implemented by the University Grants Commission (UGC) from January 13. While the UGC describes these regulations as a major step toward ensuring equality and social justice in higher education campuses, students from the General Category are viewing them as biased and fraught with the potential for misuse.

Protests From Social Media to Campuses

At present, student protests are not taking the form of street demonstrations, but are clearly visible on social media and within campuses. Hashtags such as #UGCRollback are trending. Students argue that, in the name of "equity," the new rules establish an extensive surveillance mechanism that could adversely affect the academic environment and lead to innocent students and faculty members being targeted.

What Are the New UGC Equity

Rules?

Under the new regulations, the following arrangements have been made mandatory in all higher education institutions across the country—Establishment of an Equal Opportunity Centre Formation of an Equity CommitteeA 24x7 helpline Deployment of Equity Squads According to the UGC, the objective of these measures is to prevent caste-based discrimination against students belonging to Scheduled Castes (SC), Scheduled Tribes (ST), and Other Backward Classes (OBC), to monitor complaints, and to ensure swift action.

Strict Provisions as Well

The UGC has clearly stated that strict action will be taken against institutions that fail to comply with these regulations. Such actions include—Cancellation of UGC recognition Suspension of government funding This strict approach has heightened concerns not only among university administrations but also among students.

What Are the Students' Objections?

Students from the General Category argue that the rules lack clear definitions, which could lead to arbitrary use of complaints. They feel that the powers granted to Equity Squads and committees appear to determine guilt even before an investigation is conducted. According to them, this system could turn educational institutions into a "police state," where fear replaces dialogue. Some student organizations also point out that laws and internal grievance redressal mechanisms to address discrimination already exist, raising the question of why parallel structures are being created. **Tough Questions for the Government and the UGC** Did the government conduct wide-ranging consultations with all student groups and academics before implementing these rules? Why have clear guidelines not been issued regarding the powers and limitations of Equity Squads? If a complaint is later found to be

false or malicious, who will be held accountable?

Will these regulations not have an adverse impact on academic freedom and freedom of expression?

How will the UGC ensure that, in the name of equity, no injustice is done to any particular group? Instead of strengthening existing anti-discrimination provisions, why are new punitive structures being introduced?

Review and a Balanced Solution

For now, the UGC appears firm on its decision. However, in light of growing discontent, the key question is whether the government and the Commission will move forward without addressing students' concerns, or whether the rules will be reviewed to arrive at a balanced solution. Equality in the country's higher education system is essential—but will the path to equality emerge through consensus and dialogue, or through strictness and fear? This is the question the government must now answer.

Transforming UP Through Green Buildings Conference: Dr. Singh says Green Buildings can save 30–40% energy

Sarojini Nagar MLA Dr. Rajeshwar Singh on Saturday Participated in a conference on “Transforming Real Estate in Uttar Pradesh Through Green Buildings”, organized by the Lucknow Management Association at Hotel Grand JBR, Gomti Nagar. Beginning his address, Dr. Singh said that green energy is no longer an option, but a collective responsibility towards future generations. Expressing deep concern over the environmental crisis, he said that air pollution, depleting groundwater levels and rising AQI are serious warnings for the future. He noted that globally more than 7 million people die prematurely every year due to air pollution, out of which around 2.4 million deaths occur in India alone. Citing Earth Overshoot Day, he said that in 1972 it fell on December 26, whereas now it has shifted to the first week of



August—showing that humanity is consuming far beyond nature’s capacity. Emphasizing the importance of green buildings, Dr. Singh said that this should not remain merely a technical solution but must become a mass movement. He stated, “Every citizen should feel proud that their home, their society, their market and their city are green.” He explained that green buildings can help save 30–40% energy and 20–30% water. With nearly

70% of the country’s buildings yet to be constructed, he said this is the right time to mainstream green construction. He urged the government to further strengthen incentives such as greater tax rebates, low-interest loans, increased FAR and concessions in property tax. Praising the leadership of Chief Minister Yogi Adityanath, Dr. Singh said that Uttar Pradesh has taken a leading role in the country by adopting the Green Building Code. He informed that the

state has already achieved 1 gigawatt of solar energy capacity and has set a target of 22,000 megawatts, in line with India’s Net Zero 2070 commitment. He added that the government’s commitment is clearly visible at the levels of policy, regulation and political will. Highlighting initiatives in his own constituency, Sarojini Nagar, Dr. Singh said that more than 160 Tara Shakti Kendras have been established to empower women self-help groups. These centers have been equipped with over 2,000 sewing machines and more than 30,000 eco-friendly school bags have been produced and distributed in primary schools, helping reduce plastic use. He also shared that a Solar Help Desk is operational at his office and out of Lucknow’s total 120 MW solar capacity, more than 60 MW has been installed in Sarojini Nagar alone. Referring to the Shiviri Waste-to-Energy plant, he said the facility has the capacity to

process around 2100 metric tonnes of waste per day, moving Lucknow towards becoming Uttar Pradesh’s first city to convert all its waste into energy. The conference was also addressed by Deputy Chief Minister Brajesh Pathak. Senior Vice President of LMA A.K. Mathur, Amit Srivastava (Chairman, Indian Green Building Council –Lucknow Chapter), Jai Kumar Gupta (General Manager, SIDBI), Ashok Kumar, Raj Verma, Architect S.K. Saraswat, Praveen Kumar Dwivedi, along with several experts, policymakers and distinguished Guests Were Present. Concluding his address, Dr. Rajeshwar Singh said that the suggestions and ideas emerging from the conference would be taken forward seriously at the policy level, with the objective of making Uttar Pradesh a model state for green, Clean and Sustainable Development.

safety of passengers. The sudden night inspection led to increased vigilance among the RPF personnel. This step taken by the railway

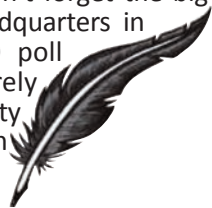
administration ahead of Republic Day is considered important in further strengthening the security arrangements of the station.

Op Sindoor setting the tone for Bihar polls

In October 2016, addressing the national council of the Janata Dal (United), Bihar Chief Minister Nitish Kumar slammed the Bharatiya Janata Party for ‘politicising’ the surgical strike. The entire nation stands with you [Narendra Modi] as you are the Prime Minister, but what about those BJP leaders who have repeatedly used the strike to play politics?” Kumar said. A couple of months earlier, as the BJP was organising Tiranga Yatras ahead of the 70th Independence Day, Kumar had taken a dig at it. Those who “never recognised the tricolour as national flag”, he said, were taking out Tiranga Yatras. Much water has flowed under the Gandhi Setu since then. As the BJP took out Tiranga Yatras across Bihar for 10 days to celebrate Operation Sindoor’s success, Kumar watched them silently—and warily, perhaps. The operation has brought springs to BJP leaders’ feet. The 2024 Lok Sabha poll blow is a thing of the past. PM Modi has started taking his own name again—Modi’s cool mind and the hot sindoor in his veins, Modi’s chest, et al. It was in his first public rally after the Pahalgam terror attack in Bihar’s Madhubani, when PM Modi had vowed to punish the perpetrators “beyond their imagination”. The vow fulfilled, he will be back in Bihar on 29 and 30 May. The BJP’s preparations for Modi’s roadshow in Patna are in full swing. People standing on both sides of the road would be showering flower petals on him. That’s how a victor is welcomed. How will Operation Sindoor impact the Bihar elections? Let’s first look at where the National Democratic Alliance (NDA) stood before the strikes on Pakistan’s terror infrastructure and military installations. DesignBoxed, a political digital campaign management company, conducted a survey in Bihar last month. I got access to its report, which has great news for the NDA: Overall, the DesignBoxed survey indicated a clear edge for the NDA. Mind you, it was conducted before Operation Sindoor. Nitish Kumar’s principal challenger, Tejashwi Yadav, also has some positive takeaways from the survey. If elections were to be held tomorrow, 46.7 per cent of respondents said they would vote for the NDA, against 35.6 percent who favour the INDIAN bloc, with 13.8 percent ‘undecided’. If Tejashwi were to swing the ‘undecided’, the game would be on. For 43.8 percent respondents, unemployment and migration are the most important issues in the upcoming elections—Tejashwi’s key plank in 2020. What would make him even happier is the survey finding that 63.76 per cent people want the current government to be replaced. This sounds incongruous, as a majority of respondents were satisfied with Kumar’s performance. Those involved in the DesignBoxed survey, however, claim that it’s no surprise. One of them told me: “You come across many respondents who are ok with Nitish Kumar but still want his government changed. It’s vice versa, too. It’s a lot to do with people’s castes becoming the main determinant.” Kumar has been the chief minister since 2005, except for a short interlude of nine months in 2014-15. The yearning for change is understandable. How much of it can Tejashwi exploit? Can he beat the caste arithmetic that seems to be in the NDA’s favour today? We will find out in November. Union home minister and the BJP’s chief strategist Amit Shah once told journalists: “People in Bihar are so political. They sit at tea stalls and read the entire newspaper—from the first to the last page.”

Five months is obviously a long time for such political people to change their mind. But it’s not just Tejashwi that CM Kumar would be worried about. The BJP says that the next election will be fought under his leadership, but it’s evasive on the question of Kumar becoming the CM again if the NDA wins. Kumar wouldn’t forget the big celebrations at the BJP headquarters in New Delhi after the 2020 poll results. The NDA had barely managed to cross the majority mark, securing 125 seats in the 243-member Assembly.



PMFBY is failing. It has the same flaws of earlier schemes

India’s farmers steward the country’s food security, yet they live in chronic distress and policy indifference. Though their contribution is crucial, they continue to be vulnerable and voiceless. Vice President Jagdeep Dhankhar who comes from a farming family, has repeatedly expressed discontent by consistently bringing up farmers’ grievances into the public limelight, stressing that “it is the government’s foremost responsibility to take care of the farmers”. Agriculture, despite accounting for only 18.2 per cent of India’s GDP, remains the primary source of livelihood for nearly 42.3 per cent of the population. However, over the last decade, India has witnessed a significant decadal drop in agricultural employment, underlining the sector’s declining viability. Agrarian distress is now endemic, driven by crop failures, falling prices, and a broken promise of security through insurance. As per the National Crime Records Bureau (NCRB) 2015 data, 80 per cent of suicides among farmers were due to debt and bankruptcy. The crisis has also exhibited a steady trend upward, with more than 1,12,000 people who work in the agricultural sector having died by suicide over the last ten years, according to NCRB data released in December 2023. The figures indicate that no fewer than one farmer died by suicide every hour in India. A 2018 survey conducted by the National Statistical Office (NSO) found that over 50 per cent of farm households in India had debt. Launched in 2016, the Pradhan Mantri Fasal Bima Yojana (PMFBY) assured crop



insurance and restored farmers’ confidence. On paper, it addressed many of the earlier shortcomings. But a closer look reveals that this ambitious insurance service ends up replicating several flaws of earlier schemes. It not only falls short of meeting the expectations of the farming community but alienates the very people it was meant to safeguard. A fundamental flaw resides in the impenetrable, convoluted, and overly technical process of settling claims. The use of satellite imaging and averaging data across vast units has created a mechanism highly disconnected from ground realities. Importantly, satellite inspections are limited in scope: they can only identify the presence or absence of crops. They cannot, and do not, determine the health or yield capacity of the crop, nor can they tell one type of crop from another. This technological weakness, when used as the basis for compensation, results in miscalculations that cost real livelihoods. A farmer who suffers heavy losses due to pest damage or loss of nutrients might be deprived of compensation just because their crops appear green from above. Even more appalling is the inherent inequity of the existing model. While farmers pay premiums on an

individual level, compensation is calculated by generalised averaging within village clusters or vaguely defined large patches aggregating both large and small landholdings without any equity-based method in delineating the units. This results in discriminatory denials of claims—most importantly, for those experiencing localised or complete loss of crops. The ongoing application of area-based measurement models exacerbates these issues. Localised weather conditions like a flash flood in a corner of a village can destroy a small farmer’s crop, while that of his neighbour remains intact. However, both are measured using the same parameter. It is deeply unfair that individual agony and suffering are erased by collective statistics. The programme also does not cover those most at risk: tenant farmers, sharecroppers, female cultivators, and non-loanee farmers. These are systematically and indirectly excluded by land title requirements, archaic tenancy laws, and bureaucratic obstacles such as Aadhaar-linked bank accounts. Women who increasingly become the main cultivators because of male migration are not accounted for in this system through absence of

formal landholding. These omissions are not accidental; they are manifestations of a design that does not see the true face of Indian agriculture in the present day. On-ground realities expose serious flaws in crop insurance delivery. Forced enrollment, delayed or denied claims, and faulty surveys have left farmers uncompensated and in debt. In Tamil Nadu’s Mayiladuthurai district, a mere 68 villages among 277 were covered in the 2024 crop insurance settlements—and compensation was paid in just 16 of them. Similar cases were found in other districts too. D Arogyam, a 55-year-old Tamil Nadu farmer who was not a loanee, was compelled by officials to sign up for PMFBY. Despite paying his premiums on time, he got no claims for two successive years of crop failure due to drought, pushing him into debt. S. Velu, a loanee cultivator from Sivagangai near Kiliyur, availed Rs 70,000 for his 15-acre field. Even though he was in the surveyed and insured area, he faced claim settlement problems as liabilities piled up. In Thoothukudi, farmers demonstrated against one-sided compensation. Villages that were affected by floods were not considered, while those with equal damage were compensated. Farmers accused the faulty surveys and demanded accountability. In Haryana, as reported by Down to Earth, Ramesh Lal from Sonipat was forced to pay a premium under threat of losing his interest subsidy on a loan, even though he never consented to the insurance coverage. When his crop failed, no claim was paid due to “tech-

nical issues” with the policy documentation he was never shown. In Rajasthan, many farmers lost their claims because the State Bank of India delayed crediting their premiums. Consequently, they went into the subsequent cropping season without anticipated reimbursement. Even when the Centre and states subsidise 80–85 percent of premium charges, private insurance companies consistently make profits while farmers do not gain much. Claims get delayed, disputed, or rejected, even as companies collect risk-free premiums. Meanwhile, crop-cutting experiments are done by inadequate manning, delayed rolling out, and poor-quality control, and the technological solutions like drones and AI-based analytics remain underutilised due to infrastructural gaps and lack of field-level training. Most alarmingly, a 2022 CAG report says that only 37 per cent of farmers surveyed had any real awareness of PMFBY’s benefits, premium structures, or claim processes. On-ground realities expose serious flaws in crop insurance delivery. Forced enrollment, delayed or denied claims, and faulty surveys have left farmers uncompensated and in debt. Threats to India are not over. Why it must build fortress-like defences

The Sindhudurg Fort, located on an islet in the Arabian Sea near Maharashtra’s Malvan town, is one of the most significant sea forts. It was built between 1664-1667 by Chhatrapati Shivaji Maharaj, the founder of the Maratha Empire, for the purpose of strategic maritime defense and protection against foreign naval threats. The fort was central to Shivaji’s plan to build a strong navy and protect the Konkan coastline, and marked the beginning of India’s maritime defense strategy. In a similar vein, having demonstrated its military prowess in Operation Sindoor, India should now transform itself into Sindoor Durg, an impenetrable fortress, safe from multi-domain threats emanating from land, sea, air or cyberspace. It will also mark the beginning of India’s new doctrine against terrorism, as outlined by Prime Minister Narendra Modi in his address to the nation earlier this month—“Terror and trade cannot go together, water and blood cannot flow together”. The

military strikes on terror infrastructure in Pakistan under Operation Sindoor have only been paused. Pakistan, still smarting from the costs imposed on it, both reputational and on its military, will be thirsting for revenge. The brief skirmish has only served as a distraction for Pakistan from its domestic issues, especially its dire internal economic conditions, and has predictably united the country, even if temporarily, against a traditional foe. Buoyed by the grant of the IMF bailout, and by promoting Asim Munir to the rank of Field Marshal, Pakistan’s politico-military leadership hopes to retain their tenuous hold on power. Since another misadventure cannot be ruled out, we have to guard against even more varied and audacious threats.

The first purpose of a fort is to provide for its own security and that of its inhabitants. India has demonstrated quite forcibly its capability to safeguard its sovereignty and territorial integrity.

India must look beyond Bangladesh

The political turmoil in Bangladesh has made it more urgent for India to complete the Kaladan Multi-Modal Transit Transport Project, or KMTP, which links Mizoram to Kolkata via Sittwe port in Myanmar. If fully operationalised, ideally with a rail link to Sittwe Port, it could offer a more resilient corridor for movement of goods to the Northeast, while also opening up longer-term trade possibilities with Southeast Asia. India’s role as the pivot in South Asia extends beyond dominant power to that of a regional integrator. Intra-regional development is primarily a function of mutual friendship, interdependent trade, economic ties, and joint ventures. The goal may be to advance national interest, but the net effect is regional prosperity, which acts as a force multiplier for India’s own development. South and Southeast Asian countries, joined together through bilateral and multilateral frameworks like the BBIN and BIMSTEC, have therefore started looking beyond the region—in line with India’s Act East Policy. Apart from economic commitments, physical connectivity—especially in infrastructure and energy—has assumed unparalleled significance. Railways, high-

ways, civil aviation, and inland waterways are now crossing borders for mutual growth and development. The East South Asia region is on the cusp of unprecedented intra-regional physical connectivity. It is the only way forward for the 21st century. For instance, Nepal and Bhutan, both landlocked nations, have gained access to Indian markets and ports. Newer cross-border rail links have been operationalised between India and Bangladesh, and several projects to connect Bhutan and Myanmar were put in place during the last 10 years.

India-Bangladesh bilateral relations, in particular, had never been this strong and comprehensive—until last year. On 5 August 2024, Bangladesh Prime Minister Sheikh Hasina resigned following a massive uprising. An interim government headed by Chief Adviser Muhammad Yunus has since been formed. This civil strife in Bangladesh has come with ripple effects. It’s brought with it a certain straining of relations, causing collateral damage to trade and commerce. There have also been instances of cross border movements and joint project developments coming to halt. Existing trade corridors have been impacted

and ongoing rail/road projects to provide shorter transit corridors across Bangladesh to and from India’s Northeastern states are on hold. It’s time now to look at alternative possibilities for northeastern states in addition to the Siliguri corridor. The Kaladan Multi-Modal Transit Transport Project requires revisiting and a fresh reassessment. During his visit to China in late March, Bangladesh’s Chief Adviser Mohammad Yunus made remarks that were considered provocative, to say the least. “The seven states of India, the eastern part of India, are called seven sisters....”

They are a landlocked country, landlocked region of India. They have no way to reach out to the ocean,” he said. “We are the only guardian of the ocean for all this region.” Shortly thereafter, Prime Minister Narendra Modi attended the BIMSTEC conference in Thailand. He met Yunus on the sidelines and reiterated his support for a democratic, progressive, and inclusive Bangladesh, according to a Ministry of External Affairs release. He also underlined India’s desire to forge a constructive relationship with Bangladesh. More importantly,

AIADMK led the way on caste census

In the intricate fabric of Indian democracy, few questions strike at the heart of equality and representation like that of caste. The recent announcement by the Union government to conduct a comprehensive caste census is a landmark moment—one that promises to reshape the contours of social justice policy in India. As the Leader of the Opposition in Tamil Nadu, I welcome this move with conviction and pride, for it affirms a demand the All India Anna Dravida Munnetra Kazhagam first articulated with clarity and foresight. This moment did not emerge overnight. The call for a caste-based census, now

accepted at the national level, has its roots in the firm ideological soil of Tamil Nadu’s social justice movement. And in that journey, it was the AIADMK, under the visionary leadership of Puratchi Thalaivi Amma J. Jayalalithaa, that laid the foundation for genuine representational equity. As early as 2021, during my tenure as chief minister, our government was among the first to demand a fresh caste census. We argued vociferously that welfare policies cannot be built on outdated data from 1931. We recognised then, as we follow now, that progress requires not just empathy but evidence. Tamil Nadu has long stood as a bea-

con of affirmative action, with its unique 69 per cent reservation policy. That achievement was not accidental but was made possible by AIADMK’s political resolve and constitutional acumen. When the Supreme Court’s Indra Sawhney (Mandal) judgment in 1992 imposed a 50 per cent cap on reservations, the very framework of Tamil Nadu’s policy was threatened. But Amma Jayalalithaa rose to the challenge. In 1993, she convened a special assembly session, passed a unanimous resolution, and led an all-party delegation to Delhi. Her persistent persuasion ensured the Tamil Nadu Reservation Act was placed in

the Ninth Schedule of the Constitution, protecting it from judicial review. That was not just governance; it was transformative leadership. Our 2021 demand for a caste census was not political posturing. It was a reflection of AIADMK’s long-standing understanding of Tamil Nadu’s evolving social realities. We recognised the urgent need to reassess the representation and well-being of Backward Classes (BC), Most Backward Classes (MBC), Scheduled Castes (SC), and Scheduled Tribes (ST) in education, employment, and welfare. This demand, when initially raised, was met with silence from the ruling DMK.

Delhi disbands school management committees

Delhi: The Directorate of Education (DoE) in Delhi has ordered the immediate dissolution of all school management committees (SMC) in government and government-aided schools. A circular states that committees would be reconstituted on May 9 through new elections. A school-level election committee managed by the head of school and supported by a teacher convener would elect new SMCs in each school, according to the circular. Due to an apparent cost hike, parents are frustrated and protesting. When SMCs should have addressed such concerns, many parents blamed mismanagement.

"The responsible authority dissolved all school management committees for government and government-aided schools of the Directorate of Education, GNCT of Delhi, immediately. The circular states



that a school-level SMC election committee, led by the school's head and assisted by its teacher convener, would hold elections to form a new SMC. Several DoE guidelines were issued. The new SMC shall comprise at least 50% women and representation from marginalized groups including Scheduled Castes, Scheduled Tribes, Other Backward Classes, and Economically Weaker Sections. The elected parents will choose a vice-chairperson. The SMC will also invite three social science, science, and math instructors as special invitees.

Hindu University establishes public policy institute

Delhi: Hindu College at Delhi University has set itself apart from other Indian universities by creating a public policy lab. Officials have stated that the goal is to include real-world policymaking into both undergraduate and graduate programs. With the goal of democratizing and decentralizing the process of knowledge generation, the lab is designed to serve as a hub for policy simulations, applied research, and field-based insights. This will bring

All corridors must have fire extinguishers for fire safety

Delhi: New heat-reduction measures at schools have been added by the DOE. DOE requires "no classes be conducted in open-air environments" and no afternoon assemblies to protect kids. It ordered schools to cancel outside activities until the weather improves. Schools must always provide clean drinking water to emphasize hydration. The DOE requires planned water breaks and RO system and water cooler maintenance. Schools are required to ventilate and have working fans in classrooms for com-



fort. According to the DOE directive, all corridors must have fire extinguishers for fire safety. It has also advised schools to teach children to cover their heads in the sun, especially while commuting. It further states that "no student, parent, or staff member shall stay or

sit in open or exposed areas under direct sunlight." Health readiness is paramount. Any heat-related disease must be treated immediately. First aid packs should include oral rehydration for sick pupils. It requires reporting all heat-related illnesses to the nearest hospital.

Global democracy has changed: Rahul

Delhi: Congress leader Rahul Gandhi said democratic politics have changed worldwide and that a decade-old rule no longer applies. The Lok Sabha Leader of Opposition argued that old political techniques are no longer effective against the modern concentration of capital, media, and social media. Gandhi stated the exist-

ing political leadership paradigm is "obsolete" and a new style of leadership must be built. Reclaiming democratic spaces and reinventing priorities like healthcare are the real challenges. "The modern concentration of capital, media, and social media overwhelms old tools. He claimed the traditional political model is anti-

quated and a new leadership style is needed. He said the Congress felt "trapped and isolated" in a political climate that no longer permitted it to operate freely, which led him to the "Bharat Jodo Yatra". The party felt confined and isolated some years ago. These new, aggressive politics aim to crush the opposition without talking.

NEET-UG on May 4 amid malpractice prevention measures

Delhi: The National Testing Agency will hold NEET (Undergraduate) 2025 at 5,500 exam centres in India and abroad, up from 4,750 in 571 cities last year. The test will be held in 552 Indian and 14 overseas cities this year. The education ministry has tasked 180 central entities with checking center readiness. Assam's CM Himanta Biswa Sarma requested that all centers be at government-run institutions. Several cities have expanded due to candidates' first-choice center allocations. NTA officials say 90% of the centers are at government-run Kendriya Vidyalayas, Jawahar Navodaya Vidyalayas, and state schools. The datesheet for CUET-UG 2025, starting May 8, is still pending. After paperleak claims and widespread complaints about NEET-UG 2024, NTA organized state- and district-level logistics and security committees. The NTA consulted district magistrates (DMS), superintendents of police (SPs), and senior local officials before choosing exam centers. They and district coordinators will oversee operations to ensure smoothness.



A survey on cybersecurity activities for curriculum design and education

Delhi: As our technological era progresses, cyber attacks have emerged as a major issue. Cybersecurity experts who can identify, stop, react to, or lessen the impact of cyberattacks are in great demand as a result of this problem. Nevertheless, there is a severe lack of trained cybersecurity experts around the globe. Many new cybersecurity education programs have emerged to meet this challenge; for example, computer science graduate programs.

NTA offers a paper leak reporting portal

Delhi: The NTA launched an internet website to report dubious NEET (UG) 2025 medical entrance exam allegations. This campaign follows the 2024 NEET-UG exam fiasco, which included question paper leaks and cheating in various states. NTA advised candidates to avoid fake claims in its publication. The organization cautioned candidates not to be deceived by unscrupulous elements who commit malpractice and make false claims. NTA Director General Pradeep Singh Kharola said candidates can report suspicious activities in three categories unauthorised websites or social media accounts claiming access to NEET question paper.

Students to be screened for 21 disabilities

Delhi: The Directorate of Education has ordered all schools, including government, aided, private, and those under local bodies like the Municipal Corporation of Delhi and Municipal Council, to screen every student for 21 types of disabilities as defined by the Rights of Persons with Disabilities Act, 2016. The Prashast mobile app and checklist instruct teachers to look for overt and subtle symptoms of difficul-



ties in pupils, such as bad handwriting, trouble making eye contact, lack of direction, and being lost in an imaginary world. Early disability identification, support, and inclusive education are the main goals. Teachers will learn how to utilize the app and record observations. Parents must

give a no-objection certificate before screening a youngster. Screening-identified disabilities will be evaluated by experts. School-level screening must end by July 25 and district coordinators must receive final reports including class-wise and consolidated data by July 31.

Implications for management education in the creation and validation of a scale measuring student well-being in higher education

Delhi: In the increasingly stressful world of higher education, students' physical, mental, and social health are all part of what is known as student well-being (SWB). The higher education sector is confronted with the increasing difficulty of preserving and improving SWB in the face of excessive workloads, unmet expectations, and uncertainty around degree completion and employment. The current tools for evaluating SWB are too narrow in scope to adequately represent its complex character. Our research fills this need by creating and validating a multi-dimensional scale that accurately measures SWB's subtleties using a rigorous multi-study, multi-method, and multi-



sample strategy. Generation, purification, refinement, validation, and generalizability were the five systematic steps that made up this process. The outcome is a five-factor SWB scale that offers a comprehensive instrument for assessing and enhancing SWB in academic settings. These dimensions include academic, financial, physical, psychological resilience, and relational well-

DU teachers raise issues of unoccupied reserved seats

The Delhi government has adopted a one-year bond program for doctors, who will face significant financial penalties if they fail. Doctors are angry about the government bond notification. Delhi doctors want the policy revoked or regularized.

An anonymous senior health ministry official states, "Health services like bond policy, working hours,



and salary come under the state administration.

Doctor bond measures have been strongly opposed by the NMC advisory. State governments make the final decision." Maharashtra, Gujarat, Rajasthan, Gujarat, Madhya Pradesh, Uttar Pradesh, Haryana, Tamil Nadu, Karnataka, Andhra Pradesh, Telangana, Kerala, Goa, West Bengal, Assam, Andaman and Nicobar Islands, Arunachal Pradesh, and others

"We are forming a committee to introduce AI laterally across all programs, especially Applied AI," stated AICTE Chairman Prof. TG Sitharam. "The goal is to integrate AI and related courses into all academic programs so that students from all walks of life can learn the basics of AI and data analytics."

The local administration on Monday afternoon issued the prohibitory order in parts of the district, but the two sides held simultaneous protests defying the order, prompting authorities to impose curfew. The controversy is said to have begun when two youths, Haider Ansari and Amanat Ansari, uploaded a video on TikTok in Janakpur, Dhanusha. Locals claimed the video hurt religious sentiments and handed the youths over to the police. Tension had started to flare in ward 6 of Kamala Municipality after a mosque was vandalized.

LAHORE

Pak church ransacked after dispute

A church has been attacked by a group of Muslim men who ransacked it and desecrated the Bible in Punjab province of Pakistan, police said on Tuesday. The Feroz Din Memorial Church in Kot Radha Kishan, Kasur district, some 50 kms from Lahore, came under attack in early hours of Monday by a group of unidentified men. Police, however, claim to have arrested a prime suspect, Allah Rakha, and booked him under blasphemy and other charges. Rakha had a quarrel with some members of Christian community in the village over some issue, police officer Mohammad Essa said. "To vent his anger, he entered the church and ransacked it. Some Christian religious symbols and church property were damaged and the holy book of Christians was also desecrated," the police officer said.

No Venezuela elections in next 30 days, says Trump

WASHINGTON

US President Donald Trump said the United States is not at war with Venezuela and will not push for elections there in the near term, arguing that the country must first be stabilised and its infrastructure rebuilt following the capture of its leader, Nicolas Maduro.

In an exclusive interview with NBC News, Trump said Venezuela would not hold elections in the next 30 days. "We have to fix the country first," Trump said. "You can't have an election if people can't even vote."

Trump said Washington's focus is on restoring basic order and rebuilding the economy. "We have to nurse the country back to health," he said, indicating that the transition would take time.

The president said US oil companies could play a central role in rebuilding Venezuela's energy infrastructure, an effort he suggested could take less than 18 months.



Assange lawyer in Maduro team

WASHINGTON

The legal proceedings against captured Venezuelan President Nicolás Maduro took a high-profile turn in a Manhattan federal court on Monday, as the embattled leader appeared with Barry Pollack as his private counsel.

Pollack, a renowned trial lawyer, is most famous for his years-long representation of

WikiLeaks founder Julian Assange, a role that culminated in Assange's 2024 release from a UK prison. The choice of such a prominent defender signals a high-stakes legal battle as Maduro prepares to fight a litany of federal charges.

A partner at the Wall Street-based firm Harris St. Laurent & Wechsler, Pollack is no stranger to complex, international litigation. His new client, whom the U.S. government has

characterized as an "illegitimate president" and a "narcoterrorist," pleaded not guilty on Monday to several severe counts. These include drug-terrorist conspiracy, cocaine-importation conspiracy, and the illegal possession of machine guns and destructive devices. If convicted on these charges, the former Venezuelan leader faces a maximum sentence of life in prison.

After Maduro op, Rubio will lead US strategy in Caracas

WASHINGTON

US Secretary of State Marco Rubio has been designated by President Donald Trump to lead implementation of Washington's post-operation strategy in Venezuela, the White House said, outlining a whole-of-government effort that spans diplomatic, economic, financial, and military tools.

Stephen Miller, a close adviser to the president, told reporters at the White House on Monday that Rubio has been asked to enforce the president's guidance and coordinate across agencies.

"The President of the United States has asked Secretary Rubio to directly enforcement of the President's post guidance and direction to be the lead on this process," Miller said, adding that the work involves "energy policy, Treasury policy, financial policy, military policy."

Miller pointed to US control over key pressure points. "We have an oil embargo on Venezuela," he said. "For them to do any kind of commerce, they need our permission."

He also cited the continued US military posture in the region. "We have our massive

fleet, our Armada still present there," Miller said. "This is an active and ongoing US government military operation. So, of course, we set the terms and conditions."

Meanwhile, Secretary of State Marco Rubio and other top officials briefed leaders in Congress late Monday on the striking military operation in Venezuela amid mounting concerns that President Donald Trump is embarking on a new era of U.S. expansionism without consultation of lawmakers or a clear vision for running the South American country.

B'desh Hindu man killed, 2nd in 24 hrs

DHAKA

A 40-year-old Hindu man, who owned a grocery shop, has been murdered in Bangladesh's Narsingdi city after unidentified attackers struck him with a sharp weapon, media reports said on Tuesday. The killing on Monday night, fifth since December 18 and second in the past 24 hours, underscores a spate of violence targeting members of the minority community ahead of the polls next month.

The victim, Moni Chakraborty, was attacked at Charsindhur Bazar in Palash Upazila at 11pm on Monday, bdnews24 reported. Police and local residents said he was returning home after closing his shop when unidentified attackers struck him. He collapsed on the spot. Locals rushed him to a hospital, where doctors declared him dead. His body was later sent to the Narsingdi Sadar Hospital morgue for autopsy.

Police name 17 in Hadi killing chargesheet

DHAKA/NEW DELHI

Student leader Sharif Osman Hadi was killed due to "political vengeance" at the behest of the Awami League, Bangladesh police said on Tuesday as it pressed formal charges against 17 people in connection with the murder.

"Through public rallies and social media, Hadi had strongly criticised the past activities of the now-banned Awami League and Chhatra League. Hadi's outspoken remarks angered leaders and activists of Chhatra League and its affiliated groups," Md Shafiqul Islam, Additional Commissioner of the Dhaka Metropolitan Police's (DMP) Detective Branch, was quoted as saying by news portal tbsnews.net.

The Chhatra League is the student wing of deposed prime minister Sheikh Hasina's Awami League party.

Nobel winner Machado vows to return home, bats for polls

WASHINGTON

Venezuela's main opposition leader Maria Corina Machado has vowed to return home quickly, praising U.S. President Donald Trump for toppling her enemy Nicolas Maduro and declaring her movement ready to win a free election.

Trump appears, however, to hope for now to work with interim President Delcy Rodriguez and other senior officials from Maduro's government, disappointing the



opposition and contributing to the nervousness gripping Venezuela.

"I'm planning to go back to Venezuela as soon as possible," said Machado, 58, an indus-

trial engineer and mother of three who escaped from Venezuela in disguise in October to receive the Nobel Peace Prize, which she dedicated to Trump.

Europe stands by Denmark as US prez eyes Greenland

BERLIN

Several European leaders pushed back Tuesday on US President Donald Trump's comments seeking an American takeover of Greenland.

The leaders issued a statement reaffirming the strategic, mineral-rich Arctic island "belongs to its people." The leaders of France, Germany, Italy, Poland, Spain and the United Kingdom joined Danish Prime Minister

Mette Frederiksen in



defending Greenland's sovereignty in the wake of Trump's comments about Greenland, which is a self-governing territory of the kingdom of Denmark.

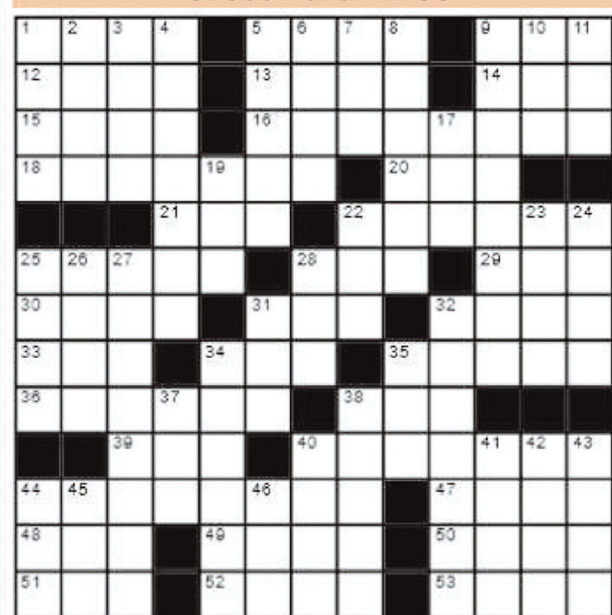
Stephen Miller, the White House deputy chief of staff, said Monday that Greenland

The first three names used to address or describe the Almighty in the Vishnu Sahasra Nama Stotram are "Vishwam Vishnur Vashatkara". 'Vishwam' is used in the sense of 'universe', and we use it limitedly as 'world'. Nadam is the tune. The Almighty is reverentially addressed as the universe itself (holding the power of the universe), the one who is all-enveloping (Vishnu) and the one who is invoked with Vashat Karam. We learn that the universe originated with the sound of Aum+karam. The originated AUM sound has A, U, and Ma, with an extension. These, respectively, denote the beginning, sustenance, and the end state. Thus, we can correlate this with our own experience of the beginning, the continuing, and the end state. As 'kala' (time) is denoted, the longer unit of time of a year begins, continues for a fixed twelve months, and then comes full circle. The fourth-half sound after the three syllables of A, U, and Ma represents the Turiya sthiti, which is beyond the three states.

Jagrat is a well-known awakened state of external focus. Swapna is the dreamy state of internal focus. Sushupti is the blissful state and is beyond the external/internal state. The fourth is beyond all the three states. As the famous example goes, we are

aware of being awake and dreaming in the first two stages. We are also aware of the third deeper stage of "we are not aware". The absence of self, who is witnessing all these three, is the Turiya state. In Turiya, the self is all-encompassing. Some schools propose the Turiyateeta state, meaning "beyond all beyonds". In the third, the experience is absent, and in the fourth, there is no one to know whether the experience is happening. A thousand-mile journey begins with the first step.

How do we experience the Pranavam or Aum or Omkar? Is it an external sound or internally generated and experienced? Is Anahata the source of this primordial shabdha? How do we experience this "Shabdha Brahma"? Will losing or turning off the external open the internal? Is the absence of all experience Purna? If the experiencing person is part of the Purna, how can experiencing happen? Submergence? Convergence? May this year sharpen the quest and inspire more to travel the path, where the journey itself is the destination. The current cacophony shall end, and the Vishwam will vibrate to a sustainable AUM.

Consumer authority slaps Rs 10 lakh fine on Rapido for misleading ads

NEW DELHI: The Central Consumer Protection Authority (CCPA) has imposed a penalty of Rs 10 lakh on ride-hailing platform Rapido for disseminating misleading advertisements and engaging in unfair trade practices. The action was taken suo motu by the authority following investigation into the company's advertisement claim: "Guaranteed

Auto. Auto in 5 mins or get Rs 50". The CCPA, in its order issued on Wednesday, directed Rapido to immediately discontinue the misleading advertisements and compensate consumers who were not provided the promised cashback. Each affected consumer is to be paid Rs 50, as originally advertised. It also instructed the company to file a compliance report within 15

days. According to CCPA, Rapido's misleading advertisement ran for over 18 months in multiple regional languages and across more than 120 cities. "Therefore, the CCPA finds it necessary to impose a penalty to safeguard the interests of consumers," it said. As per the order, between April 2023 and May 2024, 575 complaints were filed against Rapido on the

National Consumer Helpline and these covered issues such as non-refund of amounts, overcharging, service deficiency, and failure to provide promised benefits. Of these, five complaints were directly related to the misleading "guaranteed auto" claim, which could only be redeemed against bike rides and expired within seven days. The authority found that these terms

were neither clearly stated nor prominently displayed. In its defence, the company submitted that the terms and conditions were clear that customers would be eligible for coins "up to Rs 50 which could be redeemed Bike rides on Rapido platform" and that the validity of such coins was for 7 days from the time it is credited to customer".

AU\$90 million penalty: Qantas Airways fined for illegal sackings

Qantas: A judge in Australia fined Qantas Airways 90 million Australian dollars (\$59 million) for unlawfully dismissing more than 1,800 ground staff during the early stages of the Covid-19 pandemic. The penalty is in addition to the AU\$120 million (\$78 million) compensation the airline had already agreed to pay dismissed employees. Justice Michael Lee of the Australian Federal Court ruled that the dismissal of 1,820 baggage handlers and cleaners at

airports in late 2020 was the most serious breach of Australian labour laws in their 120-year history, according to the Associated Press. After Qantas's appeal was unanimously rejected by seven High Court judges last December, the airline confirmed its wrongdoing and agreed to pay AU\$120 million in compensation. The Transport Workers Union (TWU), which initiated the case, had sought the maximum penalty of AU\$121 million.
