### India's forest cover expanded by mere 2.5% in 10 yrs but 'very dense' cover

**NEW DELHI:** India's forest cover increased 2.5% merely between 2010-11 and 2021-22, but the 'very dense forest' component of it grew by 22.7% during the period, indicating effective regen-



eration and conservation efforts, claimed the central govt's first-ever dedicated publication on forest accounting. It recorded a decline only in the 'moderately dense category. forest' Released on Thursday, physical asset the

accounting showed that cover (very moderately dense, dense and open forest) increased 6,97,898 sq km in 2010-11 to 7,15,342 in 2021-22, adding 17,444 sq km (2.5%) in 10 years. During the same 10year period, 'very dense forest' (VDF) increased by 19,000 sq km (from 83,502 sq km in 2010-11 to 1,02,502 sq km in 2021-22), whereas 'moderately dense forest' (MDF) decreased.

## Amit Shah sets 160+ target for **NDA** in Bihar elections

PATNA/ARARIA: Union home minister Amit Shah set on Saturday an ambitious target of winning over 160 of total 243 seats in upcoming Bihar assembly elections, and urged BJP workers to visit every household and publicise NDA govt's achievements.

Addressing a gathering of party workers from 10 Seemanchal districts at Forbesganj in Araria on the second day of his Bihar visit, Shah attacked RJD-Congress combine, claiming their campaigns aimed to protect voting rights of infiltrators.

"BJP will kick out each and every infiltrator from the state and the country," he asserted, while insisting no bona fide Indian citizen's had been removed in the special intensive revision of Bihar electoral rolls.

## EC gears up for Bihar poll dates, announcement likely on October 6-7

NEW DELHI: With the final electoral roll for Bihar set to be published on Sept 30, the Election Commission will immediately start warm-up for announcement assembly poll dates, starting with a meeting with poll observers on Oct 3 and a visit by the full commission to the state on Oct 4 and 5. This is likely to be fol-

lowed by a meeting with the Union home secretary to finalise the logistics relating to deployment of central forces for poll security. Given that the aforesaid engagements penultimate formalities before announcement may hold the press conference soon after to release the Bihar poll schedule, possibly as early as Oct 6 or 7. There have been precedents when the meeting with the home secretary was done on the same as the poll announcement.

#### Why are 5.3cr cases pending in **Indian courts? Missing lawyers** & witnesses, long stays...

**NEW DELHI**: The Supreme Court, while adjudicating a matter related to inexplicable delays in disposal of cases in trial courts last week, observed that a speedy trial, as part of the right to life, is an unimpeachable right. But what happens when counsels are not available in over 62 lakh cases, accused are absconding in more than 35 lakh cases, witnesses are missing in nearly 27 lakh cases, and over 23 lakh cases are stayed by differ-

As of Sept 25, 5.34 crore cases are pending across all courts in the country, including 4.7 crore pending trials in district and subordinate judiciary, 63.8 lakh in high courts, and 88,251 before the SC. While reasons for delay are not available for cases pending before the Supreme Court and high courts, the National Judicial Data Grid (NJDG) has cited 15 reasons behind delays in 1.78 crore cases before lower courts, out of the 4.7 crore pending with them. Of the cases with available reasons, 81% are criminal and 19% civil. For roughly three crore cases, no reasons have been provided. The main reasons cited are "counsels not available" in over 62 lakh cases; absconding accused in over 35 lakh cases; missing witnesses in nearly 27 lakh cases; stay by various courts in over 23 lakh cases; "awaiting documents" in over 14 lakh cases; and "parties not interested" in almost 8 lakh cases. The other reasons cited by the NJDG include frequent appeals, unavailable records, miscellaneous applications blocking trials, parties seeking additional witnesses, and legal representatives of deceased parties not being on court records.

## Two Bihar wetlands join global list of Ramsar sites

NEW DELHI: Two more wetlands - both in Bihar - have been included in the global list of Ramsar Convention sites and categorised as wetlands of international importance. It brings the total number of such sites in India to 93, continuing the country's top position in Asia and third in the world after the UK (176) and Mexico (144) in terms of total number of Ramsar sites.

The additions are Gokul Jalashay in Buxar district and Udaipur Jheel in West Champaran district, bringing the total number of such wetlands to five in Bihar.

## HP cold desert now on Unesco's list of biosphere reserves

**NEW DELHI: Unesco** on Saturday designated India's Cold Desert Biosphere Reserve, located in western Himalayas and spread over 7,770 sq km of windswept plateaus, glacial valley and high-altitude desert in Lahaul and Spiti district of Himachal Pradesh, as one of the biosphere reserves of its global network.

India has a total 18 biosphere reserves, of which 13 are now in the Unesco's world network with the latest addition of the Cold Desert Biosphere Reserve in the list.

The global designation helps these sites adopt comprehensive measures to foster harmony between people and nature for sustainable development. "These globally recognised areas are more than just protected land - they are living laboratories

## Fake PwBD docus, attempts at remote access in CGLE tier-1

**NEW DELHI:** Instances of malpractice brought to notice of Staff Selection Commission (SSC) during the first tier of the computerbased Combined Graduate Examination (CGLE) 2025 completed Friday include submission of fake documents to qualify as 'persons with benchmark disabilities' (PwBD) and attempts at remote access.

### For private automobiles older than 20 years, the government is considering a fitness

Delhi: The road transport ministry has suggested a significant rise in the fitness test fee for private vehicles older than 20 years, as well as for medium and heavy commercial vehicles older than 15 years, just weeks after the government increased renewal charges for older vehicles. The cost of the test will be Rs 25,000 for trucks and buses, and Rs 2,600 for vehicles that are 20 years old. It has learned that the goal of this change is to make individuals less likely to keep their outdated cars. After 15 years on the road, the government is reportedly thinking about instituting fitness exams for private vehicles. At this time, RTOs do not conduct tests on private automobiles in order to issue fitness certificates; instead, they merely inspect them.

## An e-rickshaw headed for Chitrakoot collided with a loader, killing a mother and son

Mahewaghat, Kaushambi. An e-rickshaw carrying eight passengers from the West Sharira police station area, heading to Chitrakoot for darshan, collided with a loader pickup near Shahpur village in the Mahewaghat police station area. Following the collision, the e-rickshaw overturned. All passengers were injured after falling to the ground. A mother and son died tragically on the spot. Six people were injured in the accident. Following the accident, people from the vicinity rushed to the scene and informed the police and ambulance. ## **Total capex outlay** for 2024-25

The Union government's capital expenditure (capex) continues to be a cause for concern. Of course, the extent of its decline has reduced somewhat — from 35 per cent at the end of the first quarter of the current financial year to 15 per cent at the end of six months. But the latest number for the April-November 2024-25 period shows that the Union government's capex was still 12 per cent lower than what it was in the same period of 2023-24. Instead of aiming for the targeted 17 per cent growth to ~11.11 trillion in capex for 2024-25, the government will have to strive hard to at least cross the figure of ~9.48 trillion reached last year. What has led to this decline? A widely held view is that the seven-phase general elections, which began on April 19 and ended on June 1 last year, caused a slowdown in capex. But if that indeed is the reason, the decline in capex in the first quarter should have been reversed in the second quarter of 2024-25. And certainly, the first two months of the third quarter should have raised the trajectory of capex growth to a higher level. There has been some improvement, but a 12 per cent decline in the April-November 2024-25 period is no comfort. Look at the slightly different trajectory seen in the Union government's revenue expenditure growth during the same period. The Budget for 2024-25 had projected a rise of over 6 per cent to ~37.1 trillion in revenue expenditure. At the end of June 2024, the growth was just about 2 per cent, but it has been rising since then, reaching 4.2 per cent by the end of the first six months of 2024-25 and climbing even higher to 7.8 per cent during April-November 2024-25. So, if revenue expenditure has gained momentum, why has capex failed to follow suit? A close analysis of the government's capex numbers presents an interesting picture. Over 90 per cent of the Centre's total capex during 2024-25 was accounted for by just six sectors — roads, railways, defence, telecom, transfer to states and new schemes. Their share in total capex in 2023-24 was a little less at 87 per cent. But the 12 per cent decline in the first eight months of 2024-25 is primarily the result of a marked slowdown in only two of these six areas - roads and defence, which accounted for over 40 per cent of the total capex outlay for 2024-25. Capex on the construction of roads and highways fell by 16 per cent, while defence saw a decline of 15 per cent. This is serious and has worrying implications for both infrastructure and defence. The problem of slowing expenditure in these two areas should not have been difficult to fix. Either effective monitoring of spending is lacking, or there are serious problems with project execution, reflecting the poor expenditure-absorbing capacity of these two sectors. This is borne out by a relatively good performance of the Indian Railways, which accounts for over 22 per cent of this year's capex. At ~1.68 trillion, the Indian Railways' capex is just about 1 per cent lower than its spending during April-November 2023. With regard to the transfer of special assistance as loans to states for their capex and additional central assistance for their externally aided projects, the Union government's performance was slightly better. In the April-November 2024-25 period, these transfers rose by about 5 per cent, although much lower than the budgeted increase of 41 per

In contrast, such transfers during the entire 2023-24 had risen sharply by about 24 per cent to ~1.15 trillion. It appears that these transfers

will take a hit in the current year and for the first time since this initiative

## **Editorial** Investors line-up for Excitel's \$200-million

Extension of the Production Linked Incentive (PLI) scheme for solar energy value chain, increased allocation towards PM Suryaghar Muft Bijlee Yojana, and greater thrust to distribution and transmission infrastructure are likely to be the key features of the upcoming Budget, as far as the energy sector is concerned. Sources said these proposals figured not only in the budget wish lists of the industry, but also in the respective recommendations from the ministries of power and renewable energy to the finance ministry , ahead of the Budget. "Given the success of PM Suryaghar scheme with almost 600,000 installations in just nine months since its launch, one could probably see additional allocation to target more households," said Ashwin Jacob, partner at Deloitte India. "As far as evacuation of power from offshore wind projects is concerned, we would want to see the VGF or budgetary support to continue or get enhanced," he added. "We hope to see a decisive increase in funding to accelerate the green energy transition. Priorities must include scaling renewable energy by addressing grid and transmission challenges, advancing Battery Energy Storage Systems (BESS) for grid stability and reliable power, doubling energy efficiency and digitalizing the energy sector through AI, smart meters, and data-driven solutions. Streamlining rooftop solar strengthening of climate



programs with simplified approvals, financing, and monitoring is equally vital," said Saurabh Kumar, Vice President – India, Global Energy Alliance for People and Planet (GEAPP). Sharat Goyal, CEO of Impact Infracap also expects the government to remove restrictions on state wise caps on roof top capacity for netmetering for industrial establishments. "Further, adoption of batteries to substitute use of diesel generators for backup power should receive incentives and policy support given their role in reducing dependence on imports," he said. While the government increasingly working towards enhancing the country's RE capacity, the distribution and transmission infrastructure for its evacuation still needs to be strengthened. With the peak demand for power growing at a rate of 8-9% annually, the industry is looking forward to

resilient infrastructure augmentation. "One can expect new allocations towards augmentation of power distribution infrastructure, especially in high density/ urban load centres, in view of the sharp rise in peak demand over the last few years," said Anujesh Dwivedi, Partner at Deloitte India. He noted that there may be some allocation towards supporting the preparatory work especially on the listing of power utilities, or some incentive mechanism for promoting initiatives on private sector participation or listing of utilities at the state level because they are increasingly being seen as the much needed structural reforms the sector needs. The industry is optimistic of a wider coverage of the Revamped Distribution Sector Scheme by including smart metering in infrastructure definition.

"This would direct more financing for a sector which seeks to bring down India's

transmission and distribution losses to 12% and improve recovery for state utilities," Goyal said. Goyal also noted that power transmission despite significant potential has not seen any notable monetisation events which could address the latent investor demand. should "Government announce a time-bound privatisation programme for assets owned by PGCIL," he said. The sector also sees the PLI scheme for solar value chain to continue with possi-

structures for solar equip-

ment. Jacob highlighted. that there may be some rationalisation of duties on capital goods required for solar upstream manufacturing could be seen so that overall that industry can really take off. "We expect continuation and maybe broadening of the PLI support towards the solar module value chain. We already have a few interventions there, which are likely to be extended deeper," Dwivedi said. Similarly, on the battery manufacturing front, the industry expects localization of the value chain given competing countries have already advanced beyond India. In the green hydrogen segment, the industry believes the government may bring in hydrogen purchase for specific sectors like (green) steel. On the EV front, the industry seeks more support towards building public charging infrastruc-

ture given the anticipated

increase in the EV penetration. "Under the PM E-drive, we already have an allocation of about Rs 1,100 crores for FY26. Given that the final guidelines have not been released until now, I think even the allocation under FY25 may get added and FY26 budget may be increased as the country expects an acceleration in EV adoption in FY26," Dwivedi said. While the government has already launched a rooftop solar scheme and announced viability gap funding for offshore wind projects, industry players expect increased allocations, particularly towards solar and wind, along with higher budgetary capital expenditure in green hydrogen and battery storage infrastructure. Along with this, the sector also expects the government to increase its coverage of households under PM Suryaghar. "Under the Atmannirbhar Bhart scheme, there should be a scheme for the home grown EPCM companies to create indigenous technical capabilities in the country and reduce the foreign exchange outflow. We would also like to see a reduction on GST for engineering equipment and a reduction in import duties on chemicals in India," said Umesh Sood, CEO Simon India Ltd. Sunil Singhvi, President, Indian Electrical Manufacturers Association noted that there is a need for strong policy support to fos-



## Low affordability hits car demand: Kia India MD

**NEW DELHI:** With car going prices between 35-50% over the past 3-4 years, owing to safety and emissions mandates, affording a vehicle has become difficult for mass consumers and sales are likely to see a moderate growth of 3-4% in the coming year, Kia India MD Gwanggu Lee said on Thursday.

To generate demand, Lee suggests, govt can look at reducing taxes on cars from the current levels where midsized cars and bigger ones have a GST rate of over 45%, while smaller ones (under 4meters) are taxed at over 28%.

As the company prepares to launch affordable EVs as well as mainstream other cars, Lee said that the increase in car prices came at a time when incomes for many middle-class users did not go up at the same pace.As part of its strategy to perk up demand in the volume-laden entry SUV market, Kia drove in the all-new Syros mini offroader, which will stand besides its Sonet

This was the time first since Nov 29 that the index closed below the psychologically important 80K mark, data showed.



In the last four sessions the sensex has lost a little over 2,900 points, translating to 3.6%.

On the NSE, the nifty too followed a similar path and closed 247 points lower at 23,952 points. This was nifty's first close below the 24K mark since Nov 28, NSE data showed. In Thursday's session selling was across the board with foreign funds again leading. At close, net selling by foreign portfolio investors (FPIs) was Rs 4,225 crore. In comparison, domestic funds were net buyers at Rs 3,943 crore, data from BSE showed. According to Prashanth Tapse, Senior VP (Research), Mehta Equities, domestic markets tanked tracking negative global cues as benchmark indices slipped below their psychological levels. There was broad-based selling as the US Fed's hawkish stance raised concerns over further rate cuts next year. "Rising US bond yields have pushed global currencies, including the rupee to new lows while renewed foreign fund outflows from domestic equities could prompt investors to turn risk averse," he said. 

#### \$11.3 billion: Startup funding sees marginal rise in 2024

MUMBAI: After two years of funding slump, investments into India's startups are seeing some revival. Investors infused about \$11.3 billion into startups this year, a slight improvement from funding worth \$10.7 billion recorded last year, data sourced from market research firm Tracxn showed. In the coming year, companies are expected to see a

sizeable amount of funding cheques but the deployment of capital will be cautious, keeping in line with the trend seen for quite sometime now and late-stage



deals (over \$100 million) will take time to close, venture capital (VC) firms said. Not to say that there's a lack of capital-VC firms raised an estimated \$2.5 billion in funding in 2024 alone compared to less than \$2 billion in 2023 and some of them plan to raise new funds in 2025; but investors want to ensure they make the right bets. "As investors, we are very clear that we need to see a company's path to profitability, we need to see good governance structures, assess firms' go-to market strategies deeply and figure out founders' ability to deliver. When you diligence all of these, it takes some time and investing capital takes longer," Padmaja Ruparel, cofounder at IAN (Indian Angel Network) Group told. Quick commerce player Zepto led startup funding this year having bagged \$1.4 billion in investments alone amid a surge in investor appetite for rapid deliveries. A clutch of companies including PhysicsWallah, Rebel Foods, Eruditus and Purplle also managed to raise funD.
