#### FIR lodged against Arvind Kejriwal over Yamuna water remarks

**NEW DELHI: An FIR has been regis**tered against Aam Aadmi Party (AAP) national convenor and former Delhi chief minister Arvind Kejriwal over his statements regarding the Yamuna river water and allegations against the Haryana government.

Following a court order, hours before the Delhi elections, FIR was lodged at Shahabad Police Station in Kurukshetra, Haryana, against Keiriwal and other unidentified AAP members under various sections of the Bharativa Nyava Sanhita (BNS). Facing political attacks from BJP leaders, Kejriwal now finds himself entangled in legal trouble over his remarks on the Yamuna. The Haryana government earlier this week filed a criminal complaint against him, with Haryana Revenue and Disaster Management Minister Vipul Goel confirming that a case has been registered against Kejriwal in a Sonipat court under the Disaster Management Act.

Speaking to journalists after chairing a meeting of the urban local bodies department, Goel criticised Kejriwal's remarks as "absurd and misleading." He demanded that the Election Commission take strict cognisance of such "baseless statements," accusing the former Delhi CM of engaging in "cheap politics" ahead of the elections."The water supplied to Delhi is the same water consumed by the President, Prime Minister, and Union Ministers," Goel said, accusing Kejriwal of spreading fear among both Delhi

and Haryana's citizens.

# Trump to sign order on reciprocal tariffs ahead of PM Modi's US

US President Donald Trump plans to announce reciprocal tariffs ahead of Prime Minister Narendra Modi's visit to America, the White House said.

White House Press Secretary Karoline Leavitt told reporters she believed Trump's tariff plan could be announced before he meets with PM Modi on Thursday.

PM Modi is scheduled to reach US on Thursday and trade and tariff will likely to become one of the major issues that they will discuss. Trump's announcement of impos-

ing a 25 per cent tariff on steel and aluminium has already feared the Indian sellers and this new plan may only give a fever to the manufacturers and distributors.Trump pledged on Wednesday to introduce "reciprocal tariffs" on other nations, indicating he might sign an executive order within 24 hours, potentially escalating international trade tensions, AFP reported.

During his campaign, Trump stated: "An eye for an eye, a tariff for a tariff, same exact amount."

Experts suggest these reciprocal measures would involve adjusting



import tariffs to match those imposed by exporting nations on American goods.

In an Oval Office statement on Wednesday, Trump indicated he could authorise reciprocal duties either later that day or Thursday morning.

Economic experts caution that such measures could result in widespread tariff increases affecting developing economies such as India and Thailand.

Trump has implemented extensive tariffs on trading partners since assuming office on January 20.

A White House official disclosed to AFP Wednesday that Trump's proposed 25 percent duties on steel and aluminium imports would be additional to existing tariffs on Canada and Mexico. In early February, Trump announced comprehensive tariffs of 25 percent on Canadian and Mexican products, with Canadian energy imports facing a reduced rate of 10 percent.

However, he subsequently suspended these blanket tariffs on neighbouring countries for one month after they committed to addressing illegal immigration and fentanyl traffick-

According to the anonymous official, if these tariffs resume after the 30day period, duties on Canadian and Mexican steel and aluminium could reach 50 percent.

# India protests mistreatment, okays deportation of 96 more

**NEW DELHI:** India has out the possibility of PM protested the US handling of Indian deportees, who arrived handcuffed and shackled from San Antonio in a military plane on February 5, confirmed the government while officially PM announcing Narendra Modi's visit to Washington on February 12-13. Government sources, who confirmed that there are 96 more verified Indian nationals who may be deported to India soon, did not rule

Narendra Modi himself raising the mistreatment issue with President Donald Trump in what will be their first bilateral meeting since the latter's inauguration.

"Yes, we have registered our concerns with the US (on mistreatment)," said foreign secretary Vikram Misri, responding to a query from TOI about whether India had, like Brazil, officially protested the treatment meted out to its citizens.

Significantly, Misri also said at a media briefing that the military deportation to Amritsar, compared to earlier flights in the past, was of "slightly different nature" as the Trump administration has characterised deportation as a national security operation. "That's perhaps one of the reasons why a military plane was used," he said. Misri also revealed that, as of now, there are 487 presumed Indian.

# Modi to meet Musk during 2-day visit to US, possible discussion on Starlink's India plans

NEW **DELHI: Pri**me Minister Narendra Modi, who is on the way to the United States for his twoday visit, will meet Tesla CEO Elon Musk there and possibly they will discuss whether the South Asian market will open the door for Starlink or not, according to Reuters.

During his two-day visit, PM Modi will meet US President Donald Trump, where trade and tariffs could be the main topics of their discussions. He will also meet several leaders, including Elon Musk, over potential initiatives like Starlink's satellite broadband services in India, as reported by Reuters.The discussion between Musk and PM Modi could focus on



Starlink's operational plans in India. The government has shown support for Musk's position on spectrum allocation rather than auction, though Starlink's licence application remains under review.\"Musk is agreeable to give assurances on India security

concerns, which includes storing data locally," a source disclosed to Reuters.

In December, Starlink's internet service was suspended in India following the confiscation of two company devices - one found in a conflict zone and another in a drug trafficking incident, according to Reuters. Sources indicate uncertainty about whether Tesla's India entry would be discussed during the Musk-Modi meeting. However, discussions may include increasing India's role in electric vehicle component manufactur-

#### India's naval advancements will fuel its Indian Ocean ambitions

As India approaches its 75th Republic Day, the nation has achieved a significant milestone in strengthening its naval capabilities. In an exceptional move reflecting strategic foresight, Prime Minister Narendra Modi recently commissioned three advanced naval platforms in a single day: a destroyer, a frigate, and a submarine. However, in a fast-changing security environment in the Indo-Pacific, the developments in naval capabilities must be measured in a relative context— capabilities of arch rivals and a swiftly evolving security domain, that is. Now, five points need to be underscored in this context. The commissioning of advanced naval platforms highlights India's aspiration to establish itself as a net security provider in the Indian Ocean Region (IOR). Over the years, India's maritime security strategy has significantly evolved. The 2015 Security and Growth for All in the Region (SAGAR) vision reflects India's dedication to fostering regional cooperation in the Indo-Pacific. This vision is supported by initiatives such as the Indian Ocean Rim Association (IORA) and the Indian Ocean Island Countries (IOIC), which emphasise coastal connectivity and sustainable development. PM Modi's address at the 2018 Shangri-La Dialogue further reinforced India's strategic perspective for the Indo-Pacific. The SAGAR vision has gained traction through frameworks such as the Indo-Pacific Oceans Initiative (IPOI) and the Information Fusion Centre for the Indian Ocean Region (IFC-IOR), aiming to tackle regional security issues and counter China's expanding influence. While China's People's Liberation Army Navy (PLAN) has grown to become the world's largest by fleet size, it still lacks the operational capabilities and combat experience of the United States. India's navy, although the smallest of its armed forces, has consistently demonstrated efficiency and timely acquisitions. Compared to the Indian Air Force, which faces critical squadron shortages, the navy pragmatically acknowledges domestic limitations in engine development. It relies on foreign collaborations to fill gaps, ensuring progress. However, I'll turn to that later. To establish itself as a net security provider, the Indian Navy must sustain the momentum it has recently achieved in naval defence exports. Although this initiative began in earnest only in 2011, it gained significant traction after 2016. India has transitioned from being a cautious supplier of naval equipment, primarily targeting countries such as Mauritius, Sri Lanka, and the Philippines, to a more prominent player in defence exports. For many years, India's exports to nations such as Seychelles, the Maldives, Mauritius, and Sri Lanka were limited to refurbished ex-navy and coast guard vessels. However, this trend has undergone a remarkable transformation in recent years. Naval ships, as of 2024, account for over 61 per cent of India's total defence exports. This shift highlights India's growing capability to manufacture advanced platforms and its determination to emerge as a dependable supplier of defence equipment to neighbouring countries. This development is a critical component of India's regional and maritime strategy, especially given China's rapid ascent in modernising PLAN and expanding its influence in the Indian Ocean by providing naval assets to smaller nations. China has already established itself as the leading defence exporter to both Pakistan and Bangladesh.

It delivered two Ming-class submarines to Bangladesh in 2017, gifted a P625 frigate to Sri Lanka in 2019, and committed to exporting Yuan-class submarines to Thailand. Although the Thai deal encountered difficulties when, Germany refused to supply

# Slowing capital expenditure is good. Don't invest in BSNL, save for shortfall instead

The Union government's capital expenditure (capex) continues to be a cause for concern. Of course, the extent of its decline has reduced somewhat — from 35 per cent at the end of the first quarter of the current financial year to 15 per cent at the end of six months. But the latest number for the April-November 2024-25 period shows that the Union government's capex was still 12 per cent lower than what it was in the same period of 2023-24. Instead of aiming for the targeted 17 per cent growth to ~11.11 trillion in capex for 2024-25, the government will have to strive hard to at least cross the figure of ~9.48 trillion reached last year. What has led to this decline? A widely held view is that the sevenphase general elections, which began on April 19 and ended on June 1 last year, caused a slowdown in capex. But if that indeed is the reason, the decline in capex in the first quarter should have been reversed in the second quarter of 2024-25. And certainly, the first two months of the third quarter should have raised the trajectory of capex growth to a higher level. There has been some improvement, but a 12 per cent decline in the April-November 2024-25 period is no comfort. Look at the slightly different trajectory seen in the Union government's revenue expenditure growth during the same period. The Budget for 2024-25 had projected a rise of over 6 per cent to ~37.1 trillion in revenue expendi-



ture. At the end of June 2024, the growth was just about 2 per cent, but it has been rising since then, reaching 4.2 per cent by the end of the first six months of 2024-25 and climbing even higher to 7.8 per cent during April-November 2024-25. So, if revenue expenditure has gained momentum, why has capex failed to follow suit? A close analysis of the government's capex numbers presents an interesting picture. Over 90 per cent of the Centre's total capex during 2024-25 was accounted for by just six sectors roads, railways, defence, telecom, transfer to states and new schemes. Their share in total capex in 2023-24 was a little less at 87 per cent. But the 12 per cent decline in the first eight months of 2024-25 is primarily the result of a marked slowdown in only two of these six areas — roads and defence, which accounted for over 40 per cent of the total capex outlay for 2024-25. Capex on the construction of roads and highways fell by 16 per cent, while defence saw a decline of 15 per cent. This is serious and has worrying implications

for both infrastructure and defence. The problem of slowing expenditure in these two areas should not have been difficult to fix. Either effective monitoring of spending is lacking, or there are serious problems with project execution, reflecting the poor expenditure-absorbing capacity of these two sectors. This is borne out by a relatively good performance of the Indian Railways, which accounts for over 22 per cent of this year's capex. At ~1.68 trillion, the Indian Railways' capex is just about 1 per cent lower than its spending during April-November 2023. With regard to the transfer of special assistance as loans to states for their capex and additional central assistance for their externally aided projects, the Union government's performance was slightly better. In the April-November 2024-25 period, these transfers rose by about 5 per cent, although much lower than the budgeted increase of 41 per

In contrast, such transfers during the entire 2023-24 had risen sharply

~1.15 trillion. It appears that these transfers will take a hit in the current year and for the first time since this initiative to help states boost their capex was undertaken a couple of years ago. Significantly, this has not yet adversely impacted the states in a big way. The capex of 25 states (accounting for 95 per cent of all the states' and Union territories' total capex budget) has risen by just about 1 per cent in the April-November 2024-25 period, although states like Andhra Pradesh. Himachal Pradesh, Kerala, Mizoram, Odisha, Telangana, Uttar Pradesh, Uttarakhand, and West Bengal saw their capex fall varying margins. Eventually, however, this will have an adverse impact on the states' capex programme and its growthenhancing effect. There are two more sectors that account for another 13 per cent of the Centre's capital expenditure budget. But they bring out an intriguing aspect of why the government's capex has been slowing. They suffer from a peculiar problem, which has nothing to do with either the relevant sectors' expenditure-absorbing capacity or the absence of effective expenditure monitoring. The bulk of the capex under telecommunications was meant for infusing equity into state-owned Bharat Sanchar Nigam Ltd, or BSNL. Of the total capex of ~0.84 trillion, the proposed amount for BSNL's equity infusion accounted for as

by about 24 per cent to much as ~0.83 trillion. But the total expenditure under this head in the first eight months of 2024-25 is only 6 percent of what has been budgeted. In other words, a decision to transfer the equity amount promised to BSNL would increase the government's capex by a significant margin. Why this money has not been transferred is puzzling. Last year, against a budgeted BSNL equity infusion of ~0.53 trillion, the actual infusion was higher at ~0.65 trillion. This year, no action on this front even after eight months is a puzzle as this failure also contributes significantly to the decline in the Centre's capex. More importantly, the Budget for 2024-25 had allocated a significant amount of ~0.66 trillion for capex on central sector schemes and projects. Of this, a large chunk, estimated at ~0.62 trillion, was earmarked for new schemes that the government would announce during the year. However, in the first eight months of the current year, only 4 percent of that total outlay has been used up, leaving ~0.63 trillion yet to be spent. It is likely that the government may not need this amount or it may have kept its powder dry to meet any new schemes that it might announce later in the year, for which such capital allocations will be useful. For the Union finance ministry, currently busy preparing the Budget for 2025-26, such a state of play with regard to slowing capital expenditure could well be an opportunity.

# **Investors line-up for Excitel's** \$200-million equity deal

**Extension** of the Production Linked receive incentives and policy support towards PM Suryaghar Muft Bijlee Yojana, and greater thrust to distribution and transmission infrastructure are likely to be the key features of the upcoming Budget, as far as the energy sector is concerned. Sources said these proposals figured not only in the budget wish lists of the industry, but also in the respective recommendations from the ministries of power and renewable energy to the finance ministry , ahead of the Budget. "Given the success of PM Survaghar scheme with almost 600,000 installations in just nine months since its launch, one could probably see additional allocation to target more households," said Ashwin Jacob, partner at Deloitte India. "As far as evacuation of power from offshore wind projects is concerned, we would want to see the VGF or budgetary support to continue or get enhanced," he added. "We hope to see a decisive increase in funding to accelerate the green energy transition. Priorities must include scaling renewable energy by addressing grid and transmission challenges, advancing Battery Energy Storage Systems (BESS) for grid stability and reliable power, doubling energy efficiency and digitalizing the energy sector through AI, smart meters, and data-driven solutions. Streamlining rooftop solar programs with simplified approvals, financing, and monitoring is equally vital," said Saurabh Kumar, Vice President – India, Global Energy Alliance for People and Planet (GEAPP).

Sharat Goyal, CEO of Impact Infracap also expects the government to remove restrictions on state wise caps on roof top capacity for netmetering for industrial establishments. "Further, adoption of batteries to substitute use of diesel generators for back-up power should

While the government is increasingly working towards enhancing the country's RE capacity, the distribution and transmission infrastructure for its evacuation still needs to be strengthened. With the peak demand for power growing at a rate of 8-9% annually, the industry is looking forward to strengthening of climate resilient infrastructure augmentation. "One can expect new allocations towards augmentation of power distribution infrastructure, especially in high density/ urban load centres, in view of the sharp rise in peak demand over the last few years," said Anujesh Dwivedi, Partner at Deloitte India. He noted that there may be some allocation towards supporting the preparatory work especially on the listing of power utilities, or some incentive mechanism for promoting initiatives on private sector participation or listing of utilities at the state level because they are increasingly being seen as the much needed structural reforms the sector needs. The industry is optimistic of a wider coverage of the Revamped Distribution Sector Scheme by including smart metering in infrastructure definition. "This would direct more financing

for a sector which seeks to bring down India's transmission and distribution losses to 12% and improve recovery for state utilities," Goyal said. Goyal also noted that power transmission despite significant potential has not seen any notable monetisation events which could address the latent investor demand. "Government should announce a time-bound privatisation programme for assets owned by PGCIL," he said. The sector also sees the PLI scheme for solar value chain to continue with possible reduction in the duty structures for solar equipment.



per capita, labour force participation, skilling and gross value addition in manufacturing there is room for improvement.



#### Commercial LPG hike by Rs 16.5 per cylinder, jet fuel up 1.45%; household cooking gas remains unchanged

NEW DELHI: The cost of commercial LPG and aviation fuel prices surged on Sunday following the monthly revision aimed at aligning with trends in international oil prices. State-owned oil firms raised commercial LPG rates, used in hotels and restaurants by Rs 16.5 per to Rs 1818.50 per 19 kg cylinder. Aviation turbine fuel (ATF) prices in Delhi, which hosts one of India's most active airports, saw an increase of Rs 1,318.12 per kilo litre, marking a 1.45 per cent increment. The new rate stands at Rs 91,856.84 per kl, according to state-owned fuel retailers. The prices of ATF and LPG vary from state to state, depending on local taxes, including VAT. This marks the second consecutive monthly increase in jet fuel prices, which were previously raised by Rs 2,941.5 per kl, or 3.3 per cemt, on November 1. ATF prices were reduced by 6.3 per cent (Rs 5,883 per kl) on October 1 and by Rs 4,495.5 per kl, or 4.58 per cent, on September 1. In Mumbai, the ATF price increased to Rs 85,861.02 per kl on Sunday from Rs 84,642.91 previously. The price of commercial LPG have also increased for the seventh consecutive month. In the most recent review on November 1, commercial LPG prices were raised by Rs 62 per 19-kg cylinder. Over the course of five price hikes, commercial LPG prices have increased by Rs 172.5 per 19-kg cylinder, reaching their peak this year. Four monthly price reductions before the current cycle began in August were offset by the recent hikes. Prices for 19-kg cylinders were reduced by Rs 148 across the four rounds. Currently, commercial LPG costs Rs 1,980 in Chennai, Rs 1,927 in Kolkata, and Rs 1,771 in Mumbai for a 19-kg cylinder. However, the rate of cooking gas used in domestic households, however, remained unchanged at Rs 803 per 14.2-kg cylinder. State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise the prices of ATF and cooking gas on the first of each month.
