#### BJP MP fined for illegal mining

Kaiserganj BJP MP Karan Bhushan Singh has been hit with a penalty of over 4.88 crore for illegal sand mining after the Allahabad High Court's ucknow bench dismissed his plea against the ecovery order. An inspection in January 2019 found that his firm, M/s Nandini nfrastructure √ishnoharpur Tarabganj, nad excavated 1.72 lakh cubic metres of sand beyond the approved ease area in Gonda's Durgaganj village. The District Magistrate had mposed a ₹10 lakh fine and ordered royalty and mineral value recovery. The court said Singh may seek revision before the state authority, but the recovery will continue meanwhile.

# Med colleges under ED scanner

The Enforcement Directorate on Thursday conducted searches at 15 locations across 10 states in a money laundering investigation linked to alleged bribery in granting academic sanctions to certain medical colleges to run courses.

The FIR alleged that bribes were paid to government officials, including the National Medical Commission (NMC), in lieu of disclosing confidential information about the inspection of medical colleges to the key managerial persons related to medical colleges and middlemen.

The information enabled college authorities to manipulate the parameters and obtain approval for running academic courses at the medical colleges. The premises being searched include seven premises of medical colleges located in multiple states, and certain private persons named as accused in the FIR, the ED officials told the media.







#### J&K institute raided for suspected unlawful links

Handwara: Acting on credible intelligence inputs, Handwara Police carried out a raid at the Jamia Islamia Institute in Waripora, Handwara, on Thursday as part of an investigation into suspected unlawful activities and alleged links to banned organisations.

According to officials, a team of police personnel searched the premises and recovered multiple electronic devices during the operation. The seized equipment has been sent for detailed forensic analysis to determine its usage and to verify any suspected connections, including possible affiliations with Jamaat-e-Islami (JEI), which remains a proscribed organisation.

Police stated that the operation was conducted strictly in accordance with procedures legal emphasised that the investigation is still underway. 'Handwara Police is committed to taking firm action against individuals or entities found involved in unlawful or anti-national activities," an official said, assuring the public that transparency and accountability are guiding principles of the ongoing probe.

## **Assam assembly passes** bill to ban polygamy

Himanta promises UCC if he becomes CM again

The Assam assembly on Thursday passed a bill to ban polygamy, making it an offence, which may lead to a maximum of 10 years of exceptions.

It kept people belonging to the Scheduled Tribe (ST) category and areas under the Sixth Schedule out of the purview of the legislation.

Chief Minister Himanta Biswa Sarma said the Uniform Civil Code (UCC) will be implemented in Assam if he becomes the CM again after the assembly polls next year. During the passage of the

Prohibition Polygamy Bill, 2025, the chief minister, who also holds the portfolio of the home and political departments, said the law is "irrespective of religion and not against Islam as being perceived by a section". "The Hindus are not free

from polygamy. That's also our responsibility. This bill will cover people from Hindu, Muslim, Christian and all

## Expelled by AIADMK, ex-MLA Sengottaiyan joins Vijay's party

Actor Vijay's newly formed Tamilaga Vettri Kazhagam (TVK) received a major boost on Thursday with the entry of nine-time MLA and former AIADMK Sengottaiyan. He has been appointed chief coordinator trative committee, a move expected to bring clarity to the party's structure, which many critics have described as functioning more like a fans' association than an organised political party.

Sengottaiyan began his political career over 50 years ago, joining the AIADMK soon after MG Ramachandran launched the party in 1972. A fierce lovalist of Javalalithaa, he earned a reputation as her most efficient election campaign and tour manager. His name surfaced prominently during the 1989 pandemonium in the Tamil Nadu Assembly, when then Chief Minister M Karunanidhi accused him of assault, leading his trademark dark glasses to break during the chaos. It was in the same turmoil that Jayalalithaa alleged a

## New definition of Aravalli ranges may spell disaster, says Congress

NEW DELHI

The Congress has cautioned that the revised definition of the Aravalli Hills, which extend from Delhi to Gujarat, via Harvana and Rajasthan. can have "grave environmental and public health consequences" and has therefore called for an immediate review of the changes in the Supreme Court.

Flagging the issue, Congress general secretary, while citing newspaper report, said on Thursday that over the years, the Aravalli Hills have been 'devastated by mining, construction, and other activities in violation of all regulations and laws" and that "now it

Stating that as per the news report, the Union Ministry of Environment, Forests and Climate Change has recommended to the Supreme Court a new definition of Aravalli Hills, Ramesh wrote in a post on "X" that: "This definition is meant to restrict mining but in reality will mean that 90 per cent of the Aravalli Hills will not be counted as Aravalli any more. Evidently, the Supreme Court has accepted this revised definition. This is bizarre and will have very grave environmental and public health consequences. It calls for an immediate review.

The road to hell is indeed paved with good intentions."

The report had stated that the Forest Survey of India had red-flagged the issue while stating how important these hills were as they act as barriers to sand and dust flowing east. The apex court had on Nov 20 accepted the Ministry's definition of the Aravalli Hills which laid down that "any landform that is at an elevation of 100 m or more above the local relief will be considered as part of Aravalli Hills along with its slopes and adjacent land". However, the report stated that the ministry had not revealed that this would mean that over 90 per cent of the range will not be counted

## Firing at AAP leader's house

CHANDIGARH

Two unidentified motorcycleborne men opened fire at the house of Aam Aadmi Party (AAP) leader Daljit Singh Raju near Darvesh Pind in Phagwara, Kapurthala district, early Thursday. Police said around 23 rounds were fired at about 1.30 am, damaging window and door panes, though no one was injured.

Raju is the Phagwara coordinator for AAP's anti-drug campaign and is known to be close to Hoshiarpur AAP MP Raj Kumar Chabbewal. CCTV footage shows the two armed men parking their motorcycle at a distance, walking up to the house and firing multiple shots before fleeing.

Raising the issue of alleged misuse of social media platforms, BJP MP Sambit Patra while addressing a press conference at the party headquarters charged that the Congress, its leader Rahul Gandhi and some prominent Left-leaning people have since the formation of the first Narendra Modi-led government in 2014 not spared any opportunity to speak against India from abroad.

Citing new location-tracking features on "X", Patra alleged that the Congress was relying on social-media accounts to influence domestic political narratives from outside India. With the "X" owned by Elon Musk recently launching a new feature that discloses information about an account's user location, frequency of username changes and the date the account was created, the BJP was able to gain an insight into the accounts it

Congress leaders and supporters were being operated from countries like Pakistan,

Bangladesh, the United States, Ireland and Thailand, Pakistan. He alleged that "fake" accounts which were part of a "Left-Congress ecosystem" were being used to push anti-India narratives like "Vote Chor" to demean various political leaders and institutions. Among the prominent

leaders whose Congress accounts were being operated from abroad, he said, were the party's media and publicity department chairman Pawan Khera. Patra said the location indicator showed that Khera's account was "based in the United States".



#### India's online gaming ban shows today's thriving sector could be tomorrow's casualty

It took a mere six minutes in the Lok Sabha and a few minutes more in the Rajya Sabha to wipe out an established industry. In a matter of 48 hours, the passing of the Bill on Promotion and Regulation of Online Gaming Bill 2025 has adversely impacted 2,00,000 direct employees, Rs 23,613 crore in investments, over Rs 4,500 crore in advertisements and Rs 20,000 crores in direct and indirect taxes. The Bill, now an Act, was introduced in Parliament without undergoing the due process of a draft for public opinion, stakeholder consultations, or, at the very least, a warning. Policy corridor whispers imply that even allies were not aware of such a move. A decade-old, established sector constitutionally guaranteed under Article 19 has been asked to wrap up operations and told it will be held liable for criminal actions, including those of its employees, if it doesn't comply. While the Act aims to safeguard public health and address the concern of offshore illegal platforms, any ban, especially in the digital space, has consistently proven to have amplified the issue multiple times. The immediate fallout would include economic disruptions, shifts in user behaviour, and social harms. The opaque strategy adopted by the government in this case highlights the grave direction that policy-making is taking in India. The uncertainty goes far beyond the online real money gaming sector and will set a precedent for future policies in each sector. This swift and unconsulted legislative strike is not just a regulatory misstep but a stark warning of the growing unpredictability in India's policy landscape, one that could unravel investor confidence, domestic business trust, and exacerbate systemic issues like brain drain of talent and businesses. The immediate economic toll is staggering and underscores the bill's shortsightedness. Beyond the 2,00,000 direct jobs at risk, it affects ancillary industries like fintech, advertising, and content creation. Annual GST revenues of Rs 20,000-25,000 crore and TDS of Rs 1,080 crore (FY24) will evaporate, creating fiscal gaps at a time when India's fiscal deficit stands at Rs 15.77 lakh crore, amounting to 4.8 per cent of GDP. But the real cautionary tale lies in the investor disarray this creates. A reported foreign direct investment (FDI) of \$2.7 billion and startup funding of \$2.8 billion in real money gaming are now stranded. This unpredictability echoes broader patterns in India's policy environment, where sudden changes deter long-term commitments. For instance, the 2019 e-commerce FDI rules, which restricted inventory models for e-commerce platforms, led to a reported slowdown in US-India tech investments, with firms citing regulatory whiplash as a key barrier. Similarly, retrospective tax demands in the past (e.g., the Vodafone case) have been linked to a dip in FDI inflows, with studies showing that economic policy uncertainty reduces FDI by up to 30 per cent in emerging markets like India. The 2025 Kearney FDI Confidence Index highlights regulatory complexity and ease of doing business as concerns for investors in India, potentially shoving off billions in inflows amid global uncertainties like US tariffs. Businesses, particularly in the digital economy, thrive on stability. This bill's passage without stakeholder input, bypassing the Pre-Legislative Consultation Policy, sends a chilling message: Today's thriving sector could be tomorrow's casualty. As the industry voices alarm, with petitions likely heading to courts, the precedent risks cascading effects on adjacent digital fields where India aims for global leadership but faces investor hesitation due to such volatility. In the larger scheme, this policy unpredictability is accelerating India's brain drain, particularly in tech and digital innovation, where skilled professionals seek more stable environments abroad. Data from 2025 reveals a stark reality: Over 1,05,000 global tech layoffs this year alone, with 20 per cent occurring in India, have pushed thousands of engineers and developers to

## India-US relationship has survived darker times. Intelligence ties bind us together

**Edward** Heath, Great Britain's Prime Minister, felt the words wash over him, hot like a dragon's breath: "The United States had received nothing from India except a kick in the teeth, in exchange for \$3/4 billion last year," President Richard Nixon raged. The Indians, Nixon went on, thought "the white nations had no choice but to come in and bail India out." Alarmed, British Foreign Secretary Alec Douglas-Home stepped in. "The Indians were admittedly intolerably high-minded," he accepted. "But there was an important common interest in preserving Indian independence from Soviet and Chinese domination." The invective against Prime Minister Indira Gandhi and her nation, provoked by her refusal to back down on Bangladesh, continued in the privacy of Nixon's office, though: "A slippery, treacherous people," "bastards," "old witch," "b\*tch". Even as the political leadership in both countries raged against each other, the relationship the Central between Intelligence Agency and the Research and Analysis Wing remained robust, historian Paul McGarr writes. In 1973, the head of Prime Minister Indira's secretariat, Prithvi Nath Dhar, and the chief of R&AW, Rameshwar Nath Kao, lobbied for CIA chief William Colby to visit New Delhi. As President Donald Trump appears to be leading the India-United States relationship into an abyss from which there is no return—adding restrictions to the outsourcing of jobs on the back of crippling tariffs—the period



between 1971 and 1973 shows the two countries have been locked in airless places before. The intelligence services of both countries, though, found ways to bypass potholes and cul-de-sacs, ensuring strategic conversation continued. Little understood, India-US intelligence ties flourished in the shadow of the Cold War, as New Delhi resolutely proclaimed its commitment to non-alignment. Late in the summer of 1949, India was struggling to contain its first post-Independence insurgency, an uprising by communists in the Telangana region. The Indian Army, sent to Hyderabad to battle the Nizam's armies, found itself at war with peasant insurgents in Telangana. Thousands died in the brutal conflict, Jonathan Kennedy and Sunil Purushotham have recorded, as the Army herded Adivasis into concentration camps in near-starvation conditions. Less than forty-seven years old and with little experience in global politics, an unassuming police officer was tasked with helping India find the right tools to deal with the crisis. TG Sanjeevi, earlier a Superintendent of Police in Madras, and now Director of the Intelligence Bureau, was

ordered to make a threeweek visit to Washington.For decades before

Independence, Intelligence Bureau had been relentlessly focused on the threat of communist terrorism. Telangana was its first challenge

Independence—and, seemed, its first potential failure. To Prime Minister Jawaharlal Nehru, it seemed that the threat was transnational and a danger to the survival of the Indian republic. The colonial legacy meant India had a substantial relationship with the United Kingdom's intelligence services. The Security Service, popularly known as MI5, was a critical source of assistance in the first years after Independence. India became debilitatingly reliant on this relationship, Avinash Paliwal has recorded. "This is satisfactory," an MI5 memo on general dependence smugly noted—but India understood the need to widen its partnerships. George Kennan, then director of policy planning at the State Department, agreed with Prime Minister Nehru's assessment. To address the challenge, Kennan recorded, Sanjeevi would have to "look

beyond India's borders and

seek to in?uence policy in regard to dangers from without." This meant that, despite Nehru's socialism, America would help him push back against the Communist threat. The visit did not begin well, though. Sanjeevi was affronted by the imperious behaviour of the director of the Federal Bureau of Investigation, J Edgar Hoover, and vowed never to allow between Intelligence Bureau and the FBI. The damage was contained, however, during his subsequent meetings with the Central Intelligence Agency. Sanjeevi came away with positive impressions of his meetings with Colonel Richard Stilwell, Kermit "Kim" Roosevelt, and the director of central intelligence, Roscoe Hillenkoetter. Even though the two countries clashed over questions of ideology and global politics, the alignment of their interests wasn't particularly opaque. India's government provided arms and training to Tibet's ramshackle military after 1949, and even considered deploying troops in support of its independence. The problem was that the Indian Army just didn't have the resources. In 1954, India formalised this reality, ceding many of its colonial-era rights, like stationing troops in Lhasa, historian Karunakar Gupta has written. The Intelligence Bureau, though, looked the other way, as the CIA supplied weapons and equipment to Khampa insurgents from 1958 on, historian Claude Arpi has written. India also ignored CIA flights in support of Tibetan insurgents, which

crossed over its territory en route from Dhaka. Langley supported the founding of the Special Frontier Force, intended to carry the PLA along the China-India Line of Actual Control. The CIA also oversaw the insertion of nuclear-powered surveillance equipment to gather intelligence on China's nuclearweapons programme. Even as this intelligence cooperation continued, Minister Nehru publicly complained that the United States was interfering in Indian politics, "buying up newspapers and spreading a network of publicity organisations." Later, Prime Minister Indira assailed foreign powers plotting to "run down India." CIA agents, American intelligence officer Russell Jack Smith wrote sharply, "were to be found according to Madame Gandhi, beneath every charpoy and behind every neem tree." Even as Prime Minister Indira frequently railed against CIA intervention to bring about regime change and public outrage erupted when the journal Ramparts disclosed CIA funding for Indian anti-Communist political parties in 1967—the relationship carried on in the darkness, as it were. As Sanjeevi told CIA interlocutors in 1950, "he frequently had to take independent action without the knowledge of his government". The intelligence relationship survived even in the face of contradictory United States objectives. For example, CIA personnel told India they had detected signals linking the jihadist warlord Sirajuddin

As I write this column from Boston, cal break from America's post-Cold economic scenarios. Countries must take into account these changes as they make adjustments in their foreign policies. Of course, Trump is known to be mercurial and abrupt changes in his policies cannot be wholly ruled out. However, three things are likely to remain constant: use of trade tariffs, opposition to immigration, and smaller American investments in international security. The changes in these realms, if any, are likely to be of degree. Fundamental changes can take place only if the results of these policies are catastrophic for his MAGA base, especially via inflation or if the judiciary intervenes more firmly than it severely jolted by Trump's tariffs, imagine its way forward? Let me suggest that China will become even more central to India's foreign policy.

## Why hasn't India won the Nobel Prize for literature after Independence? Quality of education

**Speaking** in a distinguished institution, a political leader expressed concern that after Rabindranath Tagore in 1913, no Indian has received the Nobel Prize in Literature. His question—"Is the writing of our country not at the level anymore? Or has it been ignored by international institutions?"-was thought-provoking. But the tone was aloof. However, when you think about it, the answer is obvious. During the British Raj, India produced a number of great poets, artists, scientists, scholars, and thinkers. Many of

them have an international reputation. The solitary Nobel Prize in literature was also received during the British period. Under the British, our talents flourished. The educational institutions of the British rulers encouraged talents without discrimination on any ground. Did our desi leaders, post-British rule, continue that noble tradition? It is wellrecognised that the educationdeclined rapidly after Independence. Instead of nurturing talent, new policies, knowingly or unknowingly,

worked toward their suppression or migration to the West. Isn't it curious that during the British Raj, hardly any Indian writer, scientist, artist, or scholar decided to settle abroad? Whereas in Independent India, talent of all kinds began settling in Europe and America, leaving India for good. To come to the issue, the leader who pointed out our lack of Nobels seems unaware that there are al institutions of British India two essential prerequisites to help grow quality writers. One, to connect children & youth with great literature, taking care that they also get time

and encouragement to savour it. Second, to maintain a whole system of good institutions and platforms for learning, teaching, writing, publishing, and interacting. To ensure all this, staying away from narrowness or compromise must be a rule. But desi leaders, preachy and voluble, did the opposite! The British made arrangements in every field of knowledge and science to promote talentmodern public institutions, great libraries, newspapers, magazines, entire new learning disciplines like history, civics,



## New Rule: Aadhaar cannot support age verification in official records

The Uttar Pradesh government has issued a major directive clarifying that the Aadhaar card will no longer be accepted as a valid document for verifying a person's date of birth. The decision was communicated through an official order from the Planning Department to all Principal Secretaries and Additional Chief Secretaries across state departments.

The order follows a communication issued by the Unique Identification Authority of India (UIDAI) on 31 October, which stated that the date of birth recorded on Aadhaar is often "approximate" and therefore cannot be treated as an authentic proof document. UIDAI instructed all institutions to avoid using Aadhaar for age verification in sensitive or official processes.

According to the directive



signed by Special Secretary Amit Singh, several state departments were still treating Aadhaar as a birth-date proof despite UIDAI's earlier clarification. The new instructions make it mandatory that Aadhaar must not be used for appointments, promotions, corrections in service records or any procedure involving identity-based verification of age. Instead, departments have been asked to rely strictly on approved original documents

such as school certificates, birth certificates, high-school mark sheets or certificates issued by municipal bodies or health departments. These documents retain their exist-

ing official status for verifying date of birth.

In a separate initiative, the government has moved to expand Aadhaar-related services in rural areas. Aadhaar centres are being set up inside gram panchayat secretariats to reduce the need for residents to travel to towns. In Mainpuri district, a plan has been prepared to open 50 Aadhaar

centres across nine blocks. These centres will provide services including

Aadhaar enrolment, updates to address, name, mobile number or photograph, and correction of errors in existing Aadhaar records. Gram panchayat facilities already offer documents such as residence, caste, income and birth certificates, and Aadhaar services will now be added to this list. District Panchayati Raj

Officer Dr. Awadhesh Singh confirmed that required information regarding the new Aadhaar centres has been sent the Directorate of Panchayati Raj. Future action follow instructions will received from the state.

With the new rule in effect, Aadhaar will no longer be accepted as proof of date of birth for government jobs, pensions, scholarships, bank accounts or licensing procedures. Citizens will now be required to produce birth certificates or other documents.

#### State aims to boost SIR drive with revised pay for 1.6 lakh BLOs

LUCKNOW

The Uttar Pradesh government is preparing to increase the honorarium for Booth Level Officers (BLOs) and Supervisors involved in the ongoing Special Intensive Revision (SIR) of the electoral roll. A proposal to this effect, sent by the Chief Electoral Officer to the state government, is awaiting final approval. If cleared, the monthly honorarium for BLOs will be doubled from Rs 500 to Rs 1,000, and for Supervisors, it will be raised to Rs 1,500 per month.

This move comes as the SIR process, involving the distribution, collection, and digitization of forms for over 15.44 crore voters, gains pace across the state's 1.62 lakh booths. In the last 24 hours alone, more than 1.14 crore forms were digitized, with each BLO digitizing an average of 70 forms. Additionally, a one-time payment of Rs 2,000 for BLOs and a first-time honorarium for Electoral Registration Officers (EROs) and Assistant EROs

(AEROs) are also under consideration.

Chief Electoral Officer Navdeep Rinwa reported that 6.40 crore forms have been digitized so far, with districts Auraiya, Chitrakoot, Ambedkar Nagar, Barabanki, Pilibhit, Saharanpur, and Moradabad having completed over 50% of the digitization work. The final, purified voter list is expected to exclude names of deceased, relocated, and duplicate voters.

## ₹989 crore tax evasion racket uncovered

A major GST evasion racket worth 989.13 crore has been uncovered in Uttar Pradesh after the State Tax Department completed a detailed investigation into 535 firms linked to accused Ikhlaq, a resident of Meerut. The probe revealed that 335 out of these firms were fake and collectively showed a nationwide turnover of 5,478 crore. Officials have described this as one of the biggest GST fraud cases detected in the country.

The investigation began after two trucks carrying iron were seized in Moradabad on 24 and 25 October. Both trucks were linked to 144 fraudulent firms registered using only mobile numbers.



State Tax **Department** completes probe into 535 firms linked to racket

Subsequent FIRs led to the formation of an SIT, which later arrested mastermind Ikhlaq and his aide Ittehat Alam. During searches, SIT recovered Ikhlaq's diary containing the names and mobile numbers of 535 firms. The State Tax Department, led by Additional Commissioner Ashok Kumar Singh, conducted a four-day verification. Of the total, 200 firms showed no transactions, while the remaining 335 were connected to fake operations under "AK Enterprises", spanning multiple states.

The probe found strong links to bogus firms in Delhi and Gujarat. So far, two FIRs been lodged Moradabad and one Lucknow. Nine businessmen and two firms have been named as accused, while six members of the network are still absconding. Officials said the SIT and tax authorities are coordinating to dismantle the nationwide fraud network.

The accused, identified as Amit Kumar Singh alias Amit Tata, was apprehended near Gwari Chauraha in Gomti Nagar, Lucknow.

STF officials stated that Amit was attempting to reactivate the network while staying in Lucknow. Two mobile phones, a Fortuner vehicle, an Aadhaar card, 4,500 in cash and several digital documents were seized from him. He is being interrogated at the STF headquarters

Amit is closely associated with the syndicate's alleged kingpin, Shubham Jaiswal, who is currently believed to be operating from Dubai. Amit reportedly came into contact with him through an acquaintance, Vikas Singh of Azamgarh, and

Delhi: The government raised the fair and remunerative price (FRP) of sugarcane by 4.41 percent to Rs 355 per quintal for the 2025-26 season in October.

An official state-

said Cabinet Committee on Economic Affairs (CCEA) chaired by Minister Prime Narendra Modi made this decision in the interest of sugarcane farmers. Sugarcane FRP is Rs 340 per quintal for 2024-25.

Sugar mills must pay sugarcane growers FRP, the minimum price set by the Indian government. I&B Minister Ashwini Vaishnaw told the media after the meeting that the FRP of Rs 355 per quintal for a 10.25%

## Pant sorry for Test debacle against SA

Stand in Test skipper promises team will regroup and refocus

India's Test vice-captain Rishabh Pant has apologised for the team's shambolic performance in the 0-2 series loss to South Africa, asserting that the team will "regroup, refocus and reset" to come back stronger.

India were handed a 0-2 drubbing in the series that ended with the second Test in Guwahati on Tuesday. Pant led the home side in this match as regular skipper Shubman Gill was nursing a neck injury.

The team lost the game by a mammoth 408 runs, further denting the aura of invincibility around its home record and making its path to World Test Championship final more difficult.

"There is no shying away from the fact that we didn't play good enough cricket over the last two weeks. As a team and as individuals, we always want to perform at the highest level and bring smiles to billions of Indians," Pant, who is personally drawing flak for his reckless shot selection during the series, said in a post on 'X'.

"Sorry we couldn't live up to expectations this time, but sport teaches you to learn, adapt and grow - both as a team and as individuals...We know what this team is capable of and we will work hard, regroup, refocus and reset to come back stronger and better as a team & individuals," he added.

Pant insisted that representing India is the greatest honour of the players' lives.



## Ashwin, Gavaskar support Gambhir amid mounting criticism after series loss

Former stalwarts feel coach's job is to prepare team, rest is upto players


Former off-spinner R Ashwin has defended under-fire India head coach Gautam Gambhir after the 0-2 home Test series loss to South Africa, saving it is not right to call for his sacking at a time when not enough responsibility has been shouldered by the players.

India were outplayed in the series that concluded in Guwahati on Tuesday, going down by a record 408 runs in the second and final Test. A majority of the criticism has directed towards been Gambhir's planning and push for all-rounders in the squad that has affected its balance.

But Ashwin said the former opener, who has a contract till 2027, does not deserve to be removed.

Why are we doing this? It's a sport. Managing a team cannot be that easy. And yes, he is hurting too. We must understand that. It might feel nice to get someone sacked, but that's not how it should be," Ashwin said in his Youtube show 'Ash ki Baat'.

"I've never been that kind of person. It's not about suppor-



relative. I could also point out 10 mistakes. Yes, mistakes happen, but anybody can make them. It's just that when they cost you, they become very expensive," he added. Ashwin, who is retired

from international cricket as well as the IPL, said he understands the need to pin responsibility given India's formidable home record in the past but it is unfair to only target the coach and not ask questions of the players. "We want to ask for respon-

sibility. It's easy, because in Indian cricket, you know it

and I know it -- there's a lot to gain and a lot of money involved," he said. "So many people are ready

to take the job, and there will always be people putting their hat in the ring. But the fact is, a coach cannot pick up the bat and go out to play.

"What can a coach do? I'm asking you a simple question. Put yourself in the coach's position. You may say a player needs continuity and that there has been a lot of rotation, fine, agreed. But the skill to play and perform is the player's responsibility," he

Ashwin urged the players to also take responsibility.

"I haven't seen enough ponsibility tak enough players to say the coach is the problem...I didn't see enough from the players' side to blame decision-making alone. Sure, decision-making can always be better, no doubt," he said.

Players have to deliver, says Gavaskar

Former India captain Sunil Gavaskar also came out in defence of the embattled Gambhir, saying the head coach can only prepare the team and it is the players who have to deliver on the field.

"He's a coach. The coach can prepare a team. The coach can tell, you know, a guy with his experience. But it's out there in the middle that the players have to deliver," Gayaskar told 'India Today'.

"Now, to those who are asking, you know, for him to be held accountable, my question, counter-question is: what did you do when India won the Champions Trophy under him? What did you do when India won the Asia Cup under

## ISSF, BWF bank on India to ensure return to the event

NEW DELHI

The world governing bodies of shooting and badminton are delighted that India has bagged the hosting rights of the 2030 Commonwealth Games as they feel it brightens their chances of returning to the event after being dropped from the 2026

edition. International Shooting Sport Federation (ISSF) and **Badminton World** Federation (BWF) welcomed

the Commonwealth Sport general assembly's unanimous decision to award the Games to the Indian city of Ahmedabad on Wednesday.

The 2030 Games will feature 15 to 17 disciplines, a significantly higher number compared to the scaled down 10-event Glasgow 2026 edition. Glasgow dropped, among others, shooting and badminton to cut down the cost of the Games.

"The International Shooting Sport Federation is pleased to see Ahmedabad,

India, approved as the hosts of the 2030 Commonwealth Games at Commonwealth Sport's General Assembly today, providing a strong case for our sport's return to the programme," the ISSF

stated. "With India hosting the 2030 Commonwealth Games, Commonwealth Sport has an exceptional opportunity to tap into one of the world's most engaged badminton markets," said BWF.

The eight confirmed sports that will feature at the 2030 Games are athletics and Para athletics, swimming and Para swimming, table tennis and Para table tennis, bowls and Para bowls, weightlifting and Para powerlifting, artistic gym-

nastics, netball and boxing. The sports under consideration for inclusion are archery, badminton, 3x3 basketball and 3x3 Wheelchair basketball, beach volleyball, T20 cricket, cycling, diving, hockey, judo, rhythmic gymnastics, rugby sevens, shooting, squash, triathlon and

Para triathlon and wrestling. The final programme will be out next year.
