Kolkata: Union Fisheries and Animal Husbandry Minister Rajiv Ranjan alias Lalan Singh on Saturday said that the Special Intensive Revision (SIR) of the voter list is not being done by the Central Government but is being done entirely by the Election Commission. Speaking to reporters after a meeting with fisheries officials from West Bengal, Jharkhand and Bihar in Kolkata, he accused some political parties of taking political advantage of this process. The Union Minister said, "SIR has not been initiated by the Center. This is the process of the Election Commission. The Commission is only checking who are the real citizens of the country. Should the names of those who have died or left the country remain in the voter list?" He quipped, "Unfortunately some opposition parties seem to want the names of dead people in the voter list." He said that the Election Commission has given 11 options to prove citizenship. Giving his own example, he said, "I already had an entry in the voter list and I have voted before 2003. Still I filled the form because I believe in the democratic process. What is wrong in this?" He also targeted Tejashwi Yadav. On the question of Bihar leader Tejashwi Yadav's name being excluded from the voter list, the minister replied, "Was Tejashwi ji born after 2003? He had to fill the form, did he fill it?"

DU will discuss the Viksit Bharat curriculum and Gita-based courses

Delhi: According to officials, the standing committee of Delhi University (DU) will meet to evaluate suggestions for a number of value addition courses (VAC), including four that are centered on the Bhagavad Gita and one called An Introduction to Viksit Bharat. The committee's emphasis on incorporating modern applications of Indian philosophy and development topics into the curriculum is highlighted in the agenda, which was made public on Wednesday.

With themes like "Gita for Holistic Life," "Gita and Leadership Excellence,"

"Gita for Sustainable Universe," and "Gita for Navigating Life Challenges," four of the six VACs that are being considered are centered around the Bhagavad Gita. Based on Karmayoga, Jnanayoga, and Bhaktiyoga, the Gita for Holistic Life syllabus suggests teachings on self-management, resolving problems in modern life, and methods of action, knowledge, and devotion. The course will also include practical components. The other courses will cover similar thematic applications of Gita's teachings to leadership, sustainability, and life's prob-

lems. Gita may undoubtedly be able to offer us some direction, but it seems ridiculous to introduce so many VACs on Gita. In addition to practical elements like field trips to communities, self-help groups, and farmers' organizations, the proposed chapters will address the role of technology, infrastructure, agriculture, and sustainability, he said. A VAC titled "The Science of Happiness" is also on the schedule. The Centre for Hindu Studies has also suggested starting a PhD program in Hindu Studies, which is anticipated to begin.

Chirag Paswan denies becoming a future CM

Delhi: The declaration that LJP (RV) chairman and union cabinet minister Chirag Paswan would run in the Bihar assembly elections later this year surprised everyone. His Lok Janshakti Party would form a pre-poll coalition with the ruling Janata Dal United for the

are wrong. He stated violent behavior will be punished. CM Devendra Fadnavis declared, "We love Marathi, but no other Indian language should be mistreated. Sometimes I'm surprised they speak English but argue over Hindi.

He threatened harsh punishment for lawbreakers. Should a Marathi-speaking businessman who works in Assam and learns Assamese be treated similarly? Should Assamese assault him? If you care about Marathi, teach it to others and to your kids.

Starbucks workers expand strike across several US cities

Starbucks workers have extended their ongoing strike to four more cities, including New York, according to the union that represents more than 10,000 coffee shop workers. The strike stemmed from failed negotiations between Starbucks and union representatives, with disputes over wages, staffing levels, and work schedules remaining unresolved. According to news agency Reuters, the five-day strike, which began on , initially impacted Starbucks locations in Los Angeles, Chicago, and Seattle. As of Saturday, the industrial action has expanded .

Despite opposition, Surjewala will meet Karnataka Congress MLAs

Delhi: Congress national general secretary Randeep Singh Surjewala will visit Bengaluru and meet parliamentarians. The visit comes after many senior MPs humiliated the party with charges of government corruption, lack of constituency development funds, and a "political revolution" later this year. Senior functionaries say Surjewala's visit has nothing to do with party or government leadership changes. "Since some MLAs voiced grievances, Surjewala will speak to



them in groups," said KPCC working president GC Chandrasekhar. Reports of a leadership shift are false. It won't be mentioned at Surjewala's MLA meeting." Surjewala would meet Mysuru and Bengaluru MLAs during his three-day tour. He

will separately meet senior legislators BR Patil, Raju Kage, and Basavaraj Rayareddi, who have criticized the government. Congress state president and deputy chief minister DK Shivakumar told reporters: "Surjewala would meet MLAs individually.

Manipur to close relief camps by December, rehabilitation from July

Delhi : Chief secretary Prashant Kumar Singh said a three-phase scheme will begin in July to help internally displaced families rehabilitate once the Manipur government closes all relief camps by December. Singh said at the 2nd foundation day of the Manipur State Commission for Scheduled Tribes in Imphal on Friday that displaced families will be given prefabricated houses if they cannot return home by the deadline. Singh said the rehabilitation program will begin in July and continue in October and December. Since 2023, ethnic conflict between Imphal Valley Meiteis and bordering hills Kuki-Zo tribes has killed over 260 people, injured 1,500, and displaced over 70,000. Government data shows that 62,000 displaced people have dropped to 57,000,



Government issues Waqf Act rules

Delhi : The Union government issued the guidelines to operationalize the disputed Waqf (Amendment) Act, 2025, focusing on the central portal where Islamic charitable endowments will be registered and leaving other details to the states. The 32-page minority affairs ministry document will be presented to Parliament on July 21 during the monsoon session. A senior ministry official said the rules will be republished in the gazette if Parliament modifies them.

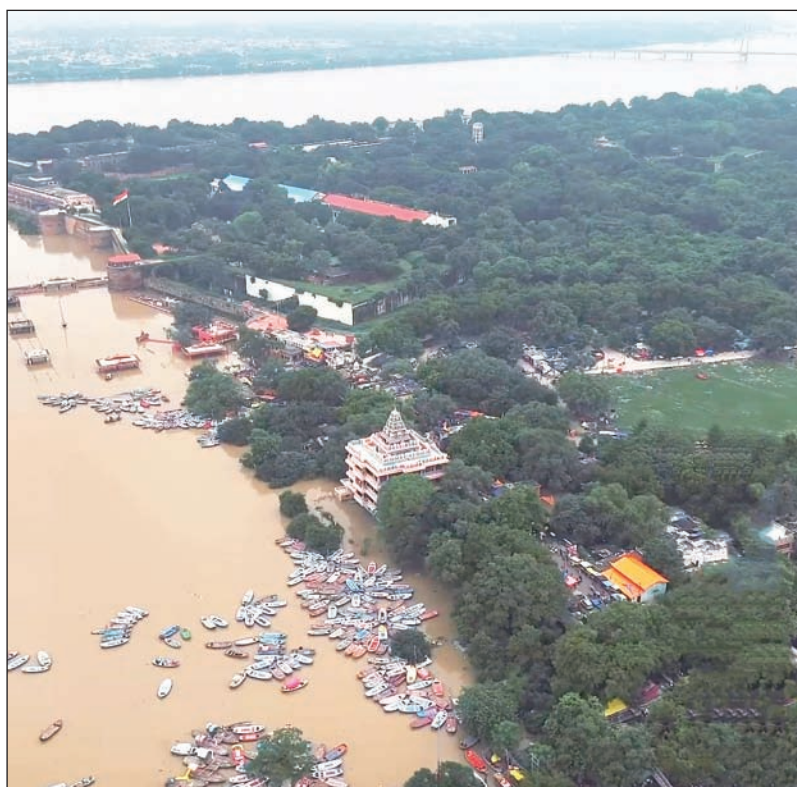

Ghazipur : Under the jurisdiction of Muhammadabad Kotwali Police Station in the district, police have arrested a wanted accused. Following the orders of the Superintendent of Police and as part of the ongoing campaign against crime and criminals, under the able guidance of Additional Superintendent of Police (Rural) and Circle Officer Chob Singh, Sub-Inspector Harishchandra Singh, in-charge of Shahninda outpost, along with his team, arrested the want-

ed accused in Case Crime Number 276/2024 under Sections 318(4)/336(2)/336(3)/341(2) of the Bharatiya Nyaya Sanhita (BNS) and Section 60 of the Excise Act. The accused, Vikki Kumar, son of Faqeer Chand, resident of Beimaan Tola, Police Station Ramkrishna Nagar, District Patna, Bihar, currently residing at Shahpur, Police Station Gopalpur, District Patna, Bihar, had been absconding for a long time.

He was arrested on 01.08.2025 and presented before the Honorable Court in Ghazipur. The arrest team included Station House Officer Ram Sajjan Nagar, Sub-Inspector Harishchandra Singh, and Constables Komal Singh and Sitanshu Pandey.

High Court strict: Said- If the strike is not stopped, then the office bearers of the Advocates Association will lose their chair

Prayagraj: Allahabad High Court said that if the strike is not stopped, then all the office bearers including the President and Secretary of the Advocates Association will have to lose their chair. They have no right to lock the temple of justice by abstaining from judicial work. This harsh comment was made by the court of Justice JJ Munir while granting unconditional pardon to the President of Ballia Bar Association. Ajay Kumar Singh, a resident of Ballia, had filed a petition regarding the dispute related to the Consolidation Act. His objections were pending for a long time due to abstaining from judicial



work on behalf of Ballia Bar Association. The petitioner knocked the door of the High Court for settlement. During the hearing, it was found that the objections of the petitioner were disposed of by the subordinate revenue court on January 22. The petition became ineffective but the court took seriously the abstinence from judicial work by the Bar Association. The court had summoned the Ballia Bar President and Secretary by

issuing a show cause notice citing the Supreme Court's decisions declaring the strike illegal in former Captain Harish Uppal and other cases. However, the Bar President Rajesh Kumar, who appeared in the court, apologized unconditionally. The court accepted the apology with a harsh comment and warning. It said that apology does not mean exemption. This time we are sparing, next time strict action will be taken. The

strike by the Bar Association is a clear contempt of the orders of the Supreme Court and the High Court. If the Advocate Association does not improve, now action will be taken to remove the office bearers from their posts. Courts should ignore the proposal to abstain from judicial work: High CourtThe court has ordered to send a copy of the order to the DM of Ballia, Consolidation Officer, all the revenue, consolidation courts of the state and the concerned Bar officials. Also, the Revenue Courts have been directed to ignore the proposal of the Bar Association to abstain from judicial work and proceed with the judicial proceedings.

has been flooded due to recent heavy rains, but no cracks or damage

have been found in the road structure. With the help of electricity department, police and revenue teams, boats have been arranged for the people, so that safe movement can be ensured. Anti-venom injections and first aid materials are available at flood posts. Continuous monitoring is going on. Ration supplies have been ensured to the affected families

and in case of any problem, the villagers have been appealed to immediately contact the tehsil or district administration. CM forms 'Team-11' to lead flood relief operations in UP

Lucknow: Taking tock of the flood crisis, Chief Minister Yogi Adityanath has deployed a 11-member ministerial team to oversee relief operations across 12 affected districts, warning that any negligence will not be tolerated and stressing the need for sensitivity, speed and transparency. The Chief Minister affirmed that the state government is fully committed to ensuring the safety, food, shelter, and healthcare of every citi-

zen affected by the floods. The Chief Minister directed all ministers in charge to immediately visit their assigned districts, inspect relief camps, and directly engage with affected families. He instructed senior officials—including DMs, SPs, and CMOs—to stay on the ground and ensure 24x7 monitoring. Emphasizing urgency, he ordered round-the-clock surveillance of embankments, swift drainage from water-



logged areas, and comprehensive arrangements for food, medicine, sanitation, and the needs of women and children in relief camps. The Chief Minister emphasized that the

supply of relief materials and food packets must be timely and of high quality, with no compromise on standards. He directed that farmers affected by crop loss, land erosion,

or household damage due to floods should receive assistance within 24 hours. To ensure transparency and timely delivery, he instructed that aid be distributed in coordination with local public representatives. The Chief Minister stressed that livestock safety is a top priority. He directed officials to relocate animals from waterlogged villages to safer areas and ensure proper fodder and veterinary care. He also ordered that all flood-affected hospitals be

stocked with anti-snake venom and anti-rabies injections, emphasizing immediate and effective treatment in cases of snakebite. While reviewing disaster management preparations, Chief Minister Yogi Adityanath directed that early warning alerts issued by the Relief Commissioner be promptly communicated to the public in affected districts. He stressed strict adherence to disaster management protocols by all departments.

CM presents PM Modi with unique GI-crafted artwork featuring Shivling, Nandi and Trishul

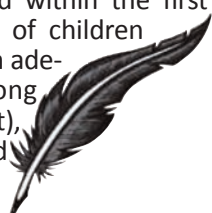

Revamp anganwadi model for Viksit Bharat. Workers should be seen as frontline educators

Integrated Child Development Services Scheme – the Anganwadi Services Scheme was launched in 1975 as an innovative experiment to address maternal and child health, nutrition, and early childhood development. Aligned with the objectives to improve children’s health, nutrition, and development, reduce mortality, morbidity, and dropout rates, and empower mothers through counselling, the ICDS framework is designed to nurture holistic development. Through a lifecycle approach, it targets children aged 0-6 years, pregnant and lactating mothers, and adolescent girls, delivering supplementary nutrition, immunisations, health check-ups, non-formal pre-school education, and nutrition counselling. Anganwadi Centres (AWCs) are the focal points for delivering ICDS services, and Anganwadi workers (AWWs) and helpers are the fulcrum of rendering these vital services through AWCs and home visits. Today, through a strong network of more than 1.4 million Anganwadi centres (AWCs) covering 100 million particularly vulnerable mothers and children, ICDS has emerged as the largest service delivery program for mother care and child development. As ICDS celebrates 50 years this year, it presents a valuable opportunity to celebrate its achievements, reflect on the gaps and challenges, and propose a way forward to align with the futuristic needs of Viksit Bharat. Since this launch, ICDS boasts a robust framework that enables it to adapt and evolve meaningfully in the future. Its evolution to currently Saksham Anganwadi & Poshan 2.0, combines schemes Poshan Abhiyaan, Scheme for Adolescent Girls, and Poshan Bhi, Padhai Bhi, emphasising holistic development and real-time monitoring. Today, all AWCs and over 101 million beneficiaries are registered on the Poshan Tracker, enabling real time tracking of service delivery and outcomes. Over the years, ICDS has played a crucial role in equitably addressing malnutrition, early childhood care, and maternal health across India. India is moving in the right direction toward achieving the SDG 2030 targets for maternal and child mortality. Research has demonstrated that early childhood interventions targeting nutrition, education, and health can substantially enhance human capital, especially in developing countries. An IFPRI study published in the Bulletin of the World Health Organisation highlighted improvements in both equity and coverage of ICDS from 2006 to 2016, with increased service utilisation (58 per cent to 71 per cent), especially among Scheduled Castes and Tribes. Another study examining the linkages between utilisation of ICDS and underweight among children aged 6-59 months from 2015-16 to 2019-21, attributed improvements in ICDS utilisation to 9-12 per cent of the observed reduction in underweight children. A peer-reviewed study in The University of Chicago Press Journals found that children who were exposed to ICDS during the first three years of life completed 0.1-0.3 more grades of schooling than those who were not. As India advances towards Viksit Bharat, ICDS must not only strengthen its existing interventions but also embrace transformative paradigm shifts to effectively address emerging challenges, harness new opportunities, and align with the evolving aspirations of society. Firstly, the pace of improvement in nutrition needs to be accelerated. Malnutrition rates remain high—stunting among children under five is 36 per cent, underweight at 32.1 per cent, and anaemia prevalence at 67 per cent, especially in comparison to global benchmarks. Sub-optimal Infant and Young Child Feeding (IYCF) practices, where only 42 per cent of infants are breastfed within the first hour, and only 11 per cent of children aged 6-23 months receive an adequate diet. Anaemia among pregnant women (52 per cent), children (67 per cent), and women of reproductive.



Religious autonomy isn’t absolute. Imarat-e-Shariah protest in Patna sidelined

Imarat-e-Shariah, a strong socio-religious group with a big influence on a section of Indian Muslims, organised a huge protest on 29 June at Patna’s Gandhi Maidan. The rally, named ‘Waqf Bachao, Samvidhan Bachao – Save Waqf, Save the Constitution’ – quickly gained momentum, with thousands of Muslim protesters from Bihar and nearby states vocally condemning the Waqf Act amendment as a violation of both constitutional rights and religious freedom. This was not just a protest; it was a firm declaration against a law perceived as an infringement on fundamental freedoms—freedoms that many believe must be protected at all costs. Speakers at the rally claimed that the Waqf Amendment Act crushes not only the Islamic principle of Waqf (charitable endowment) but also assaults the very core of religious autonomy. Faisal Wali Rahmani, head of Imarat-e-Shariah, made it clear: the Act is a dangerous overreach that jeopardises the community’s ability to govern its own affairs. “This conference,” he declared, “is a peaceful, constitutional demand to roll back this draconian legislation.” His words rang out as a challenge to those who would allow such overreach to stand unchecked. I fully agree that every Indian has



the right to free speech and peaceful protest, as guaranteed by our Constitution. But the argument surrounding religious autonomy is far more complicated than it seems. This notion of autonomy isn’t about personal religious practice—it’s about collective and organisational control. The idea that a religious group should have the unrestricted right to manage its own affairs raises some troubling questions. First, does this imply that such a group is somehow separate, not truly a part of the larger nation? Second, is there not a risk in projecting this image of self-containment—as though the community exists outside the national fabric? The implications are far more profound than they may appear. What if every community or tribe starts to argue that no one has the right to interfere in their affairs, claiming that their practices and core values are above the reach of national laws or human rights? Imagine a community that argues the gov-

ernment should have no say in child marriage, defending it as a matter of religious or cultural tradition. Would such a stance be accepted simply because it aligns with the idea that each group should be able to uphold its own values? Surely, we would not accept such practices under the guise of religious freedom. At what point do we draw the line between protecting religious rights and ensuring that these practices don’t violate basic human rights or endanger individuals? The core issue is whether any belief or practice—no matter how deeply rooted in religion or culture—can be allowed to override the fundamental principles of justice, equality, and human dignity. When leaders of the Muslim community, or any religious group, invoke the Constitution, they often present it as though it grants them an unfettered right to religious freedom—one that allows them to manage their affairs without interference from the state, its leg-

islature, or its judiciary. But what is overlooked is that this right to religious freedom is not absolute or separate from other constitutional values. It exists within a broader framework that includes human rights, equality, and justice for all citizens. The Constitution, in its design, ensures religious freedom—but it does so with the understanding that such freedom must never come at the expense of the dignity or rights of others. This means that the Constitution’s values—those of equality and justice—must always take precedence over any individual or collective religious right when they begin to infringe on these fundamental principles. Once we are clear on this, we can oppose Waqf amendments that we believe infringe upon our rights. The idea that any community has the inherent right to manage its own affairs solely under the umbrella of constitutional rights is a dangerous one. As I make this distinction, it is crucial to point out some things. While the Patna protest may be framed as a defence of constitutional rights, the very organisation leading it—Imarat-e-Shariah—operates a parallel system within the Muslim Personal Law framework despite lacking formal judi-

cial authority. The argument often put forward is that these bodies deal with matters like marriage, divorce, inheritance, and Waqf when all parties involved consent to the process. However, we all know the reality of social pressure within Indian Muslim society. In practice, these institutions often function without any regard for constitutional values that guarantee equality and human rights for all citizens, particularly women. This contradiction is visible when they invoke the Constitution to protect their own interest but fail to understand the very values it stands for. The Constitution is not just meant to protect religious autonomy and the collective religious right of a community; it is also supposed to protect the fundamental rights of every individual, regardless of their religion or background. Moreover, such protests and gatherings only represent a section of Indian Muslims – not each and every one of us. These events are led mostly by elite Ashraaf Muslims, with Pasmandas being utilised as mob followers. It is disheartening to see how these institutions, controlled by Ashraafs, continue to use Pasmandas as pawns in their own power negotiations while claiming to represent the community as a whole.

Karnataka’s fake news bill won’t survive a court challenge

Karnataka’s proposed Misinformation and Fake News (Prohibition) Bill, 2025, is poorly drafted and replete with structural infirmities. It is also at odds with existing central laws and its constitutional validity is questionable. Let’s see how. The bill deprives social media intermediaries of their statutory immunity from state persecution for user-generated content, a legal protection commonly referred to in internet law as ‘safe harbour’. India’s nodal Information Technology Act, 2000 (IT Act) provides for safe harbour protections and allows social media companies to host user content with conditional immunity, within a clearly defined legal framework. In contrast, Karnataka’s fake news bill proposes to hold social media companies accountable for violating any provision of the proposed law. The bill envisions a government-appointed Fake News on Social Media Regulatory Authority, with sweeping

powers to preemptively block or ban content it deems illegal. However, it does not clarify how these powers will sync with the safe harbour protections under the IT Act. Without safe harbour protections, social media companies could face a deluge of criminal penalties for content that is difficult to monitor and filter, such as superstitions or unscientific claims, both deemed illegal under the bill. The Authority’s blocking powers create a parallel mechanism to the content-blocking procedures already prescribed under the Centre’s IT Act. The lack of standard procedural safeguards, such as the need to notify penalised parties or offer them a fair further disregards the minimum standards set by the IT Act. That law limits content blocking to specific grounds such as public order, sovereignty, and integrity of India, friendly relations with foreign states, or preventing incitement to an offence – all of which correspond to the restriction.

Indian Muslims must face the truth—Muslim countries don’t care about them

West Asia has ever been on the boil, and its tumultuous events perturb Indian Muslims no end. Their attitude toward international affairs, particularly events in Muslim countries, is determined more by their religious identity and extraterritorial loyalty than by their national identity and the country’s interests. Since the establishment of the Mughal rule in 1526, Muslim rulers of India stopped swearing allegiance to any foreign entity, as was the practice during the Sultanate period (the reason why that period came to be known by this name), when the Sultan tacitly recognised the suzerainty of the Abbasid caliphate, which, after the sacking of Baghdad by the Mongol army led by Halagu Khan in 1258, moved to Cairo where it resided until 1527. Later, the caliphate was transferred to the Ottoman rulers of Turkey. In the political lexicon of Islam, Sultan means an autonomous governor of the caliph. The Mughals didn’t recognise the new Ottoman caliphate in Turkey, and called themselves Padshah (king) instead of Sultan. However, so long as India was under Muslim rule, it didn’t really matter whether the caliph was recognised or not. But with the termination of the titular Mughal sovereignty in 1857, the Muslim ruling class found itself stranded. In order to find an ideological mooring for their adrift theo-politics, they anchored themselves in the theocratic institution of the Ottoman caliphate. The Muslim ruling class had so maintained its foreign character that this transfer of allegiance to a new overlord outside India seemed normal and caused no consternation. Rather, this instinctive reaction was understood as a default action. The first stirrings of the newly incubated pro-Turkish sympathies became visible during the Russo-Turkish War of

1877-78. Unsurprisingly, the newly established Muhammadan Anglo Oriental College in Aligarh, the precursor to Aligarh Muslim University, chose the Turkish dress, with the distinctive Fez – the red hat with black tassel – as its uniform. This trend of associating with the Ottoman caliphate matured during the Khilafat Movement, which, in the Muslim mind, forever subordinated Indian nationalism to pan-Islamism, and also to a great extent made the Indian foreign policy sensitive to the extraterritorial loyalty of the Muslims. India’s Muslim ruling class had cultivated a sense of identity that made it easier for them to associate with their foreign co-religionists than the native compatriots. Therefore, it was inevitable that Muslims diverged into pan-Islamism when the national movement emerged in India. It’s true that Sir Syed Ahmad Khan had been wary of the pan-Islamist ideas, and opposed its propagation by the peripatetic preacher, Jamaluddin Afghani (1838-1897). But his opposition was because of pan-Islamism’s anti-British edge – and Sir Syed was a British loyalist. – rather than any thought for Indian nationalism, which he had contested. What’s known as global Islam or Ummah today was, in the late 19th and early 20th century, termed pan-Islamism. Contrary to what the terminology conveys – an ideology encompassing and shared by the entire Islamic world – it actually denoted the political attitude of Indian Muslims who, though domiciled in India, sought the meaning of their existence in belonging to the global Muslim community. India was incidental to their worldview. They were born here, but belonged elsewhere. What affected them the most, at the deep emotional and psychological.

Success to failure, UPSC is a family affair

A couplet by Mirza Ghalib could well serve as the unofficial motto of UPSC aspirants: Ragon mein daude phirne ke hum nahin qayal; jab aankh hi se na tapka to phir lahu kya hai— I’m not impressed by blood that runs in the veins; if it doesn’t spill from the eyes, what kind of blood is it? After all, aspirants live, for lack of a better description, a suspended life built on the edifice of junoon (passion) and self-doubt. But sometimes, it all comes together. The result is announced, and the aspirant’s name appears on the list. Those who succeed are elevated to near-mythical status. Their photos decorate news-

paper pages and coaching centre hoardings, and they are invited for felicitations and motivational talks. But what is not celebrated is the silent effort of an entire support system—a quiet, unpaid workforce made up of family members, friends, and partners. It has been said that it takes a village to raise a child. Cliched but true. The same holds for success in the UPSC exam. If UPSC is the Everest of Indian competitive exams, and the topper is the climber, then their family members are the sherpas who make the ascent possible. The mother, often a school dropout herself, becomes the planner.

Relatives are told not to visit, and the TV volume is turned down. The father, already exhausted by the demands of underpaid work, becomes proficient in the mechanics of prelims, mains, optional, DAF (detailed application form), and ethics papers. Siblings absorb any and all friction in silence. Affection is expressed not through words but by consoling oneself: “Let him focus, we will manage.” A natural question arises: why do families do this for an exam where the acceptance rate is lower than that of Harvard? The ideal of public service and giving back to society is sine qua non, but sometimes it is only a

necessary condition, not a sufficient one. First, the dream of cracking the UPSC is one that originates in the family, not the aspirant. A good score in Class 12. A local officer who is feted like royalty. A personal experience with socio-economic dysfunction. All these experiences (and more) plant the seed. “Ladke ko IAS/IPS banana hai”. Whether the child is a doctor or an engineer, the end goal remains the same: to make them a Collector or SP sahib. Second, the fragility of the Indian middle class, especially in small towns and peri-urban India. This class, often first-generation salaried.

Electric Buses from DTC to 17 Cities Across the States

Delhi : Delhi government is planning to launch an electric bus service called DTC that will connect 17 cities across six states. During a recent board meeting, transport minister Pankaj Singh gave his approval to a plan that will expand DTC bus service beyond the NCR. The destinations that the buses will drive to five cities in Uttarakhand (Rishikesh, Haridwar, and Dehradun), five in Uttar Pradesh (Ayodhya, Lucknow, and Moradabad), three in Rajasthan (Alwar, Bikaner, and Jaipur), three in Punjab (Amritsar, Patiala, and Chandigarh), and one in



each of Haryana and Jammu & Kashmir (Panipat and Jammu, respectively). To encourage environmentally friendly transportation, officials stated that Minister Singh had mandated the use of exclusively electric buses. During a recent meeting, the DTC board recom-

mended these routes, he added, and now the department is buying the buses and working with other states to provide the service. According to him, the interstate bus service in Delhi will be resumed with 100 electric buses after a hiatus of almost twenty years.

Arvind Kejriwal Slams BJP

Delhi: AAP national convener Arvind Kejriwal urged slum dwellers to protest against the BJP-led govt's demolition drives and reject both the BJP and Congress in future elections. Addressing a protest at Jantar Mantar, Kejriwal said, "Prime Minister Narendra Modi said 'Jahan Jhuggi, Wahan Makan', but what he

meant was 'Jahan Jhuggi, Wahan Maidan'. His promises are false, and I urge you not to fall for them in future." He alleged that the Rekha Gupta-led Delhi govt has "ruined" the city in just five months. "We left a perfectly fine Delhi. But these people ruined it. There are long power cuts, school fees have been hiked, and their

ministers and MLAs are busy looting Delhi," he charged. Calling for unity among slum dwellers, Kejriwal said, "There are 40 lakh slum dwellers. If you take to the roads, they will be forced to stop the demolitions." He added, "The Anna movement started from Jantar Mantar and removed the Congress from power.

The policy's stated goals include establishing India as a global sporting powerhouse capable of hosting major international events like the 2036 Olympics and resolving the governance issues that have plagued the country's national federations. "Broad basing of sports and achieving excellence in sports at national and international level to create a robust ecosystem that nurtures talent from the grassroots to the Olympic



podium" were the two overarching goals of the recently passed comprehensive policy, which was chaired by Prime Minister Narendra Modi while the Union Cabinet met. "The new policy replaces the two decade-old national sports policy of 2001 and outlines a vision to make India a strong contender on the glob-

al sports stage, including at the 2036 Olympic Games," said Ashwini Vaishnaw, minister of union communication and broadcasting, who announced the cabinet's decision to do so. The policy promotes tapping into the economic potential of sports and is in line with the new education program.

A New Blood Donor App Is Coming Soon to Delhi

Delhi : Delhi Chief Minister Rekha Gupta announced that the city will soon release an app listing blood donors who are willing to donate their blood voluntarily. A blood donation camp in the Anand Vihar area was the site of the announcement, given by Ms. Gupta. "Details of those who intend to donate blood will soon be available on a blood donor app. "Details about their blood type, when they last donated, and whether they are eligible to donate again .

HC cites ‘egregious misuse’ of Delhi Rent Control Act

Delhi: Delhi High Court called the Delhi Rent Control (DRC) Act, 1958, a "egregious misuse of an anachronistic piece of legislation" that forces landlords into "impecunious and desperate circumstances" while well-off tenants "unjustly" occupy premises for a pittance. The HC was reviewing petitions challenging the 2013 additional rent controller (ARC) judgments that dismissed eviction petitions by UK- and Dubai-based



owners of a Sadar Bazar property in favor of tenants. The petitioners sought eviction on the grounds that they manage two London restaurants and need the premises to grow in India. While ruling against the petitioners, the ARC noted

that they are settled in and running their businesses in London and Dubai and do not need the premises for survival"; hence, their request was not an ARC also believed the premises were too tiny for a sit-in restaurant.

High-budget projects can now be approved by DJB

“Delhi: The Delhi government has granted the Delhi Jal Board (DJB) financial autonomy, allowing it to unilaterally approve high-cost projects, including ones surpassing Rs 50 crore, which could greatly reduce administrative impediments that the agency has been facing. Delhi govt approves waiver on late payment surcharge

Delhi: Delhi govt has given in-principle approval to waive late payment surcharges on inflated water bills, which will bring relief to lakhs of people who have raised concerns about receiving inflated bills. The waiver, however, will be for domestic and government houses, not for commercial consumers. Water minister Parvesh Verma said the scheme will be launched in two months. He said that the implementation awaits a software upgrade, shifting the existing Oracle-based system to a cloud-based platform. "Once the new system is operational. The full waiver roll-out will begin.

Xbox, sales, and other businesses face Microsoft's worst layoff in years

Delhi:

Microsoft is cutting off 9,000 workers, its second huge lay-off in months and largest in over two years. Microsoft announced layoffs in its Xbox video game business and other departments. A memo to state officials listed 830 Redmond, Washington-based Microsoft employees as laid off. Microsoft called the layoffs "organizational changes" needed to operate in a "dynamic marketplace" and will affect numerous teams worldwide, including its sales business.

The corporation won't specify how many layoffs it had, but it was approximately 4% of its personnel a year earlier. Xbox CEO Phil Spencer wrote to gaming division staff Wednesday that



the changes will position the company "for enduring success and allow us to focus on strategic growth areas." Xbox would "follow Microsoft's lead in removing layers of management to increase agility and effectiveness," Spencer stated. MS had 228,000 full-time employees in June 2024, its last annual report. According to Microsoft, the latest layoffs would remove less than 4% of that staff. However, it has had at least three layoffs this.

Centre will borrow 8L cr, 54% of the objective

The government plans to borrow Rs 8 lakh crore, 54% of its Rs 14.8 lakh crore FY26 borrowing, in the first half. It didn't front-load the borrowing program to avoid raising rates while the RBI pumped record liquidity into the system. Since the market reported little demand for 30-year and longer bonds, the government announced it would borrow less in FY26. Thus, front-loading of the borrowing program has been avoided due to government (fiscal consolidation without compromising quality of expenditure).

Embark on the InvIT expressway with Gadkari's invitation to investors

Delhi : Union Road Transport and Highways Minister Nitin Gadkari, the National Highways Authority of India (NHAI) will offer units valued at 25,000 crore in its infrastructure investment trust (InvIT) issue this fiscal year to retail investors. The state-run road builder is now pursuing ambitious goals, including the completion of the monetisation of over 50,000 crore worth of highway assets and the construction of 10,000 km of roadways. This ambitious endeavor aims to entice small investors to the highways. In its pursuit of higher-quality consultants, NHAI will also forgo



the habit of going with the lowest bidder when preparing highway detailed project reports (DPR). After all, a separate cadre would be formed by the NHAI subsidiary responsible for border road construction. According to Gadkari, the objectives

of the new regulations were to reduce India's logistics costs, which are currently over ten percent, and to construct infrastructure that meets international standards. "I am confident that with the work we have done to improve mobility in the country, the coun-

Bank loan growth drops for eighth straight month in February, RBI data reveals

Delhi: Central bank statistics revealed that personal and credit card loans fell for the eighth straight month in February due to Reserve Bank of India tougher policies. Last month, banks' credit rose 12% year-over-year, slower than 16.6% a year earlier,

excluding HDFC Bank's merger. Housing Development Finance Corp, Loans rose 11% in February, compared to 20.5% a year earlier, including the merger. In January, loan growth fell to 12.5% excluding the merger and 11.4% including it. Retail

demand for unsecured loans drove strong loan growth for several years in the banking sector. However, in late 2023, the RBI tightened capital requirements for personal, credit card, and non-banking finance company loans. in its Mumbai headquarters.

Minimum age for cab aggregator vehicles is 8 years

Delhi : All vehicles, including cars, buses, three-wheelers, and motorbikes, must be at least eight years old before aggregators like Rapido, Ola, and Uber may board. In updated regulations for aggregators, the road transport ministry stated that they must also adhere to goals established by state governments for the proportion of electric and zero-emission vehicles in their fleet. A driver's license and vehicle permit must be prominently placed on the back of the front seat next to the driver, as stated by the government, so that passengers may easily view them.



Although some jurisdictions already let private motorcycles and three-wheelers use aggregators, the regulation has been updated to explicitly include these vehicles in order to clarify things, as certain states do not permit bikes on these platforms.

According to the rules, aggregators must verify that "they are fit to be on-boarded" by conducting a psychological evaluation of the drivers. It was stated that aggregators have no authority to forbid or limit on-board drivers from using

Birla Co. recovers Rs 2 crore in stolen digital gold

Delhi : Hackers breached the ABCD mobile app run by Aditya Birla Capital and stole digital gold valued at approximately Rs 1.95 crore from 435 user accounts, according to Delhi. On June 9, the scam was exposed after multiple consumers contacted the company's call center to express their dissatisfaction with the theft of their digital gold. Concerned about this, the company's technical staff launched an internal investigation and filed a first information report. According to our sources, the affected accounts now have their balances returned by the company.

Delhi : After conversations with the finance ministry about the declining share of current and savings accounts in total deposits, public sector banks are reconsidering the requirement for minimum savings account balances. Since Canara Bank, Bank of Baroda, Punjab National Bank, and Indian Bank have eliminated this rule, customers who fail to maintain the required amount will not be penalized. Finance ministry authorities may have questioned banks about penalizing clients



who don't keep minimal balance in a recent meeting. Slowing low-cost current and savings account deposits raised concerns. RBI's financial stability report stated that "banks' liability profile is changing with the share of higher-cost term deposits and CDs growing compared to low-cost current account and savings

account (Casa) deposits" Jan Dhan data reveals that many of these accounts were originally dormant, but balances climbed steadily, lenders said. Traditional public sector banks had lower balance requirements than private banks and waived Jan Dhan account requirements. Private banks waive minimum balance requirements on pay accounts and accounts with a 'relationship value' threshold, which covers fixed deposits and other assets, in addition to Jan Dhan accounts.

Center permits aggregators to use white board bikes for passenger rides

Delhi: The Ministry of Road Transport and Highways' 'Motor Vehicles Aggregator Guidelines 2025' aims to establish a light-touch regulation framework while addressing user safety and driver welfare. The guideline suggested that the state government allow aggregators to share non-transport motorcycles for passenger travel, reducing traffic congestion and vehicular pollution and providing affordable passenger mobility, hyperlocal delivery, and livelihood opportunities. The guideline states that the State government may allow passengers to travel on non-transport motorcycles under sub-section (3) of Section 67 of the Act. "The State government may, under sub-section (3) of Section 67 of the Act,



Total bids for three initial public offerings (IPOs) reached 22.5 billion rupees

Delhi : Nearly 22,500 crore rupees were raised in three separate initial public offerings (IPOs) that concluded. The combined target amount for all three was 2,562 crore rupees. According to data from the exchanges and merchant bankers, the 119 crore rupee IPO of Globe Civil Projects was subscribed 86 times, the 853 crore rupee IPO of Ellenbarrie Industrial Gases was subscribed 22 times, and the 1,590 crore rupee IPO of Mumbai-based real estate giant Kalpataru was subscribed 2.3 times.

Jindals considered a reverse merger with Akzo to list paints

Delhi : After acquiring Dulux Paints, billionaire Sajjan Jindal aims to reverse combine JSW Paints with listed Akzo Nobel India to take it public. The Jindals will control the combined business, which will also include private equity investors and public stockholders. The Rs 13,336-crore Akzo Nobel India transaction was financed by private equity funds. Once listed, Jindal will have six publicly traded firms worth Rs 4.5 lakh crore. Jindal also plans to list JSW Cement (Shiva



Cement is already listed). "It (Akzo Nobel India) is a structured transaction where, at the time of the reverse merger, and based on the performance of the merged entity, their (private equity investors') capital would get converted to a stake in the merged entity," Parth Jindal, CEO of JSW

Paints, said. The transaction will be financed by JSW Paints internal accruals and promoter contributions of one-third each, in addition to private equity. Akzo will move JSW, which entered the decorative paints industry in 2019, to fourth after Kansai Nerolac, Berger Paints, and Asian Paints.

Personal, small biz loans prop bank credit growth

Delhi: Credit to small businesses and advances in the personal loans segment have helped keep the year-to-date growth in bank credit in positive territory. According to data on sectoral deployment of bank credit as of May 2025 released by Reserve Bank of India, overall bank credit grew 0.2% from end March 2025 levels. The growth over 12 months (year-on-year) was 9%. The sluggish growth in credit was

because credit to large industries shrinking by 3.8% Rs 26.8 lakh crore - a drop of Rs 1.06 lakh crore from end March levels. Year on year credit to large industries was up 1% compared to 7.1% growth a year ago. Similarly, credit to the services segment fell by 1.4% to Rs 50.9 lakh crore, a drop of Rs 75,800 from end-March 2025. This was largely because of a 4.5% drop in bank credit to non-banking finance companies.



NCLAT reduces penalty on Google to 216 crore in Play Store matter

Delhi: Appellate tribunal NCLAT upheld the order passed by fair trade regulator CCI against Google for abusing its dominant position with respect to Play Store policies, however, reduced the penalty on the tech giant to ₹216 crore from ₹36.44 crore. A two-member bench comprising Chairperson Justice Ashok Bhushan and Technical Member Barun Mitra said Google "has abused its dominant position and has violated Section", however in some sections, violation was "not proved, but penalty was still leviable on proof of violation".

Small savings program interest rates unchanged

Delhi: For the fifth quarter, 2025, the government maintained interest rates on PPF and NSC. The rates of interest on various Small Savings Schemes for the first quarter of FY 2025-26, starting on 1 April 2025 and ending on 30 June 2025, would stay unaltered from those notified for the fourth quarter of a finance ministry notification. The notification states that Sukanya Samridhi deposits will earn 8.2% interest, while three-year term deposits will earn 7.1%. Popular Public Provident Fund (PPF) and post office savings deposit scheme interest rates remain at 7.1% and 4%, respectively. Kisan Vikas Patra investments mature in 115 months at 7.5%. National Savings Certificate (NSC) interest rates will stay at 7.7% for April-June 2025. Like the current quarter, investors will earn 7.4% from the Monthly Income Scheme. Small savings programs, mostly run by post offices and banks, have had the same interest rates for the sixth quarter.

One candidate obtains 100% in four of five CUET-UG subjects

Delhi : The NTA released Common Entrance University Test-Under Graduate 2025 results on . NTA reports one candidate earned 100% in four of five subjects. As many as 17 individuals earned 100% in three subjects. A merit list will be created by participating universities and organizations. The NTA's CUET (UG)-2025 scorecard will guide university counseling. NTA prepared to host CUET (UG) - 2025 in CBT style for 13,54,699 unique registered applicants. Between May 13 and June 4, 2025, 10,71,735 candidates took the exam. Around 6.1 lakh people registered for the General category, while 4.75 lakh individuals competed. The OBC (Non-Creamy Layer) group followed with 4.4 lakh registered and 3.6 lakh appearing candidates.



Nearly 1.4 lakh SCs registered and 1.15 lakh appeared, while 84,000 STs registered and 62,000 appeared. About 60,000 of 73,000 EWS students took the exam. Male candidates numbered 7.1 lakh, with 5.5 lakh appearing. At least 6.5 lakh women registered, and 5.2 lakh appeared. Only five third-gender people registered, and only three took the exam. About 22.5% of male candidates and 19.1% of female candidates did not present for the exam. Male can-

Move to delete papers on Islam, China, and Pakistan cleared by DU panel

"Delhi : The request to remove papers discussing Islam, Pakistan, China, and political violence from the post-graduate syllabus of Delhi University's Political Science department was approved by the department's top academic body. 'Pakistan and the World,' 'China's Role in the Contemporary World,' 'Islam and International Relations,' 'Pakistan: State and Society,' and 'Religious Nationalism and Political Violence.'

Delhi: Delhi University has allowed Four-Year Undergraduate Programme (FYUP) students to leave after three years and still receive a degree. A major step toward implementing the National Education Policy (NEP) 2020. The Thursday notification allows students who have completed six semesters (three years) of the UG Curriculum Framework 2022 to depart. An Honours degree for single-core disciplines or a general degree for multi-core subjects will be awarded. It



says: "Students interested in availing the above option can log in to the university's student portal at <https://lc.uod.ac.in> and submit their intent through the designated online process." The institution advises students to "carefully evaluate their academic and career goals" and consult lecturers or mentors before leaving early. In

August, DU will commence the fourth and final FYUP year. The NEP 2020 program offers four-year undergraduate coursework with different entry and exit possibilities. Certificates (1 year), diplomas (2 years), and degrees (3 or 4 years) are awarded based on years completed. The fourth year offers research specialization.

The dual degree option at DU will help students learn more

Delhi: The University of Delhi (DU) now allows students to pursue two degrees simultaneously. DU students can enroll in one degree through the normal mode at any DU-affiliated college or department and a second through Open and Distance Learning (ODL) through the School of

Open Learning. This policy gives existing students the option to expand their academic horizons without choosing between conventional and distant education. It has restrictions, though. Even with normal and ODL enrollment, students cannot enroll in two identical degrees (such as

BCom Hons and BCom Pass). DU dual degree qualifying requirements are simple but require careful planning. Students must meet both degrees' academic requirements. Attending classes, completing assignments, and passing tests for each program.

IP University to consider CUET scores for admission to PG courses in 2025-26 session

Delhi: Offering students greater flexibility and more opportunities, IP University will now consider CUET-PG scores for admission to 20 postgraduate programmes in the 2025-26 academic session. According to the university, once the merit lists from national-level entrance exams and the university's own admission tests are exhausted, seats in the respective programmes will be filled based on CUET scores. This provision applies to a wide range of courses, including MBA, MCA, MA and LLM. Candidates interested in applying through CUET can submit their applications online along with an application and counselling fee by



July 15. Detailed information is available on the university's official website. The courses open to CUET-based admissions include MBA, MCA (Software Engineering), MAMC, MPT (M/N/S/C), MSc in Environment Management, LLM, MA (English), MEd, MTech (CSG),

MTech (EG), MA (Economics), PG in Applied Geoinformatics, MSc in Yoga, Medicinal Chemistry and Drug Design, Bioinformatics, Molecular Diagnostics, Microbiology, MS in Packaging Technology, BEd, and BEd in Special Education.

IT-Delhi rose 255 places to 171st globally

Delhi: Among Indian universities for sustainability, IIT-Delhi rose 255 places to 171st globally, according to 2025 QS Rankings released. The QS Sustainability Rankings include 78 Indian universities, with nine of the top 10 improving and 21 new institutions entering. Two IITs—Delhi and Kanpur—are in the world's top 100 for impact. With 177 and 67 rank improvements, each became fourth and fifth in India. Bangalore's IISc is among the world's top 50 environmental education schools.

Sikh resistance during the Mughal period to be covered in DU's upcoming UG course

Delhi : The Sikh community arose in reaction to "religious persecution" and "state oppression" in the Mughal era and subsequent foreign invasions and Delhi University intends to institute a course on Sikh martyrdom for all undergraduates. The course covers the years 1500–1765 and shows how the Sikh identity developed via resistance events, such as the murder of Sikh gurus and the ascent of Sikh fighters like Banda Singh Bahadur.



Students from all academic backgrounds will be able to take it because the Centre for Independence and Partition Studies is offering it as a four-credit general elective according to the Undergraduate Curriculum

Framework, 2022. At their meeting on July 5, the University's Academic Council will consider the course for approval. The highest decision-making body at DU, the Executive Council, has the last say. Course materials state that students will "throw light on the moral basis of emergent struggle by Sikhs to resist religious persecution" and "focus on the neglected social-religious history of martyrdom in the Indian context."

CBSE mandates that all schools begin language mapping

Delhi: The Central Board of Secondary Education (CBSE) has mandated that all affiliated schools begin implementing the language instruction provisions of the National Curriculum Framework for School Education (NCF-2023) beginning with the 2025–26 academic year, marking a significant move towards improving language learning in early childhood education. During the Foundational and Preparatory Stages of schooling, the board has placed a strong focus on teaching in the mother tongue or home language. A news release from CBSE this week stated that schools have to start language mapping activities with students right away and that an NCF Implementation Committee must be formed by May 30,



2025. The order is in line with NEP 2020, which places a premium on multilingual education as a means to promote equity, inclusion, and cognitive development. Ideally, a student's mother tongue or a familiar regional or state language should be the first language of literacy (R1), according to the CBSE. "Until students attain foundational literacy in another language, R1 must be used as the medium of instruction," CBSE cited NCF-2023 (Part C, page 239). The board recognized that

the state language might be used as R1 where the mother tongue is impractical owing to student diversity or a lack of written heritage. The Central Board of Secondary Education (CBSE) has made it clear that a child's native language shall serve as the medium of teaching during the Foundational Stage (from pre-primary to grade 2, ages 3-8). R1 fundamental literacy includes reading fluently, understanding texts, and writing short sentences expressing personal.

Indian students in Canada panic as Ottawa requests docus again

Delhi: Indian students in Canada have reported receiving emails to resubmit study permits, visas, and educational records, including marks and attendance. IRCC, a federal department that handles foreign students, issued a request that panicked international students, many of whom have two-year visas. In response to the inflow of overseas students, IRCC is tightening its financial criteria and considering limitations on admissions. I was surprised by the email. My visa is valid till 2026, however I was requested to resubmit all my documentation "Avinash Kaushik, "They even want proof of attendance, marks, where we are working part-time, etc.," he said. Punjabi students reported a similar increase in emails last week. Some were required to verify their



credentials at IRCC headquarters in person. "Many students are confused and worried,". Indian students have made up a large portion of Canada's rising international student enrollment. The ministry of external affairs reports that Canada has 4.2 lakh Indian students, followed by the US with 3.3 lakh. The sudden email flood left pupils unsure about their future. "We chose Canada for its welcoming environment, but this unfair," said

Adilabad-based business management student in British Columbia. Students want IRCC to clarify and resolve their concerns. For now, urge students to submit documents quickly to avoid difficulties. "This measure looks to be part of Canada's broader attempt to reduce the number of international students," said Toronto immigration consultant Mehbub Rajwani. Caps and financial requirements send a message.

The government of Maharashtra says it would not pay for eggs for the midday meal

Delhi: The opposition vehemently criticized the decision, as Maharashtra became the latest BJP-ruled state to ban eggs from midday meals for students in grades 1 through 8. The school education department changed the list of foods served during midday meals in a government resolution this week, eliminating the inclusion of sugar and eggs. Rather, it instructed schools to serve nachni satttu and "egg pulao" as optional meals. Nonetheless, it stated that these things, as well as sugar for desserts, had to be organized by the general public without the need for further government support. The state has changed the list to adhere to the meal items prescribed by the Center, according to an official who defended the action. While some states use their own resources to offer eggs, the federal government, which provides 60% of the funding for midday meals, does not include them in its list. Goa and Madhya Pradesh recently banned eggs due to criticism from some groups. Aaditya Thackeray, a Sena (UBT) MLA, criticized the move and questioned why the government chose to substitute rice kheer and nachni satttu for eggs and sugar. He maintained that the interests of the populace, especially schoolchildren, are not served by the government.

The regulator met with the carrier to discuss restoring

Delhi: Business Standard sources reported that SpiceJet informed the Directorate General of Civil Aviation (DGCA) that it will spend Rs 400 crore in two years to restore 36 grounded planes. The regulator met with the carrier last Friday to discuss restoring grounded jets. Sources said this followed the airline's Rs 3,000 crore qualifying institutional placement from global investors and mutual funds. The airline did not respond to Business Standard's request for comment. At the QIP, the airline identified 36 grounded aircraft out of 58. This was mostly due to lesser payment defaults, aircraft maintenance financial issues, and component shortages. The airline informed the regulator that seven of the 36 grounded planes would return by year's end, sources added. The remaining 29 aircraft should be



reactivated in 15-21 months. "Overall, the airline anticipates it will take 18-24 months to bring all grounded planes back to service," source said. SpiceJet announced that it will lease seven planes to improve flying operations immediately while repairing grounded planes. It said the seven leased planes will join the fleet by November 15. Sources say the carrier's grounded jets will undergo Airbus and Boeing-mandated return-to-service (RTS) procedures. The DGCA will allow commercial passenger flights after the RTS process.

RTS is the procedure of restarting a grounded aircraft.

Maintenance, repairs, inspections, and regulatory compliance are required.

Change in rules marks discount broker turning point

Delhi: Domestic rating agency Crisil said discount brokerages like Zerodha and Groww will be most affected by recent regulatory changes to curtail investors' derivatives activity. Narayanan claimed derivative trades account for up to 80% of bargain brokers' revenue and under a third of full-service brokerages'. Largest impact, with new customer acquisition.

Ola Electric violated consumer rights as a recipient of the govt.

Delhi: The Ministry of Heavy Industries (MHI) instructed vehicle testing agency ARAI to investigate whether Ola Electric violated consumer rights as a recipient of the government's EV incentive scheme. After the Central Consumer Protection Authority (CCPA) issued Ola Electric a show cause notice for consumer rights violations, misleading advertising, and unfair trade practices, MHI took action. Charges during free service period or warranty, car delivery delays, and

service/repair delays are additional cited infractions. Old Electric is a FAME-II and PM E-DRIVE beneficiary under ARAI's eligibility requirements. Thus, MHI must get your opinions on the issue promptly "The ministry's letter to the testing centre stated. It further stated that under two EV incentive schemes, all OEMs, including Ola Electric, must maintain service centres to address consumer issues and provide warranties. Earlier, Union consumer affairs secretary and CCPA chief commissioner

Nidhi Khare confirmed that the National Consumer Helpline (NCH) has been receiving complaints for about a year. The company didn't answer problems effectively." CCPA can open a "class action" under the Consumer Protection Act if comparable complaints affect a 'class' of customers." CCPA reported almost 10,600 complaints wheeler producer. The T 30 rides on a set of 17-inch rims with a 110-section tyre on the front and a 150-section tyre at the rear. Moreover, the suspension includes 37 mm USD forks on the front and a telescopic shock absorber at the rear. Braking duties are performed by a 320 mm rotor at the front and a 230 mm disc at the rear. The motorcycle has advanced software features for an enhanced riding experience, including 3 riding modes and a 7-inch LCD instrument cluster. It comes equipped with connected features as well. There are four colours on offer - Horizon Red, Arctic White, Mercury Grey and Eclipse Black.

Tata Consultancy Services mcap cross Rs 15 lakh crore mark as shares soar

NEW DELHI: Shares of Tata Consultancy Services (TCS) jumped 4% on Tuesday, taking its market valuation to above Rs 15 lakh crore mark. The stock of the country's second most valued firm by market valuation jumped 4.05% to settle at Rs 4,133.45 apiece on the BSE.

The Indian Real Estate Sector Expects Equity Investments of Rs 74,815 Crore

Delhi : According to a survey by CBRE South Asia, the real estate sector registered equity investments of \$8.9 billion (Rs 74,815 crore) in the first nine months of 2024, surpassing the increase of \$7.4 billion (Rs 62,210 crore) in 2023 and demonstrating a year-over-year rise of 46%. The Indian real estate market has experienced a massive boom, reaching its highest point since 2018. A significant quarterly equity investment totaling \$2.6 billion (Rs 21,857 crore) between July and September 2024 is highlighted in the report.

Mumbai, Bengaluru, and Chennai drove this expansion, contributing 66 percent



of equity inflows in Q3 2024 with their respective subscriptions of \$0.96 billion (Rs 8,070 crore), \$0.40 billion (Rs 3,362 crore), and \$0.34 billion (Rs 2,858 crore). With capital inflows of \$0.31 billion (Rs 2,605 crore), \$0.27 billion (Rs 2,269 crore), and \$0.02 billion (Rs 1,681 crore), respectively, Delhi-NCR,

Pune, and Hyderabad also saw a sizable portion of investments. Domestic investors, especially construction businesses, who accounted for roughly 79% of equity inflows during the July-September quarter, were the main drivers of the increase in investment momentum.

New Income Tax Return e-filing portal in the works? What taxpayers can expect

Gurugram Rate Soars 160%, Housing Prices in Top 10 Cities Soar 88% in 5 Years

Delhi : In the last five years, the average cost of newly constructed residential properties in India's top ten cities has increased by an astounding 88%, per a report released on Monday by real estate data analytics company PropEquity. The greatest increase in prices was seen in Gurugram, where average prices shot up 160% from Rs 7,500 per square foot in 2019 to Rs 19,500 per sq foot in 2024. Mumbai, on the other hand, saw the least gain over the same period, going from Rs 25,820 per sq ft to Rs 35,500 per sq ft, or 37%. Noida (146%), Bengaluru (98%), Hyderabad (81%), Chennai (80%), Pune (73%), Navi Mumbai (69%), Kolkata (68%), Thane (66%), and Mumbai are the next cities in terms of price growth after Gurugram. In the top 10 cities—Bengaluru, Chennai, Hyderabad, Kolkata, Mumbai, Thane, Navi Mumbai, Pune, Noida, and Gurugram—the survey examined 15,000 new launch projects that included flats, floors, and villas. In the past five years, real estate prices have increased dramatically in all major cities. The factors that have contributed to such a steep rise include the massive infrastructure development, the growing interest from NRIs, HNIs/UHNIs, and stock market gainers looking to create wealth and generate income through real estate investment, rising sentiments towards homeownership, and the general shift towards luxury/super luxury homes as a result of rising aspiration and affluence.
